Senator **BRANNIGAN:** Thank you, Madame President. Ninety-four years that people have been remembering this tragic event and each year a group of people from our area come back to help us remember. I remember last year saying how hard it is to understand that genocide goes on and on around the world and when are we going to stop. I reminded myself and all year long I have been paying attention in the paper and on the news about genocide. The hauling of people out of their houses. The horrors of the killings. It just goes on and on. It's very, very upsetting if you begin to pay attention to it, everywhere in the world. These people, for all these years, have come back to remember. There are groups now, and there have been groups forever, that have said it wasn't genocide, it never happened; just the same as some people are now saying that about the holocaust, which is much closer to us. We're very proud and glad that these folks come back, they remember, and pass this on generation after generation. I appreciate the opportunity to speak about this great remembrance.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON:** Thank you, Madame President. This is a bill that I introduced when I had a number of the nursing homes in Northern Maine approach me. I certainly will tell people right from the start that this is certainly not something that is my strong suit, Health and Human Services, but it was explained to me. I guess every so many years DHS decides to pick a year and in this case they picked 2005. They have to reimburse the nursing homes the money that they owe them. For the 2005 year, I guess the State didn't have quite enough money to reimburse them. The numbers that they were going to have were 96% of the actual cost to go out to all the nursing homes throughout the state of Maine. Apparently this didn't sit well with some of the nursing homes in the state of Maine and the agency allowed them to go and take the number, what money they had, and come up with some alternative plan. The alternative plan that was set by the Nursing Home Association lowered the amount to 92% that all nursing homes would get. The extra 4% would be spread out

amongst the nursing homes based on the wages they were paying to their employees. At least in the case of nursing homes in my area, this harmed them quite a bit. They were figuring that they were going to get at least 96%, it got dropped to 92%, and they certainly didn't get to get into that pot of money for the higher wages. I don't think anyone can disagree that Southern Maine pays higher wages than Northern Maine. That is certainly a good thing, in my mind, but some of the things that weren't taken into account were things like heating costs, which I would argue that Northern Maine probably pays more, snow removal, and a host of things that weren't taken into consideration. Just wages, which no one can argue are certainly lower in Northern Maine. If you actually look into the numbers: zone one, which is Northern Maine; zone two, and three have less private pay people that are in the nursing home, more MaineCare people. They are not going to get as much money coming in as places with private pay clients. They are not going to have as much money to spend for their employees. Basically, it's a self fulfilling prophecy, if we continue to do this, take money from the lower paying places, they next time this comes around the same argument will be made. These nursing homes couldn't pay as high a wage, so we're going to take some more money away from them. They are never going to be able to be on an even playing field. While I understand that for this round there may be not an awful lot that be done about it, but I still think that there is something wrong here. I recognize that. I realize it. I also realize that three Senator rule and all that, but it is still just not right and I ask you to oppose it.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Brannigan.

Senator **BRANNIGAN:** Thank you, Madame President. Men and women of the Senate, the Senator from Aroostook, Senator Jackson, has highlighted this issue and it is a difficult issue. As he said, at one point we did not have enough funds to fund everybody at the percentage they wanted so the Nursing Home Association got together and decided how to deal with it. It was very difficult for them to do that because it meant they had to pit some groups against others. They are going to work on that and hopefully they will. Certainly bringing this to the attention of everyone involved will make a difference. For now, our committee, on the whole, felt that the best way was to keep it as it had been worked out by the people involved. I would ask that you to vote with the majority and allow this to continue until it can be better solved. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Washington, Senator Raye.

Senator **RAYE:** Thank you, Madame President. I rise to lend my support to the good Senator from Aroostook, Senator Jackson, who spoke a few moments ago regarding the inequities that are imposed upon the nursing homes in our rural areas. I can tell you that I represent several rural nursing homes who are struggling to stay afloat and by perpetuating these inequities we make their battle more difficult. The Senator from Aroostook, Senator Jackson, mentioned the issue of fuel costs. Those of us who represent northern and eastern Maine and rural parts of Maine know that with regularity our fuel costs are much higher than the state average. We do represent nursing homes that have a very rate of MaineCare patients. In fact, I have at least one nursing

home who has 100% MaineCare patients. There are no private pay patients, whatsoever, to help them cover the costs of doing business. It is a struggle. I see it in my own community. I just want to echo the comments of the good Senator from Aroostook, Senator Jackson, and urge rejection of the Ought Not to Pass so that we can move on to the Ought to Pass Report.

THE PRESIDENT: The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS:** Thank you, Madame President. Men and women of the Senate, I come from a district that is, I think, to some extent adversely affected by these policies as well, but it's extremely difficult to grapple with the issue of wage differential from one part of Maine to the other. The most dominant cost differential is housing. I did a study of this a few years ago with David Silverman while looking at some data in regards to the school funding formula. I think the best thing about housing costs is that it represents at least a quarter of your typical household budget. Whether it be a mortgage that you are paying along with insurance and property taxes, which is the housing costs, or rent, regardless of which ever one you are paying it's typically drawing about a quarter, or maybe a little more than a quarter, of what the household brings in for income. The differential in housing costs between Cape Elizabeth and Milo or Aroostook County is on the order of three to one. The fact is that you can buy a really decent house in Somerset County, where I live, for \$90,000 or \$100,000 with an acre or two of land around it. The same things would cost you \$200,000 to \$300,000 within any reasonable driving distance of Portland. It's just one of those realities that those of us who live in rural Maine, I think, have to live with, that we are going to be paying people, in any rational system, a little bit differently depending on where they live and what their housing costs are. It is interesting to note that with State employees, I'm familiar with the court system, we pay the same wages for clerks through the District and Superior Courts. We pay the same wages in Portland as they do in every other county in Maine. In Skowhegan, if you get a job in the clerk's office, in the court system, you have gone to heaven. You will keep that job for as long as you live because the benefits and the income are that valuable to you. Yet if you get that same job in Portland, the turnover down there is over and over again because the law firms are stealing those clerks out the clerk system as soon as they are trained up. They are stealing them out at \$25,000 and \$35,000 a year, which is a princely wage for Somerset County. We don't have good systems in place, frankly, either within the school funding formula or within the healthcare arena, as this is, or within the State employee sector for dealing with these dramatic differences in labor costs that exist in our state. The nursing homes got together, they came up with these differentials, and we need to honor the work that they did, as the Senator from Cumberland has said. That is the reason why I am on this report and will be voting Ought Not to Pass. Thank you.
