This is an issue that has been before the Legislature for close to 20 years now, that is of the seven members that serve on the LURC board what is the minimum threshold for the number of those that actually live in LURC jurisdiction? Currently the law says that only two out of seven have to live in LURC jurisdiction. Some of the Committee members wanted that two in statute to be moved up to four. My co-chair and I felt that the best compromise in this area would be to move the number from two out of seven to three out of seven. Our thought was that currently there are three LURC commissioners living in LURC jurisdiction out of the seven. Let's at least change the statute from two to three to ensure that the number that are living in LURC jurisdiction remains at least as it is now. That is why I moved Report "C". Thank you.

Senator **ROSEN:** Thank you, Madame President. Men and women of the Senate, the only reason I set this item aside is to take a moment to say a couple of words about this bill, which has been quietly moving through the process. It is significant because of its success and because of the work the members of the Health and Human Services Committee and many others did for the last four years. This is a bill that establishes a new health model for the public health system in Maine, a system that has never really existed before. In this State we've had a centralized function in State government in what is now the Maine Center for Disease Control and Prevention, the Department of Health in Bangor, and the Department of Health in Portland, but otherwise, we've had a very fragmented system. For the last four years people involved in the public health arena, people involved with the Healthy Maine Partnership, folks connected to healthy community coalitions, people who are connected to the Heart Association, the Lung Association, the Cancer Society, and all of the other body parts organizations that are very active in health-related items, have all worked incredibly hard to try to bring together a mechanism so that we have an on-the-ground public health system that has a Maine flavor and a Maine style. People have put in huge efforts. I particularly want to acknowledge the director of the Governor's Office of Health Policy and Finance, Trish Riley, and Dr. Dora Mills and the Maine CDC who put in tremendous time and effort. This is really a case study of how you take existing funding and resources and hundreds of people that are involved in a particular arena, and essentially, over a period of time, conduct what really was a mini version of the Paris Peace Talks with great persistence and hammer out an integrated system. Now, at this point, they are ready to deliver so it will be eligible for federal accreditation. Just to give you an example of its early success, when the State was confronting the H1N1 virus, Director Mills was able to immediately reach out and have an interactive conversation with over 200 public health grassroots people in the field and have a quick reaction and conversation, which she really has never been able to have in such an integrated manner before. I applaud the work of Representative Miller in the other Body and all the people who took her lead in this effort, and I encourage your continued support. Thank you.

In fact, I'm happy to report one of its competitors, which to our advantage, was recently not able to be successful and so that business is coming forward to the Lincoln mill. I hope that, yes, it would be successful in paying back the note. However, that will be negotiated, the terms of the note, by FAME.

Senator **BRYANT:** Thank you, Madame President. Ladies and gentlemen of the Senate, just a few thoughts on this process. There are different sides on this issue and I don't come down on any one side, but where I do come down in opposing the pending motion is that it's hard enough to get people to serve on this board. That was like throwing salt in an open wound to suggest that qualified people to serve on LURC don't live in LURC jurisdiction and aren't interested or have time to serve. We've had as many as four out of the seven LURC commissioners in the past living in LURC territory. Now current law says that two, that's the minimum threshold, out of seven. What myself and my co-chair, and I'm glad to see now the good Senator from Aroostook, Senator Sherman, are supporting at least moving the statute to three. Currently there are three commissioners out of seven who actually live in LURC jurisdiction. I urge you to support the pending motion, to at least have three out of the seven commissioners actually live in LURC jurisdiction. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Knox, Senator Rector.

Senator **RECTOR:** Thank you, Madame President. Men and women of the Senate, this is a bill to try and address some of the issues that we find our small businesses face around the State with regulation and the need for someone to sort of run defense for them. We felt that we had a means of doing that and it is the Minority Report. We're hoping that you will consider defeating this motion and allow us to present our arguments because we think there is a compelling case to be made for support of our

small businesses around the state. I will speak to that at the appropriate time. Thank you, Madame President.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Schneider.

Senator **SCHNEIDER:** Thank you, Madame President. Men and women of the Senate, I hope you will support the pending motion. This bill was a bill that we felt has already a mechanism to be addressed through the Regulatory Fairness Board. It's a board that has just gotten membership and is starting to get going. We'd like that board to have an opportunity to address these sorts of issues that were brought forward in the bill. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Piscataquis, Senator Smith.

Senator **SMITH:** Thank you, Madame President. Members of the Senate, just a couple of words. Regulatory costs are one of the top three or four items when you poll many businesses in this state. It's been time and time again. In 2007 a compilation of various reports was made by the Maine Economic Research Institute that, in compiling those reports, showed regulation as the number three item behind taxation and less government. I think probably less government could be combined with regulations as well to probably put that as number one on the list. This is a serious matter for those of us who are interested in finding ways to bring more job opportunities to the people of Maine and creating capital investment here in Maine. The private sector is speaking very loudly and clearly on this and this Legislature has done nothing to address the issue. We are very mindful, those of us who are interested in this issue, that we cannot spend money this year trying to wind our way through this. We are also mindful that the Regulatory Fairness Board has basically failed at this point. As a matter of fact, the half position dedicated to it was defunded in the budget, we found out, within the last 24 hours. We need to restart this process and at least get us back to where we have a vehicle for businesses to deal with regulatory costs and regulatory issues. I'm hoping that you will oppose the pending motion so that we can adopt the other report and perhaps table this bill momentarily while we figure out a way to get this done in view of the fact that, as of 24 hours ago, the position that was available to help address some of these very serious regulatory process issues has disappeared on us. I think we can come up with something and I would ask for the opportunity to do so. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN:** Thank you, Madame President. Men and women of the Senate, I would concur with the Senate Chair on this. This bill was presented as a concept draft. At a time when we are facing serious financial concerns this concept draft came in. This is what we were to look at, 'This bill proposes to reduce regulatory costs for businesses in the state by establishing a council on private sector regulatory costs composed of private sector business leaders.' The State would be funding something for the private sector. It would have the power to compel staffing from any State agency and have the authority to compel a State agency to cooperate. It was a concept draft and yet we are compelling people. We have a Regulatory Fairness Board

designed. This is a problem. At a time when we're trying to cut State government, we seem to want the private industry to travel. There is more I could say and I know that we worked with this. That was from the testimony that we got. We did get some further clarification in the work session. To come up and to pass a law that would allow the private sector to come in and compel State staffing to do certain things, would grant authority to something that is State funded to private sectors, is beyond my comprehension at this point. Perhaps it's a good idea, I don't know, but to be looking at concept drafts at this point in our economy is not a good idea. I ask you to please support the pending motion. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Knox, Senator Rector.

Senator **RECTOR:** Thank you, Madame President. Men and women of the Senate, just to correct a little misunderstanding, perhaps, that the good Senator from York has expressed. It was indeed a concept draft when this came in but we have refined that through the Committee Amendment "A", which is the Minority Report. It does, in fact, address a variety of the issues I think she expressed concern about. We have a structure, we do have a plan, and we are prepared to implement it if we can get the Minority Report. Thank you, Madame President.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN:** Thank you, Madame President. Men and women of the Senate, I would simply remind the men and women of the Senate that when we heard the first thoughts of this it was a concept draft. It was created after, as the Minority Report, when we said no, that there were some problems and all of a sudden we have a Minority Report being written to implement law when the Majority had said no. I would tell you that the Maine Regulatory Fairness Board has some members on it that are pretty impressive. The two chairs are former Senator Marge Kilkelly and Larry Schneider, who is the Vice-Chair. Just those two people alone are pretty impressive. They are willing to move ahead. I would strongly suggest that we should have had some more at the hearing. There were some ideas. We should vote Ought Not to Pass now and perhaps bring the issue forward next session. Thank you.

**THE PRESIDENT:** The pending question before the Senate is the motion by the Senator from Penobscot, Senator Schneider to Accept the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Gooley.

Senator **GOOLEY:** Thank you, Madame President. Men and women of the Senate, I am pleased to stand before you on this particularly hard issue. It's L.D. 1187, to allow sale and use of consumer fireworks. There are over 20 states that now allow consumer-grade fireworks. I have a whole speech but I'm going to forego it. You received a flyer here earlier. I'll outline that. Maine is one of five states which allow only novelty fireworks such as sparklers, yet you can drive a few miles to New Hampshire, whose law L.D. 1187 is modeled after, and purchase a much broader selection of fireworks. L.D. 1187 proposes a \$1,500 per year license fee for sellers of fireworks. In addition to the taxes received on the sale of fireworks, this bill is a boon to Maine's economy and it also keeps hard earned Maine dollars in Maine. That's important. It has a lot to do with the way life should be, which the sign down in Kittery says. New Hampshire estimates the annual sale of fireworks exceeds \$7.8 million and if Maine's 5% sales tax was applied it would result in at least \$390,000 in the General Fund. Over and above that is the millions of dollars in sales which Maine residents would keep here in Maine, and that's very important. L.D. 1187 also provides a higher level of safety to Maine consumers by ensuring their fireworks are safe and are not merely purchased at a roadside stand in a different state. L.D. 1187 prohibits the sale of fireworks to anyone under the age of 21. Also this bill gives local municipalities local control to adopt their own ordinances which allow or prohibit the sale, use or possession of fireworks. I hope we will go on to support the Minority Report. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator **GERZOFISKY:** Thank you, Madame President. Ladies and gentlemen of the Senate, let the fireworks begin. It's a good

day for it. It's a Friday and it's a good day for fireworks. This bill came through the committee. We had several work sessions on it. Because of the financial implications, we tried our best to find a way to be able to do this, but we were unable to find that magic formula on how to regulate industry, this product coming into Maine, and how to provide public safety. On one hand we have public safety and on the other hand we have some tax revenues. I'd certainly like to have those tax revenues because I could certainly spend them or give suggestions where that revenue should go. When I look at states like New Hampshire that sell fireworks, as the good Senator just mentioned, I see that they had 47 fires last year caused by fireworks. I realized that when I got elected to the Maine House in 2000 until I got elected to this Body, Maine had 43 fires caused by fireworks. That's public safety because you realize that you can't legally go to New Hampshire to buy fireworks and bring them to Maine, because you are breaking the law when you do that. The Fire Marshall explained to us the dangers of fireworks coming into the state and not having regulations on them. This bill brings no regulations and allowed some of the municipalities to say whether you could have them or not. I thought that was interesting. In Brunswick, my hometown, if I started shooting off fireworks across the Androscoggin River into Topsham, where they didn't allow them, I think the Senator from Sagadahoc, Senator Goodall, might have a problem with that and I'd probably get a telephone call from him. I look at states like Washington, on the other side of the country from us on the Pacific Ocean, and they allow fireworks. They had 1,693 fires and they have a population of about 6.5 million people. I look at Massachusetts, which doesn't allow fireworks but has the same population, they had 67. That's a pretty big difference between the states that are allowing these fireworks to come into them and the states that are not. If you want to talk about public safety and you are going to talk about regulating fireworks, that bill will probably come before this Legislature sooner or later. It's when the industry comes here, and the industry wants to regulate these and get them to be able to be sold in Maine, that we will pass a bill. When it's just the businesses that want to come into Maine and be able to sell fireworks with no regulations, no safeguards, no way to prevent kids from buying fireworks and cramming them down a barrel of a pipe and creating a bomb, just because that's what kids do and they are dangerous, I would hope that this Body would follow the Ought Not to Pass on this. My committee has a fire chief on this bill, we have law enforcement on this bill, and we have public safety on this bill. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Gooley.

Senator **GOOLEY:** Thank you, Madame President. I also have these same statistics that were just given to you by the previous speaker. I guess I would single out that statistics are statistics, facts are facts, factoids are factoids. Everything has to be qualified. What kind of fire? Is it a little fire that might be 5' by 5' or is a raging forest fire? I don't think there are many raging forest fires. I have statistics here which show the fireworks fires reported from the latest year. It shows that Maine had 13 from fireworks, so fireworks are rampantly used here in the state of Maine now. New Hampshire had 16. I rest my case. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Damon.

Senator **DAMON:** Thank you, Madame President. Ladies and gentlemen of the Senate, I rise in opposition to the pending motion. I do not have the statistics in front of me with regard to fires and the causes of fires, although the good Senator from Cumberland and the good Senator from Franklin have quoted some of those statistics. My sense is that there are more fires started by lighting firewood than there are from lighting fireworks, yet we don't want to prohibit that practice. I would simply say that as you consider this you should let those who light decide. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN:** Thank you, Madame President. May I pose a question through the Chair?

**THE PRESIDENT:** The Senator may pose her question.

Senator **PLOWMAN:** Thank you, Madame President. Under current law, are fireworks considered contraband in the state of Maine?

**THE PRESIDENT:** The Senator from Penobscot, Senator Plowman poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator **GERZOFSKY:** Thank you, Madame President. Yes, I believe they are.

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Gooley.

Senator **GOOLEY:** Thank you, Madame President. In response to that question, the State Police does go into New Hampshire and does give out summonses to individuals who buy fireworks in New Hampshire and bring them back into the state of Maine. That is an expense for the State Police to do that. As I said before, fireworks are already rampantly used here in the state of Maine. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator **GERZOFSKY:** Thank you, Madame President. Ladies and gentlemen of the Senate, I want to give you one absolute statistic. In 1963, when I was living in Pasadena, California, my family's home burned down on New Year's Eve. The fire was caused by fireworks, sparklers, those little things that kids have. It was against the law to have them but the kids were playing down next to the house and it caught on some leaves and the house burned with my family sound asleep. I wasn't at home that night. I was up at Colorado Boulevard getting ready for the Rose Parade. The fire department had to spend that night fighting a house fire with the Rose Bowl floats going by it, not wanting them to catch on fire. They were more interested in the floats than the house at the time. These fireworks, we all use, we all like them, and we all like to go see them. One of the biggest fireworks displays in New England is held in Bellows Falls, Vermont the first weekend in August and I would suggest that everybody go there

to watch them. They are as big as anything you'll find in Boston or in New York. New York is another city I spent quite a few of my years in and we put together a fireworks display there and spent \$100,000. It was absolutely regulated by the town and allowed. We can be very flippant if we choose and let those who light decide. I like that one, I thought that was good. Let's remember the effects of these fireworks. You hold a sparkler in your hand and you're four years old. You are playing with it and you hold that in your hand. It does not go out. That little kid is going to have a scar on her hand and in her mind for a long time. Let's remember that these things kill people and if we're not going to regulate them, we shouldn't have them. Thank you very much, ladies and gentlemen, and please follow my light.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Nutting.

Senator **NUTTING:** Thank you, Madame President. Ladies and gentlemen of the Senate, I also rise to support the pending motion. It really had quite an effect on me at the public hearing to hear the testimony of a physician, who was president of the Maine Medical Association and also head of the Maine Society of Eye Physicians and Surgeons, talking about the unfortunate circumstances where they've had to do surgery on kid's eyes resulting from accidents with firecrackers. I voted on the Ought Not to Pass Report. In the future, if there was a different bill that had a lot more regulation as part of it, I might reconsider that position. Right now this Medical Association testimony, to me, was very powerful. A lot of accidents happen and here are these doctors trying to make the best of a really bad situation. I don't think we need any more examples of that here in this state, at least not for now.

Senator **GOOLEY:** Thank you, Madame President. Men and women of the Senate, having risen three times on this issue, is it permissible to speak again?

Senator **NUTTING:** Thank you, Madame President. Ladies and gentlemen of the Senate, just very briefly, this is a 12 to 1 report out of our committee. We anticipate the federal government changing the rules on the growing of this type of industrial hemp. This, for the agriculture community, could have great ramifications in the energy front as far as using this for energy pellets for woodstoves, and in the fiber production front as well. This particular variety that would only be allowed, it was said at the public hearing that if someone was going to try to smoke this product to get high that the cigarette would have to be the size of a telephone pole. That made us comfortable. This is a product which is grown in several foreign countries. A lot of it is grown in Canada. This would only happen if the federal government says that it could. This would allow us to be more streamlined and get production up and started quicker. I urge you to support the pending motion. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Sherman.

Senator **SHERMAN:** Thank you, Madame President. I rise to lay some facts, if I may, contrary to what I've just heard. I apologize for not having my papers. After yesterday I just kind of dumped them, so this is going to be off the cuff. This is a form of marijuana that looks like a marijuana plant, it smells like a marijuana plant, it has Tetrahydrocannabinol in it, it's 3/10 of 1%. The stuff smoked around the countryside is 6%. It doesn't have to be a telephone pole size, it could be about three or four feet if you wanted to wrap that up. I wish I had the amendment here. You probably have it. If you could take a look at that. The federal guidelines are that you have to be fingerprinted if you're going to grow it. You have to have GPS coordinates on it. Background checks. You can fool yourself into thinking this is something that's tightly controlled, but on the other hand, if you think about it, the federal government is going to issue something and go into criminal background checks, fingerprints, and maps locating all of this stuff. I think that should tell you something as to whether this stuff is semi-safe or not. The thing I really am opposed to is that this is touted somehow as some sort of development for farmers. This thing may or may not happen. I mentioned the other day, if

you want to talk about canola, which is ongoing and we could help that along, or soy beans. Raye's mustard, some of that is grown up in Aroostook County. If you want o you could figure some way to do that now. There is an infrastructure there. I'm going to have this wrong because I don't have the numbers in front of me, but I think in either British Columbia or Alberta, 43,000 or 46,000 acres of this was grown. It's a crop they can't sell because there are so many substitutes for it. Pardon me if I have it wrong, but I think in Canada now it's down to 8,000 acres. In my mind, if it's touted as economic development, put it in your diaries and look three or four years from now and see what happens with this. If you had a real good chemist, and you look at the pictures of it and it looks exactly like the ordinary marijuana that you can see all around the countryside in some places if you drive the back roads, you could extract, if you wanted to, 3/10 of 1%, you can grind that up and dissolve it in ether or something, reflux it and you can enhance that if you want to do that. All I am saying is we can pass this, and I can see the headlines now of what a nice hemp state up here, come and grow it. This issue really for me is that this is a phony kind of way to help agriculture in this state. I'd rather go back before Appropriations and talk about maybe a little milk tier. That would have an impact, but I won't go back there. I don't want to pick up more rocks that are thrown at me. I just think this is, in my mind, really a phony issue to help agriculture in this state. I really don't think it's going to happen. Thank you.

Senator **SULLIVAN:** Thank you, Madame President. Men and women of the Senate, I would simply tell you that this is a Resolve. Each session we appear to have more and more casino bills and racino bills. This is a Resolve that would set up, if one of these should pass at any time, and study what we would want, would Maine control it rather than an outside company, and what would be the rules so everybody would not be playing on the rules. It is simply being proactive to something that may or may not happen. It is a Resolve. It does not allow a casino to be built through the State or anything right now. It simply is a chance to have a coming together, an understanding, and rules for if this were allowed by a vote of the people, or whatever, in this state.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN:** Thank you, Madame President. Men and women of the Senate, I stand to speak with the Senator from York, Senator Sullivan. This was a unanimous report of our committee to send it forward so we can work on it so that if and when this does happen we are not reactionary but, as the Senator said, proactive. It is time that we recognize that we are a gambling state and there is interest. We need to have good public policy in place with all the questions identified and answered as we go forward. I know there has been some angst about the title, but if you look at it, you will see that it is a concept draft for us to recognize all of the issues and flesh them out at a time that works for us and not against us. I urge you to vote for the Resolve. Thank you.

They also provided for an income tax exemption for the first \$2,400 of unemployment compensation. We now had the opportunity to conform to that. We did not. We took their \$30 million, we're passing out additional benefits, and we chose not to provide that benefit to the folks of Maine. The second thing that we agreed on unanimously was the Earned Income Tax Credit. In the non-conformity piece is a small piece where we do not conform with a change to federal government made to the Earned Income Tax Credit. We found that to be unacceptable but it is in the budget. Thank you, Madame President.

Senator **PLOWMAN:** Thank you, Madame President. Men and women of the Senate, in the last couple of sessions the LVA Committee has been asked to look at ethics, transparency, and accountability. As part of a working group, people have been invited to address the Ethics Commission on different issues that have arisen. In talking with some of the members and attending some of the meetings, it came to my attention that there has been a practice developed by some legislators to approach lobbyists during the session to ask for donations to the organizations they are employed by. I worked diligently with the Commission to come up with some language to prohibit that kind of undue influence. The language you will see as part of the Minority Ought to Pass Report is to get at that. You may say that we don't have a problem, but when a lobbyist feels that the pressure is being put on them to donate to a non-profit during session, and they don't think they have the ability to say no, and there's nothing that actually says that the legislator can't do it, it seems to me we have a problem that needs to be addressed. There is a member of the 124<sup>th</sup> Legislature who draws a nice salary from a non-profit. A recent article actually indicated that assets in his organization grew from \$170,000 to \$1 million, and membership jumped from 884 to 1,608. This person was very pleased with the success of his organization. I imagine so was the board of directors and I'm sure there is a great incentive program for someone who is that successful. The fact that mining a lobbyist during session is considered okay because we haven't prohibited it doesn't mean that it passes the straight face test.

A lot of talk which arose in committee was talking about whether you'd still be able to raise money for the Maine Lung Association if you were riding in the bicycle trek, or whether you would still be able to raise money for the Heart Association. That's not what this gets at. This says that if you are compensated by your employer to raise money you may not approach a registered lobbyist and request or accept monies. Someone else from your organization will have to do that. I think that's a good idea. I really do because if we're going to pass the straight face test of accountability and we prohibit any kind of donation from a lobbyist while we're sitting here voting on their issues, while we control the outcome of the bills in committee, then there is no way we should be asking anyone for funds for any purpose, no matter how well intentioned, if it's connected to the way you make your money, the way you support yourself, the way you earn a bonus, or the way you get recognition at your place of employment. I would urge you to reject the pending motion and go ahead and pass a worthy ethics revision because the people of the state of Maine expect us to come here and do the right thing without asking for a pound of flesh from the people who have to come before us. I appreciate your vote.

**THE PRESIDENT:** The Chair recognizes the Senator from Sagadahoc, Senator Goodall.

Senator **GOODALL:** Thank you, Madame President. Men and women of the Senate, I rise today to encourage you not to support the pending motion. This is a very challenging case. This is one of those cases where we often find ourselves in a policy position, weighing the facts, acting much like a judge. This situation, as many of you know, is dealing with individuals involved in the Health and Human Services and the background of the case at hand, which often does not allow us to review all of the facts because they are confidential. Mistakes were made by the Department, mistakes that caused financial hardship on the individual as well as probably much aggravation and frustration. However, if we reimburse this individual, this would be a major policy shift. There would be no trial. Often we allow people to potentially sue the State. That is not what this is. We are reimbursing this individual for what is a mistake by the Department, however we don't have enough facts in front of us to make a good judgment, if in fact, everything that was stated to us is the truth. I am not contesting the fact that potentially the testimony was misleading; however, we only had one side of the story. I encourage you to vote against this motion because this case is better suited for the courts. It's a major policy shift with possible unintended consequences in the future. Are we going to reimburse everyone? We cannot afford that. What we do need to do is review the policies of the Department and that's where this bill should go. Thank you, Madame President.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN:** Thank you, Madame President. Men and women of the Senate, I am going to ask you to support this piece. Indeed, mistakes were made, mistakes that very much affected families. This woman, who came before us, was told it would be easier not to sue the State. That it's expensive. It has to still go through our Committee. If you think of the number of people who have been allowed to sue the State they are few and far between. If you can't sue the State you cannot ask for reimbursement for the money that was spent because policies were not followed. I'm sorry, I wasn't elected to be a judge, and in my Committee capacity, you do what you can to bring justice to Maine citizens. No matter what a State agency does, you have to come through us to allow them to be able to sue the State. This woman spent a huge amount of money, was told things that were not true, and ended up in a situation where she was told, 'If we had done this a year ago I would have made a different decision.' That was from the judge, who was very nonchalant about it. There is a problem when an agency believes they are more important than respecting the rights of people and to follow policy. How many people have to be abused, and I'm not talking physical or sexual abuse, by the system. We always end up with, 'Sorry, we made mistakes, but it might cost us money.' In fact, the agency was bold enough to come and say to us in the public hearing, at the

end, 'If you find against us, it will be taking money out of the budget and we won't be able to serve other people.' I'm sorry, that's not a good enough excuse for me. I didn't come here to allow an agency to ride roughshod over our people. There is something inherently wrong with that. I'm sure the State carries insurance for when they make mistakes. It's called liability. Each and every one of us carry it. The reality is we need to send a message loud and clear that if you choose to deny people their rights under the laws we create and then we must be responsible for that. Otherwise, how many other laws do we make that some other agency decides not to follow? It's a slap in the face to our citizens. It's a slap to the face to the Legislature. Based on the budget and money can only go so far. Interestingly enough, this woman is saying, for the sake of the whole case and I certainly can share that with you, 'I'd just like the money back that I've spent and let what has happened happen.' I find the blatant disregard for the Legislature by some State agencies beyond compare. They have way too much and to tell us that it might cost some money so we need to continue to let them continue to break the law, to break what we've set up as policies for them, and there's nothing anyone can do about it afterwards. I could not go along with that and I am disappointed to have to stand here and say that. I'm not a lawyer and my good colleague is. I wasn't hired to be a lawyer. I was hired to do what is right for the people of Maine, and this is right for the people of Maine. I ask you to please consider that. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Brannigan.

Senator **BRANNIGAN:** Thank you, Madame President. Men and women of the Senate, I also oppose the pending motion. I agree that we cannot set this precedent. Unfortunately, mistakes are made. Those of us who work with the Department of Health and Human Services know it's a huge department dealing with very important parts of people's lives. Do they make mistakes? Of course. Every time they make a mistake and someone wants to be reimbursed, can we do that? No. In a perfect world it would have been wonderful. This never would have happened to this woman or amends would be made. Amends need to be made here by the judiciary commitment and the judiciary to take care of any errors and habits that were transpired, and do transpire, in that court, and we need to look into Health and Human Services to find and try to root out any problems that have led to this kind of misappropriation and misinformation. Right now, to set this precedent would be mind boggling, so I hope you will vote against the pending motion.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN:** Thank you, Madame President. Men and women of the Senate, unfortunately the Minority Report was not to allow Ms. Bilodeau to sue. The Minority Report was a strict Ought Not to Pass. We have one option here. I'm not sure where to start, but I'll give you a little background. In the mid-1990s the State of Maine had the lowest kinship placement in the United States. We were in the low single digits. I think Vermont came in somewhere around 13% and the rest of the country was way up there. That policy was set by DHS because kinship care does not accrue a two-to-one match from the federal government.

If you place a child with a member of the family, the State pays all of the expenses for that child. If you place the child with a stranger, the federal government will give you \$2 for every \$1 you spend. It's a very interesting way to decide what's best for our children. I actually had to put in legislation to make the State recognize that the federal government controls this and that their recommendations were that kinship care would be the first avenue that you consider for a child.

Ms. Bilodeau is the aunt of the young boy. It was her brother's baby. Three months after the baby was born she learned that the baby was indeed her brother's and she contacted the DHS in order to become a kinship caregiver. DHS instead routed her through the foster care system. Why? The two-to-one match. She didn't need to but she did. She jumped through every hoop. She hired an attorney. She had a physical. She had her house examined by the Fire Marshall. She went through every step that she was asked to. Then interestingly what happened was people stopped calling her back. Fifteen people stopped calling her back. Fifteen caseworkers and supervisors stopped returning her phone calls. This went on for about a year. She was not notified of hearings. She wasn't brought along. She just happened to advocate strongly enough for herself to find out there would be a hearing, and the people who had the child for 15 months would indeed adopt the baby. I am not an attorney. I am not a judge. I don't know if she was the best person to give this child to, but that's not the question here. When the judge said, 'A year ago I could have given you this child, but now he's bonded with someone else,' that might have been an indication of what the judge was thinking, but I'm not a judge. I will tell you that when we asked for the telephone policy for DHS caseworkers to be provided to us, we were actually handed one that has been proposed and sent out for comment. Based on the comments, it will go into effect June 5, 2009. Do you think they figured out they had a problem? I think they did. In fact, we had to specifically ask what the policy was that is in effect now. That wasn't provided to us. I thought that was interesting as well.

Confidentiality will mean that when this lady sues, she won't be able to find out any more than she probably knows now because DHS will say that they are not allowed to let any of that information out. She'll run up a huge legal bill to get the same amount of information that she has now, but then again we didn't have a vote on whether she'd be able to sue. This woman was wronged by the policies and the attitude of the Department of Human Services. She will not be raising her nephew. In fact DHS felt so badly that when the next child was born, they gave the child to her immediately. It seems she was good enough for the next child. I'm not going to make the decision as to whether she properly should have been awarded. Seems like they already made that decision as well. Those are two things you can draw just from the happenings. What happened was fifteen people shirked their duty, disregarded what was in the best interest of the child, which is to pursue kinship care to the greatest possible extent until the person is found to be not the best caregiver. If you don't return the phone calls and you don't do your job and the other person does everything that they were asked to do and incurs every cost, can you actually say that she should not be reimbursed? I really don't know how you say that, because the issue wasn't whether she was properly to be awarded the caregiver status. The issue was; did DHS, in good faith, work with this woman and do their jobs? You know what? They didn't. Thank you.

I have some trepidation about standing up on this, other than I have been encouraged to stand up on this. There has been concern about

the veteran's tax exemption for their property, their homes, that was up until a couple of years ago, \$5,000. I hope everyone knows that it gets discounted. If you live in a community where your property taxes are not at 100% valuation, the homestead exemption get discounted by that proportion, whatever is less than 100%. Last session the Taxation Committee and the Appropriations Committee moved that up to \$6,000. This bill originally proposed to raise it another \$1,000. I think there was a plan, hopefully, to get this up to a reasonable amount over a period of time. Don't forget we only reimburse the towns for 50%. Each \$1,000 costs the town \$300,000 to \$400,000, so maybe it's closer to \$400,000. This didn't seem possible at this time. This bill has been amended to just ramp this up at 5%. That is probably a little higher than the CPT, so over time there is hope that this will rise to a more reasonable point, however long that takes. Five percent on \$6,000 gets you up around \$6,300 and even that's going to cost us about \$100,000. That's the essence of this bill and the plan has been scaled down and modified, and I hope we can still move ahead with this. Thank you.
