**PASTOR GARCIA:** Good morning, President Mitchell and  
honorable Senators of the State of Maine. Thank you for the  
invitation to share at least a few thoughts with you as you open  
your day of business this day. In our worship service on Sunday  
our congregation studied a Bible passage from 1<sup>st</sup> Corinthians 12.  
In that passage the Apostle Paul writes about the  
interconnectedness of all the parts of the body. He writes that  
every part of the body has a job or a function and that every part  
has a role to play in the overall welfare of the body. The body  
would not be the same without any of these parts. The smaller  
parts are just as important as the bigger ones and less showy  
parts are equally as important as the ones that get all the  
attention. He writes, 'The members of the body that seem to be  
weaker are indispensable and those members of the body that we  
think less honorable we clothe with greater honor. Our less  
respectable members are treated with the greater respect.' On  
Sunday we talked about the country of Haiti, which has been in  
the news the last couple of weeks as it suffered a disastrous  
earthquake and the multiple aftershocks. Before the earthquakes  
if we thought of Haiti at all we might have thought of it as a God-  
forsaken place, one of extreme poverty, without much to offer the  
rest of the world, and not really mattering in the grand scheme of  
things. Even though Haiti might be a weaker part of the body of  
the world we know it is still an indispensable part of it. In the days  
following the quake our world has been inspired by the strong will  
and courage and resilience of the people of Haiti and we respond  
by reaching out to them at this difficult time. A little closer to  
home, we know that our state also has stronger parts and weaker  
parts. We have more populated parts and less populated parts,  
wealthier parts and less wealthy parts. There are members who  
can care for themselves and members who cannot. Yet we  
understand that our connection to each other and the sacred  
value and worth of all of the parts of our state and individuals who  
live in it. As we settle into our work today, it is my hope that we  
will make decisions that benefit not only the stronger members of  
our body but the weaker ones who depend on us to care for them.  
I invite you to be in the spirit of prayer with me.

Ever present God, we offer You this day with all its potential  
and all of its promise. Be with us as we undertake the tasks that  
affect Your children living in this state. Guide our decisions as we  
serve those whose lives our in our care this day. We pray this in  
Your name. Amen.
