**THE PRESIDENT:** The Senator may pose his question.

Senator **TRAHAN:** Thank you, Madame President. Could someone please explain what just happened? I was reading a document and I know the item that is on the calendar and whatnot, but the issue of why we wouldn't want the committee to have this bill. Could somebody just explain that for me?

**THE PRESIDENT:** The Senator from Lincoln, Senator Trahan poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS:** Thank you, Madame President. The Senator from Oxford, Senator Bryant, raises an issue by his amendment as to whether this legislature should remove the term limits provision that has been part of the Workers' Compensation law since its passage in 1992. This is an issue that has, to my knowledge, been discussed in the committee of jurisdiction nor have we heard from the Workers' Compensation Board in any formal way as to whether they think this is an appropriate thing to do. In fact, whatever the underlying problem is hasn't been presented to us. The current law says that a member of the board may serve two four-year terms. There is an eight year term limit, just the sort that we live under here in the legislature. That provision has been in the law, to my knowledge, since 1992. The amendment that has been presented to this Body would remove that requirement and I understand that there is some concern that because of recent turnover in board membership, that is they lose a couple of the more senior people because of term limits, that there won't be very much depth of experience on the board and that this measure is being proposed at this time in order to make sure that a couple of people, I don't even know who they are, that are presently serving have the ability to continue serving on reappointment. Frankly, this is a matter that is need of exploration by the Labor Committee. We're just about done with all of our work. If this matter is referred to the Labor Committee I'm reasonably confident that we can spend half an hour looking at it and then come back to this chamber and the other chamber with an intelligent recommendation about the merits of the proposed amendment.
