The **SPEAKER**: The Chair recognizes the Representative from Sanford, Representative Tuttle.

Representative **TUTTLE**: Mr. Speaker, may I pose a question through the Chair?

The **SPEAKER**: The Representative may pose his question.

Representative **TUTTLE**: Could somebody please explain what this bill is doing?

The **SPEAKER**: The Representative from Sanford, Representative Tuttle has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Rockland, Representative Mazurek.

Representative **MAZUREK**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. What this bill does basically is that it takes the primary seat belt law that we have now in the State of Maine, as a primary offense, and makes it a secondary offense, and basically it waters down the bill tremendously. Mr. Speaker, may I also add a few other comments?

The **SPEAKER**: The Representative may continue.

Representative **MAZUREK**: Thank you, Mr. Speaker. I am hoping that the people of this House will vote as the majority voted to Ought Not to Pass. The seat belt law has been in effect since 2008 and there have been a lot of people who have spoke out for and against it. I'm looking for a note right now, and, if I can find it, I'll be right with you. In our meetings dealing with this, these are the people who have spoken out in favor of retaining our seat belt law. The Bureau of Highway Safety, LifeFlight of Maine, a number of doctors, nurses, medical people, Maine Driver Ed and Traffic Safety Education Association, AAA of Northern New England, the Maine Chiefs of Police Association, the Maine Orthopedic Association, the Maine Public Health Association, the Maine Association of Insurance Companies, General Motors, the Alliance of Automobile Manufacturers, and the Maine Nurse Practitioner Association are just a few of the people who spoke saying that we should retain our bill, keep it as a primary offense.

We also have to look at the cost of what we're talking about. If we do away with this and make it a secondary offense, we're talking approximately \$1.5 million it will cost the State of Maine. There will also be a significant increase in the cost of Medicare at the time when we least can afford it. Just in safety alone, in the year 2009, over 70 deaths were prevented because of the seat belt law on the books, a law that requires us to buckle in our children. Now for some reason, when we reach the magical age of 18, we're now going to say we don't have to buckle in. I don't know if our heads got any harder. I don't understand why. But I think that we're talking about safety here and I really strongly would urge that Maine retains this seat belt law. Thirty-six states have had it. No state has considered repealing it except Maine. Why step backwards? Why move back when we should be moving forward? Doctors, nurses, people, all have testified very strongly in support of it. It saves lives, it saves injuries. It is something that we should really maintain, so I am asking the people of this Legislature to stop and think. Do we want to go back, move backwards, or are we going to move forward? Please keep this bill intact. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Naples, Representative Cebra.

Representative **CEBRA**: Thank you, Mr. Speaker. I just would like to clarify a few items in relationship to this bill. First, I

hold in my hand and I know I'm not supposed to show it, but I have a fiscal note on this bill. It looks like \$650,000, not \$1.5 million. When the people came to testify on this bill before the Transportation Committee, quite a few organizations lined up opposed to this, quite a few citizens from the public came and testified in favor of it. It is interesting when I look at the fiscal note on this bill, that when the original bill was passed a couple years back it was a secondary offense in Maine and the bill to make it a primary offense, there was no fiscal note attached to that. So it is amazing how this has suddenly become a moneymaker in fine money.

What I would like to also say, Mr. Speaker, to clarify the point, is that this does not remove the requirement to wear a seat belt in the State of Maine. I will say it again. It does not remove the requirement to wear a seat belt in the State of Maine. This bill would just remove the requirement, or the piece of law, that says that a law enforcement officer could pull you over for such an offense. It would put it back to being a secondary offense, so if they pulled you over for something else, this would be a secondary offense if you weren't wearing a seat belt.

As far as public safety, I've heard statistics on both sides that say it's done nothing and I've heard statistics that say it's been a great thing. But as far as my personal liberties are concerned, I prefer to have the police not be able to pull me over for this. I think that having heard from numerous constituents, out on the trail as they say, as well as emails and phone calls, I've heard from dozens of constituents who don't like the fact that it's a primary offense and I've heard from a couple of constituents who believe that it should be a primary offense. So I believe this is one of those issues that you need to decide for yourself where you stand, and I know where I stand and that would be in favor of the restoration of it being a secondary offense. Thank you, Mr. Speaker.

Representative MARTIN of Eagle Lake moved that the Bill and all accompanying papers be **INDEFINITELY POSTPONED**.

Representative CURTIS of Madison **REQUESTED** a roll call on the motion to **INDEFINITELY POSTPONE** the Bill and all accompanying papers.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The **SPEAKER**: The Chair recognizes the Representative from Whiting, Representative Burns.

Representative **BURNS**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I guess I need to know, can I continue to speak on this subject or is debate halted at this point?

The **SPEAKER**: The Chair would inform the Representative he may proceed.

Representative **BURNS**: Thank you, Mr. Speaker. I understand the concern about this bill. I understand the concern about trying to make it a secondary offense, and the concern about intrusion into our lives when it comes to us and our safety. I share some of those concerns on a lot of those issues. But on this particular issue here, to me, it is in fact a no-brainer. We have come a long way in this state and in this country since the campaign to get people to use seat belts started. We saved thousands of lives. To go backwards now, I think, would be a terrible mistake. We now have a generation of people that are used to getting into a vehicle and buckling up, just as we're used to taking our infants and our young children and putting them in a car seat. I can't imagine going back to the days when kids were all over the place, people had no restraints in their vehicles, whether they wanted them or not. I remember those days when I started police work. It was a rare occasion to see anybody in a restraint device, a seat belt, even though we were required to

wear them as soon as they were equipped in our vehicles and that was for a reason.

I'm not concerned about the fiscal note. I don't look at public safety laws as a means of making money. I am concerned, however, about the incredible cost and I'll just quote one statistic from AAA that was done as a matter of reviewing 76 Maine Medicaid car crashes that involved patients under Medicaid, \$3.2 million in cost to the public. That's an incredible amount of money and that was just in, I believe, 2009. If this situation is important enough to put in a law, which we saw fit to do, then it's also important enough to enforce. I don't know professional officers that would use this as a method to stop your vehicle to check for something else. I'm not saying that doesn't happen, but that's not professional law enforcement. I do know, Mr. Speaker, of many law enforcement officers. In fact, most that I know agree this is a very important law. They know and they believe that because they see firsthand the number of lives that it saves. You will always have the argument, well, if that person hadn't been in a seat belt, they might have walked away from that crash. I am here to tell you statistically that is not a fact, that is a rare occasion. I have seen many accidents and the majority of them, the majority of them were people wearing seat belts have saved people from serious injury and death. So I go back to the same premise. If this issue is important enough to have it in statute, which we saw fit to do, then it is important enough to allow your police officers to enforce and the way that you do that is to have it as a primary offense.

When I started police work in the '70s, there was no such thing as a primary or secondary offense. If it was on the statute, if you folks saw fit to put it in statute then we were asked and we were charged as police officers to enforce it, and that's what you're supposed to do. So some reason we got into this gray area of, well, it's a law but it's not that important a law, so we'll call it a secondary offense.

I guess my final argument to this is if it's not significant enough to enforce, then let's repeal the law all together, let's go back to education and see if that meets the requirements and the needs in order to save lives on the highway. I don't think that's the answer but rather than calling it a law that's really not important enough to be a primary offense, let's just make it a recommendation. I urge you folks to follow my light.

On motion of Representative BRIGGS of Mexico, was **REMOVED** from the First Day Consent Calendar.

The SPEAKER: The Chair recognizes the Representative from Mexico, Representative Briggs.

Representative BRIGGS: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. This bill is designating March 29th Vietnam Veterans Day. This date was

selected because this was the day the last 2,500 troops were withdrawn from South Vietnam in the Asian country. Some people asked about the significance of April 30, 1975. This was the day when South Vietnam surrendered to North Vietnam. This was the longest war in U.S. history, starting back in the 1950s. There are certain days of recognition and/or acknowledgements for other wars, such as the Cold War Victory Day on May 1st. While other states do not have recognized dates for World War II, the Federal Government does recognize three days. They are Pearl Harbor Day on December 7th; V-E Day, which is Victory in Europe, is May 8th; and V-J Day, Victory over Japan, is August 14th. Armed Forces Day is May 15th. The Korean War, its Armistice Day, July 23rd. Veterans Day is November 11th. The Global War on Terror, which is the current conflicts, is tied to September 11, 2001.

On January 14, 2011, the Department of Defense announced its program to commemorate the 50th anniversary of the Vietnam War. The program thanks and honors veterans of the Vietnam War, including personnel who were held as prisoners of war or listed as missing in action, for their service and sacrifice on behalf of the United States, and to thank and honor the families of these veterans. To highlight the service of the Armed Forces during the Vietnam War and the contributions of federal agencies and governmental and non-governmental organizations that served with or in support of the Armed Forces, to pay tribute to the contributions made on the home front by the people of the United States during the Vietnam War, highlight the advances in technology, science and medicine related to the military research conducted during the Vietnam War, to recognize the contributions and sacrifices made by the Allies of the United States during the Vietnam War. The Department of Defense representatives will coordinate with other federal agencies, veterans groups, state, local government and non-governmental organizations for their input in Vietnam War commemorative activities.

There are 15 states that have enacted this day of recognition for our Vietnam veterans and six more are currently following suit, including Maine. About 58,000 Americans died in the Vietnam War. There are approximately 46,000 Vietnam veterans living in the State of Maine at this time. The Vietnam War has many effects on the United States and in Maine. This was the first foreign war in which the U.S. combat forces failed to accomplish their goals. This hurt the pride of a lot of Americans and left painful memories. Soldiers returned in the midst of angry antiwar protests, that often placed blame on the individual soldiers. Soldiers were treated very, very poorly. Soldiers were ridiculed. They were hollered at. They were spit on. They were called terrible, terrible names. It was just awful on their return home what they have endured.

On March 28, 1985, *The New York Times* quoted Richard Nixon as saying "No event in American history is more misunderstood than the Vietnam War. It was misreported then and it is misremembered now." I would like to repeat that. "No event in American history is more misunderstood than the Vietnam War. It was misreported then and it is misremembered now." This day of recognition is different in that it is correcting a measure of injustice by treating them differently when they came home from the Vietnam War, like none other. I have heard from very few Vietnam veterans who do not wish to have a separate day of recognition. I respect their views, but I believe that this war was different than any other and, because of that, should be treated as such. This bill would represent a symbol of gratitude and respect they were denied when they came home from an unpopular war. One Vietnam veteran said that the war is over, just leave it alone. If we just left this alone to go on forever, there will never be full closure. Let's bring this to the surface,

acknowledge our shortcomings, ask for forgiveness and it will die peacefully.

My brother is a Vietnam veteran. I was a teenager when he returned home. I can remember when he came through the door I asked how come he wasn't wearing his uniform. He said that he was told not to wear it home, that it was for his own safety. My brother never really recovered from this war. He continues to suffer from PTSD and other addictions, as many of them came home with. Our family almost lost him three times over the last few years. During that time, I was assigned as power of attorney. Twice it actually came down to the point where the doctor said to me "If he stops breathing, what do you want me to do?" Today my brother is in an assisted living facility because he can't make it on his own out there. His story is not the only one. There are thousands of veterans out there whose stories are the same, many homeless.

Upon the soldiers returning home, I remember watching on television as if it were yesterday. I can remember saying to my mother "Why are they doing that to them?" I have carried this heavy burden of hurt, pain and helplessness for almost 40 years. Today I stand before you to ask to heal this wound. Help me and thousands like me, both sides, veterans and non-veterans, to heal. By also supporting this bill you would be bringing so many veterans together who have felt distant for many, many years, help them to heal, help to bring them out in the open so that they may be reached and can be healed physically, emotionally and spiritually. Today I stand before you to ask to heal these wounds. You have the opportunity, not just for me but for all Mainers who wish to say I am sorry, thank you and welcome home. Thank you, Mr. Speaker.

The Unanimous Committee Report was **READ** and **ACCEPTED**.

Representative COTTA of China **PRESENTED** **House Amendment "A" (H-37)** to **Committee Amendment "A" (H-29)**, which was **READ** by the Clerk.

The **SPEAKER**: The Chair recognizes the Representative from China, Representative Cotta.

Representative **COTTA**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I rise to speak to an amendment to the basic LD 20 and I would like to tell you a little bit about it. The previous speaker and the bill's sponsor mentions people. People over vets. I can appreciate where she's coming from, what the intent is. I too am a Vietnam veteran of two years, two tours. But the bill proposes to take March 29th as Vietnam Veterans Day. The term "veteran," when we look back at World War II, the Bataan Death March, Iwo Jima, Guadalcanal, when you move and you look at Korea in Heartbreak Ridge, you look at Vietnam, the A Shau Valley and Kason, you turn towards Desert Storm, Afghanistan, Iraq, Just Cause, these conflicts, there are veterans of these conflicts, veterans all, men and women veterans, members of a very tight knit group that shared an experience.

This bill, my amendment to this bill says that the Department of Defense will recognize the 50th anniversary of the Vietnam War and, in doing so, will start a 10-year program of significant events during this conflict. This is what my amendment proposes and it removes March 29th for the aforementioned reasons. Don't take your veterans and cut them into little bite-size pieces. We don't, as a veteran and those veterans I've talked to, we don't want a day for Afghanistan veterans, Iraq veterans, Just Cause veterans, Desert Storm veterans, Vietnam veterans. We are veterans all. Men and Women of this chamber, I beseech you to support the amendment recognizing veterans and veterans of the

Vietnam era will be recognized by the 50th anniversary, Department of Defense, administered by the director of Veterans Services in Maine from existing resources. Please do not isolate your Vietnam veterans. If you recognize the offense and the abuse and the insults they received, don't add to it. Allow them to stand with other veterans. Thank you.

Representative **BRIGGS** of Mexico moved that **House Amendment "A" (H-37)** to **Committee Amendment "A" (H-29)** be **INDEFINITELY POSTPONED**.

Representative **CURTIS** of Madison **REQUESTED** a roll call on the motion to **INDEFINITELY POSTPONE** **House Amendment "A" (H-37)** to **Committee Amendment "A" (H-29)**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The **SPEAKER**: The Chair recognizes the Representative from York, Representative Weaver.

Representative **WEAVER**: Thank you, Mr. Speaker. I am a Vietnam veteran, three tours, so I think I can speak pretty well for most of our veterans in Vietnam. March 29, 1973, was the day our troops were being rescued from the top of the embassy by helicopters. We pulled out in defeat. This is a terrible day to remember the Vietnam veterans. I know no veteran in this chamber who wants to be separate from his fellow veterans who celebrate Vietnam. I know no veterans who want to celebrate Vietnam Day. Let us celebrate with our fellow comrades. Thank you.

The **SPEAKER**: A roll call has been ordered. The pending question before the House is Indefinite Postponement of House Amendment "A" (H-37) to Committee Amendment "A" (H-29). All those in favor will vote yes, those opposed will vote no.
