#### JOINT RESOLUTION RECOGNIZING MAY 2011 AS LUPUS AWARENESS MONTH

WHEREAS, systemic lupus erythematosus, commonly known as lupus, is an immune system disorder of unknown cause and in its systemic form may affect the joints, skin and one or more internal organs, such as the kidney, heart and brain; and

WHEREAS, lupus is a chronic, complex and life-threatening disease, in which there is always the potential threat of serious illness and disability, and while lupus can occur in men, 90% of the sufferers are women in their childbearing years, with African-American women, Native American women and women of Asian descent particularly affected; and

WHEREAS, ordinarily, the immune system protects against infection by producing antibodies that successfully combat foreign infectious agents, but in people with lupus, the immune system produces antibodies that can harm the individual's own tissues; and

WHEREAS, people with lupus have many different symptoms, but the most common are fatigue, muscle and joint pain, skin disorders and inflammation of internal organs and of the vascular and nervous system. Early detection and proper treatment is critical to the quality of life and survival rate of lupus sufferers; and

WHEREAS, researchers estimate that over 1,500,000 people in the United States have been diagnosed with a form of lupus or

related diseases and approximately 100,000 new cases are diagnosed each year; and

WHEREAS, to fight lupus, new research and new approaches to diagnosis and treatment are needed and the alleviation of the suffering of lupus victims can be achieved through patient services and the promotion of early detection of undiagnosed cases through lupus awareness programs; and

WHEREAS, scientists in biology, biochemistry, immunology, genetics and other fields are seeking to understand the causes of lupus and to develop better means of detection, treatment and prevention; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-fifth Legislature now assembled in the First Regular Session, on behalf of the people we represent, recognize that May 2011 is Lupus Awareness Month in order to make our citizens more aware of this prevalent disease.

#### In Memory of:

Dr. Robert C. Frederich, of Raymond, a longtime pastor and active member of his community. Dr. Frederich was raised in Maine and spent his early years in Rangeley. He joined the United States Navy and served until 1945. He was a graduate of Wheaton College and Fuller Theological Seminary, and he received his doctorate degree from Denver Seminary. Frederich served as pastor of many churches in the Midwest, then returned to Maine to serve as pastor of the First Baptist Church in Portland for 8 years. He learned much about theology and ministry in school, but there are many things about working with people that had to be learned from experience. Pastor Frederich had this experience and selflessly reached out to other newer or discouraged pastors to mentor and encourage them, and it is because he did this and reached out to mentor my husband that my husband was able to go on to mentor others as well.

Pastor Frederich attended one of our church services shortly before he passed. Even in his challenging physical condition, he sought the welfare of others and continued to encourage others. Pastor Frederich was a great man, a husband, father, mentor and spiritual leader. His influence will continue through future generations. We are blessed to have been able to know him and have him here with us for this time. Thank you.

The SPEAKER: The Chair recognizes the Representative from Orono, Representative Cain.

Representative CAIN: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. We have established a theme this session that I am personally very proud of and I believe in it. The best work we do, we do together, and by that standard LD 1333 is not our best work.

We have shown that we can work together at the committee level, when given time and space to do so, to supplemental budgets, regulatory reform, even vernal pools, Mr. Speaker, so why not this? On a bill that dramatically changes the insurance markets in Maine, it repeals the State Health Plan, repeals the Advisory Council on Health Systems Development, that something that just today on the calendar we added a member to.

This is a rushed expansion of our rating bands that will lead to increased rates in Maine. The surcharges or taxes of \$4 on all health insurance policies is new for Maine and fewer choices and higher rates for rural Mainers and businesses will be the result.

In fact, one of my caucus members stopped me on the way to session this morning and said "Emily, if rates in southern Maine will be so much lower than northern and Downeast Maine, won't all the businesses just move to southern Maine?" That is bad for our great state, but it is not too late to go back and work together, Mr. Speaker. Democrats have offered compromise proposals and continue to stand ready to work together on LD 1333.

So let me say it again: the best work we do, we do together, and LD 1333 is not our best work. Maine people expect more. Please join me in voting red on this motion and opposing this bill. Mr. Speaker, I ask for a roll call.

Representative CAIN of Orono REQUESTED a roll call on PASSAGE TO BE ENGROSSED as Amended by Committee Amendment "A" (H-186).

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Chipman.

Representative CHIPMAN: Mr. Speaker, I have lived in Maine my whole life. Growing up I have learned several important life lessons such as early to bed, early to rise; a penny saved is a penny earned; and two wrongs don't make a right.

Last Thursday when we were debating LD 1333, I heard members of one particular party talk about when the other party was in the majority, they also brought forward lengthy amendments to bills at the last minute and forced a vote before anyone had time to read it and without giving the public a chance to weigh in.

As the only Independent member of this body, I don't care what party is in the majority. Bringing forward a lengthy amendment at the last minute and forcing a vote with no time to read and understand a bill is wrong. Two wrongs don't make a right. And, Mr. Speaker, I voted no last Thursday and I will vote no again today. Thank you.

The SPEAKER: The Chair recognizes the Representative from Farmington, Representative Harvell.

Representative HARVELL: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I just stopped in to see what condition my condition was in. This beltline is not a preexisting condition and I have the photographic evidence to prove it.

Two days ago, the Bangor Daily News released the demographics of the State of Maine from the last census. We are at 42.3 years of median age. Lincoln and Piscataquis Counties are over 48. Let me give you a little historical context of that. The Soviet Union and Germany, after the Second World War, did not face these demographics. Children under 20 years of age dropped by 7 percent; those under 40, between 20 and 40, dropped by 8 percent.

This bill seeks to set free a suffering youth that we have chained to our bad health decisions. Ezekiel said three thousand years ago that the sins of the father, the son should not be made responsible for the sins of the father. The youth of this country should not be made responsible for our bad decisions, but the current format means that they are. This bill seeks to change this. If Churchill was alive today, he may well have said never have so many strapped so few with an unimaginable guilt in their

The SPEAKER: The Chair recognizes the Representative from Bowdoinham, Representative Berry.

Representative **BERRY**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. I rise to speak in opposition to the pending motion and to permit passage, through our opposition together at this time, of the best tax reduction this Legislature can make.

In each of our districts there is a single mother, working as a teacher perhaps, and struggling to keep two kids in daycare and one other in blue jeans. By voting red today and green on the next motion, you can reduce her taxes – their taxes – and make her work pay.

In each of our districts there is a small business run by a couple who have hit hard times, but who keep at it nonetheless. By voting red today and green on the next motion, you can help reduce their taxes and make their work pay.

By defeating this motion and making way for acceptance of the Minority Report, we today can enact a policy referred to by President Ronald Reagan as "the best antipoverty, the best pro family, the best job creation measure to come out of Congress."

Mr. Speaker, the bill that would be killed by the pending motion is affordable. It carries less than 1/20th the cost of another measure passed to be engrossed by this body unanimously here today, less than 1/20th the cost.

The bill is modest. Even if passed, Maine's Earned Income Tax Credit would be about average among all states with this credit and lower than average for New England states.

The bill benefits those Maine people who need it most. At present, the one in five working families who make the least in Maine carry the highest overall tax burden. The one in five working families who make the least carry the highest overall tax burden.

The bill creates jobs and rewards work because it is based on earned income. If you do not work, you will not qualify. If you do work, if you do have earned income, your tax reduction is greater the more you work.

If there were ever a hand up and not a hand out, this is it. If there were ever a way to make work pay, this is it. If there were ever a way to lift Maine families and young children out of poverty, working families out of poverty, this is it. And if there were ever a way to reduce the burden on those who bear the

greatest tax burden right now, this is it.

Mr. Speaker, President Reagan did not exaggerate when he called the Earned Income Tax Credit "the best antipoverty, the best pro family, the best job creation measure to come out of Congress," and neither did those who voted in the minority on this bill. If you stand for working people, for working Maine families, for struggling small businesses — no matter what letter you have next to your name — I ask that you vote against the pending motion and make way for one of the best bills to come out of this Legislature this year. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Windham, Representative Bryant.

Representative **BRYANT**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I'm not sure I pushed my button, but given a chance to speak, that's always a good thing here at the House. I think for me in the committee, we're always talking about people aren't working and getting paid and all these things, but this one here is saying these are working people that are trying to move forward, we're trying to give them a step in the right direction. I think it's the right thing to do. I am opposed to the motion here, Ought Not to Pass. I wish for you all to follow my light and defeat this motion. Thank you.

Representative **FLEMINGS**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I rise in opposition to the pending motion and in support of the bill, LD 695, An Act To Reduce Taxes and Promote Employment. Much has already been said eloquently on this bill and I echo the sentiments that this proposal is one of the best things we can do to help Mainers enter the workforce, to reduce the tax burden for those who need it most, and to reduce poverty, especially child poverty, and to support our local economy.

I don't want to repeat what has been said before, but I do want to point out we had a great deal of testimony in committee, We had close to a dozen folks in support of the bill, nobody in opposition to the bill. And one of the exciting things about this proposal in addition to what we've heard already is that it, in particular, is a very effective tool to address child poverty and hunger, because it does so in a way that encourages work, that helps lead to independence and financial sustainability for struggling families, and the Earned Income Tax Credit is greater for families with children and so it effectively reaches those parents and children who need it most.

As you may know child poverty in Maine is on the rise. In 2009, 17.5 percent of children lived in poverty, as reported in the 2011 Kids Count. This is one percent higher than 2008 and higher than in previous years. For children under the age of five, 21 percent are living in poverty, and these rates are the highest in More than one in five children in Maine New England. experience food insecurity and we know that children living in poverty and with hunger face more obstacles in learning, gaining independence, and becoming successful in life. This is why this bill is so important at this time. Increasing the state Earned Income Tax Credit will help those families, will help our local economy, will help all families who need it most, and it will help workforce participation. Thank you, Mr. Speaker, for your consideration and I do hope you will join me and others in opposing the pending motion, and I request a roll call, Mr. Speaker. Thank you.

Representative FLEMINGS of Bar Harbor REQUESTED a roll call on the motion to ACCEPT the Majority Ought Not to Pass Report.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Stuckey.

Representative **STUCKEY**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. Years ago, Governor Brennan used to say that the best human service program was a job. I think he was right then and I think his premise is still correct today, except for many people it would have to be changed to two jobs. For too many Mainers today, the gap between their first job and a livable wage is too big.

Earned Income Tax Credit rewards work. To be eligible, you have to have earned income and file a tax return. Increasing the EITC and making is partially refundable would go a long way toward closing the gap for Maine's low wage earners, between their low wages and a livable wage. It would help many of the people we've moved off of welfare in the past few years actually move a step closer to getting out of poverty.

Earned Income Tax Credit also supports our local economy. Studies indicate that 75-80 percent of the EITC refunds are spent for things like housing, food, childcare, transportation, and school tuitions and loans. The rest are put into savings. In 2009, federal Earned Income Tax Credit refunds for low and lower middle income Maine taxpayers totaled \$193 million. My bet is that virtually all of that money stayed right here in Maine. If this bill had been the law of the land two years ago, Maine taxpayers receiving the state EITC refunds would have spent and invested an additional \$8 million in our local economy.

The federal Earned Income Tax Credit was enacted in 1975. Over the years, it has become arguably our country's simplest, largest, most effective and most efficient cash assistance benefit to low-income working people. You've heard when Ronald Reagan expanded the program in 1986, he called it "the best antipoverty, the best pro family, the best job creation measure to come out of Congress." President Reagan and I both think the Earned Income Tax Credit is a great way to fight poverty, support families and grow our local economy, and I hope you will all agree with us. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Saco, Representative Pilon.

Representative PILON: Thank you, Mr. Speaker. I, too, rise in opposition of the pending motion. This bill helps people that are just trying to eke out a living. If you're not working, you don't qualify for this tax credit. This isn't a handout.

I have a young man in my district that is just trying to make ends meet. He is working many jobs, he has his own business, he has worked for me a couple times. He does odd jobs, he has a little truck hauling business, and he's not going to take any kind of food stamps or Section 8. He refuses to do any of that. He's going to make a living and this is a perfect program just for him. So I urge you to support my constituent and I'm sure that everybody else in this chamber has someone just like him in our districts. So I urge you to vote in opposition of this pending motion. Thank you.

The SPEAKER: The Chair recognizes the Representative from Augusta, Representative Maloney.

Representative **MALONEY**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. When I went door to door, I was asked again and again, why don't we support the working poor?
