Pursuant to 5 MRSA Section 13070-J, the State Tax Assessor is required to submit a report to the Legislature identifying the revenue foregone as the result of the Jobs and Investment Tax Credit (JITC), the Research Expense Tax Credit (R&D), the Seed Capital Investment Tax Credit, the Shipbuilding Facility Credit, the Credit for Pollution-Reducing Boilers, and public funds spent on the Business Equipment Tax Reimbursement Program (BETR). Attached are four reports that provide you with this information.

The first attachment shows the number of individual and corporate Jobs and Investment, R&D, and Seed Capital credits for tax year 2009, as well as the value of those credits. Tax year 2009 is the last year for which we have full information on both corporate and individual filers. Statutes governing the release of confidential taxpayer information prevent us from reporting the names of the corporations or individuals that benefited from these tax credits. No taxpayer took advantage of the Credit for Pollution-Reducing Boilers for tax year 2009.

The second attachment explains the Shipbuilding Facility credit. As required by statute, the report provides information on the level of employment, yearly investment and the cumulative amount of investment. Since the inception of the credit, the level of employment has been such that the annual cost to the state treasury has exceeded the base credit amount of \$3 million per year.

The third attachment is a list of BETR recipients. For purposes of this report, businesses that filed for reimbursement during the fiscal year ending June 30, 2011 are listed. BETR recipients filed between August 1, 2010 and December 31, 2010 for eligible property taxes paid during calendar year 2009. For that period the state reimbursed \$55,263,656 to almost 1,800 companies.

Public Law 2009, Chapter 337 (LD 1468) enacted during the last legislative session amended the definition of "economic development incentive" in Section 13070-J to include not only the incentives listed above, but "federal and state statutorily defined programs that receive state funds, dedicated revenue funds and tax expenditures as defined by section 1666 whose purposes are to create, attract or retain business entities related to business development in the State." The additional incentives identified in this new law can be found in the Maine State Tax Expenditure Report 2012 – 2013 prepared for the Joint Standing Committee on Taxation on December 29, 2010.

Whenever legislation proposes a new tax expenditure or a change that prolongs or expands an existing tax expenditure, the joint standing committee of the Legislature having jurisdiction over the proposal shall hold a public hearing on the legislation and subsequently determine the level of support for the proposal among the members of the committee. If there is support for the proposal among a majority of the members of the committee of jurisdiction, they shall request the joint standing committee of the Legislature having jurisdiction over taxation matters to review and evaluate the proposal. The joint standing committee of the Legislature having jurisdiction over taxation matters shall report to the committee of jurisdiction with an advisory opinion on the legislation. A new tax expenditure or a change that prolongs or

expands an existing tax expenditure may not be enacted into law without the review and evaluation by the joint standing committee of the Legislature having jurisdiction over taxation matters.
