The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Lajoie.

Representative LAJOIE: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I'm here to speak of the former fire chief from Bangor, Jeff Cammack. As I was thinking about it, I said, "Geez, what can I say about Jeff and what would others that have had an opportunity to work with him say?" So I took it upon myself to look at it while I was in the Maine Fire Chiefs' Association as well as on the Maine Fire Protection Services Commission, which Jeff is the chair of, and I looked at it and I says to myself he's a shaker and mover, controversial at times, stubborn, and also when you do talk to him and discuss different matters, depending on what they are, it may be difficult. However, I have to say that during that time, he's willing to come to an agreement half way with the individuals that he is involved with and that would be the Maine Fire Chiefs' Association as well as the commission. And I'm sure if there is somebody here from Bangor, from the council, they'd probably agree with many of the items that I just spoke about. He's a shaker and mover and he's done a lot for the Bangor Fire He's done a lot for the Maine Fire Chiefs' Department. Association as well.

At one time, in '93 when I was president of the Chiefs' Association and maybe even a little bit before, 2003, excuse me, but a little bit before I came in, in 2004, there was this fire chief that was sitting on my left-hand side and I said to myself "Where the heck does he come from? Who does he think he is talking the way he was and coming out with new directions and new subjects?" And I had to realize also that we're about 20 percent full-time firefighters and 80 percent volunteers, so there's a different mix in the Fire Chiefs' Association. However, over a period of time and when I became president of the association, I learned more about Jeff and understood him a lot better in the sense that his heart was in public safety, his heart was in serving the people of Bangor as well as his heart was in serving the firefighters throughout the State of Maine. With that said, I think I should probably stop there.

I think my last item is that I think he would fit very well in the

State Legislature as a legislator representing Bangor with all these items that I mentioned. So Jeff, good luck on your retirement and maybe some day I'll see you here. Thank you, ladies and gentlemen.

I thank him and I recognize him for his talent in developing many of our state's fire codes and standards. I hope Mr. Dean enjoys his well deserved retirement and I certainly wish him all the best. I'm proud that he lives in Winthrop and I'm hopeful that he'll continue to reside there. He is a great citizen. Best wishes Mr. Dean. Thank you for your leadership.

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Lajoie.

Representative LAJOIE: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I stand before you again to speak about John, the previous fire marshal, the retired fire marshal. I first met John a little while after I made chief in 1994 and I wanted to bring more fire education to the Lewiston Fire Department, and at that time, working with the Maine Fire Training and Education, we were able to borrow different equipment for teaching. I decided that I wanted to borrow what they call a smoke trailer, and that trailer basically is a series of pipes and passages inside that we can change in different manners and we fill it with smoke and we had the individuals go through it with SCBAs. We also have a huge panel in the back and on the side that opens up in case there is any emergency. So anyways, I was told it was at a certain chief's

house and so I took off and I went to fetch the trailer. Low and behold, at that time I didn't know John and we met. That was our first meeting.

Then after that, being in the Maine Fire Chiefs' Association, I and two other chiefs attended the procedures where he became the fire marshal. As a matter of fact, the three individuals that were there at the time were all retired. John brought a lot of information to the Fire Marshal's Office and as it states on the sentiment, he did become a strong leadership and his commitment at the fire service was the greatest in my reign, I have to tell you, because I had difficulties in Lewiston at times. I called up John's office and he was always there to help. As a matter of fact, as trust goes. I had asked him if I could take care of certain issues within the Lewiston area so his investigators and/or he would not have to come down, and over a period of time it was agreed upon on that, and I was very, very grateful for that and it worked very well. So at this time, I'd like to wish John a very good and happy retirement and I'll probably say the same things I said for Chief Cammack. There is some place on the floor over here for you, John, if you wish to come down. Thank you, Mr. Speaker and ladies and gentlemen.

The SPEAKER: The Chair recognizes the Representative from Wells, Representative Chase.

Representative CHASE: Thank you, Mr. Speaker. Mr Speaker, Ladies and Gentlemen of the House. I had the privilege and the honor of working with John Dean for 10 years in Wells when I was a tax assessor and he was actually our first professional fire chief. He organized our fire department into a professional fire department and working with an all volunteer group before that, that was a tough job, but he did it really well. I also had the privilege of working with him on a complete townwide numbering system for the Town of Wells in the hopes of moving on, which we did, to the E911 service. So he did a great job for the Town of Wells and we knew he was going on to bigger and better things. He was just better than what he was there and he did and I send my congratulations and my thank you for John for doing all the years in the fire safety. Thank you.
