## **Non-Concurrent Matter**

An Act To Change Document Filing Fees for County Registries of Deeds (EMERGENCY)

(H.P. 1137) (L.D. 1550) (C. "A" H-711)

PASSED TO BE ENACTED in the House on March 27, 2012.

Came from the Senate FAILING of PASSAGE TO BE ENACTED in NON-CONCURRENCE.

On motion of Representative MOULTON of York, the House voted to **RECEDE**.

The same Representative **PRESENTED House Amendment** "A" (H-851), which was **READ** by the Clerk.

The SPEAKER: The Chair recognizes the Representative from York, Representative Moulton.

Representative MOULTON: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. As many of you may recall, in recent days this chamber did go through Enactment on the bill. There have been some questions, however, that have arisen. I would like to briefly address one in particular and that concerns the fact that registries have been accused of being profit centers for county government. Again, county government lacks the revenues, taxes if you will, that occur either at the state level or the local level. Besides the filing fees which are the subject of this amendment and bill, there are also copy fees which have been in dispute until just two days ago, as well as a revenue stream from 10 percent of the transfer tax on real estate transactions which, through the recession, have diminished over the past few years, with these reductions in revenue which the counties themselves rely on to fund not only the registry of deeds as well as the operations within the sheriff's department and also staff for the district attorney.

The counties also rely on the overlay tax which is paid for through bills given to town governments and we pay for through our property tax. Without the revenues generated through the filing fees which are directed towards the people who use the registry of deeds, it just means an increase in that overlay tax on the general property tax, and unfortunately with the cutbacks not only have county governments cut back on things like repairs and work on buildings, they have already worked and reduced the number of staff in the registries and the probate offices and it's reached the point where the county commissioners now have to reduce staff elsewhere, and the largest cost to county government currently is through the sheriff's department and through the district attorney's department.

The county commissioners are pretty much in a hard fix. They don't want to have to hand out increasing bills or they may be limited in what they're able to do by increasing that overlay tax, and they are facing these cutbacks. I'm sure that all of you understand this. I'm offering that for your education because you in turn may be questioned by others in this building, and I personally want to express thanks for your support of the county commissioners and the registries that you have shown to date and express my appreciation. Mr. Speaker, thank you.

Subsequently, House Amendment "A" (H-851) was ADOPTED.

Subsequently, the Bill was **PASSED TO BE ENGROSSED** as Amended by Committee Amendment "A" (H-711) and House Amendment "A" (H-851) in NON-CONCURRENCE and sent for concurrence.
