the Honorable Stanley V. Hall, of Windham, a former State Representative who served during the 103rd, 104th and 105th Legislatures and served on the Agriculture and Highway Committees. Mr. Hall was orphaned by the age of 10 and lived with his grandmother in Gray before moving to Windham where, at the age of 17, he started buying cattle and establishing a business as a livestock dealer and dairy farmer. In addition to taking care of 2 barns of dairy cows with his son Russell, Mr. Hall found time to give back to the community and to Maine's agriculture. He was a master of Pleasant River Grange, a member of Presumpscot Lodge AF & AM, Scottish Rite Bodies and a 32nd degree member of Kora Shriners. Mr. Hall served on Windham's Board of Selectmen, as a councilman and on Maine's Racing Commission. He was President of the Cumberland Fair for 29 years and served 3 terms as President of the Maine Association of Agricultural Fairs. He was inducted into the Skowhegan State Fair Agricultural Hall of Fame in 1993. Throughout his life Mr. Hall was a great supporter of Maine's youth and of their livestock and 4-H projects. In 1998, he earned the Lifetime Business Achiever Award from the Windham Chamber of Commerce. He will be sadly missed and lovingly remembered by his family and friends;

**READ.**

The **SPEAKER**: The Chair recognizes the Representative from Windham, Representative Plummer.

Representative **PLUMMER**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. Stanley Hall was my friend. Stan was a self-made man. At the time of his death, he owned several farms. I knew Stan virtually all of my life. I first learned about people from listening to my parents talk about them. They did talk about Stan Hall and they always thought very highly of Mr. Hall. I don't need to tell you about Stan's service to the town of Windham, to Cumberland County and as a State Representative because I know you all listened very carefully as the House Clerk read that to you. Instead what I'd like to do is tell a quick story about my service on the Windham Town Council with Stan Hall and a lesson Stan taught me in being a true conservative.

In 1974, the town of Windham changed from selectman to council-manager form of government. There were 21 candidates in that race and elected were three former selectmen, another old school person from the town, a couple of young guys and myself. Well, maybe at that time I was one of the young guys. I found

myself often being a swing vote in 4-3 votes, sometimes voting with the old school, sometimes voting with the new guys. One issue, in particular, stands out in my mind that I was involved with. The town of Windham, prior to this, had never owned a front end loader. They had always hired the services. They decided they needed one. They also decided they needed my swing vote, so I sat down with the town manager and the public works director and they told me they had located a very, very good used loader. They didn't look at new loaders because they knew Stan wouldn't vote to spend the money to buy a new loader, and they knew if Stan didn't vote for it a couple of the other councilors would not vote for it as well. When it came to the workshop, they laid out very well their plans and how this loader was in great shape and would serve the town well. At the end of the discussion, Stan said, "If you need a loader, why don't you buy a new one? There's no point in buying somebody else's problems." The town bought a new front end loader and I learned a lesson, a lesson that I carry with me to this day. I am pleased to tell you that Stanley Hall was my mentor. I am proud to tell you that Stanley Hall was my friend and I believe I am a better person by having known Stanley Hall.

The SPEAKER: The Chair recognizes the Representative from Windham, Representative Bryant.

Representative **BRYANT**: Stan Hall, I've known him for 25 years, unlike Representative Plummer who has been in Windham forever. But I tell you, he was a pillar of the community, the whole family was well known in the community and you have heard the accolades in the Sentiment and the short message from Representative Plummer so I'll sit down. He is missed in Windham, he was a great man and he won't be ever forgotten. Thank you.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Haskell.

Representative **HASKELL**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. I know it seems a bit odd to have a Representative from Portland talking about somebody from Windham, but I did live in Gorham for 30 years and that's pretty close to Windham, it kind of touches right on it. For years and years and years, my family did business with Hall Implement and I got to tell you, this is not the kind of a company like your ordinary company. This was the place where you go in and they always knew your first name, they were always glad to see you. They were a pillar of the community, an example of how business ought to be run, the way business ought to be run, the way people ought to be treated, and it made a difference in what those towns look like to have a company like that standing for as long as it did and as long as it has there in Windham. Thank you.

The same Representative **REQUESTED** a roll call on **PASSAGE TO BE ENACTED**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Augusta, Representative Maloney.

Representative **MALONEY**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I'll be brief. I just wanted to be sure that the body knew that last Friday I learned that the parents of the top six performing students in eighth grade at Hall-Dale are removing their children from the school district because of the way standards-based education has been implemented there. Parents tell me their children used to love school and now they hate it. One parent who is also a teacher writes to me that now her son's school adopted standards-based education, he never has any homework. This is a quote. "He has never studied for an assessment, he doesn't need to. Instead he takes an assessment and then after the teacher identifies what he has done wrong, he fixes his mistakes. This is how he becomes proficient or even how he exceeds the standard. This worries me because this approach will fail him in college and the workforce."

The failure of this approach is reflected in Hallowell's test scores. Yesterday I passed out a green sheet that shows that in the two years that standards-based education has been in place in Hallowell, their math test scores have gone down over 30 percent. This is very concerning. So now we have the answer to does standards-based education work? Well, not in Hallowell. We continue to have no information on the other five schools that implemented standards-based education at the same time as Hallowell. We've been shown some positive outcomes for one small school in Maine that implemented many changes in addition to standards-based education at the same time. So there are schools in Maine that like standards-based education and schools that hate it.

In the Augusta School System, we tried standards-based education a few years ago and we abandoned the program when

it didn't help our students. Instead we tried a different approach, a different program in the high school that has been very effective. In fact, it cut our dropout rate in half. But don't worry, I'm not going to ask the entire state to adopt this program just because it works at Cony in Augusta. Different solutions are best for different areas. If we pass this bill today, we are saying that we know better than all the local school boards and superintendents of our state. I ask you to trust that they are trying. If standards-based education is right for them, they can adopt it without this bill. If it is not, then this bill will force them to and there is one thing we know for sure about standards-based education. If it's going to work, it will only work when the entire community is behind it.

Finally, the cost of implementing standards-based education in just six districts in Maine was over \$1.2 million. At Cony Middle School, after-school sports are on the chopping block due to lack of money. Everywhere else in government we are trying to contain costs. Can we really afford to force schools to spend so much money on a new program that may or may not work for them? Thank you.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I'll be brief. I agree with the words of the good Representative from Augusta. Mostly I'm concerned with the lack of data to prove that this is a program that's going to work statewide, that we're going to be able to implement this in a school in Brownville, Maine, as well as Portland, Maine, and I'm more concerned that we've created a funding mechanism which is now going to take \$2 million essentially out of GPA, even though it's got to be above this year's funding level to implement this program. So that's money that will not be going to the kids, that's money that will not be going to their education. It's going to be going to the teachers to understand this new program, which we really clearly don't understand. So I will be voting against Enactment.

The SPEAKER: The Chair recognizes the Representative from North Yarmouth, Representative Graham.

Representative **GRAHAM**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I will also be very brief. I wasn't going to speak on this, but I think it's very important to point out three things. One is that this was a Unanimous Report out of the Education Committee. I trust the work that our colleagues have done. They have heard and worked with the Department of Education for, from what I understand, two years. I can't be on that committee because I am serving on another one, but I do trust the hard work that they do.

Second, I represent Gray, North Yarmouth and Pownal. Gray was a school district that was really struggling for many years. It is now recognized statewide and nationwide for the hard work they've done and it's much due to standards-based education.

Thirdly, I have a son who has dyslexia. He went to a very high achieving high school, but he was humiliated every day because of the way he learned wasn't the way other kids learned. He graduated, went to a college where he struggled even more because he was afraid to ask for help. He now is finishing up in a school for students who have dyslexia and I will be very honest with you. If standards-based education was there, when my son was at this very high achieving school, his needs would have been much better met. So I urge you to support this and I understand the misgivings of many, but I think it's time that we move forward. Thank you, Mr. Speaker.

The bill will not create any jobs in Maine, rather it would take away the rights of family child care providers to have a voice in ensuring quality child care for every working family in Maine. Family child care providers have a right to sit down with the state as needed to discuss and attempt to resolve the systematic issues of administration and policy that impact their joint interest in enhancing the quality of child care in the family child care system throughout our state.

Like other small businesses, Maine family child care providers should be able to both associate with each other and have a

voice in the regulation affecting their small businesses. Through their joint association, family child care providers are advocating for sensible child care policies and regulation, including legislation affecting the child care voucher system and other regulations. All child care businesses struggle to make ends meet, but those taking subsidy children struggle the most. Luckily, last session attempts to cut the subsidy rates failed because it would have caused these businesses to stop taking in subsidy children.

Maine child care providers are committed to government efficiency and a thriving business environment, job creation, and lowering the numbers of unemployed and those receiving assistance, which this bill undermines. Empowering Maine's child care providers with a voice in the decision which affect their profession is a step towards removing Maine barriers to affordable and quality child care. Building and improving upon the network of quality child care facilities is essential to all workers in the state and our economy as a whole. Collective bargaining is a valuable tool in regard because it increases productivity, decreases turnover and creates a strong culture of mutual respect. For that reason, I would ask that you vote against the pending motion. Thank you, Mr. Speaker.

This amendment supports the Majority Report, but it amends it with one sentence which is that "The commissioner shall recommend that Bangor Hydro Electric Company use design criteria that take into consideration available safety precautions against damage from solar storms and electromagnetic pulses in any structures constructed on the property...." The reason I ask for that is because we've got many things on our desks, but as you'll see there was one that is orange and it talks about this and it describes how the infrastructure is vulnerable. What Bangor Hydro proposes to do is to build a substation in large part to service Eastern Maine Medical Center. So what this does – and I've worked on this with Deputy Commissioner David Emery who is okay with that, he has a concern about these issues also – what it does is ask that there be protections built in against this kind of risk.

As you'll see, there is a letter from this Avi Schnurr who is an international expert on the whole thing. It basically recommends that there have been studies by all kinds of federal agencies and they all come to the conclusion that we, because we're in a highly developed country, that we are particularly vulnerable to problems from solar storms, as we saw just about a month ago, and the concern about a solar flare hitting us. So this is inexpensive kind of precautions that can be built in. But again, all this amendment does is recommend that Bangor Hydro consider that because it would protect the structure, if and when there is that kind of a strike, from having to be rebuilt or totally retrofitted. So it's a \$3 million investment and so I thought it was worth asking, and the Deputy Commissioner agreed, to ask Bangor Hydro to look at the best available low-cost protections that they might build into it. No mandates. So I request that you support this amendment as just an extra piece of insurance for this structure. Thank you.

Representative **EVES**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I offer a House Amendment as it relates to a very specific provision within the Department of Health and Human Services restructuring bill. The amendment that I put forward relates to the Intensive Case Management program. This program works with our forensic population in our county and state correctional facilities, in addition to individuals with serious and persistent mental illness in our communities. Many of you have approached me out of concern because of the impact this will have on our communities. We should all be concerned about the impact this may have on our communities. This is a serious public safety concern. There is good reason why we have supported this program for the past 16 years. The State of Maine put the system of intensive case managers in place after the 1996 bludgeoning of four nuns in Waterville by...

The SPEAKER: Will the Representative defer? The House is in order. The Representative may proceed.

Representative **EVES**: Thank you, Mr. Speaker. I was reviewing some history of this program and why it was initially implemented and why I believe it should be continued to be supported. Again, there is good reason why we have supported this program for the past 16 years. The State of Maine put the system of intensive case managers in place after the 1996 bludgeoning of four nuns in Waterville by a severely mentally ill man who was an AMHI class member. His mother had tried for three days to get him help from a local mental health agency, but it was a weekend and they didn't have staff. Because of an electrical storm, the phone switch at AMHI for emergency calls had been knocked out. No one called her back. The Intensive Case Management program was put in place in response to a serious public safety concern. The program is working and to change it now would be a mistake.

To be fair, the Department agreed to retain the forensic part of the Intensive Case Management program, but they are moving forward with the portion of the proposal that would contract out

the community piece and this is the piece that my amendment addresses. The Department would contract out the community piece through a program called PATH, which helps people with mental illness find housing. There are three key problems with this proposal. First, this population is not that neatly divided and homelessness is often a symptom of their mental illness and not the only issue they are dealing with. Second, not all people with mental illness are homeless. And third, because this population moves in and out of correctional facilities and Maine communities, the presence of intensive case managers working in both the correctional system and in Maine communities is essential to ensure the population transitions safely into the new surroundings. And while the Department is sure that they can write a contract that is so tight and performance-based, that the same work that the intensive case managers perform now would continue by the way of private contractors, retired Chief Daniel Wathen testified during the Health and Human Services Committee that it's difficult to write a contract that details everything that intensive case managers do.

While Chief Wathen noted it is technically possible to write a contract that covers this critical work, when it comes to assigning the actual work it would likely require a negotiation with the agency about coverage and reimbursement and often there is not time to do that. This proposal saves no money and it could potentially cause great harm. Mr. Speaker and Ladies and Gentlemen of the House, I hope that you will see the wisdom in continuing to keep the program as it currently is and thank you for the opportunity to speak.

The SPEAKER: The Chair recognizes the Representative from Cumberland, Representative Strang Burgess.

Representative **STRANG BURGESS**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I just want to share with you all that I appreciate the efforts that the good Representative has raised about the very, very important intensive case managers. We actually, through the time that we worked this bill which was quite some number of times, understood the extreme importance. These positions or the role is not going away. It will be continued. It is simply going to be put out through a contract and happen that way.

Chief Wathen testified in favor of this piece of legislation. He understood what we were doing and he believes that it can succeed. We have already heard from a number of folks in the field who have stepped forward and are very interested in being involved in this contract, so we have complete confidence that the service is still going to be provided to those most needy in our state. We did redo the bill and brought in, as the Representative said, the forensic piece of the intensive case management. So we think we've created here a really nice hybrid model that will work and will work well for our citizens of the State of Maine. Thank you.

The SPEAKER: The Chair recognizes the Representative from North Berwick, Representative Eves.

Representative **EVES**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I rise to speak in opposition to LD 1887 and against the pending motion. The committee spent a number of hours going over the proposal with the Department. I was pleased that the Department responded to a couple of our recommendations and made necessary changes to the bill. Most notably was a language change that initially gave the authority to the Commissioner go well beyond the scope of this bill. That was amended to only be limited to what was actually in this bill and that change was appreciated. I have already spoken to the intensive case manager program and the changes that have happened there, I will not spend any more time on that. But my concerns about the bill go beyond the Intensive Case Management program. I am both concerned about the substance of the bill and the process.

The process for discussing a major restructuring of a department this size should have started earlier in the session. As in the past with restructuring proposals, there should have been more back and forth between the committee and the Department as they developed their plans, and before approving anything, I would like to have had more detail in terms of what the Department was going to do. While some of the details were filled in during our work sessions, the proposal still remained vague and unclear. At this time, I do not feel confident that the Department is ready to move forward with a restructuring of this

magnitude. The Department talked of making program operations more efficient and effective, but the proposals were vague and we wondered if the resources are really there to do what they said they wanted to do.

In addition, recent events have led me to question the capacity of the Department to implement these kinds of drastic changes at this time. My confidence and I believe the confidence of this Legislature has been shaken. The Department needs to focus on getting a number of problems in order right now and I worry that this may be a distraction. I know that this bill will likely get the support of the majority at this time, but I would urge all of you to think carefully before you support this aggressive restructuring effort. The Department of Health and Human Services is responsible for the health and well being of some very vulnerable Maine people, including children in the child welfare system and people struggling with severe and persistent mental illness. We as a Legislature have a responsibility to make sure that any changes in the Department do not harm their ability to take care of these vulnerable populations and carry out the mission of the Department. I worry about the capacity of the Department to make the changes that they are talking about and continue to serve well the populations they are asked to serve.

As I said in committee, I really do hope I reflect on this vote several years down the road and I'm proven wrong. I hope that this restructuring is a success and we see all the things that we were promised, a more efficient, more successful department that is able to focus on prevention and serve people well. The problem is that we don't have enough information about the plan and the steps the Department is going to take to get there. There is simply too much at stake to be unclear about the roadmap and the compass that is being used to get us there. So at this time, Mr. Speaker, I will not be supporting this bill and I urge you to defeat the pending motion. Thank you.
