**RABBU SAKS:** In the cycle of Jewish holidays we find ourselves  
at this moment on the journey between Purim, which celebrates

the Jewish people's liberation from Egyptian bondage recounted  
in the Book of Exodus. The protagonist of the Purim story is none  
other than Esther, after whom the book that contains the story is  
named. The name Esther alludes to the Hebrew phrase *hester*  
*panim*, which implies a hiding of one's face. Esther hides her  
Jewish identity from her husband, the King, until the right time  
approaches for her to reveal her true self and save her people.

Passover, on the other hand, is a holiday of divine  
providence, with God's mighty hand and outstretched arm  
redeeming the Jewish people from bondage in Egypt. A  
traditional Passover Haggadah does not even mention Moses,  
lest we think that it was Moses who was responsible for the  
Exodus and not God.

We look around our world today and can wonder why the  
miracles of the story of Passover are no longer part of our reality,  
why we don't see God's outstretched and mighty hand bringing  
freedom to the captive and tending to the needs of our most  
vulnerable, but the journey from Purim to Passover reminds us  
that sometimes the miracle is in our hands. Sometimes the  
power to bring about change, to bring about freedom and  
redemption, to care for those most in need of care, compassion,  
and mercy, lies in our hands. May the Holy One of Blessing instill  
within each of us courage and power, like that of Esther, to bring  
about redemption and freedom in our world. *Kein y'hi ratzon*.  
May it be Your will. Amen.

#### JOINT RESOLUTION IN HONOR OF THE MULTIFACETED AGRICULTURE OF MAINE

WHEREAS, recent statistics show that farming in Maine has grown, and Maine continues to lead the New England states with 8,174 farms; the value of Maine's crops and livestock grew 24% over the past 5 years; and

WHEREAS, Maine's agricultural enterprises provide more than \$764 million through the sale of farm products and contribute more than \$2 billion annually to the State's economy, and Maine agricultural products are increasingly available locally in farmers' markets, schools and institutions; and

WHEREAS, Maine farmers are the stewards of 1.45 million acres of land, a vital resource in maintaining Maine's rural economy; and

WHEREAS, Maine is a world leader in the production of wild blueberries and brown eggs, third in the Nation in the production of maple syrup, eighth in the Nation in the production of fall potatoes, first in New England in the production of food, first in New England in the value of aquaculture sales, second in New England in milk and livestock production, and is the fastest-growing artisanal cheese-producing state in the country and is the

only state involved in the commercial production of fiddleheads; and

WHEREAS, agriculture has always been a part of Maine's prosperity, comprising much of Maine's scenic open space, providing recreational opportunities and contributing to the character of Maine's rural communities; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the First Regular Session, pause in our deliberations to honor Maine farmers and innovators who have contributed so much to the betterment of our State, to pledge our support and encouragement and to urge the youth of Maine to pursue the growing opportunities for careers in today's technologically advanced agriculture industry; and be it further

RESOLVED: That a suitable copy of this resolution, duly authenticated by the Secretary of State, be transmitted to the Commissioner of Agriculture, Conservation and Forestry, as a token of the esteem in which those in this vital field are held.

**JOINT RESOLUTION  
RECOGNIZING THE IMPORTANCE OF  
SOILS TO MAINE'S FUTURE PROSPERITY**

WHEREAS, soils are a natural resource that supports major economic sectors of our State, including agriculture, forestry and recreation; and

WHEREAS, healthy soils filter, store and release fresh water, and soil management is closely linked to the water quality in our groundwater, lakes, ponds, rivers and oceans; and

WHEREAS, wetland soils mitigate the effects of major storms and protect our coastal and riverine ecosystems; and

WHEREAS, soil is a living ecosystem that provides keys to scientific advances that directly affect human health, such as the development of new medicines, including recent advances in antibiotic technology developed from Maine soil; and

WHEREAS, good soil management can prevent damaging erosion, loss of organic matter, soil compaction and degradation of soil structure, thereby sustaining the essential ecosystem functions performed by soils; and

WHEREAS, soils are renewable only on the scale of geologic time yet support the renewable resources upon which Maine's future depends; and

WHEREAS, the 119th Maine Legislature designated the Chesuncook soil series as our official state soil to promote public awareness and education regarding soil resources; and

WHEREAS, 2015 has been declared by the United Nations General Assembly the International Year of Soils, celebrated by the Soil Science Society of America and many other organizations; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity during the International Year of Soils to recognize the essential role of all of Maine's soils in supporting a thriving Maine economy and healthy environment and ensuring a sustainable and productive future for the people of Maine.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Edgecomb.

**Senator EDGECOMB:** Thank you, Mr. President. Ladies and gentlemen of the Senate, Item 1-13, a Joint Resolution Recognizing the Importance of Soils to Maine's Future Prosperity, it was heartwarming for me to read this Joint Resolution and there's important information that I think you'll find extremely interesting when we can have a Resolution to support soils in the state of Maine and you might see why this was done. Also if I were here in the 119<sup>th</sup> Legislature, as it mentions in the Resolution, I most likely would have campaigned for Caribou Silt Loam to be the State Soil because that is the most important soil for potato production in Aroostook County, although we have other soils that qualify as good areas. Caribou Silt Loam also grows excellent onions. Also at this time I may have had some kickback from a former leader of this Body, just a couple of years ago Senator Seth Goodall, I learned when I served with him on the Natural Resources Committee, also was an agronomist, he studied agronomy and had a BS in agronomy like I did. Mine was from the University of Maine, I'm not sure what school he graduated from. He may have had a different idea on which soil should be officially named the Maine Soil. I only want to leave you with one thing today that's not in the Resolution. Please, please do not call that medium that you see, that you plant your garden seeds in and grow food, please don't call it dirt. It's soil. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Saviello.

**Senator SAVIELLO:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I would be remiss if I did not stand up to talk about my career. First, I'm sure many of you know I have a Master's Degree also in agronomy, a Ph.D. in forest resources with special emphasis on forest soils. In my academic career I never took a political science class. That probably comes as no surprise. My nickname while I went through school was Doctor Dirt. Let me be clear, as the good Senator just said, soil is not dirt. Dirt is out-of-place soil. Soil's an amendment, an important factor, influencing the production of our various ecosystems.

Soils are vital for civilizations to survive. There are actually books written on that. Soil, itself, is very complex. It would be very wrong to think of it just as a physical collection of mineral materials. It contains air, water, organic matter, and various types of living organisms. It is influenced by the organisms, the climate, the topography, the parent material, and time. I, as a soil major, a soil science major, know that it is a major component of the earth's surface. Several writers have written and documented that the kind of civilization, through history, run parallel with the destruction of soils. These civilizations have fallen because they failed to prevent the degradation of soils on which they were founded. The modern world would suffer the same fate. Today, when you think about soil, it's not dirt, it's a vibrant, living material to depend on. It's the key to our lives. Let me share with you this little poem.

Don't spoil our soil, be loyal to our soil.  
We only got so much.  
Organically sown and kept in green,  
Our plants will grow, so don't be mean.  
When you spoil our soil germs replace the worms,  
Trees and bees won't be pleased, so try to keep it very clean.  
It is time to lend a hand, to our soil salute.  
Recycle, compost, organic land, make sure you don't pollute.  
Don't forget our saying, Don't spoil the soil.  
Thank you very much, Mr. President.

Senator **COLLINS** of York was granted unanimous consent to address the Senate on the Record.

Senator **COLLINS**: Thank you, Mr. President. Six years ago the girls of the Wells High School Basketball Team discovered they had a terrible thing in common: several of them had relatives who suffered from breast cancer. The team wanted to find a way to support their loved ones and began a fundraising effort for the Breast Cancer Center of York Hospital in order to bring in an advance 3-D breast MRI machine to the hospital. With their coach, Don Abbott, who supported the girl's efforts, they

embarked on a fundraising journey that has inspired and taught the entire community. Each year girls from fifth grade to seniors in high school leave early on a Saturday morning in January and shoot foul shots, 50 shoots each, for pledges from sponsors for each shot made. In their first year alone, believe it or not, they raised \$13,000. Not being satisfied with this effort, the girls, their coaches, and dedicated group of parents reached out in their community and started different fundraising events involving the Wells Rotary Club, a golf tournament, raffle and bake sales, and t-shirt sales. This past January the girls held their sixth annual Shooting for a Cure, that's the name of the group of girls, an event that raised an amazing \$35,000 for the Women's Health and Breast Care Center of York Hospital. Their total six year contribution to this very worthy program has topped \$176,000. As the State Senator from Wells, I'm very proud of these young ladies and the parents and coaching staff. I thank them on behalf of those lives they have touched in the community of Wells and, of course, the great State of Maine. We salute them all. I might also add that just recently they were honored by the Maine Principal's Association with the 2014-2015 Sportsmanship Award for Class B. Senator **ALFOND:** Thank you, Mr. President. Ladies and gentlemen of the Senate, 24 years ago Joe Payne, raised on Peaks Island and the grandson of a fisherman, became the first Baykeeper for Casco Bay and the seventh waterkeeper in the nation. You might be asking yourself, "What is a Baykeeper?" A Baykeeper is a consummate advocate for the bay and its programs focus on reducing the pollution and improving the health of Casco Bay. During his two and one half decades at Friends of Casco Bay, Joe has worked closely with residents, advocated for compliance with environmental laws, and worked to protect the Bay's natural environment. He also created a volunteer water quality monitoring program, which allowed hundreds of clam flats to reopen after eliminating pollution. This program makes Casco Bay one of the most sampled bodies of water in the country. Joe has worked to keep more than 125,000 gallons of raw sewerage out of Casco Bay using a mobile pump-out service for recreational boats. Casco Bay runs through Joe's veins and, in recognition of his incredible work and years of service, Joe received an environmental merit lifetime achievement award from the United States EPA. Now, because of Joe's efforts, Casco Bay is one of Maine's natural resource gems, and we have Joe to thank for that. While Joe will stay on as Casco Baykeeper Emeritus, it will difficult to replace his passion, drive, and vision he brought to his work. Those of us who enjoy Casco Bay owe Baykeeper Payne a debt of gratitude and I wish him well in his next endeavors. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator **HASKELL:** Thank you very much, Mr. President. I'd just like to add my thanks and congratulations to Joe Payne as well. There are times when there are people who appear in your community who have an influence far beyond what their job description is or what their intent is. Joe's one of those people. There wasn't a meeting that went on about anything that went on that had to do with Casco Bay, whether it was a drop of water that flowed from the mountains in New Hampshire into Casco Bay, that Joe wasn't at. He was there. His face was there. His interest, his great amount of knowledge, was always there. There wasn't a time when people made a decision about what happened around that bay that Joe wasn't there to make sure that it was taken into consideration and that the right things were done. He brought us a wealth of knowledge. He will not be replaced. He may be replaced, but certainly not by anybody who's ever got the kind of passion the he did for the Casco Bay and we owe him a real debt of gratitude, and the whole state of Maine, for the work that he's done. Thank you, Mr. President.
