Joint Resolutions in Memoriam:

WHEREAS, the Legislature has learned with deep regret of the death of:

Robert Hampden Patten, of Topsham. Mr. Patten was born in Philadelphia, Pennsylvania, and the family moved to Hampden, the home of generations of his family, after his renowned physician father passed away. He attended Hampden Academy and matriculated at the University of Maine, but his college education was interrupted by World War II. He joined the Navy, attended midshipman school and was assigned to Key West, where officers lived with prominent families. By the end of his service, he was a lieutenant commanding a submarine chaser. He graduated from the University of Maine in 1947 and attended the University of Denver to complete a master's degree in speech and radio. He returned to the Bangor area and joined WABI as the State's first television anchorman. He served as Bangor's first industrial development director and as Chair and fund-raiser for the University of Maine's Hauck Auditorium fund. After a number of years as a sales representative for Sewall Mapping Company of Old Town, he joined a national tax appraisal firm, Cole Laver Trumble Company. He later founded his own company, Patten Appraisal Associates. In 1961, his family relocated to Cape Elizabeth and then, in 2005, to Topsham. He was devoted to giving back, most prominently through his involvement with the University of Maine and Rotary Club. He and his wife, Stella, were recipients of the university's highest award for fund-raising and alumni leadership efforts, the first time the award was given to a husband and wife. His many decades with Rotary Club included service as district governor for the Northeast United States/Maritime Provinces, during which he travelled worldwide. Among his proudest achievements was the collaboration with Maine Island Trail Association to develop Jewell Island. Mr. Patten will be long remembered and sadly missed by his wife Stella, whom he married in 1953, his daughters Dr. Deborah Patten and Lisa Patten and his grandsons Nicholas Mesrobian and Benjamin Mesrobian;

Senator **BAKER**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise today to honor the life of a man whose passing leaves a deep void in this community and in our state and, indeed, in our country. Robert, better known as Bob, Patten was a tireless man. From WWII until the end of his life, he devoted himself to serving the community. He gained fame in Maine as our state's first television anchor and used his experience and connections from that to work for the betterment of the Bangor community and the University of Maine. While he gave much to the Bangor area, I, for one, am very grateful that he and Stella migrated down state to Cape Elizabeth and eventually to Topsham. Continuing his work with the University and with the Rotary Club, Bob had an incredible impact on our region. Men like Bob are few and far between and it is my hope that his life and achievements are a motivation and inspiration to others. As we mourn Bob's passing, we must also take the time to be grateful for all he did for our state and our country. Today we look to the past but also let us look to the future as Bob's legacy lives on in communities throughout Maine. It is an honor to recognize his contributions today and to have his widow, Stella, here in the Chamber. Stella was undoubtedly a huge influence and support for Bob in all he was able to accomplish in life. Thank you, Stella, for sharing Bob's life and gifts, for helping us to understand the real Bob, and for ensuring that his legacy will not be forgotten.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Collins.

Senator **COLLINS**: Thank you, Mr. President. Bob Patten was just District Governor of the Rotary district when I was President of my hometown club, in the Town of Wells. Bob Patten had a great sense of humor. When you saw Bob you saw Stella. They were together all the time. The thing I remember about Bob, particularly, was that he had a great sense of humor. He was one of those individuals that when he walked in a room you knew he had a presence and he was always quick to lighten things up. Just a joy to be around. I was talking with Stella earlier this morning and he will be sadly missed by a lot of people. Great guy. I'll just say that communities, civic groups, it seems as though this generation is leaving us and it's a shame because there are not as many to take their places. These civic groups, like Rotary for example, add a lot to our communities and Bob was an important part of being a Rotarian. It was service above self. That's our motto. Bob will be greatly missed. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Washington, Senator Burns.

Senator **BURNS**: Thank you, Mr. President. Ladies and gentlemen of the Senate, it's a great honor for me today to have in this Chamber many of my extended family, especially my mother-in-law, Geraldine Jones, who I was instructed years and years ago to call Gerri or Mom, and I'll do that today. I'll take this opportunity to say a few words about a very special man. Some might even call him a hero. Not the type of hero that you hear about in the news or a person that's a celebrity, but a man who many, many folks depended upon. There are few men in my life that have made a big difference to me and greatly influence me through the years. My Dad, of course, who has passed on. My pastor for over 50 years. Another one is my father-in-law, Roland Jones, who we are here to memorialize today. I started out working in the woods, along with his sons, for my father-in-law back when I was a teenager. That's when I started to learn many of the lessons that he taught me over the years. I married his daughter 46 years ago and never looked back. Roland, as you already heard, served in the WWII and he was part of the infamous Red Ball Express that, hopefully, you've heard about that was responsible for carrying ammunition and gasoline across Europe in the days immediately after the invasion of Normandy. There was an article written about him in 2006, that I hope you take an opportunity to take a look at, about some of his exploits

and what went on in his service over there. We just mentioned the passing of Mr. Patten, that brings in mind General George Patton, who my father-in-law actually met while he was over in Europe. I recall that he said that he really didn't like him that much. Pushed his men too hard. That was my father-in-law's perception of him.

Roland came home and he married my mother-in-law, Gerri, and they were married for 68 years. They had nine children and one of them passed away in infancy. Roland and Gerri raised those eight children and every one of them turned out to be good citizens and good people. Roland started his own business, both in construction and what some would now call forestry, I called it a logger. That's what he was; a professional logger. That's where I got my start from him. He also had a farm where they raised large and small animals for income and to feed their family. He was an important part of his community and always will be remembered as such. People depended on Roland. They respected him. They called upon him for not only advice but to help them with their own properties. He had a reputation of being fair, honest, hardworking, and dependable. What great things to have to your memory. He was the type of person that helped to build this country, especially after WWII, to make it what it is today. He was a good husband and a good father. The many talents that he had he passed on to his kids. Whether they know it or not, that's where your talents came from, and also your Mom. He provided for his family back when things were tough, not like we know today. We think when we have a downturn in the economy that things are rough around here. Can you imagine trying to feed a family of ten in this country back when things weren't as affluent as they are today? It was difficult, but it's what good men and women did.

My wife, Donna, who I'm sorry to say couldn't be with us today because, as many of you know, we have a special son and that requires one of us to be home with him. My wife, Donna, likes to tell me about how special it was when she and one of the other kids, or whoever's turn it was, had the opportunity to ride in the pulp truck to Augusta with their Dad and spend the afternoon with him. On the way back they'd stop for ice cream and Dad would talk to all the locals and they would have an opportunity to spend time with him.

The last few months of my father-in-law's life he had to be at the VA Center in Augusta because of an injury and dementia problems that he had. When I'd visit Roland up at the VA Center, along with all of his peers there in that particular ward that he was in, all veterans from all walks of life, I was so impressed about the company that I was in. These were the men, again, that helped build this country. They fought for us in the wars. They came back and started businesses. They raised families. They helped their communities. They all were truly heroes and Roland was one of these. I thought about, as they were in that environment up at the VA Center, how much this impacted me that the great people that were there taking care of them, and are today taking care of those former soldiers, just don't realize the presence that they are among; the people that they are helping to serve and what they have accomplished in this country and in their lives; through no fault of their own, because all families pretty much have those memories and not everybody gets to share them. Roland was one of those that was an awesome individual and it really was a privilege to be in his midst and their midst.

As I said, Roland was a leader in his community and he made untold contributions to the community, like so many of his peers, but the wonderful thing about Roland is that he left an

indelible mark on the community and you can see that around the back of the room here with the people that have come in honor of his memory. I know what a hero he was because I watched him and I learned from him for over 50 years. Like many others, I depended on him and I saw him as a hero. It was my privilege and honor today to honor him in the Maine Senate and, Mr. President, I would ask that when we adjourn we adjourn in Roland Jones' memory. Thank you very much, ladies and gentlemen.

WHEREAS, from 1933 to 1945, 6,000,000 Jews were murdered in the Holocaust as part of a state-sponsored, systematic persecution and annihilation program of genocide, and millions of other people suffered as victims of Nazism, such as the handicapped, political dissidents and many others for racial, ethnic or national reasons; and

WHEREAS, the people of the State of Maine should always remember the atrocities committed by the Nazis so that such

horrors are never repeated, and the history of the Holocaust offers an opportunity to reflect on the moral responsibilities of individuals, societies and governments; and

WHEREAS, the people of the State of Maine should always remember those who liberated the Nazi concentration camps, some of whom lost their lives and others of whom have experienced lifelong emotional suffering, as holding an honored place in our history; and

WHEREAS, the people of the State of Maine should continually rededicate themselves to the principle of equal justice for all people, remain eternally vigilant against all tyranny and recognize that bigotry provides a breeding ground for tyranny to flourish; and

WHEREAS, the national community, pursuant to an Act of Congress, will be commemorating the week of April 12, 2015 through April 19, 2015 as the Days of Remembrance of the Victims of the Holocaust, including the Day of Remembrance, known as Yom HaShoah, April 16, 2015; and

WHEREAS, it is appropriate for the people of the State of Maine to join in this international commemoration, and April 16, 2015 has been designated as the Holocaust and Human Rights Center of Maine's Legislative Awareness Day, marking 70 years since the end of World War II and the liberation of the Nazi concentration and death camps; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the First Regular Session, on behalf of the people we represent, pause in solemn memory of the victims of the Holocaust and in honor of the survivors, rescuers and liberators; that We urge one and all to recommit themselves to the lessons of the Holocaust through the Holocaust and Human Rights Center of Maine's Legislative Awareness Day and the international week of commemoration; and that We express our common desire to continually strive to overcome prejudice and inhumanity through education, vigilance and resistance; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Holocaust and Human Rights Center of Maine and the United States Holocaust Memorial Council in Washington, D.C. on behalf of the people of the State of Maine.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you, Mr. President. Men and women of the Senate, today is Yom Hashoah, Holocaust Memorial Day. It is a day dedicated to remembering the nearly six million Jews, including one million children, who died in what Adolph Hitler hoped would be the final solution. In less than a decade four times the population of our state were murdered simply because of their religion. It is fitting today, Mr. President, that in order to put this into the historical perspective, we're doing this on the

same day that Senator Burns said such glowing words about his father-in-law who was one of the people who liberated Europe at the end of the Second World War. I'd like to read you, Mr. President, the words of Pastor Martin Niemoller, a German born Protestant minister who wrote a very powerful and well-known poem. He was jailed for his outspoken view of the wrong committed by the Nazis. He wrote, "First they came for the Socialists and I did not speak out because I was not a Socialist. Than they came for the trade unionists and I did not speak out because I was not a trade unionist. Than they came for the Jews and I did not speak out because I was not a Jew. Than they came for me and there was no one left to speak for me."

It's important, Mr. President, that we tell that story and that each generation pass down the story because there are fewer and fewer people still living who can tell the story firsthand. We are honored today, Mr. President, to have two of those people in our presence. First of all, Evelyn Panish is here. Evelyn was born in Germany in 1930 and lived in Berlin until fleeing with her family to China. In 1940, Evelyn and her husband escaped Nazi persecution by immigrating to Shanghai via Russia, Siberia, and Manchuria. They immigrated to the United States in 1947. She now lives in Freeport with her husband, Mort. Also with us today, Mr. President, is Charles Rotmil, who was born in Alsace Lorraine in 1932. In 1938, he moved with his family to Vienna. Two years later, they escaped to Belgium and then to France, in their attempts to flee the war against the Jews. By 1943, his mother and sister had died in a train crash and his father had been gassed in Auschwitz. Father Bruno Reynders, a Benedictine monk, took Charles and his brother under his wing, along with 400 other children. They lived in hiding, under false names, until the liberation in 1945. In 1946, he arrived in the United States, spending many years as a schoolteacher and now is a filmmaker, photographer, write, and artist living here in Maine.

Mr. President, thank you for your attention to this and we are honored to be in their presence. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Alfond.

Senator **ALFOND:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I also stand here today to honor those who perished, those who survived, and those who liberated the Holocaust survivors. My family lost people, friends and family, in the Holocaust. This Joint Resolution is important to me and to all faiths because we must remember our history. We all have lessons to learn about each other; to celebrate our differences and diversities and to, especially, share tolerance. Thankfully there are organizations like the Holocaust Human Rights Center here in Augusta, at the University of Maine at Augusta, that use the lessons of the Holocaust and other genocides to combat prejudice and discrimination in Maine and beyond. They encourage individuals and communities to reflect and act upon their ethical and moral responsibilities in our modern world. I think it's just incredibly important that we do this. It's important that we remember our history and thank you, Mr. President, for the honor to speak.

Senator **PATRICK:** Thank you very much, Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, I stand before you today to ask you to vote against this Minority Ought Not to Pass Report. This bill amends the Municipal Public Employee's Labor Relations Law by requiring that all collective bargaining negotiation meetings include a member of the body with final authority to approve the collective bargaining agreement. This bill is a commonsense addition to clarify and support the State's purpose of the Municipal Public Employee's Labor Relations Law. All this bill does, ladies and gentlemen, is it codifies what is already common practice within the negotiations and if you're going to have a negotiation what's the sense of a negotiation if you don't have someone there that can have the final say. The testimony was that already in 90% of all

negotiations this happens. What I believe this would do is correct the 10% of the times when it doesn't happen and it's actually commonsense. I would ask for the membership to vote in opposition to the Ought Not to Pass Report and move on to the Ought to Pass Report. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Volk.

Senator **VOLK:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I'm just going to be very brief here. As the good Senator from Oxford pointed out, this is already done most of the time. We heard from Maine Municipal Association, Maine School Management, that this is not something that they feel needs to be in statute, nor should it be in statute. In fact, federal law actually controls the process and says that no party should dictate who is in there for collective bargaining. I ask that you follow my light.

**THE PRESIDENT:** The pending question before the Senate is the motion by the Senator from Cumberland, Senator Volk to Accept the Minority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?
