Senator **CYRWAY** of Kennebec moved the Senate **INSIST**.

On motion by Senator **PATRICK** of Oxford, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator **PATRICK:** Thank you, Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, this is actually a great transparency bill. The bill amends the law governing what is required to be disclosed on or in political communications to support the election or defeat of a candidate. Specifically, telephone calls that name a clearly identified candidate during the 21 days preceding a primary and the 35 days preceding the general election. It requires that all pre-recorded automated telephone calls and scripted live telecommunications, including those made for the purpose of researching the views of voters, that name a clearly identified candidate during the 21 days before a primary election or 35 days before the general election clearly state at the start of the call the name of the person or organization that made or financed the expenditure for the communication. The bill requires that, for scripted live telecommunications, if the respondent requests additional information on the persons or organizations that made or financed the expenditure for the communications the caller must describe where such information, including information relating to the source or sources of funding for the person or organizations, is available for inspection.

What does this bill actually encompass? How many times have we all lamented on the nasty visceral advertisements on the TV? If you listen to those advertisements, they do disclose who they are, but they are always at the end of the statement and they are all garbled and you can't tell who's actually doing the attack ads. Ladies and gentlemen of the Senate, I think the public deserves an opportunity to hear who's funding and who's supporting these attack ads, clearly and concisely, because I think a lot of times people are always saying, "We hate these ads. We absolutely hate these negative, viral, visceral ads," that they don't actually know who is the author of the ad. If this helps in any way to help some citizen make up their mind clearly and know and understand that through the transparency and clearing stating who the name of the person was, I think this is a good public thing. I think it's great that the public has the opportunity to have more transparency, to get more understanding on the issues, because I'll tell you one thing right now, almost every constituent I talked to said they hate those ads. They don't know who these groups are. They don't understand what's said at the end. Mr. President, I'd ask everyone to vote against the Insist motion and follow my light.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I don't have any prepared remarks on this. I just wanted to say I think we all support transparency in these issues and currently, as the good Senator from Oxford County has pointed out, there are already requirements in place that this be disclosed at the end of the call. My only objection to this is that in some cases this covers calls that are sometimes done for polling purposes and when you are polling someone and you announce at the beginning of the call who exactly, what organization, it's coming from that can bias the

poll and lead to less accurate information. Now, a person has every right not to answer that or give any information or what have you. Already, currently in law, there is a requirement that that be disclosed. Whether it comes at the beginning of the call or the end of the call, personally I think it makes no difference, but when we're talking specifically about biasing the results of a poll than I think we're having some unintended consequences there. Absolutely, at least I can speak for myself, I can't speak for anyone else, but I think, absolutely, I certainly want to make sure we have transparency on these. The Senator from Oxford County said that these might be garbled at the end of the call; they could be garbled at the front of the call. I don't know how that makes a difference there. That's my two cents.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator **PATRICK:** Thank you, Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, I'm thankful that the good Senator from Androscoggin brought that up about polling. What it is about push polling, so many people are disgusted with push polling that does try to influence people's opinions and stuff. This bill amends the push polling laws to require that a caller disclose at the start of the call the person or organization sponsoring the authorization authorizing the call and the organization making the call if different from the sponsor and it's not going to be garbled because within the law it says it has to be "clearly state at the start," not garbled. Clearly state. Current law requires only that the disclosers to made at some point during the call. This is going to say at the front of the call. Ladies and gentlemen of the Senate, the one thing I'll say about the Veterans and Legal Affairs Committee, we really work on these issues. We give it a lot of thought. We understand what the public wants. This was a unanimous report out of committee. Unanimous report of our committee. It's a bipartisan supported bill to help the transparency of the public during the elections. I would ask you to follow my light. Thank you.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY:** Thank you, Mr. President. I was kind of on the fence on this one, but it was explained to me that this kind of shadowed the federal law and I went along with it, the same as Senator Patrick did. I can see the other side as well, that sometimes if you say it beforehand that it can actually, people probably hang up before they go to do the polling, so that can kind of construe things and also at the end they put it. I think that I was going to leave it up to the Senate here to vote on which way they really want this taken care of, but it was really, I think it could go either way. I'm fine with it either way only because, I think, that if you do it before sometimes it could construe the way a person feels, knowing who it is at the beginning and at the end I don't think that they are trying to construe what the poll is, but I think that it could be thought of that way. I guess that's kind of a mixed feeling on it. Thank you, Mr. President.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Cumberland, Senator Alford.

Senator **ALFOND:** Thank you, Mr. President. I don't know. I'm listening to this debate and it comes down to a couple of simple

things to me. One, transparency. I think this Body deserves to put out, I think, very thoughtful reforms around elections and this one seems to be a very good one. Can we be transparent? Can we be transparent on who's paying for different polls before elections? It's pretty simple. I guess it's a funny kind of discussion when we're worried about the pollsters. I think pollsters are going to figure out how to get accurate polls. This is what they do. I'm not really that concerned about their business model. The business model that I'm concerned about is our constituent's. How many of us, every day during election season, get either an e-mail or a phone call from a constituent that's disgusted by something that has come on the phone? When I tip the scales here, I'm going to tip the scales with my constituents, not really the pollsters. I think the pollsters, I think they're going to figure it out. I'm going to tip the scales on transparency. I think that Maine people deserve to know who's paying for ads all the time. Thank you, Mr. President.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from York, Senator Dutremble.

Senator **DUTREMBLE:** Thank you, Mr. President. Ladies and gentlemen of the Senate, let's be honest. If we change this to the beginning of the phone call, we've all been there, we can hang up on them that much quicker because nobody wants to listen to them anyways because when do they call you? At suppertime, when you're trying to eat. You're trying to enjoy time with your family. You're trying to put your kids to bed. They bother every single one of us and all our constituents. That's all we hear, "I hate those phone calls." Let's put it at the beginning so we can hang up right away. Thank you.

The following Joint Resolution:

H.P. 933

#### JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES AND THE UNITED STATES CONGRESS TO REQUIRE EXPANSION OF FISH HATCHERY OPERATIONS

WE, your Memorialists, the Members of the One Hundred and Twenty-seventh Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the President of the United States and the United States Congress as follows:

WHEREAS, the Atlantic salmon, *Salmo salar*, is a salmon found in the north Atlantic Ocean and in rivers that flow into the north Atlantic Ocean, and the fish has historically been an important economic asset to the State of Maine; and

WHEREAS, the major rivers of the State once ran thick with salmon traveling upstream to spawn; and

WHEREAS, salmon populations have been reduced to nearly undetectable numbers in most rivers in Maine; and

WHEREAS, the Federal Government has designated the Atlantic salmon as an endangered species; and

WHEREAS, the Federal Government spends millions of dollars annually to restore the species with no significant success; and

WHEREAS, there are specific hatchery operations that can improve upon the current results; and

WHEREAS, a significant number of salmon originating in Maine are being harvested in a commercial fishery off the west coast of Greenland; and

WHEREAS, this fishery is a major obstacle to the restoration of salmon in Maine rivers; now, therefore, be it

**RESOLVED:** That We, your Memorialists, on behalf of the people we represent, take this opportunity to respectfully request that the President and the United States Congress direct the United States Fish and Wildlife Service and the National Marine Fisheries Service to expand hatchery operations to rivers in Maine by partnering with the State and with the many non-government organizations that are focused on restoring Atlantic salmon to their historic natal rivers; and be it further;

RESOLVED: That We, your Memorialists, urge that additional resources be made available to the United States State Department that would assist its efforts through the North Atlantic Salmon Conservation Organization convention to help with the curtailment or suspension of the wild Atlantic salmon fishery off the west coast of Greenland; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Barack H. Obama, President of the United States, to the President of the United States Senate, to the Speaker of the United States House of Representatives and to each Member of the Maine Congressional Delegation.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator **PATRICK:** Thank you, Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, I just want to add one point that I forgot to add the other day. I'll be brief. We heard time and time again that there are things that require a photo I.D. I don't disagree with that. There are a bunch of things. One thing I will say is some I agree with and some I don't. What my I.D. would be would be my driver's license unless they required us to have one from the State. There are many times that we have had discussions in this building about the misuse of our driver's license, taking photos of our driver's license and all kinds of things, for ways that were not intended. One of the problems I had was that I actually banked at Maine National Bank in Rumford for seven years. Had my loan. Didn't have to give my I.D. to borrow thousands of dollars. Went to the counter year after year and never was asked for an I.D. Then one time I went in and Assistant Manager says, "I want to see an I.D." I said, "I've been here for seven years. What do you want an I.D. for?" She said, "I can ask for it. I'm the Assistant Manager." I said, "Well, okay. You won. I'm going to show you my I.D. and I'm going to go to the counter and I'm stopping my accounts and I'm going to pull my home mortgage and I'm going to go across the street." That's exactly what I did because a lot of times, ladies and gentlemen, an I.D. for the wrong reason is an I.D. for the wrong reason. I just wanted to bring that forward. Thank you.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Androscoggin, Senator Libby.

Senator **LIBBY:** Thank you, Mr. President. Men and women of the Senate, the Senator from Cumberland, Senator Diamond, posed a question through the Chair and nobody's answered, so I thought I'd offer a couple of answers from the fiscal note. This initiative will cost the taxpayers of Maine \$433,000 the next biennium, so almost one half a million dollars. The other question was whether this is a mandate. This is, in fact, a mandate on the municipalities. Thank you.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT:** Thank you, Mr. President. Men and women of the Senate, there was a couple of statements yesterday. No one ever claimed that there's never been voter fraud in the state, just that it was so small and infrequent as to be statistically unimportant and this bill would not do anything for that. As well as the case that was brought up about a recent incident, that incidence was looked at on its merits. I did receive calls from my constituents. The matter was looked into. It was resolved. The problem was solved. Solution is in to fix it permanently. This is a wonderful way of solving problems that exist, not to do knee jerk reactions to create more problems down the road. Thank you.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK:** Thank you, Mr. President. I just rise again to speak on this. Having done the research yesterday, the risk is 1 in 15 million people. It seems to me spending \$400,000 plus on that kind of a risk is, indeed, prolificacy. I do not think that we can afford that kind of expenditure in the state of Maine. We have a State budget that is sorely strained. We have taxpayers that are having to pay more than they wish to pay. For us to spend over \$400,000 on something that does not seem to be a problem here seems to be a waste of money and I would think that we would not vote in favor of this and I'll ask everybody to follow my red light. Thank you, Mr. President.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Lincoln, Senator Johnson.

Senator **JOHNSON:** Thank you, Mr. President. Ladies and gentlemen, word got out of the action here yesterday on this bill. I received an e-mail from a constituent. He said, "I saw on the news the Maine Senate thinks a photo I.D. is needed to vote. Is that correct? That will disenfranchise my 88 year old parents. My father is blind. Gave up his driver's license years ago. My mother opted out of the photo when she was allowed to. Any need for a photo I.D. will require them to travel to Rockland or Augusta from Jefferson. My parents hate asking for help and they will have to in order to obtain photo I.D.s. My parents were disenfranchised 60 plus years ago when they became residents of Washington D.C. Since they returned to Maine, upon my father's retirement, they have never not voted. I say this is a bad idea." I urge you to vote against the pending motion.

**THE PRESIDENT PRO TEMPORE:** The pending question before the Senate is Passage to be Engrossed as Amended. A Roll Call has been ordered. Is the Senate ready for the question?
