The Honorable Lois Anita Snowe-Mello, of Poland, a longtime state Representative and state Senator. Senator Snowe-Mello was born in Passaic, New Jersey. She attended Franklin School of Science and Arts, County College of Morris and Arizona State University and graduated from County College of Hair Design. She worked as a beautician, a social worker for Morristown, New Jersey, an admitting officer at Scottsdale Memorial Hospital in Arizona and at Maine Central Medical Center in Lewiston and a manager at Olan Mills Portrait Studios. From 1997 to 2004, she served in the House of Representatives representing Minot, part of New Gloucester and Poland, and she served in the Senate representing Auburn, Durham, Poland and New Gloucester during the 122nd Legislature, 123rd Legislature and 125th Legislature. She served as chair of the Senate Committee on Engrossed Bills and Senate chair of the Joint Standing Committee on Marine Resources. Senator Snowe-Mello was a member of the Republican State Committee from 2000 to 2004. served as the Vice Chair of the Androscoggin Republican Committee and served as State Committeewoman for the Androscoggin Republican Committee. She was a member of many religious, fraternal and civic organizations, including the Poland Historical Society, the Board of Directors of the Autism Society of Maine, the Androscoggin County Chamber of Commerce, the Order of the Eastern Star and the Sportsman's Alliance of Maine. Senator Snowe-Mello will be long remembered and sadly missed by her family, her friends and her colleagues in the Legislature and throughout the State;

## READ.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator BRAKEY: Thank you, Mr. President. I'll just say a few words. Today is a day of great sadness as we remember and honor one of own. It was only three years ago that Senator Lois Snowe-Mello sat in one of these chairs, at one of these desks, as a member of this Chamber. Someone with more institutional memory than I would have to remember which chair and which desk, but she spent six years here and eight down the hall, in the lower Chamber, representing, at different times, the communities of Auburn, New Gloucester, Poland, Minot, and Durham. I know that many members in this Chamber personally served with Lois. I have only heard the stories of Lois in her prime, but there are plenty of stories to go around. She was small of stature, but mighty of spirit. She was a spitfire. There is no better word I can think of to describe her. She had an opinion on everything and she always let you know. As a result, she never shied away from controversial issues and she always spoke up for what she believed to be right. The former Senate President Rick Bennett shared a story from this Chamber when Lois was still serving in the Maine House. He said, "I voted in the wrong way on something important to her and she hustled down the hallways to the Senate Chamber and gave me a good talking to." She was unabashed about letting people know, her friends as well as her adversaries, when they were in the wrong and she was also very supportive when you were in the right with her. For those who knew and worked with her, we all have those stories. For me, Lois was not just a good friend and colleague. She was a mentor and an unofficial grandmother to me. When I decided to seek this office Lois was my partner every step of the way. I benefited from her experience. She encouraged me, she challenged me, and when I got here she continued freely giving me her advice. You know a life well lived by the amount of positive impact on the lives around it. As I visited with Lois over the last few months, both in the hospital and in hospice, so many people came to visit. While there were many dignitaries, Governors, and United States Senators visiting and sending their regards, what was most impressive were her constituents. From her constituents the stories and memories have been pouring in. It seems that everyone has a story of a time that Lois helped them or their family with an issue, or even just listened. That was one lesson Lois always taught me. Her motto was "Listen, heed, help, and lead." In the last few days, speaking with her myself, holding her hand, even as she was in and out of consciousness, even as her eyes could barely open, you knew that she was still listening. While she couldn't respond so easily any more, if you looked closely you could see that same gusto in her face, the fire in her eyes looking back at you when you spoke with her. For much of the last two years Lois spent much of her time caring for her husband, Brian, who fell ill and passed last year. It hasn't been a full year since Lois sat in the Chamber with us as we honored Brian Mello and his life. Today we are joined by some of Lois' closest friends, Paula Baril of Poland, Lucille Ouellette of Auburn, and Rita Madore of Auburn, as we honor Lois. It was comforting

to know that as Lois went through this she never went without a friend, a family member, by her side for a single moment. Thank you, Mr. President, for allowing me this time to speak in honor of our friend and colleague Senator Lois Snowe-Mello. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator PATRICK: Thank you, Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, I, too, rise today to say some words about my friend Lois Snowe-Mello. Lois and I actually went back both to the House and Senate and I got to know her really close on an economic development tour. I don't think she laughed any harder than that weekend that we spent together. We went to Presque Isle and, being a real quiet, reserved person, we had a karaoke and was drinking Coca-Cola that day. No one would get up and sing, so I decided to get up and dedicate a song to her birthday, on her 55<sup>th</sup> birthday. She just laughed with that neat laugh that she always had and from there on we developed -- I sat with her on the bus, came back during those two days and developed a relationship that was kind of an odd one because she had a hard time sometimes figuring out whether I was me or whether I was Senator Jackson because, if anyone knows me, Troy is known as my brother from another mother and we were always together. At one time Lois actually introduced me to her husband at a Sportsman's Alliance of Maine thing as Senator Jackson. She got up after she realized it and came over and said, "Oh my God, Senator Jackson, I introduced you wrong." I'm just saying, "Thank you, Lois." Our relationship was really neat and I will forever miss that wonderful laughter. I actually sat in her chair. The year she got done in the Senate she wrote her name and I think it's where Senator Whittemore is sitting. It's etched forever in that. I just think she brought a lot to the table. She could be funny. She could be witty. She could be knowledgeable. If you didn't vote the right way, she wouldn't mind coming and talking to you, especially if she knew you well, which she did me and we had a lot of great discussions on the issues and stuff. I will for always remember that kind lady with the neat laughter and stuff. I'm just thankful that I had an opportunity to have her as part of my life in the Legislature. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO**: Thank you, Mr. President. Ladies and gentlemen of the Senate, first I want to congratulate Senator Brakey. I think he's done an outstanding job, both here and in the press, recognizing my friend and fellow Senator. I would describe her as my friend and colleague and I had the opportunity to serve with her both here in the Senate and in the House. As I reminisce, as she came close to her passing and in her passing, I best remember her for the House. That's where one member of the other side would stand up and speak and we all knew no matter what she said the spitfire, well described, would rise to counter their argument. Sometimes I would cringe, other times I would smile, but I was always impressed with how she did it respectfully and with power. She will be missed. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Washington, Senator Burns.

Senator BURNS: Thank you, Mr. President. Ladies and gentlemen of the Senate, it is a pleasure, my honor, to stand up and speak very briefly about Senator Snowe-Mello. I didn't have the privilege of knowing her as long as many in this Chamber, but the time that I did know her, and come to know her, in the  $125^{\circ}$ Legislature was a blessed time. This occasion, to me, is both a solemn occasion and a happy occasion. It certainly is a solemn occasion because Lois is going to be very much missed by all that knew her. She's an example of the great things that come in small packages. Her demeanor was such that she lit up the room around her, but on the other hand, as you've already heard, she also was very good at speaking her mind about the issues she believed very deeply in. As my good friend, Senator Patrick, was just speaking about confusion that happened on occasion, I can't help but think of the time when I was in the House and somebody, a Representative, by the same name as I use got into a lot of serious trouble and when she first heard about that she was very disappointed and very upset with me. Thankfully somebody reassured her, "No, no. That is not the David Burns you're thinking of." She was a wonderful lady and, as I said, this is also a happy time for some because I knew her, I knew that she had a personal relationship with her Lord and Savior, and I know where she is today. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator GERZOFSKY: Thank you, Mr. President. Ladies and gentlemen of the Senate, I'd like to draw you a picture. I do that often when I stand up and speak. This one I think everybody's going to visualize very well. Being a freshman, getting elected in the 120<sup>th</sup>, and being assigned to the Criminal Justice and Public Safety Committee, I go in and I take my seat. I have sitting on my left Senator Paul Davis. I have sitting on my right, I'm only a freshman, I didn't know where the bathrooms were yet in theory, was Lois Snowe-Mello. I've often mentioned here one of the greatest experiences I ever had was that first initial session I went through because of the seatmates I acquired and the relationships that were made. Lois and I would go, we would carpool together, often and go on tours of prisons and juvenile detention centers and courts and things that Criminal Justice and Public Safety go on tours with. She would drive down to Topsham and I would pick her up. If it was in warm weather she used to love me picking her up in a convertible and we would go off and we would spend an awful lot of time in cars, driving to Charleston, to Thomaston, to different places. We'd have a lot of fun and people used to ask me, "Now, Stan, you guys are so opposite on your voting. You never vote alike. What can you possibly find fun?" Well, we both had families. We both had triumphs. We both had tragedies going on in our lives. We talked about everything except reproductive rights and some of her passionate concerns that were opposite of mine. We just didn't go there. We went to where we were comfortable. I've done that with several of my friends on the other side of the aisle. We talk and we enjoy each other for who you are quite often. We were up in Thomaston Prison. My first tour of Thomaston Prison as a Representative and Representative Snowe-Mello was with me. We did the tour and then we went into the Warden's Office. Well, as I've been known to do once or twice, I said something that he didn't really like and he said so. Well, I don't care what bear you are, but I was the cub that day and I had a bear that was wearing

lipstick, a Momma bear that went up one side of this guy and down the other side of him and I just stood there in absolute amazement, Mr. President. I just never saw that little lady tear into somebody that hard. I had just recently met her. That warden wound up coming into our committee the next day to apologize because nobody in their right mind would ever want to take on Lois when she was in a mood and when she was defending a friend. She was a lot of enjoyment to me, a lot of enjoyment to a lot of us. She took her job very, very seriously. She did some good work I didn't always agree with, but it was important work. Those times when we could support each other and vote the same, we always enjoyed that the most. There was a lot of laughing going on between us. When Senator Patrick mentioned that little woman's laugh, he was absolutely right. It was infectious. When she got going she was really guite cute. I loved Lois and I still love her today because she was just a personality and she was a good personality and she brought a lot of respect to her office. Along with the rest of the Body, I'm going to miss her. We're going to all have fond stories to tell and that's what I think the end of life is, those stories that you leave behind that people cherish and remember and I hope that we all do that with Lois because she was, I always called her Lois, just a thrill to be round. I wanted to say that, Mr. President. Thank you very much for giving me the opportunity.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Collins.

Senator COLLINS: Thank you, Mr. President. Ladies and gentlemen of the Senate, I first encountered Lois Snowe-Mello, God bless her, when I first came to Maine House of Representatives in the 118<sup>th</sup> Maine Legislature. She was a lot of help to me as a rookie, freshman legislator. There was a group of us who used to talk about what happened in the State Capitol that day back at the good Representative, former Representative, John Buck's room. Paul Waterhouse, and a few others would congregate in their room after session and discuss what had happened that day. Lois was part of that. Now, protocol was kind of thrown out of the window. Conversation got pretty heated at times. A lot of cigar smoking, that kind of thing, when it was allowed. Lois would take it all in and Lois would express her opinion. Some of these off-premise meetings got to be almost the same limelight as a locker room at half time. It was pretty colorful. Lois, believe me, could hold her own. She let you know her opinion and she'd sit there and take it all in, very quietly. All of a sudden she'd tell you her opinion. I got to tell you, a lot of these guys would stop, motionless, and listen to her. Now, I guess we all try to influence our colleagues and she had that ability. She talked very easily, softly, to you sometimes, but if you voted the wrong way you found out very quickly you voted the wrong way. I will miss her, personally, and I mean that sincerely. She was just a great person, a dedicated legislator to her constituency, and she will be sadly missed by the people of Maine. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Piscataquis, Senator Davis.

Senator **DAVIS**: Thank you very much, Mr. President. I sat here thinking about different things about Lois and a lot of things come to my mind. I was privileged to be the leader of the Republican caucus the last four years of my first stint here in the Maine

Senate. During, I think, the second term that I was leader Lois came to see me one morning. I knew her a little bit. I'd been to a few meetings where she had been and she told me that she wanted to run for the Senate. I said, "Fine, that's wonderful." There was another Representative, who was a doctor, that wanted to run too. By the time Lois got done with him he didn't want to run any more. She would come in and see me guite often and I would say to her, "Lois, on your way home tonight you've got to do 50 doors." She'd come in and say the next morning, "Senator Davis, I did 75 last night." She'd want me to know that and she'd also write about 150 notes during the day that day. Lois was small in stature but if you underestimated her at your own peril. She was not to be messed with. I can tell you. She was guite a lady. I think about my good friend Senator Patrick and speaking of confusion. Lois could do that to you alright. She came into my office one morning. She was madder than a wet hen. We had had session and she came in and she told me, she says, "The staff won't take pictures of my guests." She said, "They've done this to me and I'm fit to be tied." I said, "Alright, let's go in and see the President, see what's going on." Well, we went in and saw the President. In the long short story of it is that the guests left two hours before that. There was no picture to be taken. Bob Crockett was the Sergeant-at-Arms at the time and he was beside himself, to say the least. That was Lois. Another side of Lois, though, I remember one morning we had a bill here that had to do with the plumbing inspectors in small towns. At that time I think the fee was \$100 they would get for going to inspect septic systems. This particular bill would double it or something and she didn't like that idea at all. She got up and she very eloquently gave what I felt was a very moving speech about it. How the little homeowners couldn't afford it. That was Lois. She was always thinking about the little guy back home. That was her. That's what she did. She was great. She also could show a tremendous amount of gratitude. One morning my wife and I got up and Lois was in the hospital in Lewiston. This was probably six or eight years ago. I said to Patti, "Let's go down and see Lois Snowe-Mello. She's in the hospital." We drove down to see her and I can't tell you the gratitude that woman showed us for simply driving down and visiting with her. It just moved me. She was a wonderful person. She always had a lot of good advice for me when I was a leader. Sometimes I found it useful. I will cherish the memory of being able to serve with her, to be able to. She will be greatly missed, but let's think that she's in a better place now. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator **MASON**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I just wanted to stand up and say a few words about Lois and maybe share a couple of memories. As I've said before, in this Body when we lose a former member we lose a part of extended family. That is true whether you are a Democrat, or you are a Republican, or you are an Independent. I believe that we forge bonds here that are very hard to forge anywhere else in this world. When one of us grieves we all grieve just as we did when Lois' husband, Brian, died just a little under a year ago. We feel for each other and I'm thankful for the bonds that I have with every single one of you in this room and other Senators that I served with in the past. Lois was so proud to be a Senator. If I could think of one thing that Lois was proud of it was to serve in this Body. There are a few people that I have learned

in my role now as leader and in my role as a member who have respect for this Body and Lois was one of those people. There are two others in this Body that I can say that for and that's Senator Haskell and Senator Gerzofsky. Those are two people that if you want to learn how to respect this Body you talk to them and Lois was the same way. In 2010 I decided that I was going to run for the State Senate and I'd known Lois for years. I've known Lois for probably 20 years. My Mom got involved in Republican politics and Lois was a figurehead in Androscoggin County. I'd known her for a long time, but I got to know her in a different capacity in 2010. I remember sitting at the Androscoggin County Headquarters on Sabbatus Street in Lewiston, where U.S. Cellular is now. I had just come back from a day of doors. It was September and we all know how that feels, especially when you're in a heated race. Lois walked in and asked me what the heck I was doing there. She goes, "You're never going to win this race. You haven't knocked on enough doors." I said, "Geez, Lois, I've knocked on 5,000 doors." She goes, "Well, you need to knock on one more." That was just the kind of person that Lois was. On election night in 2010 I had won the race and I was sitting there and everybody was calling me Senator and I felt really good about myself and Lois walked in. Lois very quickly reminded me that I was very much the junior member from Androscoggin County and that she was the senior member and there was one in between and that was Senator Craven, so I was third on the pecking order. Well, we got to the Senate and I sat right where the Senator from Kennebec, Senator Cyrway, is and guess where Lois sat? Right where Senator Whittemore is. I always knew when I was voting right or wrong because I'd hear, "Garrett, Garrett." I'd just turn around and shake my head. Now, in Lois' definition, I am the senior Senator from Androscoggin County, sorry Nate and Eric, and I hope that I can bring to that role as much tenacity, grit, determination, and pride that she brought to that role for herself and I think that we would all do well and be better Senators if we followed a little bit of Lois' legacy. Thank you, Mr. President.
