**THE PRESIDENT**: The Chair recognizes the Senator from Washington, Senator Burns.

Senator BURNS: Thank you, Mr. President. Ladies and gentlemen of the Senate, I just want to rise and give a few comments in my support for this nomination. Our country started this history back in 1791 with the first Chief Justice of the U.S. Supreme Court, John Jay, and in Maine, in 1820, our first Chief Justice of the Maine Supreme Court when we separated from Massachusetts. Since then our court system has had a very rich tradition of the third branch of our government and the people that serve there and those who are in leadership there. The present nominee, Chief Justice Saufley, has spent 25 years in the court system in this state, beginning in 1990 as a Judge at Large, 1993 as a Superior Court Justice, 1997 as an Associate Justice, and in 2001 and since as our Chief Justice of our law court, the Supreme Court. It was very interesting to listen to Chief Justice Sauflev's presentation to the Judiciary Committee last week when she talked about the priorities that she set when she came into office. I'll just briefly mention some of those. Her first priority for the court system was safety. Under her leadership, our courts are now extremely safe compared to what they were when she first took office, making sure that those who have to go there to

seek justice and those who work there every day are protected from violence. Improvements in the court facilities: which we've seen in at least seven counties and ongoing proposals. Unified court dockets, elimination of the backlog in our court system, which, under her leadership, will be completed at the end of the summer of 2016. Because of her initiative and the law court's individual participation in our court system, we'll have our backlog taken care of. Under her leadership we have seen great strides in our judicial system, especially in the area of specialty courts: co-occurring disorder courts, the veteran's court, and our drug courts. Things that we should all be very proud of and, to a great extent, are due to the efforts of Chief Saufley. It really was a privilege, and has been a privilege, to participate in the confirmation process of these judges in our court and especially so when we have an opportunity to set in a confirmation process for a law court position and, in this situation, the Chief Justice of the law court. As I mentioned the other day in committee, this only happens once in seven years and I will never have that opportunity again and many others won't either. It really was an honor. The committee took advantage of the hearings the other day to talk, have a conversation, if you will, with Chief Justice Saufley. A unique opportunity to have a back-and-forth discussion about her perspectives of our system of justice in this state, where we've been, and she sees us going. It's a unique opportunity that I really cherished and I know those on the committee cherished it also. I think that we can be very proud of our court system here in the state of Maine. I've been involved with the court system since I started in law enforcement in 1970 and I've had the privilege of working under many judges and meeting many other judges and now the opportunity to be here in the Senate, in this Body, and to meet some of the finest legal minds that can possibly come forward to come and be confirmed by this Body. Chief Saufley is no exception to that. In fact I would say she's one of the shining examples of the court system that we have here in the state of Maine. As far as I'm concerned, it's second to none. We should be very happy about that and it's my pleasure today to support this nomination and it's a privilege to give that support, Mr. President. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Volk.

Senator VOLK: Thank you, Mr. President. Ladies and gentlemen of the Senate, I, too, want to rise and just briefly express my support for the reappointment of Chief Justice Saufley. At the nomination hearing Attorney General Janet Mills came in and testified quite passionately in favor of this reappointment and one of the things that really struck me that she said was the courts should be above politics. Chief Justice Saufley, if you look at her record, has embodied this statement throughout her career. She was originally appointed to the judiciary by Governor McKernan and she has since been reappointed by Governor King, as well as Governor Baldacci. It was Governor King actually who elevated her to the post of Chief Justice. I have had the honor of interacting with this woman who, by the way, was also an historic choice to be Chief Justice. She is our first female Chief Justice in Maine and she was also the youngest Chief Justice ever appointed in Maine. Quite a distinguished career. I've had the pleasure and the honor of interacting with her. She came to Scarborough High School last fall and I was just amazed at the way this woman, who holds one of the highest posts in the state of Maine, interacted at such a

wonderful level with the students and they really were quite amazed as well. She showed an interest in their lives. It wasn't just all about her answering questions from them. She was asking them questions about their interests and their studies and what did they think about the cases that they heard. That was just very impressive. A couple of other quotes that I wanted to share with you from this hearing. Michael Welch, from the Maine Trial Lawyers' Association, said that she was overwhelmingly rated highly and the epitome of the consummate jurist. The last quote was, "I doubt we will ever have a Chief Justice that works as hard as she does." It is certainly my honor, and it's all of our honors, to be able to confirm this nomination this morning. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Lincoln, Senator Johnson.

Senator JOHNSON: Thank you, Mr. President. I rise to gladly add my support to our confirmation of Chief Justice Leigh Saufley. She came before the committee and spoke not only of what her accomplishments had been, of her proven ability to hold the Chief Justice of the State of Maine responsibilities, but she also spoke of what the ideals were that she and, under her direction, our court system live up to every day. Those include placing fairness and justice foremost and working for the integrity of our court system so that every person in the state of Maine who comes before the court can experience and expect that treatment in our court system. To me, that's the core of our justice system, being just. We also had the opportunity to talk with her about what her view of the current circumstances and the future direction the courts. I found that to be very impressive as well. She spoke about the need to innovate and adjust with the times. There will soon be a case management system in place, which will enable far more of the information about what's happening in the courts to be interacted with by all the people who are working with the court system and within the court system and ensure that those records are appropriately available as needed. She spoke with us about the fact that family law was never anticipated to be the nature of what it is today in the design of the court system and how at the time when family law was first instituted divorces were rare. Families were very different. Times have changed and so many families coming through our court system today are dealing with some of the most troubling and difficult times of their lives and they come through different doors. She spoke of the need to have a single door for families to come through, depending on what their matters are relating to their family circumstances are, that they get handled in a way that makes that experience certainly living up to those ideals of fairness and justice and integrity, but also a bit less complicated. She spoke of some of the other things that we need to work on still in the State of Maine and find better ways to deal with both as a Legislature and in our court system. Domestic violence and human trafficking, drug abuse. The need for things like step-down housing for drug addiction because, in spite of the great success of the drug and co-occurring disorders court, which they are working to expand across the state of Maine and build on that success, there's also a support needed outside of the court system for that recovery process. I think that she spoke well of our need to do what it takes in the Legislature to support the work of the courts and the needs of the people of the state of Maine from that viewpoint. I'd very much appreciate the opportunity to have those discussions with Chief Justice Saufley and urge you all to support her for her

fine and wonderful work in that capacity in the past. I'm sure she will continue to serve us very well in the future. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator HASKELL: Thank you very much, Mr. President. Colleagues of the Senate, I'd like to take an opportunity, because they don't come around very often, to speak personally about my experiences with the Chief Justice. She's over there going, "I hope not." I do want you to understand the kinds of opportunities that she's created in our system. Not very long ago, it seems, along with the First Lady of the State of Maine and U.S.M. Professor Peter Pitegoff, the Chief Justice stepped forward and created what was to be a task force on juvenile justice. If you know the Chief Justice, she knows that you know that she prefers a small group of people who know what they're talking about and very quick results. The task force was designed to be maybe a dozen or possibly two dozen people. What we found out very, very quickly was that there were people clamoring at the door to be part of the juvenile justice task force; to have their say, to talk about what their part was. That task force expanded to about 50 or so people who all showed up on a regular basis because the Chief Justice was part of this, the First Lady was part of this, the law school was part of this, but I think mostly because when the Chief Justice says, "Here's something that's important to us," people show up and they did. A series of 72 recommendations were put together by that group. Believe it or not, the large group was able to get something done, but that was not good enough for the Chief Justice, for the First Lady, and for Professor Pitegoff. They insisted that there be an implementation council. In order words, some group to get the work done so we didn't just have another report sitting there being dusted off. I was truly privileged, along with Professor Chris Northrup from the University, to be co-chairs of that implementation council. We reported back to these three people on a regular basis on our work on implementing these 72 items that were in there. I'll tell you that many of them were implemented, many of them have made a huge difference in our juvenile justice system, but it's not without leadership that that kind of thing happens and it's not without that foot on the gas pedal of let's get this done that was created by the Chief Justice. I am eternally grateful to her for that opportunity for me personally, but also for all of those involved in the juvenile justice system in the state. We owe a great debt of gratitude for her persistence and her focus on this issue, as well as many others. It's such a pleasure here today to be able to speak in favor and strongly supporting this re-nomination. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator **MASON**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise today to support the nomination of Chief Justice Saufley for another term to the court. I think it's important for us, especially when we have personal experiences with someone, to put something on the record for posterity's sake. That's one of our jobs here as a Senate, to confirm nominees. Today we have a great one in front of us. My first term in the Legislature in the 125<sup>th</sup> was my first time here, first time chairing a committee, and I got to chair the Criminal Justice and Public Safety Committee. As you can imagine, we get to hear from the

court from time to time. One of my first experiences with Chief Justice Saufley was when the Supreme Court started doing their Court For A Day program. As someone who believes deeply in the power of education to change somebody's life, that meant a lot, that the court would take their time to come to a high school and actually hear cases in front of students. It was such an awesome experience and I know that for a fact that there are kids that are studying pre-law right now because of that experience. It was just a fantastic day at Lisbon High School and I think that those things ought to be noted on the record when people do great things. I'd like to thank the Chief Justice for that. She is such a wonderful ambassador for the court and I'm proud that she is our Chief Justice and look forward to what she's going to do over her next term. I congratulate her on her reappointment. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator KATZ: Thank you, Mr. President. Men and women of the Senate, I think when the public thinks of a Supreme Court Justice they think about someone who is stern, with no sense of humor, someone who is unapproachable, and someone who is out of touch with everyday people. We are very fortunate, Mr. President, that Chief Justice Saufley flunks all three of those tests every day. Just to give you perhaps some idea of what it is like to appear before the law court, you're there and there are these seven Justices in black robes sitting up there, higher than you are, and you never know where the questions are going to come from. It's a very intimidating situation to be in. Chief Justice Saufley, as she did when she was a trial judge, immediately places people at ease. Whether it is the running of the court, the administration of the court; whether it is the way that she considers cases and writes her decision, not being afraid to dodge the tough issues; or whether it is putting on her political hat and being an advocate for the needs of the judiciary, both on the second and the third floor, four words come to mind, Mr. President, when I think of Chief Justice Saufley: breath of fresh air. She is the face of the judiciary in the State of Maine and how fortunate we all are for her public service. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Valentino.

Senator VALENTINO: Thank you, Mr. President. Men and women of the Senate, I rise today, also, to say a few good words about Chief Justice Saufley. As the good Senator from Cumberland had said, this is an extra-ordinary event. This is not something that happens every day. I do feel that it is important for us to stand up and to say a few of our thoughts on there. As a former chair of the Judiciary Committee, I have had the honor of working with Chief Justice Saufley. We've done a lot on court security. We toured the new capital judicial center as it was being built and had the wonderful hard hats on for our photo opps. The drug court, judicial nominations, and everything else, including budgets for the judicial branch. I always look forward to her State of the Judiciary and her humor and her bluntness on matters of importance to the judicial branch. Just to recall one quick story. I was in the other Body, in the House, and she had given her State of the Judiciary. I was new. It had been my first term that I was there and it was something they had just started, coming down to

high schools. She mentioned during her speech, "If you are interested in having us come down to one of your high schools let me know because there's an opportunity, maybe, to do one or two schools. We're just testing this out." Literally, I think I tackled her in the aisle as she was walking away from the podium and said, "Come to Thornton Academy," as everybody is around her. She leaned over to Ted and said, "Okay, put her on the book, put her on the book and Thornton Academy." I must say, she was so generous when she came down. People that know me know that I have a tendency to organize and maybe push a little bit. She came down not just for the presentations of the court but I managed to have her stay for a nice luncheon, got her on TATV for an interview, and she was so gracious with all of the students. Everything we did, she just really made a wonderful, wonderful day of it. She's a leader, a mentor, and a rational voice for the people of the state of Maine. I applaud this reappointment and the unanimous recommendation of the Judicial Committee. She has been, and will continue to be, an outstanding Chief Justice for Maine. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator **GERZOFSKY**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I also rise to give my unanimous support, my strongest support, for this nominee. The Chief Justice has been just as good as everybody that has gotten up says she is. I'm going to make this short and sweet because I believe that the past chair and current member we have worked side-by-side on many issues, even looking at the criminal code, which was an act of love, I think. I just want to say, short and sweet, the Chief Justice rocks and everything that's been said about her today certainly is appropriate. Mr. President, I urge all my friends and all the other Senators here, there's a difference, to support this nominee. Thank you very much.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator CUSHING: Thank you. Mr. President. Ladies and gentlemen of the Senate, sometimes we rise to give our words of recommendation and we diminish from the important things that were already said, so I will keep my statement brief, but I did feel that Justice Saufley deserves to be recognized and have extended greetings brought to this Body on behalf of what a tremendous role model she has been, how she has served our state and the Judicial Branch very capably, and I think it's a testimony to the quality of what we have here in Maine, that we have someone of her caliber that leads our court. I had the similar experience that many of you did in attending some of the local sittings of the court in high schools and, for myself, my daughter had participated in the mock trial program. They ultimately sat for their competition before a panel which included the Chief Justice. She takes a tremendous amount of time to impart in the young people what a value it is for them to consider the law and I think in today's society it becomes even more important that we have role models that exhibit the grace and the pose that the Chief Justice does in her interactions with the public. Many of those, unfortunately, as we know, come from behind the bench, so for her to take the time and effort to publicly come out to interact with us here in the Legislature on important issues and to be the face of the court to the public in a positive

way, I think, speaks for her commitment to this role. I want to add my personal endorsement for this nomination. Thank you, Mr. President.

Senator **SAVIELLO**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I'd like to share with you what I shared at the memorial service for Mike this past fall.

Thank you. I'm honored to be with you here today. Although I've never gone to sea I have some saltwater in my veins. My Dad, you see, was a Merchant Marine. He served this country during WWII as a Merchant Marine and went to sea the first six years of my life. He loved the sea and I'm sure he'd be here today to offer his thoughts and condolences. In New York City there's one of the most memorable lost at sea memorials

anywhere. It is located in the west side of Battery Park in Manhattan near the line to board the ferries to the Statue of Liberty and Ellis Island. The memorial is designed and based on a photograph from an actual WWII event. In that event a German submarine attacked and sank an American Merchant vessel, thought to be an oiler. The submarine surfaced, took photos of the survivors. The memorial depicts the scenes in one of those photos. The submarine did not pick up the survivors. They were lost at sea in the vast Atlantic. There's a plaque at that memorial and it reads, "Dedicated to all Merchant Marines who have served America from the Revolutionary War to the present day. In the prosecution of war and in pursuit of peaceful commerce, unrecognized thousands have lost their lives at sea. Their sacrifice has helped secure America's liberty and prosperity." The sculpture was inspired by a photograph of the victims of the submarine attack on the Merchant Marine ship. It serves as a memorial to the Merchant Marines resting in unmarked ocean depths. Lizzie Clark Hardy, at a memorial service, said these words in a poem: Sometime at Eve when the tide is low I shall slip my moorings and sail away, with no response to the friendly hail of kindred craft in the busy bay. In the silent hush of the twilight pale, when the night troops down to embrace the day, when the voices call in the water's flow, sometime at eve, when the water is low, I shall slip my moorings and sail away. Through purple shadows that darkly trail over the ebbing tide and the unknown sea, I shall fair me way in dip of a sail and a ripple of waters to tell the tale of a lonely voyager sailing away to the mystic isles where at anchor lay the crafts of those who had sailed before over the unknown sea to the unknown shore. A few who watched me sail away will miss my craft from the busy bay. Some friendly barques were anchored near, some loving soul my heart held dear in silent sorrow will drop a tear but I shall have peacefully furled my sail in mooring sheltered from the storm and gale and greeted friends who had sailed before over the unknown sea to the unknown shore

Let me close in a different version of the 23<sup>rd</sup> psalm: The Lord is my pilot; I shall not drift. He lights me across the dark waters. He steers me in deep channels. He keeps my log. He pilots me by the Star of Holiness for His Name's sake. Yea, though I sail mid the fenders and tempests of life I will dread no danger; for He is near me. His love and His care shelter me. He prepares a harbor before me in the Homeland of Eternity; He anoints the waves with oil; my ship rides calmly. Surely sunlight and starlight shall be with me wherever I sail, and at the end of my voyaging I shall rest in the port of our Lord forever.

Mike, rest in peace. Your Mom and I will keep your promise.
