Senator LANGLEY: Thank you, Mr. President. Men and women of the Senate, it's a joy to rise today to honor the George Stevens Academy Basketball Team. If you are a member of the Education and Cultural Affairs Committee, every day when we introduce ourselves to begin our work we take a couple of minutes to brag about the kids and teams in our districts and have guite nice rivalries going amongst our members. Today I have here visiting us the top ranked George Stevens Academy Eagles, who raised the gold ball and took home the Class C State Championship for the 59 to 46 win over Waynflete Flyers at the Augusta Civic Center on February 27th. At the beginning of the game Waynflete had posted the first score of the game one minute in before sophomore Taylor Schildroth shot a clean three pointer to add to his nine point run in the first guarter. The Eagles had a 14 to 7 lead into the second quarter, but saw that slip to one point with less than one minute left. A field goal by Chase stretched the lead to three at the end of the first half, 25 to 22. It was truly an exciting game to watch. They went into the final guarter at 40 to 35 and pulled away to win by 13 points. The Eagles' run to the State Championship was not without drama. After the top ranked Eagles crushed number eight Fort Kent 73 to 28, and in the finals shot down number five Schenck 68 to 39, they had to gut out a tough 55 to 43 win against Bucksport. Senator Rosen and I share this school, so one of our teams won and one of our teams lost in this process. With the State Championship GSA finished 21 and 1 for the season. The Eagles boys are now 3 for 3, winning Class C Regional in 1979, 2003, and now in 2016, and they were also crowned State Champions in 1943. I'd like to point out to this Chamber that this team now if forever linked to the State House because tragedy has befallen the State House here today. If I were to ask this Body what would be the worst thing that could happen here in this Body, it might be a budget negotiation breaking down and government shut-down happening. You could maybe think of the worst thing. I would contend today that what is the worst thing that happened is when the team was coming through with their gold ball and when it ran through the scanner this morning the ball was snapped off the top of the stand. I would contend that that's far worse than maybe a government

shut-down due to budget negotiations failing. Next week I may have to put in a Joint Resolution where we pay for a new ball, but rest assured that measures are underway as we speak to have that ball replaced and, frankly, the team coaches have said they will cut the current one into little pieces and every team member will have a piece of gold ball to take with them into the future. We'll get that ball to them at their school. They will forever have a story linked to this Body. With that, men and women of the Senate, thank you very much.
