Raymond John Lagueux, of Lewiston, on his induction into the Franco-American Hall of Fame. Mr. Lagueux grew up in Lewiston, the son of a Franco-American father and a Polish-American mother. He studied French at Lewiston High School, later earning degrees in French and German from Providence College and French language and literature from The Ohio State University. He taught the first French language program at Farmington State Teachers College. He also taught several classes at the University of Maine at Augusta's Lewiston-Auburn

campus and for Lewiston Adult Education. Mr. Lagueux enjoyed teaching his Franco-American students and encouraged them to think positively, be confident and understand that their dialect or accent is valid and universally acceptable. In 1970, he worked with the Franco American Heritage Center, later the USM Lewiston-Auburn College Franco American Archives, for which he was the first chairman. From 1997 to 1999, he was a local coordinator for the Forum Francophone des Affaires. In 2004, he joined the board of the Franco American Heritage Center at St. Mary's, now the Gendron Franco Center, serving as secretary and vice-chair and ultimately as chair and interim executive director before retiring in 2015. Marcel R. Viger, of Kennebunk, on his induction into the Franco-American Hall of Fame. Mr. Viger was born in Salem, Massachusetts and resided in Biddeford for 52 years before recently moving to Kennebunk. A bilingual advocate for the French-speaking community, he practiced law in Biddeford for over 35 years, one of the few attorneys in the area who spoke French. He was invaluable to those who needed to speak with someone in French but be represented in English. He joined with Robert R. Gosselin and Albert Deshaies to start the St. Joseph's Federal Credit Union to assist Franco-Americans in obtaining loans. Mr. Viger was the first president of the credit union and also a board member. Mr. Viger served as city solicitor for Biddeford through the 1970s. He was also involved in the choir at St. Joseph's Church, the restoration project of St. Joseph's Church, the Tri-City Community Chorus and the St. Louis Alumni Association. He served in the United States Army, with 2 years in the Judge Advocate General's office at Fort Dix in New Jersey and 6 months at Portsmouth Naval Shipyard. He made tape recordings and handwritten copies of traditional French songs for children to help preserve French culture for the future. Paul Vachon, of Augusta, on his induction into the Franco-American Hall of Fame. Mr. Vachon grew up on Mt. Vernon Avenue in the heart of Augusta's Sand Hill. A tough basketball player, he was the starting point guard for Cony High School's 1973 Class A State Championship team. Following college, he returned to his community as a teacher and a coach. In 25 years of coaching, 23 of which occurred at Cony, he built a 451-50 record. His teams won 7 Class A State Championship crowns and 11 Eastern Maine titles. He developed 3 Miss Maine Basketball winners and helped many of his players go on to successful college playing careers and coaching careers. He was one of the first coaches to understand the implications of the introduction of the 3-point shot to high school girls basketball. His teams were relentless on defense and ran every chance they could on offense, often kicking the ball back out for a trailer to score a 3-pointer. Mr. Vachon was a colorful figure on the sidelines. His frenetic, emotional demeanor often infuriated opposing fans just as it endeared him to the fans of his teams. His greatest gift, however, was his ability to motivate his students in the classroom and his players on the court. The skills he taught involving hard work, teamwork and enthusiasm served them well. was the 1997 winner of the Maine Chapbook Award for her nonfiction book, *Wednesday's Child*, and she has written a sequel, *Down the Plains*. Currently, she teaches literature courses in Franco-American women's experiences, contact literature and creative nonfiction writing. She is a founder and the Executive Director of the Franco-American Women's Institute. They met as students, married in 1971 and settled in Madawaska in 1975. When Mr. Lavertu was a child in school. French was forbidden there, even on the playground. As an adult, Mr. Lavertu wanted to address this problem, and he became a member of the Madawaska School Board in 1985, serving for 12 years. He was recognized for his contribution to making the bilingual education program in the St. John Valley one of 5 designated national "Portraits of Success." In 1992, he was committed to the "Save Our French" movement, which became the seed for founding Le Club Français, also known as L'Association Française de la Vallee du Haut-St-Jean, which preserves and promotes French Acadian history, language and culture. Both Mr. and Mrs. Lavertu have been instrumental in the continuing success of this endeavor. Since 2009, he has served as president and she has served as secretary, and both are very active on several committees of the association. The efforts of Le Club Français helped lead to the success of the 2014 World Acadian Congress in Maine. Senate called to order by President Pro Tempore ROGER J. KATZ of Kennebec County.

Leon A. Gorman, of Yarmouth, renowned businessman and philanthropist, who shared Maine's values and spirit with the world through L.L. Bean, the company his grandfather founded in 1912. Mr. Gorman was raised in Yarmouth, attended Cheverus High School and graduated from Bowdoin College in the Class of 1956. He served in the United States Navy for 6 years before returning to Maine to join his grandfather at L.L. Bean, Inc. in 1960. Mr. Gorman was appointed President in 1967 following the death of his grandfather and served in that capacity for over 35 years. He was named Chairman of the Board of L.L. Bean, Inc. in 2001 and Chairman Emeritus in 2013. Mr. Gorman had a deep love of the people and places of Maine and he worked to protect and strengthen the State's natural and human resources. Together with his wife, Lisa, Mr. Gorman helped protect thousands of pristine acres along the St. John River, the 100-Mile Wilderness and Katahdin Lake. His philanthropy extended to providing financial support to such entities as the Coastal Studies Center at Bowdoin College, the Casco Bay YMCA, Pine Tree Council of the Boy Scouts of America, the United Way of Greater Portland, the Appalachian Mountain Club, the Nature Conservancy of Maine and numerous other organizations. Mr. Gorman was awarded honorary degrees from the Maine Community College System and from Bowdoin, Bates, Wheaton and Thomas colleges. He was the recipient of numerous business awards for his work in transforming his grandfather's 2.25-million-dollar company into the 1.61-billion-dollar enterprise that is today known across the world for its commitment to quality. integrity and service. Mr. Gorman felt his proudest accomplishment was growing his grandfather's company "from employing less than 100 people in 1960 to tens of thousands of good people over the generations, a company based on solid Maine values of integrity, customer service, respect for people, a love of the outdoors, and perseverance." Mr. Gorman will be greatly missed and long remembered by his loving wife, Lisa, his family, his many friends and the people whose lives he touched. SLS 710

Senator BREEN: Thank you, Mr. President. As many folks in this Chamber know, Maine lost a visionary businessman early last fall when we lost Leon Gorman. I was privileged to represent Mr. Gorman for just a short time before he passed away and I'm humbled today to honor him here on the Senate Floor. Many of us are very familiar with the success that he brought to the company we all know and love, L.L. Bean. It started as a small company focused on clothing and gear for hunting and fishing and a funny looking boot that was brown on the bottom with rubber and tan leather on top that's now become an iconic symbol of Maine. However, one of the things I'd like to focus on is his difference from many other retailers in that he was an exemplary employer. By focusing the growth of L.L. Bean's call centers and fulfillment operations and other key functions right here in his home state of Maine, the company that Leon Gorman shepherded has employed thousands of Mainers in good paying jobs with good benefits, often for several generations in one family. Leon Gorman's commitment to his workers has paid off in extraordinary loyalty, with many workers staying for decades. To this day L.L. Bean remains in the top ranks of Maine's best places to work. Maine has benefited from more than just the great company. Why? Because L.L. Bean's successful brand has become almost synonymous with Maine's brand. Customers all over the world associate L.L. Bean with quality, honesty, and integrity. The company's 100% satisfaction guarantee is the gold standard in retail, earning customer's trust and loyalty over multiple generations. Consumers the world over equate made in Maine with the quality, durability, integrity, and trust that in no small measure came from everything that Leon Gorman did with L.L. Bean. Lastly, Mr. Gorman was more than a captain of industry. He was also a generous philanthropist and avid conservationist and a fundamentally good human being. As you just heard, there were multiply organizations in New England and Maine, all over the world, that he supported generously. His personal commitment to his community reached from some of the world's highest mountain peaks to getting on his hands and knees. For the last 12 years Leon Gorman not only served meals at the local soup kitchen every week, he also pulled the oven out from the wall and cleaned every nook and cranny before he ended his own shift. Leon Gorman, the patriarch of one of Maine's wealthiest families, never put himself above anything or anyone. His humility, his work ethic, his compassion, and his success will forever remain a model for every man, woman, and child in the great state of Maine. Thank you, Mr. President.

It truly is an international juggernaut. In fact, I'm sure we all can recall this, whenever you are out and someone says, "Where are you from?" and you say, "Maine." What are the next

words that come out? Lobsters, blueberries, L.L. Bean, the Bean boot. Imagine that. No matter where you are. As soon as you say you are from Maine all of a sudden it's L.L. Bean and the Bean boot. Leon's relationship to the state was much more than the retail stores and catalogs. Leon and is wife, Lisa, were, and continue to be, transformational philanthropists. They've given to Maine's higher education systems, social services, conservation, YMCAs, to name just a few. At the memorial service a speaker said this about Leon, that I truly believe captures him perfectly, "Leon was the most powerful, private person in Maine, but he often thought and acted in ways to help the least powerful, most easily forgotten people in the state." # JOINT RESOLUTION RECOGNIZING THE AMERICAN LEGION ON THE 97TH ANNIVERSARY OF ITS BEING CHARTERED BY THE UNITED STATES CONGRESS

WHEREAS, on March 15, 1919, members of the American Expeditionary Forces gathered in Paris, France to form a new servicemen's organization and, in St. Louis, Missouri the following May, soldiers who had returned from Europe approved the organization's draft preamble and constitution and name, the American Legion; and

WHEREAS, the United States Congress chartered the American Legion on September 16, 1919 as a patriotic veterans organization focusing on service to veterans and service members and their communities; and

WHEREAS, the American Legion has evolved into one of the most influential nonprofit groups in the United States, with over 2,400,000 members in 14,000 posts nationwide; and

WHEREAS, on August 9, 1921, the American Legion's efforts resulted in the creation of the United States Veterans Bureau, forerunner of today's Department of Veterans Affairs, and the American Legion continues to lobby for adequate funding to cover medical, disability, education and other benefits for veterans: and

WHEREAS, on December 15, 1943, Past National Commander Harry W. Colmery began writing the first draft of what became the G.I. Bill of Rights and, on June 22, 1944, after the passionate advocacy of Past National Commander Harry W. Colmery and National Commander Warren Atherton, President Franklin D. Roosevelt signed into law the original G.I. Bill, ushering in monumental changes to society in the United States, including access to higher education and improvements in housing for veterans across the nation; and

**THE PRESIDENT PRO TEMPORE**: The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator DIAMOND: Thank you, Mr. President. Ladies and gentlemen of the Senate, just briefly. There have been a few questions coming around about this bill. It's kind of gone through both houses, but it is something that's going to impact every single one of us, whoever runs for office, or ever puts a sign up for any reason. I just want to give a quick explanation about this. This is the result of the United States Supreme Court decision on June 18, 2015. There's this little town in Arizona called Gilbert. In that same town there's a little church. It's so small that they don't have a church building, so the church meets at various places throughout the community. They did that and they found out from the town government that they were in violation of the sign code. They challenged that in court. They lost, they being the church, Pastor Reed. They appealed it and they lost the appeal and then they went to the Supreme Court. The Supreme Court, as I said, in Reed, which is the pastor's name, versus the Town of Gilbert looked at this whole process and came to. I'll give you a little summary, the end of their decision by saying that any sign that's placed that's based on content that's placed in any way in a public way in the community all have to be treated the same. That is, we can't have different rules and regs and laws for signs that pertain to political candidates or to bean suppers or to church announcing where church is maybe gathering. The decision was very clear. It said that everything had to be treated exactly the same. As a result of that, there were several law suits pending and so L.D. 1592 in the State of Maine addresses our current law

that needs to be changed so that we meet and satisfy the Supreme Court decision. Again, any sign with the same content. and that could be, for example, Roger Katz for Senate, has to be treated exactly the same as would be the bean supper that's happening. That means they cannot be regulated differently. In this bill, L.D. 1592, what we've said is that maximum size of signs, all signs, 4 x 8 feet. They cannot be any closer than 30 feet, and this is the one that may get some of you. We're used to sometimes putting signs up every 3 or 4 feet, especially towards the end of a campaign period. What this says is that you cannot have the same content-based sign any closer than 30 feet. Your opponent can be right next to you, but yours can't be any closer than 30, neither can your opponents as far as that goes. Everything has to be regulated the same, in summary, everything has to be treated the same, and the 30 foot rule is what we put in this bill. The recommendation was 200 feet. We rejected that, of course, for obvious reasons. Maximum size is 4 x 8. Sign has to have your name and address, which we do on it now anyways. There now will be the same enforcement of the same sign police, which will be the Department of Transportation. I'm not sure if they are going to have little cars that come around and check on these and measure the sign difference and the length between the two, but that's what it is. Not to be confused, same content regulates the 30 feet. Same content. Again, I think this may or may not have some impact to your constituents, especially when it comes to events that are happening in your community, if they want to put a sign in a public way. It has to be with that regulated distance. Mr. President, that's it. There isn't anything you can do about it. If you have any questions I'd be happy, and I'm sure the Senator from York who also knows all about this, to answer questions, either one of us. Thank you, Mr. President.

**THE PRESIDENT PRO TEMPORE**: The Chair recognizes the Senator from York, Senator Collins.

Senator **COLLINS**: Thank you, Mr. President. Ladies and gentlemen of the Senate, yes, this is the result of the court proceedings and its conformity. It's going to be required. We had a tough time with this at the committee level. A lot of folks were in question whether or not they want to support it. I think that we have to support this in order to conform with the courts. I'd recommend that we do that. I have an idea things are going to change down the line. For now, I think we have to conform to it and I'll just reiterate what Senator Diamond of Cumberland said, I don't know who's going to enforce these regulations. We have a shortage now of people out on the road doing things for our highways and bridges and I can't imagine DOT sending out folks to monitor the signs. I guess I'll resolve to voting for it. Thank you, Mr. President.
