**JOINT RESOLUTION
RECOGNIZING THE IMPORTANCE OF EDUCATION TO
PREVENT SERIOUS SUBSTANCE USE DISORDERS**

WHEREAS, substance use disorders occur when the recurrent use of alcohol or drugs causes clinically and functionally significant impairment, such as health problems, disability and inability to meet major responsibilities at work, school or home; and

WHEREAS, rates of serious substance use disorders, including opioid addiction, are rising in Maine; and

WHEREAS, children are especially susceptible to influences that may lead them to experiment with drugs and alcohol and eventually develop substance use disorders; and

WHEREAS, effective substance use prevention education brings to children the knowledge and skills necessary to recognize the risks of substance use; and

WHEREAS, successful substance use prevention education involves schools, law enforcement, community organizations and individuals; and

WHEREAS, Maine's system of learning results includes substance use prevention education among the health education content areas; and

WHEREAS, the Department of Education and the Department of Health and Human Services have collaborated to produce the Maine School Substance Use Policy Guide for schools to use when adopting a substance use prevention education policy and curriculum; and

WHEREAS, the Maine School Substance Use Policy Guide provides a toolkit for schools to use to implement substance use prevention education policies and curricula; and

WHEREAS, the Legislature recognizes the importance of local policies and curricula to implement effective substance use prevention education programs; and

WHEREAS, the Legislature encourages the ongoing development of the Maine School Substance Use Policy Guide and its use in schools; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize the essential role of substance use prevention education in preventing serious substance use disorders and encourage the use of the Maine School Substance Use Policy Guide.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Hancock, Senator Langley.

Senator **LANGLEY:** Thank you, Madame President. Men and women of the Senate, I rise today to support the Education Committee's continued support of substance abuse education. We had a bill this session that would require the DOE to create a

model policy for substance abuse education for use in Maine schools, but the DOE has, indeed, a model policy which helps local districts to develop policies around substance abuse education. In our committee what we learned from the folks that are experts in this field is that schools do have these policies but it's helpful to us, as a community and as a state, to keep bringing this issue forward and keeping it in our sights, hence this Resolution being in front of you today.

I would like to tell you a quick story about this past session. Each member of the Education Committee, as part of a project, spent a day shadowing a principal in a local school. On the day that I chose and went to shadow a principal in my district I arrived at 7 a.m. on a Friday and at 7:15 in the morning we had a meeting with the guidance department and the councilors, the social workers, to develop a plan for what to do with a brother and a sister, how they might have to move this brother and sister to a safe house if their father, when released from jail, were to show up at school to find them. He was in jail for holding the family hostage the weekend before at knife point while high on drugs. For me, seeing this firsthand in the schools and what the schools have to deal with, it, unfortunately, is in their midst every single day. This, to me, is an example of the issue that would require a community, state, and federal solution in our country. The reason that you see this in front of us today is just as a constant reminder that we have a lot more work to do. Men and women of the Senate, thank you so much for listening.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK:** Thank you very much, Madame President. Ladies and gentlemen of the Senate, I wish to also speak very briefly on this, commending the work of the Education Committee and the Department for this particular initiative. We all know about the very difficult problem presented for our society with drugs and the only way to stop this is to stop it at the very beginning so people don't even begin to think about using drugs and other substances early on in their life. An impossible task. How are we going to do that? I think we can look to the success of the anti-cigarette campaign that's been going on for the last 50 years now. It's taken a long time but it's worked. The incidence of smoking is decreased. The percentage has decreased. It's still there. There are people who make that choice but the frequency is much less than in the past and this, in the face of an enormously powerful lobby, the tobacco lobby, the money going in there, Surgeon General's reports, has made a major difference in there. It's curious. I have an exactly parallel story to that of the Senator, which is to say, having heard of the Education's visits to local schools, I, too, said, "What a good idea." I've gone to four schools in my district and it's fascinating. I have to say one of the small schools in my district, very impressed with what they doing with drug education early on and there are dealing with people proactively. They are dealing with them one at a time and it's working. We talk a great deal about solutions down the way, down the road, but the fact is if we can get kids early on it makes an enormous difference. This particular small school in my district has had remarkable success. This is certainly a pathway. I commend you and thank you for your attention.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY**: Thank you for permission to speak, Madame President. Ladies and gentlemen of the Senate, I'd just like to take the moment, since this is a really great Resolution, for a reminder for the schools to pay attention to what substance abuse programs are needed in the schools. We know it's out there. We've seen the big climax of drugs in just the recent year or two here that has really taken off. I was a DARE officer in schools since 1992 and I've seen, through the years, quite a lot of changes, but also the violence. As you know, when I first started, when I was younger, we had the movie CHIPS. I actually got to meet Poncherello back when they were the number one rated show. They never drew their gun, never showed blood on TV. Today, you look at the graphic media out there now, all we see is blood, gore, swearing. You see partial nudity. There's just about everything that you see is given to our children. We really are seeing that on television, radio we're hearing it, music. It's just out there and we have to be aware of what the changes are happening and how it progresses. We challenge ourselves and the media knows it, how it challenges, when we go to test ourselves. I remember when I was a kid, when I watched my first scary movie I used to put my hand in front of my eyes. I think it was King Kong, I'm not sure. I could remember testing myself on how much I could take. We test ourselves even now. We test ourselves with these games, video games, and how you can get to the next level. The drug culture is the same way. It tests yourself to how far you can get. If we do not let our kids have the tools to make good decisions and realize what is happening because of our society and how to make those good quality decisions on peer pressure and what they're listening to and what we're exposed to we are failing our children. I tried to get the DARE program supported by the State last year and next year I probably will do the same thing, but I think that we really need to get it back into the schools. We do have violence in the schools and I've been at schools when I've had a parent come at our school, or was attempting to come to our school, when high on cocaine. The wife said she wanted a divorce and he said, "Well, I'm going to go get my kids whether you want to or not." He loaded his 30-06 and headed to the school. We had a lockdown and we managed to get him just before he got to the school. The child, the parent's child, really was traumatized by that. She was part of that lockdown and when I had her in 5th grade, she was a 1st grader then, I managed to have her in DARE in 5th grade and also in 8th grade, when she actually spoke to the students and told her experience of when the father got arrested and went to prison. He got out in four years and he actually overdosed and died from cocaine use. There are some serious situations out there. We really need that education in the schools. I thank you for this Resolution and I think that we really need to take a look at how we can get education into the schools. Thank you.

Senator **PATRICK**: Thank you, Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, I will be opposing this motion. This is a bill that tries to change a law that was put in place in 1985. One of the things about the institutional knowledge that we lose through term limits and stuff is to remember what happened, what took place, back in 1985, 31 years ago. We had a gentleman who was a lawyer that testified that actually was here with the original bill when it was installed. A lot of these labor bills should try to strike a balance between the

injured individual worker and the employer. From what I understand out of this bill, I believe this bill, the change, will not alleviate the problem. I am a firm believer that because of the limited amounts of strikes that we've had year after year, they get less and less and fewer and fewer because changes are the rules and regulations are already, in my interpretation, in balance already. This would, therefore, drive a further imbalance in the way we look at strikes. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Volk.

Senator **VOLK:** Thank you, Mr. President. Ladies and gentlemen of the Senate, what this bill does is it actually restores the employment security law to its original intent, which is to deny unemployment benefits when someone has chosen to participate in a labor dispute. Labor unions exist in order to help workers get by in the event of a strike. These strikes are voted on by the workers. In my mind, that is one of the benefits of belonging and paying dues to a labor union. Almost all states deny benefits to striking workers because they are voluntarily striking for financial gain and they have a job that they will return to. This bill would still provide benefits when the strike is for safety or if the workers were locked out or lost their job, like in the case of Hostess Baker strike. It really just clarifies, because right now what happens is that there is a lot of confusion when these workers go and they try to apply for unemployment benefits. We just need a little more clarity at the Bureau of Unemployment in order to make things a little more obvious in our law. Thank you.
