Dear Honorable Members of the 127th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 1517, "An Act To Enable an Alternative Organizational Structure To Purchase Group Health Insurance for Its Employees."

While I support the principle of enabling alternative organizational structures (AOS) to use scale to lower the cost of the insurance benefits they provide, this bill does not go far enough. Given the number of teachers and public employees throughout the state, there is much more we could do to allow municipal employees, state employees, university and community college employees, among others, to pool together to achieve cost savings. This bill does not provide an AOS with the option to join the state's benefit plan; instead it focuses on a narrow solution to a broad problem.

In his testimony presenting this bill, the bill's sponsor described the current challenge to the AOS system as an unintended consequence of the federal Affordable Care Act (ACA). That is being far too kind. The ACA was a sham, sold to the American people upon the premise that government mandates could lower the cost of insurance for hard-working men and women in this country while destroying the ability of the private sector to compete. In reality, the ACA continues to threaten the ability of the State of Maine, as an employer, to provide quality affordable benefits to state employees.

In December, Congress delayed the implementation of the Cadillac Tax until 2020. Had they not acted, many public employers in Maine, including the State and the University System, would be punished for providing generous, affordable benefits to our public sector employees and they still will be punished, until Congress acts to repeal this draconian measure that is certain to harm Maine people and Maine institutions.

I invite the Legislature and the newly established Commission to Reform Public Education Funding and Improve Student Performance in Maine to examine opportunities to reduce the cost of health insurance across all public sector institutions by leveraging scale if we pool our resources together. I am not content to nibble around the edges of our ballooning public costs. Now is the time for bold action.

For these reasons, I return LD 1517 unsigned and vetoed. I strongly urge the Legislature to sustain it.

Senator BAKER: Thank you very much, Mr. President. Ladies and gentlemen of the Senate, I rise today to recognize the Maine Marine Patrol for their dedication to keeping our coastline safe. We also had occasion to work on a bill that brought out a lot of comments from folks and we saw some of the darker side of our fishing industry too. We heard some things that these folks have to deal with daily, and I don't envy them that part of their job. I'll bet they love many parts, but having to work some of the darker character of some folks, that, fortunately, are a minority. must tax their skills and abilities. They are ready for an emergency. They're ready for the routine of their job. They're ready to face the ocean and whatever it throws at them every day. Then they work with some of the dark sides of character. I

don't know how you'd write a job description and then fill it with some people that are more dedicated and enjoy their job more than this group. I was a little ahead of myself. I wanted to come shake their hands. We're well represented in Knox County by these folks and I thank you all for your service to the people of Maine and I will still come over and shake your hands in a minute.

There's a friend of mine that owns a dock on Newbury Neck. That's out in the bay, western bay. Some folks, some families, were there vacationing, as it's a beautiful spot. I was standing there filling my tanks and the Moms were concerned about one of the boys who had slipped away in a kayak. If you're not careful, it looks more like a lake, certainly, if you're from away and don't know that the tides actually turn. Their boy, who was about 12 to 14 years old, had gone out over half way out into the bay. They were watching him and he was struggling. He was not able to fight the tide or the current to get back to shore. As the good Senator Miramant was just saying, I have their numbers in my phone as well. Called the Marine Patrol and they have a boat in the Ellsworth pier. They were able to launch somebody fairly quickly. It just goes to show you that they are there. They are out there on the frontlines. They are easily accessible and they risk life and limb to help people get off the water safely. I see them every day. Like I said, I live on the water, the Union River. It's elver season, so I've gotten to know many of their members by first name as they are down checking licenses during this time. If don't know much about elver season. it happens in the middle of the night. These folks are out working all night long during the fishing season here. They keep tremendous hours. Thank you, men and women of the Senate, for letting me add my remarks.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator BRAKEY: Thank you, Mr. President. I just want to speak very briefly. Since we're doing a roll call, I want to speak very briefly to the report and the reasons why I would encourage this Body to adopt the motion before us. What this report does is it would make naloxone, commonly known as Narcan, available over the counter. We've had debates in this Chamber. I know we've had debates over similar issues last year, around this, around Narcan. Narcan is a substance that when an individual is having an overdose on opiates Narcan can be administered and that individual can be spared from death. I know that some folks question the value of it, of Narcan, on the basis of their worry that this encourages risky behavior and I think we all agree in this Chamber, every single person here would agree, that we do not want individuals overdosing on these opiates in the first place. I hope that someone who is suffering with an addiction to opiates, and finds himself in this position, will have the opportunity to learn the lesson from the terrible mistake that they're making. At the end of the day, you can't really learn the lesson from such a terrible mistake if you're not alive to learn the lesson. This bill would simply increase access to Narcan. Often times by making Narcan available over the counter, often times it's the family members who are worried about their son or their daughter or who would benefit from being able to have access to this, to have it on hand. This was a bi-partisan report, Republicans and Democrats. As someone who is pro-life, I view this as very much a pro-life bill. We are simply creating the opportunity for individuals to save someone's life so they might have the opportunity to learn the lesson of their mistakes and change their life around. Thank you very much, Mr. President, and I hope the Body will join me in supporting this report.

**THE PRESIDENT**: The Chair recognizes the Senator from Washington, Senator Burns.

Senator **BURNS**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I'll be very, very brief. I think that passing this bill in this form is a very bad message to be sending to the community that is now struggling with substance abuse. As far as I'm concerned to do this, to make this available over the counter to folks other than first responders and emergency services, is really telling people you have a license to experiment. I think this is a bad move for the state of Maine. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator CYRWAY: Thank you, Mr. President. Ladies and gentlemen of the Senate, I'd like to just comment that this is enabling people to use drugs more often. We've had situations where actually there has been in other states use of this sometimes ten times to bring themselves back because they get dependent on it. They say, "Well, I have something that can bring me back." I've talked to, I've worked with, individuals when I was working in the jail. I was a Program Coordinator and I worked

with substance abuse counselors and I also worked as an Assistant Jail Administrator. Actually we had a scared straight program where we would actually bring inmates from the prison to high schools and talk and speak on these situations. Drugs are a very highly addictive substance which can actually get to the point where they don't look for a high any more, they just look for a rush. When it gets to that point, when you start buying this over the counter, they're going to be depending on that. They are going to say, "Hey, you got your Narcan on you, because I've got to use this." They're going to use it and then they're going to depend on that person to be the responsible person and put that in the hands of that young individual and say, "You're going to be responsible for my life." I don't think that's right, to just have over the counter and you're going to be responsible for somebody's life. We're talking really a large responsibility that you're putting on these people. How many of you, if you think about, have actually gave a shot to somebody? I would say 90% of you have not done that. I know Dr. Gratwick has. It's not an easy thing to just give somebody a shot. I remember my first time, I had to give it to a cow. It wasn't fun. I said, "Geez, am I going to hurt this cow?" Then when you give that shot this Narcan puts them in a serious hurt because it really is trying to revive them. You're going to watch them go through a really major change. It's scary. This is for first responders. This is not for just your everyday person to go and do that. I can't even imagine taking a family member, or parent, that's hooked on drugs and expecting their child to go get the Narcan and put it to them. Be careful when you go and vote for this because I think that this is a really big decision. I'd also like to just say this is basically not Sudafed. This is something very important. Thank you, Mr. President, for allowing me to speak.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Breen.

Senator BREEN: Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise because I was lead Senate sponsor of this bill and I couldn't be prouder. I think one of the fundamental questions when we talk about addiction is: is it an illness? It is in all the medical literature. It is in my experience. It certainly is in our treatment regimes. Addiction is an illness. This is one treatment that will allow the folks in our communities and our towns, whether they're young people or elderly people or homemakers, whoever they may be, suffering with the illness of addiction to live another day and seek treatment. There was a time when it was only first responders who could use a device like an AED to revive folks who suffer with heart disease. Now we look around all over our communities and we have AEDs. We have folks in the community who know how to perform CPR. We don't tell folks with heart disease, "Oh, we're not going to use this device because, guess what, after we use it you're still going to have heart disease. Sorry." We don't have the same approach to people who have asthma and are having an asthma attack. If I have my daughter's inhaler in the drawer I get it out and I help. You know what, the next day she's still going to have asthma. I don't say, "Sorry, you've had enough asthma treatments." Ladies and gentlemen of the Senate, Mr. President, this bill is very simply about saving lives of people who suffer from the illness of addiction so that they can live another day and get to treatment, so that they can live another day and find rehab, so that their families do not have to feel helpless, and that their families have

hope that that person will live and have another chance to get well. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator HASKELL: Thank you very much, Mr. President. Men and women of the Senate, I'd like to read a little bit of testimony to you that was provided to our committee when we heard about this bill. This is the testimony that came, there's a lot of testimony in here. I could be up here quite a while if I talked about the places where this has saved a life. You can't treat someone who's not alive. This is testimony that came from the Maine Chiefs of Police Association. This is a statement of Chief Douglas Bracy, who was the Legislative Committee Chair on behalf of the Maine Chiefs of Police Association. I think it's important to hear what it is they have to say. They speak in here about how law enforcement is the first to respond and they talk some about overdoses and its expansion. Their statement is, and I quote directly, "The Maine Chiefs fully support L.D. 1547." The responses to our opiate crisis that has occurred from our law enforcement officers has been stunning to me in the last year, year and a half. It's been amazing to me that these people on the ground are recognizing that value of treatment and they also recognize the value of Narcan. The York Police Department reported four saves since the inception of its program in 2015. They go on to say, and I will quote, "Although some would argue that we are enabling addicts to continue their ways, we would strongly disagree." Most people don't choose to become addicts. Circumstances such as over prescription fueled this crisis over the last several decades. This is again a direct quote from the Chiefs of Police, "We applaud the sponsor of this bill and our Attorney General for recognizing the importance of Naloxone and for their efforts to make it available." Once again, the Chiefs of Police fully support L.D. 1547. I encourage you to do the same.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK**: Thank you very much, Mr. President. Ladies and gentlemen of the Senate, just very briefly. I did my medical training in Harlem Hospital. A number of years in the early 1970's, when Narcan was just a brand new drug. It was quite dramatic. Last year a whole lot of people died in the emergency room of drug overdoses. This year many of them survived. Narcan works. I have to tell you that I'm a very profound believer in the sanctity of life. I think life is very important. I know, personally, probably six people who would not be here if it were not for Narcan. Those are people who made a major contribution to our society. I'm not aware of major side effects for the medicine itself. I'm very much in favor of this bill. Thank you, Mr. President.

**THE PRESIDENT**: The pending question before the Senate is the motion by the Senator from Androscoggin, Senator Brakey to Accept the Majority Ought to Pass as Amended Report, in concurrence. A Roll Call has been ordered. Is the Senate ready for the question?

Senator **PATRICK**: Thank you, Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, I rise in opposition to this motion for several reasons. In the newspapers many times over the last several years we've heard of issues where we have puppy mills, we have people have multiple amounts of animals that have been abused; and we, as a collective society, just are appalled at what happens. This bill doesn't do that. What this bill does is allow a group of people to sue the State. I have been on the Committee for 14 years now and suits against the State I do not take lightly and have very rarely ever voted for them. I think this may be the second one that I've voted for in 14 years.

How does this differ from the abused animals that we're are outraged at? Well, Maine requires that all daycare facilities in the State apply for and maintain a license through the Department of Health and Human Services. The Department of Health and Human Services is controlled by the rules for the licensing of childcare facilities which sets guidelines not only for the licensing of childcare facilities but also the qualifications of applicants and employees and the rights of the children within those facilities. What is this bill about? This bill is about numerous families who entrusted their greatest asset, which is our children, to the care of a daycare provider. Ladies and gentlemen, the Department of Health and Human Services, within the department that oversees

this, had 26 to 29 openings during the time that these atrocities to the children, our greatest asset, went on. I really think that there was bungling from the start to the finish. I do realize that they made some corrective actions, which are okay; but when you have kids that are abused day after day, week after week, month after month, for years, shame on us for letting that go. Shame on those that had the responsibility in DHHS to make sure that those kids were taken care of, make sure the complaints that the parents were making were heard, and that there would be corrective action taken for these children who were abused. There were many sorts of abuse that were rained on these kids, and I think that maybe some of the other people will be up to talk about them, but it's appalling to me how we can let any State agency or anyone abuse our kids and get away with it. Was there abuse? Absolutely. Does DHHS know there was abuse? Yes. Did they actually do their due diligence and make sure there were corrections to this daycare center? Well, it's now closed down; but that doesn't take the pain and suffering that these kids had to put up with for years.

The thing of it is, what we decided to do, in agreement with the parents -- there's probably five or six groups of parents and kids that were abused that brought a suit forward -- because of the liability to the State of \$400,000, we actually are only going to allow one group, the group as a whole, to have the opportunity to sue. It doesn't say they're going to win, but they want the opportunity to sue because of the shortcomings of what DHHS did, the abuse that their kids had at the hands of the daycare provider; and I can't see what harm it would do for all of us, unanimously, voting for this, to make sure that they have their day in court, Mr. President. Thank you.

"The Senator from Piscataquis, Senator Davis, questioned whether the Committee's Amendment "A" (S-425) to L.D. 1647 was Germane. The Chair has made the ruling and it is as follows: Committee Amendment "A" (S-425) to L.D. 1647 is germane. L.D. 1647 seeks to amend a section in 29-A MRSA dealing with the suspension of one's driver's license as it relates to operating under the influence and length of suspension from 150 days to 180 days. The Committee Amendment "A" (S-425) makes the same change to other provisions of the operating under the influence laws. This amendment simply seeks to make the statutes consistent with the proposed 150-to 180-day suspension.

Senator DIAMOND: Thank you, Mr. President. Ladies and gentlemen of the Senate, just a guick summary. We were most of the way through this debate yesterday and it centered on the fact: should we be suspending driver's licenses for non-driving offenses? I think we've been, as a Legislature and as a Senate, very tough on drugs. We've been tough on drug users. We've been tough on OUI. We've been tough on all those things. This is a case where it's separate from the toughness. This is a case of where we're saying we're going to suspend licenses for something that had nothing to do with driving. Over the years, over the past 30 years, we've been very good about this, as a collective Body, with Governors, and the Secretary of States, we chose not to do that. I'm asking you, urging you, to resist that. We've done well. We've been really tough on these people that violate our laws on drug use and driving and OUI and that sort of thing. This is a separate issue. This issue is talking about applying something to suspend a driver's license that has no relationship to that driving. I know the temptation is there. It has been over the years. I'm going to ask you to resist that because this is not the proper way to deal with our driver's licenses. Thank you, Mr. President.
