**JOINT RESOLUTION RECOGNIZING JANUARY 27TH AS
EITC AWARENESS DAY**

WHEREAS, in order to promote the federal and Maine state earned income tax credit, which enhances family household budgets, we recognize January 27, 2017 as EITC Awareness Day; and

WHEREAS, 4 of 5 people eligible for the credit claim it, which demonstrates the importance of raising awareness of this credit and urging individuals to find out if they qualify for it; and

WHEREAS, throughout the State, IRS-certified volunteer tax preparers who are members of CA\$H Maine and AARP Tax-Aide, a collaboration of 10 statewide coalitions including 50 nonprofit and for-profit partners, provide free federal and state tax preparation; and

WHEREAS, since 2003, CA\$H Maine has also educated hard-working families and individuals about programs in the community that can increase their income, reduce debt and build savings; and

WHEREAS, in 2016, these volunteers helped Maine residents save more than \$3,500,000 in tax filing fees and claim over \$5,200,000 in earned income tax credits, returning over \$21,200,000 to Maine residents in federal income tax refunds; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-eighth Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize January 27, 2017 as EITC Awareness Day; and be it further

Dear Speaker Gideon:

Enclosed are the reports required under 5 M.R.S.A. §12023, due February 1, 2017. The reports include: a list of all procurements in 2016 exceeding \$10,000 for which competitive procurement was waived; a list of contributions made in 2016 that exceed \$1,000; the revised policy on contributions that was updated in December 2016, and a resolution adopted by the Board on March 24, 2011 that discontinued making donations, restricted memberships and adopted a budget for contributions to approved organizations. In 2016, the Maine Turnpike Authority made \$86 million in payments to approximately 680 vendors. The vast majority of these payments, approximately \$77.5 million, were for competitively bid products or services or were legally or legislatively required. The Authority sole-sourced approximately \$8 million in 2016. Most of these products or services were either proprietary in nature or were procured under long-term contracts. As these long-term contracts expire, the Authority will seek competitive bids.

Representative **MADIGAN**: Madam Speaker thank you, and members of the House. On January 8th, the River Valley Community of western Maine learned of the death of Mexico Fire Chief, Gary Wentzell. Gary Wentzell served the citizens of Mexico for 35 years as a member of the Mexico Fire Department and served the past 25 years as the Mexico Fire Chief. Over the last twelve years I got to personally know Gary having worked with him in my position as the Mexico Town Manager. Always positive, always upbeat. I never met a person who was more respected by his peers across the entire State of Maine or who was more dedicated to the people he served. He was the best. Upon his passing in a Boston hospital after a battle with cancer, several members of his department went to Boston to bring him home. The convoy of Mexico firefighters and police officers was escorted through Massachusetts by the Massachusetts State Police until they crossed the New Hampshire border where the New Hampshire State Police took over the escort. At the Maine border the escort was turned over to the Maine State Police for the rest of trip on the interstate highway. The York and Ogunquit Fire Departments greeted Chief Wentzell convoy as it entered the state with two ladder trucks, back-to-back, ladders fully extended on an interstate overpass, the American Flag flying from the ladders of each truck. Four uniformed firefighters stood at attention on the bridge and saluted as the convoy went by. Convoy proceeded to Auburn where, once again, they were greeted by ladder trucks from Auburn and Mechanic Falls, back to back, ladders fully extended, American Flag flying on an overpass over Route 4. Fifteen uniformed firefighters stood at attention on the bridge and saluted as the convoy went by. From Auburn, the convoy was met by firefighters from all over western Maine. Fire trucks from Mexico, Rumford, Dixfield, Canton, Peru, Roxbury, Andover, Greenwood and Turner entered the procession to bring Chief Wentzell the rest of the way home. Local police, State Police, the Oxford County Sheriff's Department and Med-Care Ambulances joined in, lights and sirens on. The escort reached Route 2 in Mexico and continued until it passed the Mexico Fire Station on Main Street where Mexico residents stood to pay their respects as the convoy went by. Chief Wentzell was home. Funeral services were held a few days later at the Mountain Valley High School. Several hundred residents from the River Valley attended the service along with over 150 emergency responders from towns all over Maine.

Little more needs to be said about what kind of man Gary Wentzell was. This level of respect says all we need to know about him. I am blessed to have known him and to have worked with him for so long. We are all blessed to live in a state where a man like Chief Wentzell is so highly respected by everyone who knew him. He will always be remembered as a person dedicated to his profession, who loved his job and served his community to the best of his ability. Chief, you were truly loved and will be missed by everyone. Thank you for your service. We are all better off because of you.

The **SPEAKER**: The Chair recognizes the Representative from Dixfield, Representative Pickett.

Representative **PICKETT**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, this is one of those times when a heavy heart is shared collectively by Democrats, Republicans, and Unenrolled. I would like this morning to reference the sentiment that was prepared for my friend of 40 years who recently passed away. Gary Wentzell of Mexico, Maine was not only a fire chief, he was a dedicated and a courageous firefighter. He was a standout family man and human being. When Gary lost his hard fought battle with cancer this month, the turnout for his memorial was amazing. Firemen, both past and present, stood to praise this gentle and hands-on guy. As the memorial went on, it became obvious that this loving family man had more than one family. Story after story eulogized Gary and told how he befriended each one of them and acted sometimes as a surrogate dad when necessary for all of the younger firemen who served alongside of him. No one deserves the sentiment more than Chief Gary Wentzell and I am proud to offer this one in his honor. What makes Gary's sentiment presentation doubly meaningful for me is that one of my cosponsors, Senator Lisa Keim, from my home town, just lost her son, her young son, in a very tragic accident. The details were carried in all the papers and news broadcasts across our state this past weekend. Most of us here in the Legislature have children and I am certain we all share in Senator Keim's and her husband Blue and family's heartbreak. I would at this time like to ask Madam Speaker, if we could have a moment of silence? Thank you.

At this point, the Members of the House stood and joined in a moment of silence in honor of the son of the Senator from Oxford, Senator Keim, Loren Keim of Dixfield, who passed away on Saturday.

The **SPEAKER**: The Chair recognizes the Representative from Farmington, Representative Harvell.

Representative **HARVELL**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. It's been a rough weekend for me. Nature can prepare you to bury your parents, can't really prepare you to bury your children. I first learned of Loren Keim's existence on hiking Mount Katahdin with Blue and Lisa and the families. And Blue and his brother Fox and I, and Loren had spent hundreds of hours hunting and fishing together. I've been a close friend of the family for 30 years. Just last fall Blue and I, while putting up some tree stands, were sharing a beer and sharing like proud fathers our sons' accomplishments. Loren was in his senior year at Orono and Joshua, my son, was graduating from chemical engineering and like proud fathers, we were a bit bragging and one upping each other, slightly. Couple weeks later after the elections, Loren came by the house to go sit in one of the many tree stands that we'd put up and he was very excited about his

mother's election and his introduction into politics. We shared that and his thought for the future. And spending the last few days with the family has been very hard. But 2,000 years ago, Jesus prepared his disciples for his departure and he said to them, let not your hearts be troubled, ye believe in God believe also in me, for in my Father's house, are many mansions, if it were not true I would not have told you so and I go there to prepare a place for you that where I am you may be also. And that brought me comfort over the weekend, and I pray that that has given the Keims comfort as it has thousands of people for thousands of years.

Representative **JORGENSEN**: Thank you, Madam Speaker. Madam Speaker, Members of the House, I was -- I saw this in the calendar today and felt that I did not want it to pass without comment. I was very glad to see this well-deserved memorial item relating to the Ornithologist, Charles Huntington. Professor Huntington was a remarkable man in every way. I met him on my very first day of freshman year in college in the early 1980s. I remember my ornithology classes, especially the 4 a.m. field trips, like they all happened only a couple of years ago. I see Chuck now in so many of the birds that I observe, the many species and their behaviors that he introduced me to back then. And like everybody, he enjoyed a showy bird, but he was a stalwart advocate for all the little brown birds, the sparrows, the flycatchers, the creepers that are sometimes hard to spot and often even harder to identify among the leaves. To read that he did his doctoral thesis on Grackles seems very fitting. That's exactly the sort of under-sung species he always stood up for. I sometimes wonder would I have become a birder without Chuck? I don't know. But I do know that both in the field and in the classroom, I and countless others of his students, between 1953 and 1986, learned a great deal from him, from his quiet, patient approach as a lecturer and as a field person. I'm grateful to have known him, I'm grateful that he's given me this opportunity to speak about birds on the House floor. And I think Maine is a better

place because of him and I'm honored to recall him here today. Thank you very much, Madam Speaker.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Freeport, Speaker Gideon, who wishes to address the House on the record.

Speaker **GIDEON**: Thank you, Madam Speaker Pro Tem, Ladies, Women and Men of the House. So it is unusual for me to leave the rostrum and come address everyone from the floor, and I thank you for giving me the opportunity to do that today. It's a hard decision for me to come down here and speak, but I felt that it was very important. Yesterday morning in my community and in other communities across the state, but, you know, on my street, in my neighborhood there were flyers distributed. Probably everyone in the chamber knows about this. There have been news stories about it. And these flyers were distributed by the KKK and indicated that they were awake and ready to defend neighborhoods. And, probably for those of you who live in communities where similar messages were delivered at people's doorways or the end of their driveways, maybe if you live in those communities or maybe even if you don't, you have heard from your constituents and you yourself have felt the many emotions that come with the delivery of such a message. Today, as I was contemplating whether to come down and stand and rise and speak, one part of me thought we don't need to give any credence to such a message. The other part of me thought, we cannot be silent when such a message is delivered and our responsibility to stand up as human beings or as State Representatives, or as Mainers, and to reject the idea of the KKK or the message they deliver or racism in any way is our fundamental responsibility. So I stand here today to do that, recognizing our history in this country, recognizing what our fore mothers and fore fathers did to reject racism in this country, recognizing that we all have a duty to protect that history and to protect each other because a threat to any of us is, in fact, a threat to all of us. Tonight in Freeport, our community has chosen to come together. Not so much to talk about the message that was delivered, but to reaffirm our values as a community and as people and to

reaffirm our respect for each other and our desire to protect each other. You are all welcome to join us at the Freeport Community Center at 7 p.m. or to think about doing this in your own communities if this has landed in your lap as well. Thank you very much for giving me the opportunity to address you all today.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Monmouth, Representative Ackley, who wishes to address the House on the record.

Representative **ACKLEY**: Thank you, Madam Speaker, Madam Chair, my friends and colleagues here in the House, on the record I am rising for the first time in this chamber to wonder aloud about the times we find ourselves in today. I wonder, with the exception of this past weekend, when the Ku Klux Klan was last seen in Maine. If I'm not mistaken, history books tell us it was perhaps 50 years ago, certainly not in my lifetime, perhaps not in my mother's lifetime. If you're a Mainer, or a Native American, of Native American or Franco American decent, or perhaps you are of the Catholic faith, probably already knew that answer. Perhaps you are politely remaining silent right now.

The SPEAKER PRO TEM: The House will be in order. The member may proceed.

Representative **ACKLEY**: It saddens me to hear that these flyers were distributed throughout the state. This is not the Maine that I know. That brings me to my second observation. Why it is that Klansmen wear hoods? It's because they are afraid. It's because they know they are bullying, they are intimidating, they are threatening, and they are counting on the hoods of anonymity so that they cannot be held accountable and those they attempt to intimidate might also remain silent. Every battered spouse, every small child in school, every first-generation immigrant to our fair nation is likely to be familiar with this. Pastor Martin Niemöller wrote a relevant poem on their tactics. He said, "First they come for the socialists, and I did not speak out because I was not a socialist. Then they came for the trade unionists, and I did not speak out because I was not a trade unionists. Then they came for the Jews, I did not speak out because I was not a Jew. Then they came for me and there was no one left to speak for me." So, Madam Speaker, I am not the object of attention today but I cannot and I will not remain silent because if and when they come for me, I'm counting on you and all Mainers to be there to raise your voice on my behalf. The Founding Fathers of our country based their principles on the philosophies of the enlightenment. Edmund Burke was one and he said, "the only thing necessary for the triumph of evil is for good men, good people, to do nothing." Some believe silence implies consent. And I believe intimidation generates fear, fear tends to give rise to silence, and the problem is that some of us will question why the rest of us remain silent. Well, my father who is a veteran and a defender of our freedoms, he raised fearless boys. Today, I invite anyone within ear shot to join me in speaking out however they choose, to raise your voice for brotherhood and justice for all and break the spells of fears and silence. Thank you, Madam Speaker.
