PROCEDURAL ORDER

On Tuesday, February 7, 2017, the Maine State Senate referred three Questions to the Justices of the Supreme Judicial Court pursuant to Article VI, Section 3 of the Maine Constitution, related to An Act to Establish Ranked-Choice Voting, which was approved by Maine voters on November 8, 2016, pursuant to Article IV, Part Third, Section 18 of the Maine Constitution.

The Justices hereby invite a representative for each of the Maine Senate, the House of Representatives, Governor LePage, the Secretary of State, and the Attorney General, and any other interested person or entity to submit briefs addressing

1. whether the Questions propounded present a "solemn occasion," pursuant to article VI, section 3 of the Maine Constitution; and

2. the law regarding the Questions propounded.

Any person or entity submitting a brief to the Court must do so by filing the brief, as described below, with the Executive Clerk of the Supreme Judicial Court, at 205 Newbury Street, Room 139, Portland, Maine 04101, at or before 4:00 p.m. on Friday March 3, 2017.

Responsive briefs are not required, but any person or entity that filed an initial brief may file a responsive brief at or before noon on Friday, March 17, 2017.

Briefs and responsive briefs must conform to the requirements of M.R. App. P. 9(f), and comply with the following:

a. the front cover must be white and must contain the following information:

- the designation that the matter is "Before the Justices of the Supreme Judicial Court";
- the docket number of the matter, OJ-17-1;
- the title of the matter, "In the Matter of Request for Opinion of the Justices";
- the title of the document as either a "Brief of" or "Responsive Brief of" followed by the name of the person or entity filing the brief or responsive brief; and
- the name, address, and Maine bar number of counsel representing the filer or, if the filer is not represented by counsel, the name and address of the filer.

b. Briefs must be in 14-point font or larger, double spaced – except for quotes.

c. Briefs may not be longer than 25 pages. Responsive briefs may not exceed 10 pages.

d. Briefs are not required to be bound.

e. Any person or entity filing a brief shall provide two copies to the Clerk's Office, and an electronic copy of any brief (which need not be signed) shall be simultaneously emailed in the form of a single text-based pdf file to lawcourt.clerk@courts.maine.gov.

Oral Argument will be held on Thursday, April 13, 2017, at 8:30 a.m., in Courtroom 12, in the Cumberland County Courthouse.

Representative **DENNO**: Madam Speaker, Ladies and Gentlemen of the House, I wish to speak to the Sentiment today in honor of Brandon James Thibeau of Cumberland. Brandon, the son of Rick and Jane Thibeau of Cumberland, died at the age of 22 from neuroendocrine cancer. Brandon was a fireman for Cumberland and North Yarmouth and was selected Cumberland's Firefighter of the Year in 2016 by unanimous vote. In his final days, he completed a fire science program at SMCC. The week before his death, he showed up at the fire house for a training session wearing his oxygen tank. He never felt sorry for himself and he never gave up. He was a young man of rare qualities. He always wanted to help his family. As a kid, he insisted on mowing the family's lawn because he thought it was too much work for his dad. Two days later, he would be out there mowing again. On a family trip to a camp near Rangeley, Brandon proposed to his girlfriend, Lindsay Nunley, on the top of Bald Mountain, but only after having asked her father for his blessing. Lindsay of course said yes. Brandon was one in million. Robert Field, who served with Brandon in the Scouts, said of him that Brandon represents everything admirable about being an American. Steve Wills, SMCC Fire Science Department Chairman, called him the most courageous student I've ever had. His death has been a loss not only to his family, his fiancé and his fellow firefighters, but to the entire Cumberland North Yarmouth community. We will not see another Brandon Thibeau soon. Thank you, Madam Speaker.
