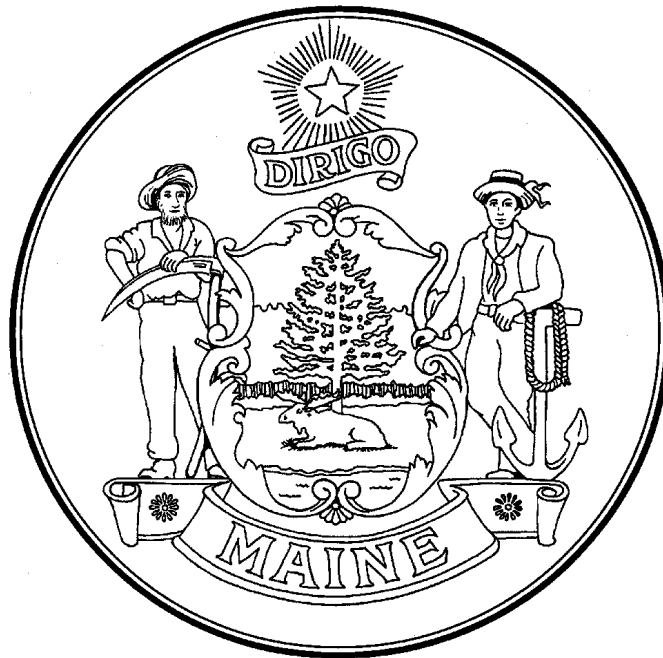

Dear Honorable Members of the 128th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 213 "An Act To Provide Funds for Access for Veterans Seeking Health Care."

For many years Maine has not been compliant with the federal REAL ID Act. Because of this, Mainers, including many veterans, are being denied access to federal healthcare facilities because Maine state identification does not meet federal REAL ID standards.

However, veterans are not the only Mainers who are being denied entrance to federal installations. Business owners are reporting that their truck drivers cannot deliver goods to military installations. There are also reports of first responders unable to attend training at secure federal buildings. Of course, if Maine does not become REAL ID compliant, then Mainers will not be able to use their state identification to board domestic commercial flights.

Unfortunately, this bill only fixes a small portion of the problems presented if Maine does not become REAL ID compliant. The bill proposes a program that will be very difficult for the Department of Defense, Veterans and Emergency Management to administer using existing resources. Though I agree with the sentiment to help veterans seeking medical care, we cannot forget all the other groups that have experienced problems due to REAL ID.

I respectfully urge the Legislature to not provide case-by-case carve-outs for groups being affected by REAL ID. Rather, my advice to the Legislature is to speedily pass LD 306, "An Act To Require State Compliance with Federal REAL ID Guidelines", which would help all Mainers adversely affected by REAL ID.

While there appear to be reasonable arguments on both sides of the REAL ID debate, due to the federal insistence on enforcing its harsh terms and a complete lack of interest—or perhaps will—in Congress to amend or repeal the REAL ID Act, I believe we, as elected state officials, must unite in going forward with implementation.

Because this bill proposes only a limited fix to a much larger, much more complex issue, I cannot support it. For this reason, I return LD 213 unsigned and vetoed. I strongly urge the Legislature to sustain it.

(H.P. 169) (L.D. 213)

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Golden.

Representative **GOLDEN**: Thank you, Madam Speaker. Madam Speaker, back in December I learned about a problem that Maine Veterans in New Hampshire -- that Maine Veterans living on the New Hampshire border were facing because of an issue with Real ID. I asked them questions, had it confirmed by several offices, and then requested an after deadline bill for the purpose of purchasing passports for these veterans. I did this because it was confirmed that the Department of Veterans Affairs had sent mail to these veterans informing them that they would not be able to get onto the base, where their VA Clinic is located, with a Maine license. The letter also said that a VA ID card would not work either. It did say, however, that a passport or passport card would be a sufficient form of identification. Before the public hearing, however, the base

commander put out a statement saying that veterans could access the base with a VA ID card after having submitted themselves to, and passed, a background check. So, I went to the hearing and suggested to the committee that they should table the bill, because it seemed that these two federal agencies were sending out conflicting information. Members of the committee later heard that the VA was not doing a good job at issuing these VA IDs, and that many veterans did not have them despite the VA having said, three years ago, that they were going to issue them to all enrolled veterans by mail. Then, on March 2nd, the Chief Executive sent a letter to legislative leaders calling upon the Legislature to act, because veterans on the New Hampshire border were being denied access to health care. And on March 3rd, a letter arrived from U.S. Congressman Bruce Poliquin stating the same. At this point, the chairs of the committee decided it was time to take action. They amended the bill to provide \$15,000 for passport cards, because they are significantly cheaper than a full passport, and they also added a provision that directed that any unspent funds be used for financial assistance to veterans experiencing a financial crisis. The bill, as amended, received unanimous committee support. It seems that the committee passed an amended bill that is a win-win prospect for veterans. Either it's going to help purchase IDs for those veterans that need them, or it's going to help veterans experiencing a financial crisis, like the veteran the Chief Executive highlighted in his State of the State Address this year. The bipartisan support continued for this bill out of committee, as it was enacted by this House by a vote of 110-8, and in the other body, unanimously. The Chief Executive has made a decision to veto this bill. He wants us to pass a bill to comply with Real ID. That debate is coming. The Chief Executive believes that will solve this problem for these veterans. I believe we should ask ourselves if that is in fact true. New Hampshire Veterans...

The SPEAKER: The member will defer. The Chair inquires why the member rises?

Representative **FREDETTE**: I think by asking whether or not it's true or not, he's impugning the motives and the character of the Chief Executive. He can say he disagrees with him, but to say that, essentially, he's lying, I think is impugning the character of the Chief Executive.

On **POINT OF ORDER**, Representative **FREDETTE** of Newport objected to the comments of Representative **GOLDEN** of Lewiston because he was questioning the motives of the Chief Executive.

The SPEAKER: The Chair would remind all members not to question the motives of another member or the Chief Executive.

The Chair reminded all members that it was inappropriate to question the motives of other members of the House or the Chief Executive.

The SPEAKER: The member may proceed.

Representative **GOLDEN**: Thank you Madam Speaker, certainly not my intention to challenge the motives of the Chief Executive in this regard in any way. Just challenging the information that I have and the information that he may have, and I believe that it is different than he does. I believe that because New Hampshire Veterans using the same facility have been told that starting this fall, they will not be able to enter the facility unless they have physical possession of a Real ID license issued by the State of New Hampshire. A waiver for our state from the Department of Homeland Security does not dictate a decision made by the Air Force or the Department of Defense, and if we pass LD 306 into law it's still

going to take many months, maybe more than a year, before we're able to produce and issue Real ID compliant Maine licenses. Madam Speaker, this seems like a very straightforward vote to me. If we override this veto, it is 100 percent assured that this new law will help veterans that are in need of our help. I know that my colleagues behind me want to do that. I suspect that we all want to do that. And I strongly encourage my colleagues in the House to override this veto. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Belfast, Representative Herbig.

Representative **HERBIG**: Thank you, Madam Speaker. I request a roll call.

The SPEAKER: A roll call -- pursuant to the Constitution a roll call is in order. The Chair recognizes the Representative from Ellsworth, Representative Luchini.

Representative **LUCHINI**: Thank you, thank you, Madam Speaker. Madam Speaker, Men and Women of the House, I also want to chime in and urge your support for overriding the veto before us today. And I'll just add a few points to what the Representative from Lewiston said. As we worked this bill in Veterans and Legal Affairs Committee, we identified a problem that our veterans are simply unable to access health care on a military installation in New Hampshire. And as was referenced, we received several letters to that extent. So, as a committee we decided that since noncompliance with Real ID was a legislative decision, probably before most of us were here, that it's also our responsibility as a Legislature to fix it. Because allowing veterans access to health care is a truly, truly important matter for Mainers. I think we've heard that taking a vote on Real ID may solve this problem, but in fact, the reality is quite different. It's important to note that even if we were to take the Real ID vote today, implementation takes time, and the New Hampshire military installation where this clinic is located has said you need a real, physical, Real ID compliant card. So, we shouldn't wait and say, wait until the Real IDs come out. It could be a year before these people could access health care. I'm also a bit disappointed to read in the veto letter that the department has said that they have difficulty in administering financial assistance for veterans. And I'll just point out that current law, since 1983, actually, has put a statutory responsibility to the Bureau of Veterans Affairs that they need to be able to administer emergency financial assistance to veterans. That's been the law since 1983 and just earlier this year, in the Supplemental Budget, we appropriated \$375,000 to the bureau for just that purpose. And in the Biennial Budget, which is before us now, which VLA is working on, they've requested another additional \$750,000 to be spent in the same way that this money that would be appropriated in this bill would be spent, in the exact same account, under 37-B, 505. And so, this bill has a fiscal note of \$15,000. Any unspent money will be rolled into the account that's been requesting a lot of additional money. This is a small amount of money, but it can make a world of difference to some of those veterans who are trying to gain access to health care. So, for those reasons, I urge your support of overriding the veto of LD 213.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, we had the opportunity to listen to General Farnham this morning, and Adria Horn, Director, Bureau of Vet Services, and understanding the issues that have been discussed today, their conversations have indicated problems with implementation

and, actually, use of this particular bill, and I believe that the Chief Executive's veto message lays out, obviously, what I think is in fact the real issue here is, which is making Maine compliant with Real ID because it is going to be the law of the land. And so, I think at the end of the day, what we need to do is really focus on what the real issue is, which is Real ID, which will solve lots of issues for lots of different people, and someone who spent this past weekend in uniform in the guard, someone who's flying to Chicago on Thursday for four more days to do military service, my vote in sustaining the Governor's veto on this certainly is not an anti-veteran vote but a larger view and perspective of looking at what are the real issues and how can we help the most people, and that is by supporting Real ID and I will be voting to sustain the Governor's veto and ask that you follow my light. Thank you, Madam Chair.

The SPEAKER: The Chair recognizes the Representative from Kittery, Representative Rykerson.

Representative **RYKERSON**: Thank you, Madam Speaker, Men and Women of the House. The real issue is that I have neighbors who can't see their doctors. That's the real issue. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Newcastle, Representative Devin.

Representative **DEVIN**: Thank you very much, Madam Speaker. Madam Speaker, Men and Women of the House, Real ID is a real issue. The State of Maine, on both sides of the aisle, we have a lot of concerns. There is confidential information that may, if not handled properly, escape the clutches of the Federal Government. We're concerned about that. That's why we've been fighting this. The other reality, as my good friend and the Representative from Kittery said, this is a health care issue. There are men and women who are veterans, who have served this country proudly, who presently cannot have access to the health care that they so rightfully deserve. There's no other excuses, and we need to move forward. Thank you.

The SPEAKER: The Chair recognizes the Representative from Norway, Representative Winsor.

Representative **WINSOR**: Thank you, Madam Speaker, Men and Women of the House. I'm a little confused and I can't talk about other people's experiences, I can only talk about my own. For the past 20 plus years, I've been a member of the Veterans Health Care System and I've had very good luck with it, apparently, compared to some others. About a year ago, I went in for my annual physical and I noticed a sign on the wall, I was at Togus, and it said, renew your ID, get a modern one. So, I wandered in and went through the process where they took my picture and all that, and about six weeks later I got my VHIC card, that's a Veterans Health Identification Card, in the mail, the modern one, which is Real ID compliant, apparently. So, last Friday when I heard that this bill had been vetoed, I went over to Togus to see whether this was still true. And, I can honestly tell you that I walked in and there at the reception desk was a sign that said ID, that way. Went over to where the sign said to go, talked to the ladies that were working there, and they told me with all assurance that yes, anybody who is a member of the system, who's signed up for veterans' benefits, health benefits, was eligible to get an ID card from them at no cost to anybody, other than the VA. So, I didn't see that as a particularly big barrier. Now, I understand that the folks who are taking benefits from New Hampshire have to deal with the New Hampshire VA. But, my understanding is that every VA facility or clinic in Maine, any veteran who is part of the system can go there and get a modern ID which complies with the

requirements to go through the federal facility. That's my experience and I share it with you for whatever you chose to take it. Thank you.

The SPEAKER: The Chair recognizes the Representative from York, Representative Hymanson.

Representative **HYMANSON**: Thank you, Madam Speaker. Colleagues, I think we should be able to walk and chew gum at the same time. That means we should be able to pass this and consider Real ID in the legislative session. So, I hope that you override this veto with me.

The SPEAKER: The Chair recognizes the Representative from Warren, Representative Sutton.

Representative **SUTTON**: Thank you, Madam Speaker. I'm not a veteran, I don't have a veterans ID, but this morning in caucus we heard from Brigadier General Farnham and he told us that a passport card will not get you onto the base in Pease Airforce. So, I just wanted to pass that information around to those who do not have benefit of this information. Thank you.

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Golden.

Representative **GOLDEN**: Thank you, Madam Speaker. I just wanted to rise and acknowledge my good friend from Norway, Representative Winsor, who talked about the fact that he has received a VHIC card, and I'm glad for that. And, you know, I think the Department of Veterans Affairs is a very good organization that provides important services and care to our veterans. But, I think that the, you know, instances of, you know, the bureaucracy being too slow sometimes, long wait lists to get things done is well documented. And I can just say that, you know, having read on their website issued in April 2014, the VA said that they're going to get these IDs to all veterans in the entire nation. That was three years ago, I certainly haven't received one yet. I've been to VA appointments in the recent past as well and I just feel like, particularly because the VA itself initiated this whole issue where they sent out a letter to 500 veterans and in that letter, it explicitly stated to these veterans, who are the veterans we're talking about, that a VA ID card would not be sufficient for the purposes of going to their appointment. If you are one of these 500 veterans, who do you believe? The VA has told them that these IDs would not work. The base commander has said that they will. And, you know, in regard to the Brigadier General's, you know, I wasn't in the caucus, I don't know exactly what he may have said or not, but what I do know is that it says right here in a letter dated 24 January 2017 from the Base Commander of Pease Air National Guard Base that a Maine Veteran, if the veteran has a U.S. Passport, a Veterans ID card is not required and that they will be able to access the base. So, you know, it just seems like there's a lot of misinformation flying around about this. But, I do just want to come back to a simple fact, in my opinion, Madam Speaker, which is that this is a bill that has gone through a process, it has enjoyed bipartisan support throughout that process. And again, if you're inclined to sustain this veto because you're worried that maybe it's not necessary in regards to the IDs, or if you think that the VA should take care of this issue, or that the Federal Government should figure it out, I would just ask you to consider again, that the committee put a provision into this bill that says, any unspent funds that don't go towards buying these IDs will go towards an account at the Maine Bureau of Veterans Services to help veterans who are experiencing financial hardship. That's the same account and for the same purpose that the Chief Executive has requested roughly \$1 million this year. This is like a down payment on something

that I'm pretty confident we all want to do, which is support veterans who are experiencing financial hardship. If you don't think the IDs are necessary, I think that you should consider that this is also a chance for us to take a vote to confirm the bipartisan support for veterans, and to put this money towards helping veterans who are experiencing financial hardship, and I'm sure that we are going to want to do even more of that when we have budget talks later on this session. But, again, I would just, you know, encourage my colleagues, let's show veterans our support for them right now and let's override this veto. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Kittery, Representative Rykerson.

Representative **RYKERSON**: Thank you, Madam Speaker, Men and Women of the House, I apologize for rising again. I just want to relay what my neighbors, who have served our country, have said when they got to the gate of Pease to get their health care. They were told that they weren't allowed in unless they have an active Military ID, they obviously didn't have that, they are not active military, or a license from a state that had Real ID, or a passport card or a passport. That's what they told me, that's what I know. Thank you.

The SPEAKER: The Chair recognizes the Representative from Pittsfield, Representative Strom.

Representative **STROM**: Thank you, Madam Speaker, Men and Women of the House. I voted last week, I voted against this bill the first time and I plan on voting to sustain the veto today. I'm a 20-year veteran myself, in the United States Navy, and I just don't believe in throwing money at something that's just going to fix part of the problem instead of the full problem, when we have the ability to do that so easily by passing what we know we can. Thank you.

After reconsideration, the House proceeded to vote on the question, 'Shall this Bill become a law notwithstanding the objections of the Governor?' A roll call was taken.

The SPEAKER: The pending question before the House is 'Shall this Bill become a law notwithstanding the objections of the Governor?' All those in favor will vote yes, those opposed will vote no.

JOINT RESOLUTION RECOGNIZING APRIL 2017 AS AUTISM AWARENESS MONTH

WHEREAS, autism is a spectrum disorder, which means no 2 people with autism are affected the same way, and it is a complex developmental disability that usually appears during the first 3 years of life and results in a neurological disorder that affects the functioning of the brain and social interaction and communication skills; and

WHEREAS, in the United States, one in 68 children is diagnosed with this spectrum disorder and prevalence has increased 30% since the United States Centers for Disease Control and Prevention's study in 2008; and

WHEREAS, autism knows no racial, ethnic or social boundaries and neither income nor lifestyle nor education affects its occurrence and it is estimated that more than 3,500,000 people live with autism spectrum disorder in the United States; and

WHEREAS, autism costs the United States over \$236,000,000,000 in annual health care costs, most of which are in adult services, and these costs are anticipated to increase; and

WHEREAS, while a single specific cause of autism is not known, current research links it to biological or neurological differences in the brain, and outdated theories and myths, such as autism being a mental illness, have been proven to be false; and

WHEREAS, with support, people with autism can live full lives and make meaningful contributions to society; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-eighth Legislature now assembled in the First Regular Session, on behalf of the people we represent, pause in our deliberations to acknowledge that the month of April 2017 is Autism Awareness Month and to pledge our support and encouragement to all those affected by autism; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Autism Society of Maine as a token of our respect and support.

His wife Ashley, and the Fulford family, has reason to be very proud. I thank the Representative from Biddeford, Representative Fecteau, for bringing this sentiment forward. Representative **FECTEAU**: Thank you, Madam Speaker. Ladies and Gentlemen of the House, I stand here today to celebrate the life of Coach William Fulford and this distinction presented to him. A distinction that, quite frankly, falls short of capturing the depths by which Will left his mark in this world, in his well-lived 29 years. Will Fulford was indeed a Coach of the Year; however, he was also a cherished mentor, educator, friend, son-in-law, brother-in-law, grandson, husband, brother, and son. In all these roles, Will would have been worthy of an award. Will was my friend, and the husband of my good friend, Ashley, who joins us here today in the gallery. The two of them were especially dynamic together, dedicated to their professions, and above all, to the student athletes they coached. I have never met two people who complemented one another with such harmony. The strength of their love made it possible to challenge, encourage and cultivate confidence in the student athletes they coached in Biddeford. Abby Laverriere, a senior at Biddeford High School, shared how Will impacted her life. She said, "Will was just so many different things to me. He was a friend, a role model, sometimes he felt like a parent. He took really good care of us. He meant the world to me. I trust him with my life. I have so much respect for that man. He was incredibly genuine. He just put so much thought into everything you said." In Will's time with Biddeford's Cross-country programs, he coached an individual state champion and brought several boys teams to the State Championship meet. Most recently he coached the Biddeford girls to their first state meet since 1994, ending a 23-year drought and finishing sixth in the state. The passion that Will coached with shined through with his student athletes, like Abby. I was blessed to know Will, and it is without a doubt a tremendous honor to stand here today to recognize this distinction from the *Press Herald* and share this lasting legacy that Will has gifted to friends, his students, and his family. Will lived his life following this quote from long distance runner, Steve Prefontaine. "To give anything less than your best, is to sacrifice the gift." Will never sacrificed his gift. Instead, he shared it with everyone who is so fortunate to know him every single day. Thank you, Madam Speaker.

Hadn't seen Will for a long time. Will went to our church, and his mother taught my son, and him, in class there. Representative **ESPLING**: Thank you, Madam Speaker. Ladies and Gentlemen of the House, I rise today to express my sincere condolences in regards to the loss of Sister Frances Carr. One of the last remaining members of the Sabbathday Lake Shaker Village religious community in New Gloucester. Sister Frances came to Shaker Village when she was 10 years old, brought there by her mother after the death of her father. At the time, orphans and children whose parents could no longer afford to care for them were often brought to Shaker communities instead of orphanages. While not everyone who grows up in the Shaker community stays, Sister Frances felt a calling to remain and was a leader in the community. Sabbathday Lake Shaker Village was established in 1783 and is the only active Shaker community in the world. The community is situated on 1,800 acres of farm and forest, with 17 historic structures from the 1780s through the 1950s. Sister Frances leaves behind Brother Arnold and Sister June, who continue to live, work, and worship at Shaker Village. The Shakers are best known for their popular 19th century Shaker furniture and a long list of Shaker inventions. Shaker Village can be toured throughout the summer. You can also visit the museum, library, and gift shop. They host many craft workshops, educational programs, and events throughout the year, and they also continue to hold Sunday worship services. When I drive up the hill to Poland on Route 26, I pass Shaker Village, the historic buildings on my right and the apple orchard on my left. I am reminded of the deep roots the Shakers hold in our community, of their rich history, and their overwhelming contributions, really, to the world. Much work has been done and will continue to be done to preserve this fantastic history of Sister Frances, the entire history of the Shakers, and the preservation of this historic property. Shaker Village is a gem for Gray, New Gloucester, and the Poland area and an absolute treasure for the State of Maine. Thank you.

The SPEAKER: The Chair recognizes the Representative from Bowdoinham, Representative Berry.

Representative **BERRY**: Thank you, Madam Speaker. Madam Speaker, Women and Men of the House, it is an honor to stand today and speak to the memory of Dahlov Ipcar, because just as lobster and blueberries and pine trees are Maine icons, there are certain individuals, maybe one or two in a generation, who themselves become Maine icons. I think of Longfellow or Blaine or Hamlin, of Sarah Orne Jewett or Perkins to name a few -- Chamberlain. And certainly, Dahlov Ipcar is one of those Maine icons. Dahlov lived for 100 years from 1917 to 2017. She painted and drew from her very first days to her very last day. Her paintings were exhibited in the Metropolitan Museum, in New York City, and the Museum of Modern Art, in New York City, and the Corcoran Gallery, in Washington, D.C., and the Whitney Museum of American Art, in New York City. And there are murals on public buildings in the United States where her work can still be seen today for the public. But, she's best known, I think, for having produced more than 30 children's books, many of which are near and dear to our hearts, because we read them to our children, and grandchildren, or maybe had them read to ourselves. Ipcar's work is notable for its joy and line and color and for its imagination. But, her work is not only an act of joy and imagination, it's also an invitation to imagine and to create with her. It's an invitation to travel on the wings of our own imagination and to see the world both as it is and as it could be and to see the beauty of both worlds. Her work is an invitation to the child to dream about what they might someday do in their life. So, for example, in the book *I Like Animals*, which she dedicated to her son, Charlie, who is with us here today, "when I grow up, I'll have a zoo or a pet shop. When I grow up, I'll be a farmer or a woodsman." Her work is also an invitation to see the world through the eyes of another as in the *Cat at Night*, we see the transformation of a darkness and shadowy world to a world of color and light and adventure. Her work is an invitation to travel to another continent on the map, perhaps Africa or Asia, some place far away. And, it is also sometimes an invitation to travel to another continent in the mind, as in *Deep Sea Farm*, one of my favorites, where an undersea farmer cultivates his crops of sea cucumbers and takes care of the Sea Cows and protects them from the Sea Wolves. Madam Speaker, at least three generations have been raised and inspired by Dahlov Ipcar. Many more generations will come who will continue to be raised and inspired by Dahlov Ipcar, and her works, and her paint brush, and her imagination. Despite her loss of eyesight in her later years, Ipcar never lost her insight or her habit of painting and

making art on a daily basis and having shows, regularly, where she was treated like a rock star. Dahlov Ipcar painted on her very last day in life with joy, with imagination, and with generosity to the many generations who have learned joy and imagination from her. As a state, as a species, we owe Dahlov Ipcar and her family an enormous debt of gratitude, a debt we can repay when we share with the world our own light, our own joy, our own imaginations. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Bath, Representative DeChant.

Representative **DeCHANT**: Thank you, Madam Speaker and Ladies and Gentlemen of the House. I'd like to rise and add my voice to what was just spoken. Maine has the good fortune of having a strong creative economy, that happens in a variety of ways throughout our state -- in music, in dance, in theater, and in visual arts. When a person reaches the pinnacle of a career and an influence, as Dahlov Ipcar does, it is an amazing opportunity for us to recognize it as a state and as a Chamber. Living in Bath, I do also operate an art gallery in my spare time, and so, Dahlov Ipcar was supportive in our endeavors at the Chocolate Church Arts Center. She donated prints to us to help auction off at special events. It was reassuring to know that a person of her talent, her compassion, and her humanity existed and dwelled merely over the bridge, down a peninsula, and to the Island of Georgetown. And so, to her family who lent her to us, today is an amazing opportunity to acknowledge and celebrate a life well lived. Thank you.

This being an emergency measure, a two-thirds vote of all the members elected to the House being necessary, a total was taken. 132 voted in favor of the same and 5 against, and accordingly the Resolve was **FINALLY PASSED**, signed by the Speaker and sent to the Senate.
