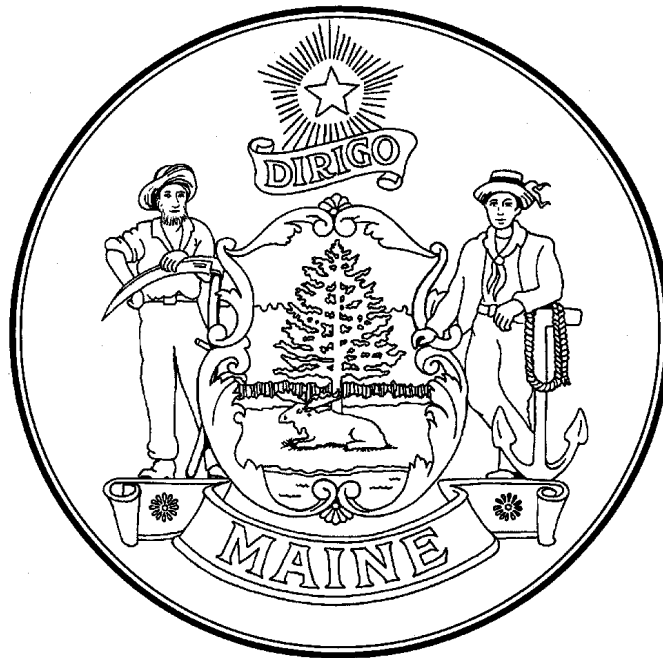

Dear Honorable Members of the 128th Legislature:
Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 7, "An Act To Allow Conveyance of Land Previously Conveyed by the State to the Town of Bridgton."
This bill gives the town of Bridgton the ability to convey non-waterfront portions of a piece of property held for public use, if the town determines the portion to be conveyed have no identifiable public use. It also requires that revenues received by the town from such conveyance be held in a trust for parks and recreational purposes.
The state conveyed this parcel of land to the town in the 1970s with deed restrictions limiting its uses for recreational purposes. If the town does not have a use for portions of this property, which was conveyed for specific public purposes, then it should revert back to the state, and the state should benefit from the sale of the parcel or portions thereof.
For this reason, I return LD 7 unsigned and vetoed. I strongly urge the Legislature to sustain it.

The accompanying item An Act To Allow Conveyance of Land Previously Conveyed by the State to the Town of Bridgton

(H.P. 8) (L.D. 7)

The **SPEAKER**: The Chair recognizes the Representative from Bridgton, Representative Ginzler.

Representative **GINZLER**: Thank you, Madam Speaker. Madam Speaker, I rise to rebut the Chief Executive's decision to veto LD 7. In 1971, the state conveyed a parcel of land to the Town of Bridgton to be used for recreational purposes. Much of this parcel had been used for logging and it contained cabins. In 1981, the conveyance was amended in statute to allow the town to sell the majority of that parcel that contained these structures. Fast forward to 2017, and the Town of Bridgton asked the Legislature to once again further amend the 1981 law to allow it to sell the remaining small portions of the original parcel because, being non-waterfront, it had no identifiable public recreational use. The proceeds, however, would be placed in the Moose Pond Trust Fund for public recreational projects. The Town of Bridgton has adhered to the intent of the 1971, and 1981, laws by using the sale of land to fund public recreation. In 2017, it wishes to once again do the right thing, for the right reason, in the right way. I appreciate the committee of jurisdiction for their 11-2 vote. Please override this veto by following my light. Thank you.

Dear Honorable Members of the 128th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 329 "An Act Concerning the Law Governing the Posting of Newspaper Legal Notices and the Statewide Repository for Legal Notices."

Because we are now well into the Information Age, and given the ubiquity of the internet in our modern life, I believe that it is good policy for legal notices to be posted online. However, I also believe that requiring legal notices to be printed in newspapers at a fee does nothing but prop up a dying, antiquated industry. This requirement is a taxpayer subsidy of the worst sort. It serves to blur the line between a free press and one dependent on the State for revenue.

In the future, I would like the Legislature to explore whether we may eliminate the mandate that legal notices are posted in newspapers, but still maintain adequate notice to the public by posting online notification.

Because I think the issue of legal notices still requires attention, I cannot support this bill. For this reason, I return LD 329 unsigned and vetoed. I urge the Legislature to sustain it.

Representative McLEAN of Gorham moved that the House **ACCEPT** the Majority **Ought to Pass as Amended** Report.

The **SPEAKER**: The Chair recognizes the Representative from Gorham, Representative McLean.

Representative **McLEAN**: Request permission to speak to my motion?

The **SPEAKER**: The Representative may proceed.

Representative **McLEAN**: Thank you, Madam Speaker. This bill that we have before us, LD 306, complies with the federal Real ID law that was passed shortly after the September 11th attacks in 2001. For many years now, Maine has opted not to comply with this law because of concerns about privacy. We have requested waivers many years, and we have been granted those waivers from the Federal Government since that time. Unfortunately, this year we're not permitted to get another waiver. And so, we're faced with a question of whether or not we comply with the federal Real ID law, or we throw up our hands and say we're not going to do this.

The Transportation Committee heard lots of testimony about the privacy concerns, but also about the impacts on our constituents if we don't comply. And for me, and a majority of the committee members, the concerns of constituents, the

challenges they would face getting on an airplane or entering a military base, for example, were far greater than the privacy concerns that were aired to the committee. That all being said, I think the privacy concerns that were raised are very important, and we do have a divided report because I do believe that the debate we will have this morning is an important one. As an American, we value our right to privacy, we value the right to not share information or data -- those are important. And while those are important, I feel that we are compelled to comply with this law. I think Maine is put in a very unfortunate situation and I'm disappointed that our Federal Government has put us in this position, but I feel like we have no other choice at this point in time. And so, for those reasons, I urge my colleagues in the House to support this Ought to Pass motion. Thank you, Madam Speaker, and I request a roll call.

The same Representative **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought to Pass as Amended** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The **SPEAKER**: The Chair recognizes the Representative from Gardiner, Representative Grant.

Representative **GRANT**: Madam Speaker, Ladies and Gentlemen of the House, I rise in opposition to the pending motion. For 10 years, Maine's political leaders of both parties have been united in their opposition to the federal Real ID law and have refused to sacrifice our citizens' right to privacy to the overreach of the Federal Government. Past Legislatures have resisted turning our state's drivers' licenses into virtual national identity cards. Real ID was a bad law when Congress passed it in 2005, attached to a must-fund Iraq War funding bill, and it is still a bad law. Other states continue to reject it. After a decade of Legislatures before us, telling our congressional delegation that Maine would not comply with this law, there has been no progress in Washington. Maine applied for waivers from the Feds as we waited, in vain apparently, for Congress to act. Fast forward to this January when the Department of Homeland Security turned up the heat on states like Maine that have refused to comply and started denying our people access to federal installations with Maine drivers' licenses as identification. The Feds also announced that next year Mainers won't be able to use their drivers' licenses to board commercial airlines. When talking to my constituents about Real ID, their initial response has gone along the lines of, "Why can't you folks just figure it out? It seems pretty simple." But when I tell them the hoops they're going to have to jump through to get one of these Real ID licenses, and how much it's going to cost, many have said, "How come that isn't being covered in the news?" Under Real ID, license photos must be taken with facial recognition software, and documents, such as certified birth certificates and original social security cards, must be scanned into a database at the Bureau of Motor Vehicles, where it will be kept for seven years. Given the present state of cybersecurity, we cannot assure anyone that this new database will be secure. Worse, Real ID creates an interlinked network where other states' motor vehicle departments and the Federal Government have access to Maine's Bureau of Motor Vehicles database. At any time, with just a rule change, the federal Department of Homeland Security could link all 50 states' databases and voilà, a National Identity Database with no congressional action required. My colleagues on the Transportation Committee have amended the bill that is before us now to give Maine citizens a chance to opt out, so they can choose to have a

Real ID license or a regular one. I know they sincerely think this is a workable solution. But, how confusing is that? How many people after the headline appears tomorrow, "Maine complies with Real ID," will remember that they can't use their regular Maine drivers' license as federal approved identification? How many inconvenienced folks will there be who didn't read all the way to the bottom of the newspaper article, or who forget between now and the time their license needs to be renewed that they will need a passport or passport card to get on a plane if they opt out? And, here's another scary fact, the same federal department who oversees this monster of a law, can at any time change the rules and decree that there won't be any more opting out. Americans have a fundamental right to privacy. Real ID infringes on that right. Let's tell our Representatives and Senators in Washington, once again, to do their jobs. We have sent the message loudly and clearly for more than a decade that we find this law an outrageous transgression on our citizens' right to privacy and a high handed, unfunded federal mandate. Have they successfully ignored us long enough to make us feel we have no choice but to do their dirty work for them? Nearly every one of you I have spoken with dislikes this law as much as I do, but have told me that at this point we have no choice. I cannot accept the notion that we have no choice. We do have a choice. On our desks are red and green buttons that show it is in fact our responsibility to choose. We can choose to protect our citizens' fundamental rights to privacy, or we can allow ourselves to be bullied by the Federal Government. There is a way to both protect our citizens' rights and their ability to conduct their personal and business affairs wherever those affairs take them. We can protect our privacy, push back against the Federal Government overreach, and still meet the needs of our constituents to access commercial flights and federal facilities. There is another alternative, and if we vote this motion down, we can discuss it. Once we go down this road there will be no turning back. Once lost, this precious right to privacy will not be reclaimed. I urge you to put the long-term damage ahead of any short-term inconvenience and reject Real ID once again. Thank you, Madam Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Naples, Representative Cebra.

Representative **CEBRA**: Thank you, Madam Speaker. I stand in support of the pending motion, and I don't have a script to read to you this morning, but what I do have is 7 years on the Transportation Committee and I want to tell you a little bit about that. Transportation has always been a nonpartisan committee. It's been a fantastic committee to work on, because when you have an issue like this that comes before the Transportation Committee, good people come together and figure out a solution. Senator Diamond sponsored the original bill, I was a cosponsor, happy to do it. Originally, 10 years ago, or eight years ago, when Real ID came up, I was a cosponsor of the bill to prohibit us from doing this. But, 10 years, or eight years, have passed and things have changed considerably, and now we're under the gun. Now under the leadership of Representative McLean and Representative Parry and our Senate members, we've been able to hammer out a compromise, and the beauty of this compromise is it takes care of what the Federal Government needs us to take care of and it also gives the people of Maine an opportunity to say, "No thank you, I don't want to do that." I think it gives us the best of both worlds. I think we're able to get out from a sticky situation where people would be at an airport, unable to travel. And I also think our civil liberties are protected because of the opt out. Driving with a license, we have to remember, is

a privilege, and while we need this to travel, traveling is also a privilege that we need to take seriously. We need to take our security seriously and we also need to take our liberties seriously. I think this compromise has done all of that, and I thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Arundel, Representative Parry.

Representative **PARRY**: Thank you, Madam Speaker, Ladies and Gentlemen of the House, I rise in support of the pending motion and in full support of my House Chair. We worked a long time on this. This is an issue that I was, had been, 100 percent against, like Representative Cebra mentioned. But, we really came to the point where, as you look into the Committee Amendment, is, it states the Secretary of State may issue, at the applicant's request, a Real ID compliant license. So technically, I believe it's an opt-in because everybody has the choice if they have this license that's fully compliant or they get the current license at the current cost of the license they have now. If you're someone that does not go into federal buildings or does not travel by plane, you never have to get this license. But I think that Secretary Dunlap, I think, said it perfect right near the beginning, and this was before the amendment, was you have two choices: you can vote yes and take some civil liberties away, or you can vote no and throw your constituents into chaos. And I believe he was absolutely right. But that's also why I believe that by adding the opt-in into this bill we gave every single Mainer a choice. If they would prefer to send their documents to the Federal Government to get a passport or passport card, they have that choice. But, if you're going to get on a plane, starting next year, or if you want to get into a federal building, you're going to need to have one or the other. I also think that it's really important that people realize this. And I think that it will be awhile before you can actually get a compliant Real ID. This will take some time to implement, but if we pass this legislation, as I understand from Homeland Security is, your current license you will be able to still use, but we will be starting the process of coming into compliance. There are currently 45 other states that are either in full compliance or moving towards compliance. Currently there are five, including Maine, that have legislation like we did that prohibit us from issuing Real IDs, and this bill just takes that proportion of the prohibition away and puts it so that the Secretary of State, as I said before, may issue, at the applicant's request, a Real ID compliant license. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Brooks.

Representative **BROOKS**: Thank you, Madam Speaker, and People of the House. I rise today in opposition to the pending motion. I rise with a conviction of freedom and a sense of freedom. I think it's important that we do have the freedom of choice, and I was sent here as a voice of people in my community, and I am afraid that this is a bill that is important that we stand up for, that we stand and acknowledge the complexity of the issue while at the same time acknowledging that in our community we have a lot of safety guards and we do have a freedom to make a choice here. I do believe that in our community we have a rich history of diversity. And diversity is important to stand up for. The diversity that we express in our community and on the House floor today, I want to just acknowledge that it is a difficult option that we have today, whether we choose, as a privileged member of the elected body that we are in today, to choose to support this mandate, or if we voice our concerns and vote

against the Real ID law. I think there is more than one way to approach this law, and we do have a voice as a state body, and as a state body, I think it's important that we respect the diversity within our community and that we do not automatically rush to judgment and encourage a type of unfair and unjust profiling, so to speak. Driving is something that's very critical for transportation issues. It is something that we, I'm going to vote against the pending motion because I do feel that we are-- the balance of justice has tipped too fairly, too unfairly, in whichever direction you want us to say, that we do have an interconnected neighborhood and interconnected community, and it's important that we don't automatically judge people, and I apologize for not having a well-formed speech, but I'm going to vote against this pending motion and I appreciate the opportunity to be here to express those thoughts. Thank you, take care.

The SPEAKER: The Chair recognizes the Representative from Weld, Representative Skolfield.

Representative **SKOLFELD**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. In 1775, Benjamin Franklin said, "Those who give up essential liberty to purchase a little temporary safety, deserve neither liberty nor safety." Well, I've always believed in that concept and I think that Mr. Franklin had it pretty well right. However, 200 or more years later, the world has changed. No one could ever envision in 1775 what was going to take place a couple centuries later. Now, I agree with my good friend Representative Cebra and Representative Parry that we need to do something, and I believe that the opportunity to opt in or opt out on this program is sufficient to calm this old fellow's soul and realize that we can move forward and I will support this motion. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Winthrop, Representative Hickman.

Representative **HICKMAN**: Thank you, Madam Speaker. I certainly wouldn't have minded if the Clerk kept reading. Because this is an amendment that I think is important, because we have just adopted something that I oppose, but we have adopted it and so I would hope that, even at this late hour, we can do something that will further protect what little bit of privacy we have left. The summary of the bill is what I will read because it states five things. This amendment requires the Secretary of State to provide notice to an applicant for a Real ID compliant drivers' license or nondriver ID card, at the time of application, of the document retention policies of the Secretary of State governing documents provided by an applicant. It prohibits the Secretary of State from providing a document, or a copy of the document, collected in connection with the issuance of a drivers' license or nondriver ID card to a person other than a law enforcement agent. It prohibits the Secretary of State from copying, scanning, or storing a document collected in connection with the issuance of a drivers' license or nondriver ID card, except for a document collected in connection with the issuance of a Real ID compliant drivers' license or nondriver ID card. It clarifies that the Secretary of State may not disseminate social security numbers collected in connection with the issuance of a drivers' license or nondriver ID card. And this would be true for both Real ID and those who opt out. And finally, it provides that the Secretary of State may use biometric technology, including but not limited to retinal scanning, facial recognition, or fingerprint technology, only to produce a Real ID compliant drivers' license or nondriver ID card, but not for the license or an ID card that a person gets when they opt out. According to the Secretary of State, this amendment does not take us out of compliance as we have just voted this Majority Report, and it does no harm to the overall intent of the Majority Report. So, I respectfully ask members of this House to consider this amendment and vote to support it. Thank you, Madam Speaker.
