**JOINT RESOLUTION RECOGNIZING
FRANCO-AMERICAN DAY**

WHEREAS, the State of Maine is named after the Province of Maine in France, and the towns of Paris and Calais owe their names to the capital city of France and the French port city of Calais, respectively; and

WHEREAS, more than 1/3 of the population of Maine is of French and Canadian descent and Franco-Americans in Maine have contributed much to the beauty and quality of this State; and

WHEREAS, French is the primary language of thousands of Maine citizens and there has been a resurgence in the use of the French language and a heightened appreciation of the Franco-American heritage throughout the State; and

WHEREAS, clubs and organizations to promote French culture and language have sprung up throughout the State, including the Francophone Caucus at the Capitol; and

WHEREAS, fluent French-English bilingual people are a cultural and economic resource to the State; and

WHEREAS, cultural tourism can be greatly enhanced by the genuine Franco-American centers throughout the State, and the large Franco-American presence in Maine can further strengthen our relationships with Canada, France and the rest of the francophone world; and

WHEREAS, the first Franco-American Day was celebrated on Wednesday, March 6, 2002 at the State Capitol; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-eighth Legislature now assembled in the First Regular Session, on behalf of the people we represent, proclaim that Wednesday, April 19, 2017 is Franco-American Day, to be celebrated at the State Capitol; and be it further

RESOLVED: That Franco-American Day be celebrated to commemorate the rich history of the French people in the State of Maine and the United States of America.

READ.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Eagle Lake, Representative Martin.

Representative **MARTIN**: C'est mon plaisir aujourd'hui compensé eu norte du Maine. Finally. Il n'y na pas de neige. The SPEAKER PRO TEM: The Chair recognizes the Representative from Biddeford, Representative Fecteau.

Representative **FECTEAU**: Thank you, Mr. Speaker Pro Tem. Mr. Speaker, Ladies and Gentlemen of the House, distinguished guests, I don't want to set bad precedent this morning. The Franco Caucus has an agreement that we will not be speaking to sentiments, but we did agree that, in this case, since Representative Beaudoin served here in the House, it would be appropriate for us to provide the opportunity to make comment. I also apologize for earlier objecting to the sentiment and not reading the French. I was distracted by all the text that came before it and got thrown off so, in the heat of the moment, I didn't read the French and now I've passed the opportunity to do so, so unfortunately, I will not be reading in French today. The Honorable Paulette Beaudoin, better known as mémère, was not only my State Representative for 38 years of my life, she was also my neighbor. She was the kind of neighbor who welcomed you into her home to share all the latest and greatest. She was the kind of neighbor that took pride in sharing her work in this building with a much younger version of myself. In fact, my first time in this building was thanks to an invitation from Paulette. I was in the backyard when mémère came across the lawn and said, "Hey, do you want to go to Augusta with me? Governor Baldacci is having a bill signing ceremony and you can come with me." I ran into the house, asked my mom for permission, changed, and returned with a button-down shirt tucked into a pair of jeans. Needless to say, mémère did not approve. "No, no, no, you can't wear jeans to the State House," she told me. She set me straight, as my père and my mémère had to do for my entire life, perhaps with fewer French curse words. For me, however, what stands out above all else when I think of mémère was her work to provide seniors with access to lower-cost prescriptions. For several years, she organized bus trips to Canada to provide an opportunity for seniors to buy prescriptions at a lower cost. This was undoubtedly a source of great pride for her. She connected dozens of Maine seniors, many of them of Franco heritage, with their prescriptions at a cost they could actually afford. There is much more I could say about her today, and I do want to conclude with just this: There are

many that have served in this body over many years, and I would argue that mémère's love for public service would challenge any of those before or after her. I'm confident she's in the chamber with us today, probably seated in what she would consider a borrowed seat, Representative Denno. And so, Representative Beaudoin, congratulations, you're officially the mémère of the Franco-American Hall of Fame. You've earned it.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Biddeford, Representative Grohman.

Representative **GROHMAN**: Thank you, Mr. Speaker, Women and Men of the House, I'm also pleased to have an opportunity to speak about my friend and mentor, Paulette Beaudoin, as well. A month or two before Paulette died, very recently, I took her out to breakfast at our local restaurant, Biscuits and Company, and if you're a regular there, you'd know the breakfasts are pretty substantial. Paulette got the biggest thing on the menu. It's several eggs, couple of biscuits, and thick cut bacon. It was bigger than she was. But it wasn't a contest. She crushed it and mowed right through it. I think Representative Fecteau made reference to this, Paulette sat right up front, right up there, everything that took place in here had to run past her. In fact, on his first day in office, Paulette buttonholed our then-new Chief Executive and gave him a talking to, an image you can easily find on a popular search engine. It's worth looking at. While you are at it, you might find an image of Paulette holding an AR-15 assault rifle as well. She sponsored legislation to equip our State Police with them and was very proud of that, and tested them herself. She was a dynamo. As Representative Fecteau said, she was known around the State House as mémère. She never quit. She called me just a few days before she was admitted to hospice care to call me about an issue that she saw in *Governing Magazine*, which she still received and read religiously. She loved Joan Rivers, all of her outfits were from Joan Rivers, and she was a similarly driven and strong woman. I think they had a lot in common. She went out on her own terms, may she rest in peace. She's still watching me, because her daughter lives right across the street from me in Biddeford, which is just wonderful. And I'll just close by saying I had the honor of serving as one of Paulette's pallbearers, and after we laid her in the ground her priest, a very formal Catholic Priest as you can imagine, in full regalia, held me back and grabbed my arm, just about so it would fall off, and he growled at me. He said, "Do her justice." Paulette, I'm doing my best. Thank you.

In Memory of:

Gilles Edouard Auger, of Sanford. Mr. Auger was born in Sanford in 1935 and graduated from St. Ignatius High School. He was the first in his family to attend college, earning a bachelor's degree in French from the University of Maine at Orono. He was awarded a Fulbright Scholarship, earning a Diplome from the Sorbonne in Paris, and later received a master's degree in education from UMO. Mr. Auger taught French at many schools in the State, including Lubec High School, Gould Academy, Sanford High School and Nasson College. He spent the rest of his career at the Department of Human Services, retiring in 1997. Mr. Auger was very active in Sanford community affairs, serving as Voter Registrar, Town Moderator, a board member of the Goodall Library and the Sanford Historical Committee, the first president of the St. Ignatius Parish Council and a founding member of both the York County Teachers Federal Credit Union and the Sanford-Springvale Historical Society. He also held memberships in the Knights of Columbus and the Benevolent and Protective Order of Elks. In 2003 he and his wife, Claire, were inducted into the Franco-American Hall of Fame. Mr. Auger will be long remembered and greatly missed by his family, his many friends and his community;

You know the Federal Government in 2016 updated our grid reliability standards relating to EMP attacks, and now this mandatory standard required Maine transmission to withstand a 100-year event. I was happy to see this bill amended down, and any standards above the FERC Standards are inefficient and costly to the rate payer. Therefore, I cannot support this amendment.

The SPEAKER: The Chair recognizes the Representative from Farmington, Representative Harvell.

Representative **HARVELL**: Are we out of synch? Somebody is out of synch with the board, right? Okay.

The SPEAKER: The Board will be corrected. The Chair thanks the Representative from Farmington.

The Chair recognizes the Representative from Kittery, Representative Rykerson.

Representative **RYKERSON**: Thank you, Madam Speaker. Men and Women of the House, this is really not a fiscal impact bill, it's a matter of reporting, of finding out what we are doing for grid reliability, and I urge you to vote for this amended resolution.

The SPEAKER: The Chair recognizes the Representative from Farmington, Representative Harvell.

Representative **HARVELL**: Thank you, Madam Speaker. I feel a little bit more at speed. Ladies and Gentlemen of the House, this bill started, as it has every session, in an attempt to protect our grid from an EMP blast, a nuclear strike, or a coronal mass ejection from the sun, which, by the way, takes only slightly longer to arrive than a missile from Russia. Had we passed LD 529 in its former incarnation, the event of a nuclear war, Maine would have been bankrupt, we would have likely all been dead, but our toasters would have worked. Like so many bills that couldn't possibly pass, we've turned it into a study. It was studied before and it's studied now. And one of the issues you run into in these studies is it just might be possible that nations don't want other nations to know what their grid reliability may be or not be. So, the limits that you may have to study this are directly related to national security. In its current state, it would have no more effect than if you held it up as a shield against a nuclear strike, and I ask you to vote no.

The SPEAKER: The Chair recognizes the Representative from Bowdoinham, Representative Berry.

Representative **BERRY**: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House, I just want to clarify that there is no further study that is required by this amended bill. The motion before us would simply ensure that this body is in possession of important information, not sensitive information but important information, to allow us to do our job in setting policy if something were to happen outside of the 100-year event that was already referred to. We would certainly have some egg on our face if we did not have that information to make good decisions by. Thank you, Madam Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Bridgton, Representative Ginzler.

Representative **GINZLER**: Thank you, Madam Speaker. Madam Speaker, I rise to oppose the motion. First, a little history is in order. The state contribution to the retired teacher's healthcare was once capped at 30 percent. Some years ago, the cap was raised to 45 percent. This bill would raise the cap to 50, then 55, then 60 percent by 2021. The hefty fiscal note that accompanies these caps are: \$3.5 million in 2017, going up to \$13.9 million in 2021. And remember these are estimated costs, and we're talking about healthcare. These state contributions are not credited to the state contribution of 55 percent to K-12 education. They exist out of the box. Retired teachers were not, and are not, state employees. The responsibility does not reside with the state. The solution could be a statewide teachers' contract, and for that reason I oppose the motion and recommend people follow my light. Thank you.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Collings.

Representative **COLLINGS**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I'd like to talk a little bit about the history of this bill as well. This is an issue for about 100 years the State of Maine has dealt with. They've brought together many committees, they've studied this over the years, and there's been an implied promise from the State of Maine to teachers that in exchange for a lifetime of molding future generations, and contributing so much for so little pay, that in retirement they would be taken care of. That's a promise that's been made. They have been trying to find a way to stay true to that promise. Up to this date, it hasn't fulfilled the complete promise. Part of the issue is, going back, is that women were always the teachers, primarily. It wasn't until more men were teachers that bill was put in to have more things taken care of in retirement for teachers, and I believe it was the Representative from Aroostook County finally putting legislation, a Representative Lisnik, and eventually they allowed teachers to get up to 30 percent and it stopped there. Never reached what it should have. In 2001-2002, I believe, there was bipartisan support in the House and the Senate, different bills were put in, and everyone in both chambers thought it was a priority. They had the will to do so, and in 2001 and 2002 they incrementally started to increase the contribution to healthcare payments for teachers. It went from 30 to 45 percent. I think it ended in 2006. The intent was always to get it up to 100 percent, and it never has. So, the issue is we made a promise to teachers. We've been trying to fulfill it for 100 years. In the last 10 years or so we haven't kept up with that, and what I'd like to say is I think it's time that we need to fulfill our promise to the teachers of the State of Maine. Many came to this building to talk on this bill, and when we heard the stories of the teachers that gave so much to our state, living in abject poverty, I think morally we need to do this but also, for as far as education being so important to everyone all across the state in all backgrounds, if we don't take care of teachers in their retirement, we're not going to attract teachers in the future here. And the state retirement system, there is a blatant disparity. Other people that retire get 100 percent, some of them are close to 90 percent, and the fact that these teachers are getting so little in retirement and living in poverty, I think that after about 100 years we should take a stand as leaders of the state and take care of those that gave so much. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Madam Speaker. I'd like to pose a question through the Chair.

The SPEAKER: The member may proceed.

Representative **FREDETTE**: Thank you, Madam Speaker. My understanding is that the contribution to the retirement system for retired teachers is not calculated as part of the 55 percent calculation as passed by referendum by the people of the State of Maine. I would ask the question of why isn't it and why shouldn't it be?
