JOINT RESOLUTION RECOGNIZING APRIL 2017 AS SECOND CHANCE MONTH

WHEREAS, every person is endowed with human dignity and value; and

WHEREAS, redemption and second chances are American values: and

WHEREAS, an estimated 65 million American citizens have a criminal record; and

WHEREAS, individuals returning from prison and those who have paid their debts after committing a crime face a "second prison" of stigma and obstacles, also known as collateral consequences; and

WHEREAS, individuals with criminal histories encounter significant barriers such as an inability to find housing, employment or education, regain voting rights, volunteer in their communities, secure identification documentation and pay off substantial financial debt accrued as a result of conviction and incarceration; and

WHEREAS, these barriers can contribute to recidivism, which increases victimization, decreases public safety and results in lost human capital and economic output for communities; and

WHEREAS, the designation of April as Second Chance Month can contribute to increased public awareness about the "second prison," the need for closure for those who have paid their debts and opportunities for individuals, employers, congregations and communities to extend second chances; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-eighth Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize April 2017 as Second Chance Month, and we urge citizens to observe this month through actions and programs that promote awareness of the "second prison" and provide closure for those who have paid their debts.

Dear Honorable Members of the 128th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 23, "An Act To Provide for Legislative Review of Federally Mandated Major Substantive Rules under the Maine Administrative Procedures Act."

Under current Maine law, the Executive branch is authorized to work with the Federal government and form cooperative agreements where state agencies get paid by the federal government to implement federal rules and laws. This works well because state agencies have a better understanding about the needs of Maine citizens and businesses than the federal government. This bill will drastically change this process by stripping this authority from the Executive branch and giving it to the Legislature.

If this bill goes into law, there are many programs that could be negatively impacted. Some of these programs require frequent approvals of updated industry supported standards. How will the Legislature be able to keep up with these changes when they are in session for only part of the year? This bill could easily add years to programs to process, which could cost Maine industries millions of dollars in lost revenue.

For a long time the state has had successful cooperative agreements with many programs, including school lunch inspections, milk and dairy, forestry, potatoes, eggs and fruit and vegetables. Eggs and potatoes alone have at least a half-billion-dollar impact on the Maine economy, which is especially critical in struggling rural areas. There is no problem with the current system; therefore, the Legislature should not risk hurting businesses just to have a little more power.

For this reason, I return LD 23 unsigned and vetoed. I strongly urge the Legislature to sustain it.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Madam Speaker. Ladies and Gentlemen of the House, in reading the Chief Executive's veto, I can't help but concur with his message in regards to the potential for havoc that this may create at the state level, in regards to things that may happen at the federal level but then having to come down to the state. I think that the process particularly works well at this time, and I think the Chief Executive's veto is well written and I ask that you support sustaining the veto. Thank you, Madam Speaker.

Representative MARTIN of Sinclair **REQUESTED** that the Clerk **READ** the Committee Report.

The Clerk **READ** the Committee Report in its entirety.

The SPEAKER: The Chair recognizes the Representative from Montville, Representative Zeigler.

Representative **ZEIGLER**: Thank you, Madam Speaker. Fellow Representatives, I presented this bill. This bill is simply a sunlight bill. It does not affect any processes between sessions. The rulemaking continues to go on. What it allows us to do as legislators is to review those rules that were made in the interim. It does not affect the Executive's ability to execute his duties. Thank you.

The SPEAKER: The Chair recognizes the Representative from Brooksville, Representative Chapman.

Representative **CHAPMAN**: Thank you, Madam Speaker. Just to add to the information on this bill, it does provide only that the information on major substantive rulemaking from the Executive Departments comes to the Legislature. It does not add to the powers of the Legislature. It does not subtract from the powers of the Executive. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette, and inquires as to the Point of Order.

Representative **FREDETTE**: Thank you, Madam Speaker. I question whether or not there's a quorum present and ask for a roll call.

The same Representative inquired if a Quorum was present.

The Chair ordered a quorum call.

The SPEAKER: The Chair recognizes the Representative from Chelsea, Representative Sanderson, and inquires why the member rises.

Representative **SANDERSON**: We have some Representatives in our seat who don't realize that the vote, that they may have pushed their button but the board was reset and they are now voting on quorum.

The SPEAKER: The Chair will specify that the open vote right now is for quorum call. There was initially a mistake when I opened the quorum call. It did read on the board initially the vote regarding the veto, but, in fact, this is quorum call right now.

More than half of the members responding, the Chair declared a Quorum present.

After reconsideration, the House proceeded to vote on the question, 'Shall this Bill become a law notwithstanding the objections of the Governor?' A roll call was taken.

The SPEAKER: The pending question before the House is 'Shall this Bill become a law notwithstanding the objections of the Governor?' All those in favor will vote yes, those opposed will vote no.

The SPEAKER: The Chair recognizes the Representative from Canaan, Representative Stetkis.

Representative STETKIS: Thank you, Madam Speaker. Although this bill is no doubt based on good intentions, I believe we have many more pressing issues in our state. The committee heard from the Maine State Department of Environmental Protection, of the cases of lead poisoning in the Only 15 percent, 31 cases, involved State of Maine. renovations between the years of 2011 and 2015. Only five of those cases involved contractors over those four years. Private renovators, homeowners, do-it-yourselfers, they accounted for more than five times as many cases, 26 of the 31 over that same four-year period. All this under current law. This amendment just directs contractors to follow federal law, which, of course, they are already doing. The amended bill, with a fiscal note of almost \$200,000, sets up a new position and program within the DEP to basically address a situation that affected five people in a four-year period, just two percent on all lead poisonings in Maine under current state and federal law. We currently have about as many drug overdoses in a single week as this bill attempts to address in lead poisonings over a four-year period. I would hope we would concentrate our efforts in those areas and vote down this motion. Thank you.

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Handy.

Representative **HANDY**: Thank you, Madam Speaker, Women and Men of the House. My home town of Lewiston has the highest rate of lead poisoning, not just in the State of Maine, but in the country. You might want to call it our own love canal or Flint, Michigan. We cannot stand by and watch family after family after family have their children tested for lead to find out that they have tested positive. We need additional qualified people to abate the lead problem in my city and those cities in our state with old housing stock. I'm not ready to sit back and take a backseat to this. This is the most important legislation. We need to enforce the EPA rules and we need to do it for the protection of our children. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Monmouth, Representative Ackley.

Representative ACKLEY: Thank you, Madam Speaker, Men and Women of the House. We have a small problem with lead poisoning and it's called measuring. If you look at the years starting in 2011, the number of cases that have been investigated by our State of Maine is fairly small and it's because we're not accurately measuring them. What I can tell you that I know is that children are particularly susceptible to exposure from tiny amounts of dust that are created through renovation. The amount that you could hold on a fingertip will cause a child to lose an average of five IQ points. Who pays for this? Well, I would say that children and their families here in the State of Maine pay, but when those children show up at public school, we all pay. The reality in this building is that we spend an awful lot of time investigating how we can make our schools more effective, whether that be through looking at teachers, looking at administration, looking at infrastructure, and the big guestion that we have not spent nearly enough time on is, how we can better prepare kids to come to school?

The SPEAKER: The member will defer. The Chair recognizes the Representative from Dixfield, Representative Pickett, and inquires as to why he rises.

Representative **PICKETT**: Thank you, Madam Speaker. Would the Speaker please direct the good Representative to address you rather than the opposite side of the aisle?

On **POINT OF ORDER**, Representative PICKETT of Dixfield asked the Chair to remind Representative ACKLEY of Monmouth to address the Speaker and not turn to the rest of the House.

The SPEAKER: The Chair will remind all members when speaking to address the Chair. The member may proceed.

The Chair reminded all Representatives to address their comments toward the Speaker.

Representative **ACKLEY**: Fair enough. Madam Speaker, I appreciate the concern about making sure that folks who are in the business of renovation can do so effectively. But the reality of this bill is that renovation is part of the problem in terms of creating lead dust from old homes. And so, I ask the members to support the measure today.

The SPEAKER: The Chair recognizes the Representative from Biddeford, Representative Fecteau.

Representative **FECTEAU**: Thank you, Madam Speaker. Madam Speaker, I don't want to exhaust this debate, I just want to point out a few facts. Fact number one, the folks from the Environmental Protection Agency came before our committee and they stated that, in fact, though, federal law is rarely enforced. And so, what this Amendment does, it provides funding to train folks to conduct abatement in old housing stock. Fact number two is that Maine has over

350,000 homes that were built before 1978 and over 150,000 that were built before 1950. What we know about old housing stock is it is likely that there is lead paint in these homes. And Representative Ackley made a strong point as well regarding children. The CDC, in 2012, said that children, there is no safe level of lead exposure for children. Zero, absolutely none. And so, with all that in mind, I think this is a very reasonable measure to make sure that more folks are trained in lead abatement so that they can make sure that old housing stock in Maine is safe for our children and the future of our state. Thank you.

The SPEAKER: The Chair recognizes the Representative from South Portland, Representative Battle.

Representative **BATTLE**: Thank you, Madam Speaker. Rumor has it that the reason we're all here is because we're not all there. So, I don't know how much we've been exposed to lead growing up ourselves. But I do know that in my experiences I have seen it firsthand and, it could be progressive. And when you see a child that's smiling and happy and moving about their life normally, and then you start noticing some of the side effects, I think anything we can do to prevent it, to help these children, we should. Please and thank you.

The SPEAKER: The Chair recognizes the Representative from Dresden, Representative Pierce.

Representative PIERCE: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I wasn't going to speak on this but I am a licensed lead instructor. Most restoration people who do renovations actually have their lead licenses. We get a break on our insurance for having lead licenses and having supervisors. There is a problem in Lewiston. It's old houses that have been neglected by the landlords, that have been neglected by the housing authorities that allow people to move in there. That's why they're an outlier in the country. You don't see that in Augusta. You don't see it in Bath. These housing authorities take money from the Federal Government Federal Housing Authority. They are supposed to be making sure that these are lead free. So, it's really a fall down or lapse of inspections by the housing authorities that are creating the lead crisis in Lewiston. These are facilities that have not been painted, have not been renovated and are dilapidated. That's why they're the outlier. Thank you. I'll be opposing this motion.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, this was an interesting bill, lively debated in our caucus this morning. I will be voting against the motion and I would ask for a roll call.

The same Representative **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought to Pass as Amended** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Lebanon, Representative Gerrish.

Representative GERRISH: Thank you, Madam Speaker, Men and Women of the House. This bill establishes the Department of Public Safety to create a program to collect and dispose of expired marine flares. The problem with that is that the State Fire Marshal's Office has been offering this very service since 2004. Fire Marshal Thomas testified to this in committee and told us that anyone in the state can contact his office and they themselves will come and pick up the flares. These are not necessarily safe devices to be transporting around to our local fire departments and such. Fire Marshal Thomas also expressed great concern about the dangers of all kinds of people handling these flares. I think the main issue here is there are many Mainers all over the state with expired marine flares in their barns, their sheds, and they don't know that they can simply call the Fire Marshal's Office to come pick them up and bring them to the state incinerator. We do not need this bill to achieve this and it is an unfunded mandate. Thank you.

The SPEAKER: The Chair recognizes the Representative from South Portland, Representative Battle.

Representative BATTLE: Thank you, Madam Speaker. Ladies and Gentlemen of the House, I'm going to ask you to support this bill. I've been the Harbor Master for the City of Portland and South Portland, and I cover southern Casco Bay all the way out to Jewell Island. I was a Deputy for 14 years; I've been the Harbor Master now going on now over a year. Every year, I get dozens, hundreds of calls or stopped along the way. People ask me, "What am I to do about flares?" I checked with local fire departments and I'm almost certain, at one point. I checked with the Fire Marshal's Office. I may not have, but I thought I had. And doing the same thing when I was in the Coast Guard. We have hundreds and hundreds of these things around the state that we need to properly dispose of and that's what this bill starts a program going forth, for safety sake, moving forward. Please support the bill. We need to clean this mess up before it becomes a major nightmare. Thank you.

The SPEAKER: The Chair recognizes the Representative from Limington, Representative Kinney.

Representative **KINNEY**: Madam Speaker, Ladies and Gentlemen of the House, I rise in opposition to the pending motion. I have boarded hundreds of vessels representing the United States Coast Guard. A vessel is only required to have three flares onboard to meet the minimum federal requirements. When I ran across expired flares, I would tell the owner of his vessel, or her, "Please, you need to replace your flares. But please do not throw out or utilize your old flares because in an emergency, 20 or 30 flares at a time might not be enough to save your life." Thank you.

The SPEAKER: The Chair recognizes the Representative

from Harpswell, Representative McCreight.

Representative McCREIGHT: Thank you, Madam Speaker. This bill started when I was asked a question by a Harpswell lobsterman who said, "What do I do with my expired flares?" And like most constituent questions, I thought I could answer it in a day, maybe two. But, what I discovered was, going online, talking with the agencies involved with boating, both commercial and recreational, the answers that are out there are incorrect, illegal, contradictory, and just plain wrong. So, I set about finding out what could be done. We have, as someone mentioned, we have basements, sheds, garages full

of expired flares because, as was also mentioned, you are required to carry them if you have a boat over 16 feet and for recreational boaters, if you are in certain waterways. So, in 42 months, they expire, you keep a few onboard. But if you've been fishing for 20 years or boating for 20 years, you have more than a few. You have dozens. And in the state, because these are required by state and Coast Guard federal law, we have thousands of them. Working with others interested -recreational boaters, lobstermen, Coast Guard, Coast Guard Auxiliary, fire chief -- we came up with a proposal that I spoke to the Fire Marshal about on multiple occasions. He was very supportive. When it came to the hearing, he did testify against the specific plan that we had. So, we made an amendment, which he fullheartedly supported. I would add too that this was very carefully crafted to cost no money. So, I disagree that it is an unfunded mandate. The Fire Marshal, or the Department of Public Safety, owns a federal, an FDA approved incinerator. This is the best way to get rid of flares. All the information on websites tells you to do things that cause pollution, cause you to be unsafe. So, the Fire Marshal fully agreed. He didn't like the idea of them being taken to fire departments. He wants to pick them up. He will incinerate them in his FDA approved incinerator. He has magazines where he can store them until he's ready to incinerate them. But, I would also point out that he did mention that he's been able to do this; however, I can tell you from my dozens of conversations with boaters, with commercial fishermen, with harbor masters, with agency heads, no one knows about it. So, the second half of the bill requires the agencies, any agencies involved with boating, to put this on their websites. No additional cost, they already have websites. And the next time they print -- they're going to print anyway, so no additional cost -- the next time they print, to put this information there. I would also propose that this is important that this go into statute because as generous as our current Fire Marshal is about being willing to pick up flares, he won't be the Fire Marshal forever. So, we need this to be in statute for the protection of people and property and to protect the cost that could come from any disaster. Thank you very

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Schneck.

Representative SCHNECK: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House, I rise in support of the pending motion. Representative Hanington, of Lincoln, and I were approached by a group of rural Maine driving schools to undo changes to the learner's permit process enacted in the prior Legislature. This bill, "An Act To Allow Learner's Permits To Be Issued by Driver Education Schools," seeks to allow driving schools to once again issue the learner's permit to students who have actually completed the requirements to begin student driving. This bipartisan legislation simplifies the lives of rural parents and students. It's optional for the driving schools, and it's supported by the Secretary of State's office and the Bureau of Motor Vehicles. As the most rural state in the nation, proposed legislation works best when it takes into consideration the extreme difference in population density from south to north. Testimony received in committee heavily favored support of LD 877 by legislators, instructors, students, and the Bureau of Motor The process included input from rural driving schools, parents, and students. As a result of changes enacted in the 126th Legislature, driver education schools are no longer able to issue learner's permits. The process to obtain a learner's permit now requires that a teenager complete a driver education course. Upon completion of the course and written exam, the teenager must go to a Bureau of Motor Vehicles office to complete the process for the learner's permit. Consequentially, more than 14,000 learner's permit applications for process had to be transferred to the Bureau of Motor Vehicles at the time the current law was enacted. This large number of learner permit transactions, formally handled by the schools, had to be moved to BMV Offices, increasing pressure on those offices. We are told that rural driving schools are hearing from many parents about family hardships incurred as a result. They talk about problems getting teenager student drivers to rural BMV Offices to apply for the learner's permit, especially with both parents working and students involved in after-school activities. For some families, missed work time to get a teenager to the BMV during business hours means lost pay. Additionally, the delay between completion of the course requirements and finally being able to get to a motor vehicles office may cause driving students to lose some of what was learned in class. I hope you will agree with me that making this change is the right thing to do. Thank you, Madam Speaker,

The SPEAKER: The Chair recognizes the Representative from Oakland, Representative Perkins.

Representative **PERKINS**: Thank you, Madam Speaker. Thank you for allowing me to speak on this. In our driver's education world, many parents have to after they receive their

permit, after they receive their certificate, then the parents have to drive maybe an hour, hour and a half to take and get their child a permit. Every dollar counts nowadays. Every dollar for the parents, it might be a single mom, it might be a single dad to take time out of their heavy work schedules to drive to Augusta, or to drive to Rumford, or to drive to Bangor. Maine is still a very rural state north of Portland. And we need to help our parents and as elected officials, all of us, that's what we are here to do, is help our constituents, to help our people, to help our people from Maine to make a little bit more money to make life a little bit easier. Back long ago, a number of people from another committee said, "Jeez, they don't want to do this. They don't want to hire anybody extra to issue permits." The system the Secretary of State has inline, all set up, it would be very easy and very cost efficient. Thank you, Madam Speaker, for allowing me to speak.

The SPEAKER: The Chair recognizes the Representative from East Machias, Representative Tuell.

Representative TUELL: Thank you, Madam Speaker. I also rise in support of this legislation and I think that's quite ironic given that I could never get a driver's license. Having said that, I did work in the local location where our BMV Office rented space. And routinely, what you would see is, you would see people lined up, up and down the hall, waiting in line patiently to get their driver's license, get it renewed, get a driver's test, whatever the case may be. And you would hear all this chatter in the hall and it was, routinely, you would hear parents saying they had to take a day off from work, and whatnot, to go take their kid to this driver's to finish up. So, I guess what I would say is a lot of the rural areas don't have a fulltime BMV Office. They have a mobile office and sometimes they have to set an appointment up and it really is quite harder than I think it needs to be. So, I will be supporting this. Thank you.

The SPEAKER: The Chair recognizes the Representative from Glenburn, Representative Guerin.

Representative **GUERIN**: Thank you, Madam Speaker. Ladies and Gentlemen of the House, I stand in support of LD 877 as a win-win. As someone who is careful when spending taxpayers' money, I see the first win: less time for BMV employees. And as the mother of five children, I see the second win: less time commitment for parents and children with busy schedules. Thank you.

The SPEAKER: The Chair recognizes the Representative from Lincoln, Representative Hanington.

Representative HANINGTON: Thank you, Madam Speaker, Ladies and Gentlemen of the House. First of all, I'd just like to bring to your attention my daughter got her permit two days and she was going to miss the mobile office when it comes to Lincoln once a month, well, at the Congo Church. So she, as most teenagers, you're impatient. So yes, we spent a hundred dollars. We could afford it. Jean took off time, Sarah took off time from school and she went to Bangor and she got But as the good Representative Schneck mentioned, he and I was approached, and this was the same bill that was put in last year and it was defeated by the rural driver's education schools. The owners of these schools came to us in hopes that we could submit legislation to undo the burdensome changes made to the learner's permit process enacted by the prior Legislature in the 126th. LD 877 would once again allow learner's permits to be issued by the driver's education school, once students have successfully completed the requirements to begin student driving. This bill is bipartisan and it makes it easier on parents who have children that are of age to begin driving. Under current law, driver education

schools are no longer allowed to issue learner's permits. In the past, driving schools were able to give students the test and upon successful completion, these students left the school with a permit in hand. Once again, once the student completes the course and passes a written exam, the student must go to the Bureau of Motor Vehicles to complete the process and collect their permit. This is burdensome. For some who live in rural areas of the state, the BMV are generally not right around the corner. Parents are forced to take off a day from work, in some cases a whole day, to bring their child to the BMV. Maine is one of the most rural states in the nation. This proposed legislation takes into account considerable differences between the more urban and rural portions of our state. It may be easy for parents to drive the child to the BMV in Portland, Lewiston or Bangor, but currently isn't easy in my neck of the woods. It is important to keep in mind that the BMV will still have the option and the authority to issue leaner's permits, as this change is not mandatory for driving schools. The passage of LD 877 would remove the estimated 14,000 permit transactions from already timely strapped BMV Offices. Why not give the permitting process back to the schools that were able to efficiently process these transactions? This is going to be a, if this passes, this is going to be just the opt in or an opt out. And I feel that it would generally help, you know, the families that are strapped with income. Thank you.

The SPEAKER: The Chair recognizes the Representative from Dixfield, Representative Pickett.

Representative **PICKETT**: Thank you, Madam Speaker. Ladies and Gentlemen of the House, every now and then a piece of legislation comes around that really does provide some real relief for our constituents. In this case, I think it provides relief for those in the rural areas of our state for the many reasons that have been stated by the previous speakers. This is one of those and I really think we owe it to these people with busy schedules, these people that are burdened to have to go and take time out of work and all the other things we've heard, to pass this bill and move it through to give them the relief they deserve. Thank you.

The SPEAKER: The Chair recognizes the Representative from Newcastle, Representative Devin.

Representative **DEVIN**: Thank you very much, Madam Speaker. Madam Speaker, Men and Women of the House, I just want to let everyone know that Lincoln County does not have a motor vehicle branch office nor do we have a motor vehicle mobile unit location. Consequently, I will be supporting LD 877. Thank you very much.
