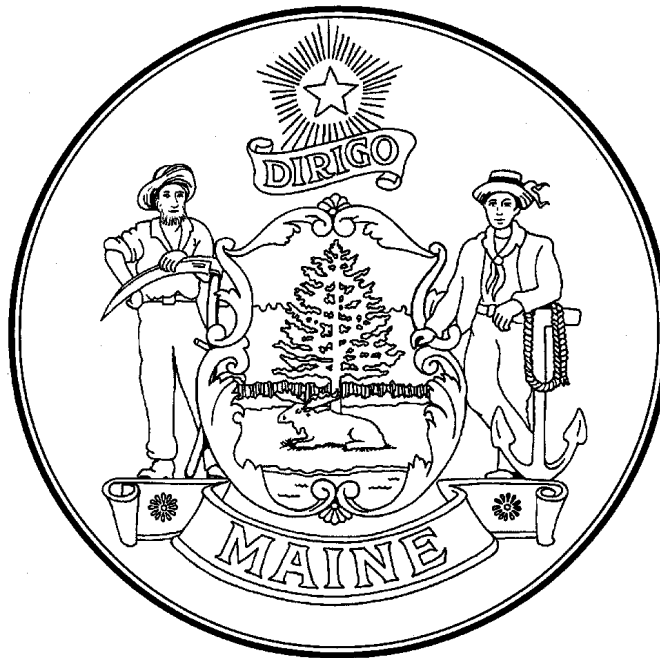

The **SPEAKER:** The Chair recognizes the Representative from Monmouth, Representative Ackley, who wishes to address the House on the record.

Representative **ACKLEY:** Thank you, Madam Speaker. Madam Speaker, we are here on the first day of a state shutdown. It's a Saturday and I'm here to work hard. I'm a son of Monmouth and have been luckily adopted by the towns of Litchfield and Wales, as well, and they are in total 9,000 citizens, 300 of which are state workers. Madam Speaker, I'd like them to know, I'd like you to know, that I am ready to come back tomorrow, I'm ready to come back the day after that. It's important for the people that I serve to know that I'm here for them and ready to do what is right for the people of the State of Maine and the people of Monmouth, Litchfield, and Wales.

The **SPEAKER:** The Chair recognizes the Representative from Farmington, Representative Harvell, who wishes to address the House on the record.

Representative **HARVELL:** Thank you, Madam Speaker, Ladies and Gentlemen of the House. Some of you know me from prior sessions, some of you have just met me but, you know, if we don't really know people very closely in our lives, we don't know what happens to them. We exercise power in this building and we do it every day. We tell people what they can put on bottles. We tell them how fast they can drive. We tell them what they can hold when they're driving. We set the speed limit and we make policies that affect every single person here, and some of the policies that affect people affected me two years ago. I lost my job, some of you know that, some of you don't. It's not anything I'm greatly... It concerned me, it concerned my family. It's an adjustment I'm making. But, because we exercise power, and because we have egos, and we are in a fish bowl, and we get tired, our passions start to take control of us, and it's not a good thing for anybody; because we cannot get a divorce. At some time, we are going to have to come together, and we better make it sooner than later, because we can't get a divorce. It's not like getting rid of your spouse, you never see them again. We're going to be here every day until it happens and after it happens. Two thousand years ago, in Isaiah, God said "Come, let them reason together." And if God can bridge that divide between humanity and mortality, that 10 feet isn't all that much.
