Representative **GUERIN**: Thank you, Madam Speaker. I would just like to say that I will be voting against the pending motion. The good Secretary of State is able to study this and bring forth laws anyway, and I would encourage him to do so without the necessity of having a formal study.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Portland, Representative Moonen.

Representative MOONEN: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House, I rise in support of the pending motion, and to respond to my colleague and friend from Glenburn, she's absolutely right. Secretary of State's office can study any issue that they'd like without a resolve telling them to do so. However, there are reasons why we pass resolves telling people to study things. one of those being that, for a Department, the cloture deadline is generally much earlier than it is for us. So, for example, in the first year of the session it's typically early December. This resolve would authorize the report to come to us on January 15th, so this gives the Department more time to properly complete their study, issue a full written report and bring it to our Committee for us to take action on it. Another thing that -a reason that we pass resolves is that it notifies people who would be affected that their laws are under review. So there's a lot of notaries in this state, it's really important that they be aware that there's a comprehensive study of every law that affects them going on, so that they can participate in that

Finally, this is a proposal to study the uniform law, which is a law proposed nationally by commissioners from all across the country, and when we get a report back on this, we actually want a written report that explains why the Secretary of State's office recommends that we do adopt certain portions of the uniform law, and why they recommend that we don't adopt other portions of the uniform law. Otherwise, we're going to be kind of flying blind in terms of having a written record of why they think we should do certain things or why they think we shouldn't, and it's really important that our notaries in Maine have an explanation for why we're changing that. So, the value of a written report is really important and, of course, the resolve provides more time, so that's why we'd like to pass this, but, at the end of the day, we'll get a study either way. Thank you, Madam Speaker.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, I'd like to start off by requesting a roll call on this item, and I would start off by recognizing that in the work of the --

The SPEAKER PRO TEM: The Member will defer.

The same Representative REQUESTED a roll call on ACCEPTANCE of the Unanimous Ought to Pass as Amended Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER PRO TEM: The member may proceed.

Representative FREDETTE: Thank you, Madam Speaker. Ladies and Gentlemen of the House, first of all I'd like to thank the work of the Marijuana Implementation Committee for their hard work on this. As people know and recognize, this is a very complicated issue. You are essentially taking something that has been illegal, and is still federally illegal, and trying to create a whole new system for planting, growing, distribution, testing, retail, and whatnot. And so, to recognize that this is difficult work in and of itself, and has taken time. I don't believe reflects poorly upon either the Committee or the Legislature. because this is tough stuff. I also want to recognize a bill that we previously passed in the last Legislature, whereby the Chief Executive in negotiations with leadership, a bill was passed whereby the Chief Executive had requested, and a bill was passed, that we set aside a certain sum of money, I believe it was about \$1.4 million, so that the Chief Executive, upon the passage of a bill, could hire professionals to do required rulemaking. Now, I am certainly open to a suggestion from anyone in this body that thinks that rulemaking can happen in 30 or 60 or 90 days. If anyone thinks that that's possible, I'm certainly open to having someone discuss that before this body. The Chief Executive has called me and he's indicated to me he believes that rulemaking will take at least nine months. So, in regards to this issue, in regards to the passage of this bill --

The SPEAKER PRO TEM: The Member will defer. The Chair will remind members that you cannot refer to the Chief Executive during debate and his actions during debate. Thank you.

The Chair reminded all Members that it was inappropriate to question the motives of the Chief Executive.

Representative FREDETTE: Thank you. And, so, as we look at this bill, we do know that we need to pass a law in order for rulemaking to happen. That's essentially how this process works. I understand from our members on the Committee that they have been working diligently since we came back into session, and I would point out that today is February 1, 2018, which is the date for the expiration of the prior moratorium that was passed by this body, the other body, and signed by the Chief Executive; and so, as we speak, there is no moratorium in effect. It is also my understanding, and I can stand to be corrected, that to a certain extent, licenses cannot be issued by anyone because we don't have any rules yet. And so, part of this is a little bit bureaucratic stuff that we need to do, and whatnot. And so, my point is this: I believe that the work of the Committee is going to continue to be ongoing. I think we can speculate whether or not -- today we know that we do not have a moratorium in effect, and we know that they can't issue licenses because there is no rulemaking. I think we need to let the Committee go back to work. I suspect that when we ultimately see a bill come forward, it probably will have some language in it regarding extension of a moratorium. I suspect we'll have some lively debate on it at that point in time, but until that happens, I am not going to support an extension of this moratorium bill until April 18, 2018. I feel as though it puts us in a little bit of a box in order to pass another bill, so I think we can continue to rely upon the Committee to continue to do its due diligence and its hard work, and so I will not be voting in favor of this bill, and I ask you to follow my light. Thank you.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Falmouth, Representative Pierce.

Representative PIERCE: Thank you, Madam Speaker Pro Tem. I stand in support of LD 1775 and want to speak to my remarks on that. Thank you. The Joint Select Committee is back to work after the failure of 1650 to pass last session in the fall, in our Special Session, and we've been considering many of the objections that were -- that came about on the opposition to this bill. We've been meeting with the executive branch, stakeholders, members of this esteemed body and the esteemed body down the hall in order to find compromise and consensus to move forward, to get something passed for the people of Maine. We unanimously voted this short-term moratorium out of Committee for the mere fact that we are working hard, we anticipate a bill coming back soon; but if we don't have a short-term moratorium in place, we are unable to really protect our municipalities, and municipalities are confused, they're wondering what's going on, they're asking us to lead, we haven't passed a bill, and the short-term gives them some comfort that while we're doing our work that they -- that we have that in place. I think what's most important here is that we will be bringing a bill back that will work to provide

public health safety for our kids and our communities, and this short-term moratorium offers the opportunity for us to do that work, do it diligently, bring it back to this body, while also making sure that our communities feel that they're cared for in this interim time. Thank you.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative FREDETTE: Thank you, Madam Speaker. May I pose a question through the Chair?

The SPEAKER PRO TEM: The Member may proceed.

Representative FREDETTE: Thank you, Madam Speaker. My understanding is that this is an emergency bill, and therefore would require a two-thirds vote of those voting and present; is that correct?

The SPEAKER PRO TEM: Upon Enactment, the member is correct. A roll call has been ordered. The pending question before the House is Acceptance of the Unanimous Ought to Pass as Amended Report. All those in favor will vote yes, those opposed will vote no.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Topsham, Representative Tepler, and inquires as to why the Member rises.

Representative **TEPLER**: Madam Speaker, I would appreciate, and I suspect many other members of the body would appreciate, clarity about a yes or a no vote.

The SPEAKER PRO TEM: The Chair will clarify. A vote of yes is in favor of the House Accepting the Unanimous Committee Report. A vote of no will be in opposition to the Unanimous Committee Report.
