#### **SENATE PAPERS**

The following Joint Resolution: (S.P. 680)

JOINT RESOLUTION RECOGNIZING FEBRUARY AS 2-1-1

MONTH

WHEREAS, 2-1-1 Maine is a comprehensive statewide directory of more than 8,000 health and human services available in the State; and

WHEREAS, in order to promote the 2-1-1 Maine health and human services and emergency preparedness helpline, which provides Maine citizens free and confidential referrals to needed resources, we recognize February 2018 as 2-1-1 Month; and

WHEREAS, 2-1-1 Maine helps to identify existing gaps in health and human services; and

WHEREAS, throughout the State, 2-1-1 Maine provides around-the-clock service through efficient and effective responses to questions arising from the growing complexities and needs in health, financial and human services; and

WHEREAS, 2-1-1 Maine provides emergency operations during times of natural and other disasters, including providing accurate and timely information for preparations and longer-term referrals for follow-up services, as evidenced by its role in supporting the Maine Emergency Management Agency during the agency's responses to the 2016 drought and the October 2017 wind storm; and

WHEREAS, during this past year, 2-1-1 Maine has directed nearly 6,500 Maine citizens to heating and utility assistance services, which may have prevented people from contacting the wrong agency for a federal Low-Income Home Energy Assistance Program benefit, prevented utility shutoffs and saved people from spending winter nights without fuel; and

WHEREAS, since 2006, 2-1-1 Maine call specialists have assisted with more than 700,000 requests to locate health and human services information; and

WHEREAS, 2-1-1 Maine handles a number of specialized services, including the opiate helpline and the gambling helpline, and is also a resource for finding information about such needs as tax preparation and mental health services; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-eighth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize February 2018 as 2-1-1 Month.

READ.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Presque Isle, Representative Stewart.

Representative STEWART: Thank you very much, Madam Speaker. Ladies and Gentlemen of the House, I just wanted to take a brief moment to stand and recognize this Joint Resolution recognizing February as 2-1-1 Month. Some of you may be familiar with the organization. I think we've had some information about them distributed in this chamber before, but I got to work up close and personal with some of their organization in my work on the Opioid Task Force in the past year. There's new leadership in the organization, and I'm very optimistic at the vision which the organization has and its upcoming role that it will be playing in our state. I think, personally, I view this organization as an ally for folks in need of help, and whether that's talking about homelessness, drug addiction, or some other issue that government may be able to assist with, and help folks across the state with those battles that they're facing. So, in that, I would request that you join me in thanking, and recognizing, and helping to spread the word about 2-1-1 and all they do for our state. Thank you.

Subsequently, the Joint Resolution was **ADOPTED** in concurrence.

The following Joint Resolution: (S.P. 683)

#### JOINT RESOLUTION SUPPORTING MAINE CEMENT MANUFACTURING AND OPPOSING SUBSIDIZED FOREIGN CEMENT IMPORTS

WHEREAS, the Dragon Products Company cement plant in Thomaston is the only cement manufacturer in Maine and in all of New England; and

WHEREAS, Dragon Products Company directly employs over 100 citizens of the State in the process of manufacturing cement from limestone and Dragon Products Company's manufacturing operations directly or indirectly support over 500 Maine jobs; and

WHEREAS, the Canadian Province of Quebec has subsidized the construction of McInnis Cement's new 2,000,000-ton per year capacity cement manufacturing plant in Port-Daniel-Gascons, Quebec; and

WHEREAS, both McInnis Cement executives and Quebec officials have stated publicly that there is no Canadian market for the new plant's cement production and that over 90% of the new plant's production will be exported to the United States to compete directly with Dragon Products Company and other domestic cement manufacturers; and

WHEREAS, McInnis Cement has completed construction of a deep-water cement import terminal in Providence, Rhode Island to serve the Boston, Massachusetts and southern New England cement markets and is building a 2nd deep-water cement import terminal in the Bronx, New York City to serve the New York and New Jersey cement markets; and

WHEREAS, McInnis Cement started manufacturing cement in July 2017 and shipped its first vessel of subsidized Canadian cement to its Providence terminal in August 2017; and

WHEREAS, the subsidized Canadian cement being exported by McInnis Cement to the United States poses a threat to the continued operations of the Dragon Products Company cement plant in Thomaston and the hundreds of Maine jobs directly or indirectly supported by the plant; now, therefore, be it

RESOLVED: that We, the Members of the One Hundred and Twenty-eighth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to:

- 1. Condemn any violation of international trade laws and treaties between the United States and Canada;
- 2. Express our full support for the efforts that may be undertaken by domestic cement manufacturers to bring countervailing duty and antidumping petitions against McInnis Cement before the United States Department of Commerce and the United States International Trade Commission:
- 3. Support international trade litigation against McInnis Cement through all appropriate means to preserve Maine cement manufacturing jobs and to enforce the international rule of law against subsidizing exports and dumping products into the United States; and
- 4. Support the efforts of Maine businesses and local governments to purchase, to the maximum extent possible, Maine-manufactured and other domestically manufactured cement for use in all public and private construction projects across the State.

Came from the Senate, **READ** and **ADOPTED**. **READ**.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Brooksville, Representative Chapman.

Representative CHAPMAN: Thank you, Madam Speaker Pro Tem. Actually, I may have jumped the gun just slightly here. I wanted to speak to this matter; is this the appropriate time to do so? Thank you. The Joint Resolution before us provides the opinion of the Legislature, communicating it outward, and the Legislature does so in many forms and many ways for many reasons. I'm a little concerned that the resolution before us makes specific reference to a specific company, at this -- in support and a specific company in a denigrating fashion. This is a little unusual and might seem unseemly. On the other hand, the thing that really bothers me about the Joint Resolution before us is that it asks for -- I mean, it expresses a support for litigation and, in fact, takes an opinion on which side of the litigants should prevail in a judicial matter. And the thing that is of concern to me is that every member of the -- of this body has sworn an oath or made an affirmation to support the Constitution, the structure of which calls for a clear division of separation of the branches of government that are separate and equal; and this, in my mind, is treading on the part of the business of the judicial branch, rather than the legislative branch. And, further, Madam Speaker Pro Tem, I think that the matter of the oaths of office to which we are all subject are counter -- are symmetric with the constitutional provisions for impeachment to which all elected officials are subject, and it seems to me that I would feel that if I were to vote in favor of this, which asks to do something that is in the judicial branch rather than the legislative branch, I would feel that I was violating my affirmation of office and would therefore be committing an impeachable offense. So, for that reason, I'm going to ask for a roll call on this matter so that I can register my disapproval. Thank you, Madam Speaker.

The same Representative **REQUESTED** a roll call on **ADOPTION**.

Fewer than one-fifth of the members present expressed a desire for a roll call which was not ordered.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, I oftentimes don't find myself on the same side of an issue as Representative Chapman. I am concerned with some of the language in this particular bill and some of the items that it specifically lays out. I guess I'm -- in reading this, I think about

the blueberry industry in Maine which, by and large, had been the only real player in the blueberry market for some time, and now, today my understanding is is that a lot of Eastern Canada now is very aggressive in the blueberry market, which is changing the role in what Downeast Maine, for example, has to deal with with blueberries. And, so, as I read this, I find some concern, along with the good Representative from Blue Hill, and I'm going to ask that this item be Tabled to later in today's session.

The same Representative moved that the Joint Resolution be **TABLED** until later in today's session pending **ADOPTION**.

The SPEAKER PRO TEM: That motion is not in order at this time. A Tabling motion is not debatable. You can't make the debate and then move the Tabling motion.

Subsequently, the Chair  ${f RULED}$  that the motion was  ${f OUT}$   ${f OF}$   ${f ORDER}$ .

On motion of Representative SANDERSON of Chelsea, **TABLED** pending **ADOPTION** and later today assigned.

The following Joint Order: (S.P. 685)

ORDERED, the House concurring, that the Joint Standing Committee on State and Local Government shall report out, to the Senate, a bill requiring Legislators, legislative staff and lobbyists to personally attend and complete a course of education and training regarding harassment, including sexual harassment, at the beginning of every legislative session.

I am pleased to submit on behalf of the Board of Trustees of the Maine Community College System (MCCS) the attached report on certain procurements, contributions, and policy changes for the period July 1, 2016 through June 30, 2017 as required by 5 M.R.S.A. §12023.

To report the information required by §12023, MCCS developed a customized reporting feature in the business management module of our information systems for each of the seven colleges and the System Office, and then fed that module with data from the purchase order, cash disbursement, and credit card systems. Combined, the seven colleges and the MCCS System Office make tens of thousands of purchases and expenditures each year. While the task of reporting on these transactions is complex, our review indicates that the colleges' compliance with existing policies is extremely high, and expenditures are consistently mission related. In those few areas where we have identified need for improvement, refinements have been made or are under way.

MCCS will continue to use its internal controls and annual outside audit to adapt its systems to changing needs, and our Board of Trustees will continue its own ongoing attention to these matters at its regular meetings.

As indicated in the enclosed report, the WCDA did not make any significant procurements, contributions or changes to policies and procedures in the past year. In March 2015, the Authority was given the commercial side of the former base by Cutler North, LLC, a private developer that had failed in its redevelopment effort. The WCDA now owns roughly 20 acres and five commercial buildings comprising 75,000 square feet. The Authority is working to bring these facilities back into productive use.

and a privilege for me today to stand and recognize my friend, fellow community member from Dover-Foxcroft, Luis Ayala.

I'd like to tell you a little bit about Luis. It's not just the 400 wins, it's about his life experience. Luis came to this country when he was nine years old. When he was old enough, he joined the United States Army and served honorably on behalf of our country, and to his good fortune, met his wife there. She brought him back to Dover-Foxcroft. After he suffered through a bit of cultural shock here in Maine, during his first winter, I think he settled in very nicely. He has with him today his wrestling team. As you heard, he's won over 400 contests and his wrestling team this past weekend won the Penobscot Valley Conference wresting championship. He's won 12 out of the last 20 championships in that league.

This past year his name was put forth for the U.S. Cellular National Coach of the Year award. Luis is a very humble man. He said, "Thank you very much," and I think that he would've preferred at the moment to leave it right there; but not his community. So, his community rallied around him, and through online voting, Luis became one of 15 finalists. U.S. Cellular came to Foxcroft Academy, big celebration, awarded a \$5,000 check, and I think probably Luis thought that was the end of it; but it wasn't. Signs went up on lawns like it was a political campaign in town. The community rallied around him, his former players, parents; and, at the end of the day, with 15 finalists, Luis finished first. But you have to do more than just win the online contest, if you will. He submitted a resume, if you will, of his accomplishments. It was viewed by several national prominent names, Kurt Warner being one of them, looking at what kind of an impact did you have on your school? What kind of an impact did you have on your community?

Luis is well-known as one who coaches multiple -- multiple soccer teams, multiple wrestling teams. In fact, I think we need to add another finger to each hand so he can keep track of the number that he's coaching at any given time. He's an outstanding, outstanding coach. But I think, more importantly, the testimonies I hear from people in the community and his former players, is Luis has a special knack for reaching out to those students who really don't have an advocate, who do not have a role model. His living room is oftentimes filled with pizza and laughter and support for young men that lack that in other places in their lives. So, it is with great pride that I stand today on behalf of the Dover-Foxcroft community, as a member of the Board of Trustees at Foxcroft Academy, where Luis works. We're all very proud of Luis Ayala and his athletes on behalf of our area. Thank you, Madam Speaker.
