Dear Honorable Members of the 128th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 1725, "An Act To Ensure Stability for Certain Holders of Liquor Licenses."

This bill was originally intended to clarify liquor licensing law to provide more flexibility related to ownership structure for in-state manufacturers that also want to operate a restaurant. Under our old law, the structure was required to be exactly the same for both entities. If a manufacturing operation was owned 60-20-20 by three business partners, that ownership split would have been required to remain the same for an associated restaurant. In the first regular session of the 128th Legislature, LD 1642 resolved ownership issues between a manufacturer and its associated restaurant, allowing more varied ownership structure of the two entities.

Rather than address any perceived problems, this bill actually creates a new problem. It would create inequity among in-state alcohol manufacturers who also have an interest in a restaurant, based solely on when they were licensed—holding any new licensees to a different standard than those who were licensed prior to January 1, 2018. LD 1725 does not add any further protections to manufacturers and is simply not necessary. If enacted, there would not be equal protection under the law for licensees.

For these reasons, I return LD 1725 unsigned and vetoed. I strongly urge the Legislature to sustain it.

Dear Honorable Members of the 128th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 1476, "An Act To Ensure Continued Coverage for Essential Health Care."

This bill presupposes that we have a crystal ball with which to foresee the future of health care in Maine. Speculation, especially in health care, rarely produces good results. Moreover, without knowing what economic and federal regulatory conditions will drive health policy in the future, it would be imprudent to limit the discretion of policy makers.

In passing this bill, the legislature decided to ignore our current challenges and worry about possible future policy issues, proving—yet again—that their priorities are misplaced.

I stand by my opposition to the Affordable Care Act. I will not sign into Maine law the same provisions that have made the Affordable Care Act a disaster at the federal level.

For these reasons, I return LD 1476 unsigned and vetoed. I strongly urge the Legislature to sustain it.

**JOINT RESOLUTION HONORING IRISH HERITAGE**

WHEREAS, millions of Irish people emigrated from Ireland in the 1800s to escape brutal poverty and starvation due to the Irish potato famine, and most of those people came to America to start new lives and to embrace and contribute to a new land; and

WHEREAS, tens of thousands of Irish immigrants arrived in New England and many came to Maine, and the Irish have been and remain an important part of Maine's culture, history and society; and

WHEREAS, within a few years of their arrival in the United States and in Maine, these Irish immigrants became part of the American cultural landscape while preserving the best of their native culture, and they dedicated themselves to helping build this State and Nation; and

WHEREAS, 4 signers of the Declaration of Independence were Irish-born and 9 signers were of Irish ancestry and 19 Presidents of the United States have proudly claimed Irish heritage, including George Washington, the father of our country; John Fitzgerald Kennedy; Ronald Reagan; and Barack H. Obama; and

WHEREAS, the over 33,000,000 Americans of Irish ancestry, like their forebears, continue to enrich all aspects of life in the United States, in science, education, art, agriculture, business, industry, literature, music, athletics, entertainment and military and government service; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-eighth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize the valuable contribution to our State and to our Nation of all Irish-American citizens and we urge the citizens of the State to commend and celebrate the integrity and richness of the Irish culture.

**READ.**

The SPEAKER: The Chair will remind Members of the House and guests in the House that the House will be in order. The Chair recognizes the Representative from South Portland, Representative Reckitt.

Representative **RECKITT**: Madam Speaker, Honorable Members of the Maine House. I am pleased to thank each and every one of you, and I mean each and every one of you, who agreed to be part of this resolution honoring Irish heritage. We are Mainers, and the people of Ireland are similar in that we work hard, face adversity, but in the end our spirits rise to the top and we come together.

Today, my father's Irish blue eyes are no doubt smiling, and were he alive today, you would have been treated to his outstanding baritone voice singing the National Anthem. It is especially significant this year because on April 5th, there will be a celebration marking the anniversary of the Good Friday Agreement, 20 years of peace and progress in Northern Ireland. Maine's own George Mitchell played a crucial role leading that process by encouraging conversation and cooperation from all sides.

I first met Senator Mitchell years ago when he lived in what is now District 31 in South Portland, the one I am privileged to represent. We may occasionally feel divided by politics here in the Maine House, statewide, and nationally; however, the conversations I have had with each and every member of the House and Senate have reminded me to my core that we are all reaching every day for what we feel is best for Maine. So, this afternoon at 1 p.m. in the Hall of Flags, come join my friends from the Maine Irish Heritage Center, Irish dancers and musicians and sportsmen, and enjoy tea and Irish soda bread, and get a head start on all the rest of the citizens of Maine who must wait until Saturday to be Irish for a day. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Waterville, Representative Madigan.

Representative **MADIGAN**: Thank you, Madam Speaker. Men and Women of the House, I am a member of the Irish diaspora. My family emigrated here, well, my grandmother and many members of my family emigrated here, but she came here alone when she was 16 years old, by herself, and began her life here. My grandfather also came here at a very young

age. I grew up in a large extended Irish-American family and community, so much so that I didn't even know, until I was probably later on in elementary school, that not everybody had a big parade, you know, their family members marched in. I grew up listening to stories told to me by my grandmother about leprechauns and banshees, and as a child I was afraid of leprechauns because I thought they caused mischief in my house. So, anytime anything happened, I blamed it on leprechauns.

The SPEAKER: The Representative will defer. The House will be in order. The Representative may proceed.

Representative **MADIGAN**: Thank you. My grandmother loved this country, she loved it fiercely, for the opportunities it gave to her. It gave her so many opportunities. She had six kids. I had the privilege of, when I was about ten years old, returning to Ireland with her and my Aunt Rosemary, who just died two days ago, so they could show me the village where my family lived for hundreds of years. I was lucky to see the house where she was born in, milked the family cows, chased the family chickens and gathered eggs, to see that she really did walk a lot, a very long way to school every day. That family farm is about 11 miles from the border with Northern Ireland, so the Good Friday Agreement is very important to me because it certainly helped my family.

My grandmother left a country wracked by hundreds of years of desperate poverty and violence and war to come here, and I think that's what makes America great, is that people come here and build their culture and share it with everyone here and we become something stronger for it. So, thank you very much.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Collings.

Representative **COLLINGS**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I wanted to congratulate Representative Reckitt from South Portland for the great job she did helping organize this event and also want to remind people that we have a lot of activities around the state, particularly in Portland. On Saturday, at the Irish Heritage Center, which is on the corner of State and Gray Street, if you meet around 8 a.m., we're going to march down and raise the Irish flag at the West End; and if you'd like to see the Saint Patrick's Day parade, it will be noontime in Portland, so anywhere on Commercial Street you'll be able to see that. And it's a special day for me, having a lot of Irish background on both sides of my family, particularly my mother's, who a lot of the family came right before the Civil War and were -- one of my great-great grandfathers was in the Civil War and he played the bugle when they charged; and my youngest son heard that, and he's like "What's so great about playing the bugle? That's not that great." And I said, "Well, if you want to go play a bugle while people are shooting at you, then..." but, anyway. So, I'm very proud of my family and the rich tradition of Irish in this country, and like all the immigrants in this country, we make this country great; and so proud to be an Irish-American. Thank you.

(H.P. 1238)

TABLED - January 23, 2018 (Till Later Today) by Representative BEAR of the Houlton Band of Maliseet Indians. PENDING - **ADOPTION.**

The SPEAKER: The Chair recognizes the Representative from the Houlton Band of Maliseet Indians, Representative Bear.

Representative **BEAR**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. It's an honor to rise today to ask that we honor Tribal Chief Commander for her achievements and contribution to our people and to the State of Maine over this past several years of service that she's performed.

Chief Commander is one of the reasons I am here today, working with this body and other tribal representatives and leaders. I was able to come down and represent our perspective on the many issues. She was the primary motive - - motivator for this happening. And, as an example of how she had sought to make sure that we were part of important forums on the issues, I have here a record of a meeting she had with the President of the United States, where she reminded him that the United States had political and legal obligations to defend the tribe from harm, and that she felt that this wasn't being done as much as it could've been/should've been, and that much of what the tribe had accomplished under her leadership was by people rising up in the tribe itself and with Wabanaki neighbors to assist us. She was specific, though, in that when she reminded the President that he should know that "the first treaty the fledgling United States executed was the Treaty of Watertown with my people," she says, "and the Micmacs on July 19, 1776. When the nascent United States was facing a global superpower in the form of the British Empire, the Maliseet people answered the call, joining you in arms to secure your country's freedom. When we were not citizens and could not vote we came as allies to your defense in subsequent wars [as well]. Now, we need [you] to come to our defense..." This is an example -- another letter to the Governor of the State of Maine in the last -- during the last session as well --

The SPEAKER: The Representative will defer. The House will be in order. As a reminder to everyone, both in the chamber and in the gallery, when any member is speaking let's please -- please afford them the privilege of silence in the chamber otherwise. The member may proceed.

Representative **BEAR**: Thank you, Madam Speaker. The letter to the Chief Executive again reminds the Chief Executive that our efforts as a sovereign government and our claims, our rightful claims, had been disregarded historically due to a lack of documentation, and that at the time there were no signed treaties available that indicated that there was a release of any claimed lands. Our intention is to seek justice. She spoke constantly about obtaining justice for our people and it is in that

sense that it is a great honor to, in her footsteps, follow her lead and to ask us to honor her today.

I also want to make a brief comment about the past resolution with regard to honoring the Irish people. We as a tribe have been influenced by the Irish, I would want to speak to this just a moment, in our language and in our stories. With us, the leprechaun would have been described as Geow-lud-mo-sis-eg, which would be the little people who in some way were protecting us, even in the dark. So my father was always telling me about how the Irish had influenced us. This may not be news to you, but it was news to me when he said that the Irish had actually taught us how to make baskets. Now, that was a surprise, that my father, a lifelong resident, he was born on the reservation, lived on the reservation, died on the reservation, would tell me, his oldest son, that the Irish taught us how to make the splint basket, a wicker type of weave. I never wanted to really talk about that, because I always thought that might help hurt our marketing, but in deference to the Irish, thank you for teaching us how to make the wicker-style woven basket. But, as you know, we also make baskets that are birchbark, and woven with awls and split blackroot and what have you; but, in deference to the Irish today on Saint Paddy's Day, and in honor of my Chief, it's an honor to ask you to honor both. Thank you.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Collings.

Representative **COLLINGS**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I wanted to rise briefly and thank Chief Commander and honor her here briefly. I worked with her for quite some time when I was a legislative aide many, many years ago in this building, and always appreciated working with her and, being from Northern Aroostook County, appreciated all the work she did for her tribe in Aroostook County and all the people she employed in the tribe, and other people that weren't tribal members. You know, she was very busy traveling around the country, advocating for the Maliseet, and as I traveled around the country for work with other tribes I used to always -- I would actually joke, because I would see her in Las Vegas or Tennessee or D.C. but I'd rarely see her in Maine, so we always would joke about that. But, you know, the Maliseet, they -- where Representative Bear is from, that community, that band is one band but they are a large group. They have tens of thousands of members over in Canada. I've enjoyed friendships with many of them, and I see in Canada they have a lot of success with a lot of businesses, and it is my hope that here in Maine Legislature we can work with the Maliseet to help create economic development for both them and the people of Aroostook County; and so for Chief Commander, I just want to say thank you for all your years of service, not just to the Maliseet and Aroostook County, but she was a person who always helped other tribes, and if there was ever an issue of social justice anywhere else she always would come and try to speak up for it. So, I'm very glad that she's being honored today, and at one point she was one of the longest-serving executives of tribes in this country and was well-regarded, and so I'm always pleased to work with her and all the tribal leaders here in the state. Thank you.

Representative **TUELL**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I want to begin by congratulating all of the Spirit of America award winners from Washington County, the Friends of Whitneyville Library,

Richard Stanhope, of Machiasport, and Kenneth "Bucket" Davis, of East Machias, on being recognized for all they have done for our small rural communities way down east. It is volunteers like each of these folks, not us here in Augusta, who keep this state rolling despite everything we throw at them, and who do so with a commitment and enthusiasm that you just can't find anywhere else. But, today, Madam Speaker, I am compelled to rise and formally congratulate a man whom I have had the pleasure of serving with on the East Machias Board of Selectmen for the past nine years; a man who has gone toe to toe with three chief executives: one Independent, one Democrat, and one Republican, inviting the small-town values that our state was built on; a man who is more known by the -- who is more known by veteran legislators and local clam diggers by his unlikely handle than by his birth name. Today, I rise to recognize Bucket Davis. Bucket went to high school with my father. I went to school with his kids. He has been working in and around and at our local schools for over 30 years, serving as selectman in town for over 20, and fishing alewives since before East Machias became a town, it seems. But, more than all of those things, Bucket has been a mentor, a champion for our county, a champion for our small-town way of life, and someone who you could always count on when you need to make sense of a complicated world around you. And, contrary to popular belief, Bucket is one of the people outside this building I listen to a great deal as well. So... I lost my place.

Back in 2009 when our town lost one of our selectmen to cancer, Bucket suggested I run. At the time, I had never served in office, and really didn't think I had what it took. Next thing I knew, I was calling town meetings to order and drafting testimony for bills here at the State House, which Bucket would then talk me into reading at public hearings and such. Five years later, it was Bucket that told me I should run for the Legislature. Now, I'll let you all be the judge as to whether that was a good thing or not, but for someone who came to Augusta to speak on everything from school consolidation to revenue sharing cuts, to property tax legislation, that was quite a jolt. I tell you all this because Bucket has helped more than one young person in their lives. I'm one, but there are many, many, many others. He has taught seventh and eighth graders how to fish and smoke alewives, and if you don't know what smoking alewives is, you've never been Downeast. He has coached basketball, played music with kids, and made our community school a community school in every sense of the word. He has volunteered for the fire department, our local Fourth of July celebration, and paid off elderly residents' property taxes in danger of losing their homes. And while some might be tempted to paint selectmen as somewhat less than reputable, Bucket Davis is the personification of the Spirit of America Award, and public service. He is honest, straightforward, and he pulls no punches, whether you are friend or foe, whether you like what he has to say or you don't. He's authentic, he's real. He's that rare breed of community leader that made our state what it is today: one not beholden to the petty intrigues and dogmas that seem to grip so much of our discussion in this chamber and the other body, but one who proudly serves the community he represents and grew up in, and gives his all doing so, whether it is easy going or a raging blizzard like we've had the past couple days.

Madam Speaker, Ladies and Gentlemen of the House, the next time you see Bucket in the hall or around this building, and you probably will before session is out, congratulate him, for he's truly one of a kind and worthy of an award such as this. Thank you, Madam Speaker.

Representative **MASTRACCIO**: Madam Speaker, Women and Men of the House. It seems very appropriate to be honoring Dr. McGuckin today for his 40-plus years of service as a family physician.

He was born in Manchester, England of Irish parents, studied in Northern Ireland, and earned his degree in medicine from University County Galway. He first came to America like so many immigrants, sponsored by a family member, and later returned to do his residency at Saint Mary's Hospital in Rochester, New York. It was there he met Neil O'Brien, a fellow Irishman and head of maintenance at Saint Mary's, who brought the young doctor home for dinner, and that is where John met Sheila, his future wife. They came to Sanford in 1977. As his daughter, Roisin, told me in a recent email, and I quote, "He has always loved how Maine allows him to be close to the ocean, like he was in Galway, Ireland. Dad has always loved being a doctor and I have felt immense pride in my father's vocation. He is known as a straight shooter, telling people to quit smoking, lose weight, and wear their seatbelts before it was cool to do so. He has also always had conviction and did not welcome drug representatives into his office, stating to us as kids that he disagreed with the way that money was able to get in the way of care for his patients. I recall dad going out in major snowstorms to deliver babies, calling to say he'd be late coming home because he was doing house calls, and spending Christmas morning going to the nursing homes and different floors of the hospital to share holiday greetings. He is still doing many of those things, and is dedicated to maintaining his own independent practice. He always made time for his five children; dropping us at school, coaching soccer, and coming to speak to our classes about his job. He has very loyal patients who have made me blush telling me heroic stories about my dad. He is a very devoted father, and now grandfather to ten grandchildren. We learned to be dedicated and hardworking in all that we do and to strive for excellence from both of our parents, but as a physician, my dad modeled those things."

Madam Speaker, I could not say it any better than a loving daughter could. Thank you, Dr. McGuckin, for choosing Sanford and bringing your talents and dedication to our city and state. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Bowdoinham, Representative Berry.

Representative **BERRY**: Thank you, Madam Speaker. Madam Speaker, I rise in support of the pending motion, simply to say that energy is a complex business. Our electrical grid has market mechanisms that date back for a hundred years or more. I think we can all agree generally on the principles that we want, what we seek in our electricity. We want to be able to count on it, we want to be able to afford it, and we want to feel good about it. We want the lights on, we want them to come back on when they go out, we want the bills to be low and we want the future costs for our children and our grandchildren to be low.

Energy storage is a solution that potentially, if we do adjust the markets to properly recognize its value, that could potentially have enormous impact, economic and environmental, here in Maine. It could improve reliability, keeping those lights on. It could improve resilience, making them come back. It could reduce costs to ratepayers and it could improve the market for renewables as well. So, it's really a win-win. I thank the sponsor of the bill, Senate President Thibodeau, for putting it forward, bringing it to our Committee. I thank all those on the Committee who voted for it. It's very important and timely that we study this issue, and create market mechanisms that will better reflect the true value of storage in the next Legislature, hit the ground running, and so I hope that those in the chamber will vote in favor of the pending motion. Thank you, Madam Speaker.

I'm eager to add my support to this uniquely bipartisan effort that can create a reliable foundation of care for those in -- for those living in and working in four of Maine's assisted living residences. There are currently seven state-funded affordable assisted living facilities. These facilities were developed so that aging individuals who need daily living supports can have the supports they need while maintaining their independence. These residents have their own apartments while also receiving services such as meals, personal care, and medication administration. The daily living services that are provided help to ensure that these individuals maintain their independence as long as they are able to do so. From personal experience, I can share that the residents are well cared for by a truly adoring staff. It's important to note that assisted living benefits residents through a social living structure that increases general health, independence, and activity, while it eliminates abuse, neglect, and the malnutrition that accompanies many disabled and senior Mainers.

Sparked by my own experience, I am pleased to support LD 1742, as I believe the funds requested are an investment that provides a practical and ideal return. The state funds the support services offered in assisted living facilities through individual contracts with the agencies providing the services. The seven assisted living facilities are located in Augusta, Bangor, Camden, Millinocket, Portland, Saco, and Sanford. The state negotiates these contracts separately and some of these facilities are losing significant amounts: Bangor, Millinocket, Camden, and Sanford. Penquis operates the first three of these facilities. Maine Health operates the fourth. Penquis has been clear that they cannot continue to sustain these losses and will have to end this service if something doesn't change. That would place housing for 90 individuals in jeopardy.

I am intimately familiar with the sacrifice and investment Penquis has made in particular. The Penquis board accepted management for these facilities close to 10 years ago because

of the organizational commitment to supporting Mainers. As a business, Penquis was aware the facilities were underfunded but felt an obligation to the residents. After 10 years of flat funding, the Penquis board is in the unenviable situation of no longer having resources to subsidize these residents. LD 1742 proposes to address this crisis in two ways. In the short-term, it provides \$500,000 to provide short-term funding to ensure that all facilities can keep their doors open. In the long run, it asks DHHS to look at the funding mechanisms for assisted living facilities to develop a long-term stable funding stream.

Assisted living facilities provide a cost-effective means of providing for seniors and the disabled who can handle some of the activities of daily living but still need some support to remain stable. The alternative for most of these residents will be to move to a step up in care, nursing PNMI, and unneeded cost to the State. Please consider supporting LD 1742. Thank you.

The SPEAKER: The Chair recognizes the Representative from York, Representative Hymanson.

Representative **HYMANSON**: Thank you, Madam Speaker, Men and Women of the House. Just for some background, this is a pilot program that started more than 10 years ago, and people in this pilot -- the idea was to keep people out of expensive nursing homes and other private non-medical institutions, assisted living places, by allowing people who pay rent -- so these are people who pay rent for their apartment, are elderly, but they can't fend for themselves in all ways that they need to, and if they didn't have these services they would have to move to another facility. So, they pay their own rent but the program pays for assistance. So, assistance are things like assistance with medications and meals, light housekeeping and laundry, assistance arranging transportation, overnight attendants for people who are unsafe walking. So, what we heard in the public hearings was that, if we didn't have this funding, and this pilot program which has been highly successful didn't continue, people would be faced with one of three choices. One, they could stay in place with no services, but that was not an option for the majority of the residents taken care of by this program. Number two, they could move to a DHHS-funded PNMI, private non-medical institution, or a nursing home, which would increase the cost to the state; or they could return to potentially unprepared and unsafe residencies. So, this really -- this program does save money, and it's \$500,000, a one-time cost, so there are seven of these, \$70,000 each or somehow other apportioned. And, unless we act, the state will be left with a significant population that either has no safe place to live, or which must be placed in more expensive nursing home or PNMI facilities. So, this bill really represents a compassionate and practical solution to the problem. Thank you, Madam Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Bowdoinham, Representative Berry.

Representative **BERRY**: Thank you, Madam Speaker. Madam Speaker, I rise simply to say that this same measure has been killed by Democratic legislatures, by Republican legislatures, and by divided legislatures. I see nothing that has changed. It is a fantasy; a pleasant one, but a fantasy that buying socialized government-owned power from Canada will actually do anything to improve our economy here in Maine. It would be above market and it would put a lot of Mainers out of

work. So, for that reason, with great respect to the sponsor, I need to vote Ought Not to Pass on this bill. Thank you.

The SPEAKER: The Chair recognizes the Representative from Turner, Representative Timberlake.

Representative **TIMBERLAKE**: Madam Speaker, may I pose a question through the Chair?

The SPEAKER: The Representative may proceed.

Representative **TIMBERLAKE**: How does passing this bill to allow a 100 megawatt hydroelectric take jobs away from Maine, when we used to have them up and down the rivers of the State of Maine? How is this bad for the State of Maine, and how is this not renewable energy? And that's what I just heard the good Representative say, and I'd like an explanation of how they come up with this not being renewable and how it's bad for the State of Maine.

The SPEAKER: The Representative from Turner, Representative Timberlake, has posed a question through the Chair. The Chair recognizes the Representative from Bowdoinham, Representative Berry.

Representative **BERRY**: Thank you, Madam Speaker, and, I do appreciate the question. The answer in part is that it would hurt Maine's biomass industry. Currently our loggers depend on our existing RPS for some of their jobs, and I think we all are fully aware of the predicament that they've been in over the last several years. The purpose of our RPS in general is also to support, Madam Speaker, the construction of new renewable and efficient resources right here in Maine, not outside of the state.

Another observation that I probably should have made earlier, and has been made before with respect to this bill, is that there are plenty of hydro facilities in Canada which already qualify because they're under 100 megawatts. So, one would think, if this was such a great deal, that they would have bid in already to the RPS. They have not done so, and I think it's just further evidence that the subsidized rate that the government-owned power in Canada enjoys in Canada is not the rate that we would pay for it here. The State of Vermont is good evidence of that. They're currently paying an above-market rate for Canadian hydro. I don't see this as a solution; neither did the previous Legislature, or the Legislature before that, or the 125th. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Turner, Representative Timberlake.

Representative **TIMBERLAKE**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. As a businessman in this state, and as one who pays high electricity charges in this state, I would welcome anything that would lower the interest rate. I also harvest wood and supply the chip mills of the State of Maine for their biomass industry. So, my theory is, in the free market industry in the State of Maine, that anything we can do to make it so my family can go to the tenth generation and the eleventh generation is something we want to do. Now, there's nothing that says if we allow this reduction in the megawatts it's going to -- we have to buy it. If it's not a good deal, we're not going to buy it. We're only going to do it if it's a good deal. And it allows us to lower the rates, possibly, to the businesses in the State of Maine. Now, are we protecting an industry in the State of Maine like the solar and the wind and the biomass? Is this what we're really doing? Or are we in stopping the hydro industry? Because I think hydro is probably one of the most renewable industries there are out there, and I really don't understand why we wouldn't allow this to happen. I hope you follow my light on this vote, because we're setting bad precedents.

The SPEAKER: The Chair will remind all members to please direct their comments through the Chair. The Chair recognizes the Representative from Berwick, Representative O'Connor.

Representative **O'CONNOR**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I am well aware that this proposal has failed to pass through this legislative body multiple times, and each time I shake my head as to the whys. Time after time, I simply follow the money. Companies are protecting their own bottom line, closing doors to competition of all renewables. If we are truly interested in renewable energy, we should allow every form to compete. Industries have a lack of confidence in one another, which hinders their ability to compete against each other and succeed in the face of that competition. The mills, along with renewable energy companies, argued the measure would change the rules of the game after they had invested millions. They said large Canadian hydro plants could crowd out the smaller players, and indeed, it could; but it could also lead to new innovative technology and investments, in an effort to build a better product, by those very same renewables. Waste to energy comes to mind. Let's be clear; we are facing unprecedented retirements in New England, and we should be open to clean, renewable hydropower. With the retirement of oil, coal, and nuclear plants, it has been estimated by ISO New England that another 8,300 megawatts of generation capacity will be lost by 2020. They say we will require another 6,300 megawatts of gas-fired capacity to replace them.

I find it highly unlikely that the increased investments in the wind industry will be able to reach those goals, nor will solar, and the end result of those investments will result in a negative return on the past, present, and future investments, as well as increased rates to the consumers. This statement is not to insult the positive efforts that have been made in wind and solar, but simply an effort to point out the real costs and concerns. Lifting the 100-megawatt cap on hydro would likely have no overwhelming effect on wind, biomass, or solar power, as there are currently limited generation lines coming into Maine that connect with large Canadian hydro plants, and many of our current hydro facilities are nonfunctional. What it will do is remove an unfair advantage that some industries enjoy and open up a valid avenue for future investments from one our most precious resources, the power from our rivers, lakes, and tides, and to place us in a position to be considered for future investment for greater interconnection to hydropower. Hydropower is green, clean, and abundant, and has the possibility of significantly reducing electric costs to consumers and businesses. Unfortunately, unless we lift the 100-megawatt cap that hydro is saddled with by the renewable portfolio standard, we may never realize its true value, and be able to step into the private marketplace in time to cover the 8,300 future megawatt loss and replace it with generation from an excellent natural commodity.

I would just like to say, the way that this cap came into play was a bunch of lobbyists that happened to be out in the parking lot and tossed that number into the air to see what stuck, and that did. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Orono, Representative Tipping.

Representative **TIPPING**: Thank you, Madam Speaker. Madam Speaker, I usually stay quiet during these debates, but I just have to say that we've heard a lot about this is in favor of hydro. When I served on Energy, Utilities and Technology Committee, I received a letter from a hydro plant in my district, testifying against the raising of this cap. There are a number of

hydro people and companies in this state who have made investments in the state to increase hydro production who are also against changing the rules of the game midstream. I'm just reading through a letter that was given to the Energy, Utilities, Technology Committee from a hydro power facility. We continually make difficult decisions about our hydroelectric assets here in Maine. Like all business, predictable and reasonable policies are important precursors to our business decisions and investment. This is about Maine jobs, this is about developing hydropower here in Maine, not a foreign country, and that's why I will be supporting the Majority Report.

The SPEAKER: The Chair recognizes the Representative from Canaan, Representative Stetkis.

Representative **STETKIS**: Thank you, Madam Speaker. I'd like to pose a question through the Chair.

The SPEAKER: The Representative may proceed.

Representative **STETKIS**: As I -- I'm not sure if I caught it right, but I'd be curious to know if the Representative from Bowdoinham, I believe he had mentioned that he opposed this bill in part because of the above-market energy cost? I'd like to just understand if that's what he said.

The SPEAKER: The Representative from Canaan, Representative Stetkis, I believe has posed a question. The Chair recognizes the Representative from Bowdoinham, Representative Berry, to respond.

Representative **BERRY**: Thank you, Madam Speaker. I appreciate the question of the Representative from Canaan, because I did -- I feel in light of the previous debate it's important to clarify that point. There is currently no barrier to Canadian hydro to bid in to Maine's energy market. They can do so already and it's absolutely nothing to prevent that. What is at stake here is whether a very minor modest subsidy which goes to Maine renewables would be opened up more widely, and whether we would, in fact, through this bill be subsidizing a foreign production of energy which is probably existing already. As I stated earlier, there is currently Canadian hydro that qualifies for Maine's RPS and could even be subsidized by Maine. They have not sought to do that, so what that indicates is that Canadian hydro probably can't even compete at that higher slightly subsidized rate. But, certainly, there are no market obstacles right now.

I think the points raised about a free market and competition are actually very valid ones. I think we all agree that we want to keep rates down and we need to be careful what we do subsidize or not subsidize and so, you know, the question here is whether we're going to provide an additional subsidy for a foreign resource. Thank you, Madam Speaker.

The money, the \$10 million was chosen -- what was chosen to be defunded by the Department were the school-based health centers. Over the past amount of time, it's clear that they cannot make up the difference in funds that they can find, and so this is a way to put back that funding. These are extraordinarily important centers. They co-locate with schools. They are clinics that exist in the school because it's a good place for them to be. They are not, and never have been, part of the Education Department funding, so the funding should continue to be from Fund for Healthy Maine. It's stated as one of the places where we can spend the Fund for Healthy Maine money and, in fact, we have \$9 million in unallocated funds now in Fund for Healthy Maine. There are 16 clinics. They cost about \$36,000 a year, each one of them, on average. That's \$576,000 total. There's plenty of money in Fund for Healthy Maine to support that. They are -- they do great work, and so I ask that you support this motion by supporting the Majority Report. Thank you, Madam Speaker.

Representative **MADIGAN**: Thank you, Madam Speaker, Men and Women of the House. I just want to take this opportunity to tell you that this funding is a direct way to help children that normally would not have a way to get some healthcare, either because they have high-deductible policies or have high co-pays. Funding like this makes healthcare available to children right in their school, and it breaks down an important barrier for them to get necessary healthcare and mental healthcare. Thank you.
