**PETITIONS, BILLS AND RESOLVES REQUIRING REFERENCE**

Bill "An Act To Increase Safety for Maine Citizens by Amending the Definition of 'Likelihood of Serious Harm' in the Laws Governing Mental Health and Hospitalization To Include Consideration of a Person's Potential for Future Serious Harm"

(H.P. 1321) (L.D. 1889)

Sponsored by Representative MALABY of Hancock.

Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.

Committee on **HEALTH AND HUMAN SERVICES** suggested.

Speaker GIDEON of Freeport moved that the Bill be **REFERRED** to the Committee on **HEALTH AND HUMAN SERVICES**.

The SPEAKER: The Chair recognizes the Representative from Hancock, Representative Malaby.

Representative MALABY: Madam Speaker, I rise in opposition to the referral to Health and Human Services.

The SPEAKER: The Representative may proceed.

Representative MALABY: Thank you, Madam Speaker. Madam Speaker, this bill addresses something called blue papering, in which a law enforcement individual may encounter someone who they perceive as suffering from a mental illness; and there are two essential aspects of blue papering that are of concern to a Legislature. A, is the process. We addressed the process in Maine two years ago, in LD 1145. This bill seeks to address the criteria under which a law enforcement individual

can deem someone in need of an evaluation, and perhaps blue papering and subsequent treatment. It is my understanding that these bills have always gone to Judiciary. LD 1145, which addressed the process, went to Judiciary. I suspect also this should go to Judiciary, because it addresses the legal standard under which law enforcement can deem someone in need of treatment. Thank you, Madam Speaker.

Subsequently, Speaker GIDEON of Freeport **WITHDREW** her motion to **REFER** the Bill to the Committee on **HEALTH AND HUMAN SERVICES**.

On motion of Representative HERBIG of Belfast, the Bill was **REFERRED** to the Committee on **JUDICIARY**, ordered printed and sent for concurrence.

Bill "An Act To Streamline the Management of Maine's Transportation Infrastructure by Initiating the Process of Terminating the Maine Turnpike Authority"

(H.P. 1322) (L.D. 1890)

Sponsored by Representative ESPLING of New Gloucester. (GOVERNOR'S BILL)

Committee on **TRANSPORTATION** suggested.

On motion of Representative HERBIG of Belfast, **TABLED** pending **REFERENCE** and later today assigned.

**ORDERS**

On motion of Representative BERRY of Bowdoinham, the following Joint Order: (H.P. 1320)

ORDERED, the Senate concurring, that, notwithstanding Joint Rule 353, the Task Force To Study Rising Transmission and Distribution Costs is established as follows.

**1. Task Force To Study the Rising Transmission and Distribution Costs established.** The Task Force to Study Rising Transmission and Distribution Costs, referred to in this order as "the task force," is established.

**2. Membership.** The task force consists of 13 members appointed as follows:

A. Two members of the Senate appointed by the President of the Senate, including a member from each of the 2 parties holding the largest number of seats in the Legislature;

B. Two members of the House of Representatives appointed by the Speaker of the House, including a member from each of the 2 parties holding the largest number of seats in the Legislature;

C. Five members appointed by the President of the Senate as follows:

- (1) A representative from each of the 2 investor-owned transmission and distribution utilities in the State;
- (2) A representative of a consumer-owned transmission and distribution utility;
- (3) A representative of a small energy consumer; and
- (4) A representative of an industrial energy consumer; and

D. Four members appointed by the Speaker of the House as follows:

- (1) A representative of a conservation organization;
- (2) A representative of an energy generator located in the State;
- (3) A representative of an organization with expertise in elder and aging advocacy; and
- (4) A representative of an economic development organization in the State.

**3. Task force chairs.** The first-named Senator is the Senate chair of the task force and the first-named member of the House of the Representatives is the House chair of the task force.

**4. Appointments; convening of task force.** All appointments must be made no later than 30 days following the effective date of this order. The appointing authorities shall notify the Executive Director of the Legislative Council once all appointments have been made. When the appointment of all members has been completed, the chairs of the task force shall call and convene the first meeting of the task force. If 30 days or more after the effective date of this order a majority of but not all appointments have been made, the chairs may request authority and the Legislative Council may grant authority for the task force to meet and conduct its business.

**5. Duties.** The task force shall:

A. Review of transmission and distribution costs for both residential and industrial consumers since 2000 for:

- (1) Consumer-owned transmission and distribution utilities;
- (2) Small investor-owned transmission and distribution utilities; and
- (3) Large investor-owned transmission and distribution utilities;

B. Compare the costs of transmission and distribution in the ISO-NE region, as defined in the Maine Revised Statutes, Title 35-A, section 1902, subsection 3, to other regions in the United States in which the bulk power system is operated by a system operator;

C. Review and evaluate the cost differences between transmission and distribution;

D. Review and evaluate the legislative and regulatory policies affecting distribution costs;

E. Review and evaluate the cost containment provisions of law designed to prevent overbuilt transmission and distribution lines;

F. Review and evaluate different compensation models for transmission and distribution utilities in other regions in the United States in which the bulk power system is operated by a system operator;

G. Review current transmission and distribution rate structures in the State and evaluate the effectiveness of lower rates in promoting economic development;

H. Determine if the costs of advocacy before the Legislature and administrative bodies on behalf of transmission and distribution utilities are borne by ratepayers;

I. Develop recommendations for changing current regulatory policies and determine the costs of implementing those recommendations versus the cost of leaving current policies in place;

J. Review and evaluate wheeling charges;

K. Review and evaluate time-of-use billing; and

L. Examine any other issues to further the purposes of the task force.

In conducting the duties under this subsection, the task force shall seek public input and shall consult and collaborate with stakeholders and experts in the fields of energy policy and economic development.

**6. Meetings.** The task force shall hold at least 4 meetings.

**7. Staff assistance.** The Legislative Council shall provide staffing services to the task force, except that the Legislative Council staff support is not authorized when the Legislature is in regular or special session.

**8. Report.** No later than November 7, 2018, the task force shall submit a report that includes its findings and recommendations, including suggested legislation, to the Joint Standing Committee on Energy, Utilities and Technology.

**READ.**

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. If you actually take an opportunity to look at this Order, it does address and look at a legislative perspective at rising transmission and distribution costs here in the State of Maine, otherwise known as T&D.

As people are well aware, over the last several months there have been ongoing confusion, concern, and issues related to people's electric bills being either higher or lower; at the end of the day, basically, some real issues that have gone to the PUC in regards to some concerns with issues in people's electric bills. I think that this is a timely issue, as we know that the Chief Executive has been an ardent proponent of trying to drive down the cost of electricity, both as it pertains to the elderly and our industrial customers. It's important to our economy, safety, and our resilience issues. And so, I see this as an opportunity for the Legislature to have some -- look at this in a timely way, before we come back into the next legislative session, and I urge its passage. Thank you, Madam Speaker.

Subsequently, the Joint Order was **PASSED**.

Representative **STEARNS**: Thank you, Madam Speaker. **READ.**

The SPEAKER: The Chair recognizes the Representative from Winslow, Representative Nadeau.

Representative **NADEAU**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. This is the story of a young man named Ryan Fredette, also known to his friends as "the ginger ninja," because of his red hair and his wrestling abilities. He has achieved, at his young age, seven state championships. Four of those were in wrestling, with a record of more than 200 wins and more than 100 pins. This season only, he had 49 wins, zero losses, and 22 pins. Two state championships in football, one state championship in track. In wrestling, he is a two-time KVAC champion, four-time northern regional champion, two-time all-state champion, and two-time New England finalist. This year, he was named New England Champion and voted by the coaches at the New England championship as outstanding wrestler. This is quite an achievement, as it has happened only five times since 1959, and only two people in these five were from Winslow: Ryan, and Tommy Smith.

We, as the Maine State Legislature, would like to thank Ryan and his family, along with the coach, for being here today. If, as Olympic wrestler Dan Gable said, "Everything

else in life is easy once you've wrestled," then Ryan indeed has a bright future ahead of him. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from China, Representative Theriault.

Representative **THERIAULT**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I want to recognize the success of this young man from Winslow and what he's accomplished in his wrestling career at Winslow High School. His career record is 200 wins, 17 losses, and 106 pins. This year he was 49 and 0, with 44 of those wins coming in the State of Maine. He won the state championship at the 182 pounds and became the New England champion. He was runner up last year, with a record of 50-1, losing his last match, and participated in the New England tournament three years in a row. On top of that, he was named the outstanding wrestler for the New England tournament, out of 177 schools represented at the tournament.

I followed Ryan through the whole tournament and watched all of his matches on Facebook, thanks to the dedication of his father, who videoed all of them. I know Ryan through his father, Kevin, who is a career firefighter for 29 years for the Town of Winslow. I reached out to him to help the China Fire Department, and he joined and helped us -- he joined my fire department for five years to help with our training program, and he has since left the department, but we certainly appreciate everything he did to help us and keep the -- and I have kept in touch with him ever since. I want to wish Ryan the best of luck in his future endeavors, and I know whatever he puts his mind to, he will be very successful. Thank you very much.

Representative **GINZLER**: Thank you, Madam Speaker, Members of the Body. I rise in objection to the motion Ought to Pass. This bill, 1684, is a state mandate on local districts. It is well-meaning, but wrong-headed. Most, if not all the districts

provide school lunches to all students one way or another. Furthermore, this bill, the way it is written, restricts districts' ability to address the mounting debt, nearing \$400,000, that is incurred by unpaid lunch bills. And, lastly, and I think very much most importantly, I believe that it seeks to shelter high school students from the reality that there is no free lunch, that someone is on the hook for it. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Alfred, Representative Sampson.

Representative **SAMPSON**: Thank you, Madam Speaker. I'd like to just address a couple of points to this bill, to keep in mind that this is not dealing with children who are free and reduced lunch. These are children whose parents have signed them up for lunches and can afford it. These are the same parents that will take them to piano and ballet and soccer and all those things, and pay those bills. But these are bills that are not being paid. And the other question I'd like to pose is: what are we actually defining as "shaming?" Thank you.

The SPEAKER: A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought to Pass as Amended Report. All those in favor will vote yes, those opposed will vote no.

The **SPEAKER**: The Chair recognizes the Representative from East Machias, Representative Tuell.

Representative **TUELL**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, I rise in support of the pending motion. When this bill was put forward, I was involved with the group that originally put it forward, of local schools and local communities in my area back in early September. Through the generosity of a member of the other body, we got that bill submitted, got it through Leg. Council with bipartisan support, have come and testified for the bill in Committee; and along the way, there were some things that were brought to light about some of the issues around the previous budget and what happened with school funding. Now, one of the things you may hear is that we put \$162 million into schools, and we did that so as to -- but we put some reforms in at the same time. One of the things that we omit out of that discussion, or don't quite mention, is that we had a -- there was an agreement to reduce property -- reduce taxes on businesses. However, some of these reforms got stuffed in at the end of the discussion period. One of these reforms is to create new mega school districts, which many of us fought against ten years ago when that whole thing was created, consolidation was proposed ten years ago, there were many of us opposed then. And after that, consolidation happened, schools got together, some got together, some couldn't get together, and actually made the tough decisions and did what they had to do. This new iteration, this bill, takes penalties away from some of those who are already consolidated, who have already made the commitment to consolidate and find efficiencies locally. This isn't a stick, it isn't a carrot, it's a sledgehammer. It's a sledgehammer. And local schools are under siege each and every day. I know there's others in the -- others here who will -- can tell you a lot more about it and how this is -- how these penalties are back door consolidation, and these new school management leadership centers are a whole new layer of bureaucracy. I know during the public hearing on this bill, we had some folks from my caucus who also attended and spoke, who expressed concern that there is no way out of a school management leadership center once you get in. So, think the bill that we had last week, where we had the big whole issue as to how people get out and all of the heartburn that that caused. That's only going to magnify as time goes on. There's no way out of these management leadership centers.

The other issue that was brought to light was, as others have mentioned --

The **SPEAKER**: The Chair recognizes the Representative from Bridgton, Representative Ginzler, and inquires as to what her Point of Order is.

Representative **GINZLER**: Thank you very much, Madam Speaker. I guess what I am asking is that it seems to me we are straying way beyond the specific amendment here, which has to do with school funding for one line item in the budget, and I believe we are getting onto other issues. Thank you.

On **POINT OF ORDER**, Representative **GINZLER** of Bridgton asked the Chair if the remarks of Representative **TUELL** of East Machias were germane to the pending question.

The **SPEAKER**: The Chair would advise the member from East Machias to please be sure to keep his comments relevant to Report C.

The Chair reminded Representative **TUELL** of East Machias to confine his debate to the question before the House.

The **SPEAKER**: The member may proceed.

Representative **TUELL**: Thank you, Madam Speaker, and I apologize for getting a little bit afield. I will say that this: the concerns that were echoed in the public hearing is that schools are already consolidating, and should not be penalized. And some have documented that they're already consolidating and are being penalized. So, not -- so, passing this bill would give some schools that are already doing what we have asked of them, time and time and time again, some relief. I would encourage you to support the pending motion. Thank you.

The **SPEAKER**: The question before the House is acceptance of Report "C." The Chair recognizes the Representative from Bridgton, Representative Ginzler.

Representative **GINZLER**: Thank you, Madam Speaker. Last year, Representatives and leaders from both caucuses on the Education Committee, and leadership of both caucuses, worked extensively, long days and hours on the education section of the budget, specifically, an area called Section C. There were 64 line items in Section C, one of them was C22; one of those 64 line items. It had to do with funding system administration. The agreed-upon compromise regarding system administration funding within the EPS formula was reached, and it was agreed by all that we would gradually remove system administration from the EPS formula, in favor of more money being directed to instruction. This amendment, and the reason I'm rising in opposition to this amendment, this amendment seeks to amend C22, that one line item, in the interest of fairness, but actually may do harm. Certainly, one of the unintended consequences of this is it will increase the mill rate and it will increase local share. You're right, we did add \$162 million to the baseline of education, which will go forward in the future. The budget was reached for the two years. I ask that we continue with that agreed-upon compromise for these two years. Certainly the next Legislature can, and will, address the budget after that. Thank you, Madam Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Guilford, Representative Stearns.

Representative **STEARNS**: Thank you, Madam Speaker. This seems to be my big day. Boy, people get caught up in this business about administration. And, I guess -- I guess it was agreed upon, by somebody at some point last year in the budget proceedings, that system administration is not essential. The way that Essential Programs and Services is designed was, every category in the world of education, every single category, is assigned a cost. And the people who put -- it's zero-based budgeting, if you will; starting from scratch

every single year. It's fiscally responsible. Some components of it can be argued about. One thing that cannot be argued is every town in the State of Maine, by statute, must have a Superintendent of Schools. That's a requirement. That's a requirement in this state. To take a required action and say that's not essential, that's zero, is odd. And had those deliberations been made in the light of day, I would've spoken up at that time and mentioned that fact. Now, you can do that as a political gesture, that's fine. The folks that are creating local school budgets really don't care about that. They look at the line -- the amount of money that they're going to get from local taxation, from state aid, and any other sources, and then they go through and develop their budget as to what they must do, what they are mandated to do, and what they would like to do for the -- in the best interest of the kids, and the local folks vote on that. One thing that they are mandated to do are tasks such as payroll. Somebody looks after school safety. That's, I would say, in light of what we have looked at in the last month across the United States, maybe that administration is quite essential, that we look at the safety of schools. Someone has to do the fiscal management of the schools. We're now looking at bringing CDS into the schools --

The SPEAKER: The Chair recognizes the Representative from Bridgton, Representative Ginzler, and inquires as to what her Point of Order is.

Representative **GINZLER**: The Point of Order here, once again, I think we are going far afield of this amendment. This has to do with a very specific inclusion of additional funding on one line item. This is not an argument about the importance of school administration, which nobody debates.

On **POINT OF ORDER**, Representative GINZLER of Bridgton asked the Chair if the remarks of Representative STEARNS of Guilford were germane to the pending question.

The SPEAKER: The Representative will answer -- the Chair will answer the Representative just as when the Representative got up to explain her position. It is necessary sometimes to expand on the issue before us so that members who are not from a committee of jurisdiction may fully understand the issue.

The Chair advised Representative GINZLER of Bridgton that the remarks of Representative STEARNS of Guilford were germane to the pending question.

The SPEAKER: The Representative may proceed.

Representative **STEARNS**: Thank you, Madam Speaker. And, I do concur, the line that I'm talking about is system administration being reduced to zero. We could make that same adjustment by just increasing the mill rate, which went from 8.19 to 8.51, which is a significant cost to the local property tax payers. That adjustment simply could've made that go to 8.52 and you would've gotten to the same place.

What -- the amendment that we're talking about, that was passed in the other body, simply allows the Department of Education to recognize those systems that have already demonstrated a high level of achievement and a high level of efficiency. Some people handle the administrative cost by -- they might have a superintendent 40 days a year, because they want the minimum amount spent on system administration. Why spend more than you need? And the local people are well-equipped to take care of that. So, with that, I would ask you to follow my light. Thanks.

The SPEAKER: The Chair recognizes the Representative from Presque Isle, Representative Stewart.

Representative **STEWART**: Thank you very much, Madam Speaker, Ladies and Gentlemen of the House. I'm not going to get too much into the nuances here, but what I will simply say

is that, if we were in fact to make this change for the budget without appropriating more money, which this bill does in fact not do, to education, what it will mean is that the mill rate at the local level will increase, thereby increasing taxes at the local level, making your property taxes go up. I do not believe that that is what some folks want to do, so I want to make sure that everybody is aware of the situation and how this would impact that dynamic. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I oppose the pending motion, and I ask the Clerk read the Committee Report.

Representative FREDETTE of Newport **REQUESTED** that the Clerk **READ** the Committee Report.

The Clerk **READ** the Committee Report in its entirety.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Kornfield.

Representative **KORNFIELD**: Thank you, Madam Speaker. With all due respect, I think several of the speakers are a little bit confused about Amendment "C," or Report "C."

Report "C" asks to put off the -- let me start again. No wonder they're confused. Report "C" says that we will zero out the administration for this one year, and at the end of this year, it will end. And the reason that I think this is important to do, and why I went with Report "C," is that the 279s, which are the state's -- the state telling the school exactly how much they would have to spend, have already gone out, they went out a long time ago. The schools are in the process of making their budget. I think it would be very disruptive if we changed anything this year, but I fully intend to put in a bill that would do exactly the things that Representative Stearns just mentioned at the beginning of next year. Thank you.

The SPEAKER: The Chair recognizes the Representative from Bridgton, Representative Ginzler.

Representative **GINZLER**: Thank you, Madam Speaker. First of all, I just want to amend one thing. We are not -- Amendment "C" does nothing with regard to zeroing or not zeroing. The current bill, as it stands right now, does not zero out system administration. I want to make that very clear. It is, however, gradually lowering the contribution by the state for system administration costs. That is true. And it's added incentive money for those schools who will then regionalize certain cost centers. So, there is still an allocation for system administration, plus an incentive component. That still remains, both this year and next year.

The only reason I'm standing here is to let you know that, by law, our school funding is a cost-sharing function. We share the cost, state and local. And there -- for that reason, the state, as we had looked at this budget, the state wanted to put more money into instruction and move the system administration to the local responsibility. And, as I mentioned, this is a cost sharing. We share everything. And the -- it doesn't necessarily mean that one line item has to be sort of split in the middle, but rather that we collectively look at the total cost of education, and we decide what is local and what is state. The state, by virtue of your representation, your leadership, decided that we would move more money into instruction and less money into system administration. So it is still a cost-sharing model. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Dover-Foxcroft, Representative Higgins.

Representative **HIGGINS**: Thank you, Madam Speaker and Ladies and Gentlemen of the House. I do know where I am and what day it is today, so... I try to practice a very basic

tenet when I come here every day, and I hope at the end of the day I've done no harm, and maybe some good along the way. The issue here before us is... sounds very good, will put more money in our classrooms, supporting our students and teachers. Who doesn't want to do that? We all do. But we also have to recognize there are services that need to be provided in the management of our schools' systems administration. So, if we take a certain amount of money, and we decide to put a larger percentage of that into our classrooms and not pay those dollars to support systems administration, then somebody has to pay, somebody has to pay that. And if we're not contributing the share that I think many people think we should for systems administration, then that share then transfers to the local, and the local taxpayers have to pick up an increasing share of systems administration that the state has already -- has traditionally paid for. So, it is in fact a tax shift. We feel good about it. We feel good about taxing local people more for systems administration, because we can put more money in the classroom. Either way you cut it, there are X number of dollars that are going to be expended to run our system and support our schools.

So, I would support the pending motion, which I believe is a more reasonable way in which for us to move forward. Parenthetically, I might add, that in my previous life, I had the pleasure of managing school consolidations for the State of Maine and, yes, I'm still here. And we were very successful in forcing people to do things. The real winners were the people that got to repaint the lettering on school buses with RSUs instead of SADs. So, I think that we should be thinking about not penalizing our school systems, we should be encouraging them; but I support the pending motion, because I believe it's the right way for us to go to manage our schools. Thank you.
