The SPEAKER: The Chair recognizes the Representative from Belfast, Representative Herbig.

Representative **HERBIG**: Thank you, Madam Speaker. Madam Speaker, Women and Men of the House, I rise to speak in support of the pending motion. This bill addresses two of the most pressing issues before us: preserving vital services for aging Mainers and adults with intellectual disabilities and autism, as well as our county jails.

Protecting services for Maine's most vulnerable is a priority that's especially personal to me. My own family knows firsthand what it's like to care for a loved one with an intellectual disability. My community has struggled to make up the difference as providers who helped care for our neighbors have closed their doors. It's been devastating. The state should not be in the business of deciding which of our loved ones receive care.

Across our state, families and communities like mine and so many others in this Chamber need us to act.

The SPEAKER: The Representative will defer. The House will be in order. The Representative may proceed.

Representative **HERBIG**: This is our chance to show them that we will not abandon our most vulnerable, their families, and the workers who care for them, and I'm hopeful that today, we will do just that.

LD 924 will provide critical funding for our county jails. I have certainly heard a great deal from sheriffs and county administrators, and I'm sure you all have as well. The bottom line is that, without this funding, jails will be forced to make deep cuts to programs that prevent crime, reduce recidivism, and make our state safer, and our communities will be left to pick up the state's slack. For public safety, for property taxpayers, we can't let this happen.

I hope you will join me in supporting the pending motion just as the Appropriation Committee did unanimously. The decision we make on this bill will impact each of our districts and every corner of the state. Today we can make meaningful action to make Maine safer, healthier and more stable. Thank you, Madam Speaker, and I request a roll call.

errors bill, the section fixing the error related to the Maine Clean Election Fund.

As I'm sure we're all likely aware, in the final budget bill that we passed last session, we included a \$3 million advance transfer to the Maine Clean Election Fund. It was intended to ensure that the program was sufficiently funded during this election cycle. However, as we learned just a couple of months ago, an error occurred in the drafting, creating a negative allocation during fiscal year '19, preventing the Ethics Commission from disbursing Clean Election funds after July 1st, so the money has already been appropriated, however the Commission simply lacks the authority to spend it. The errors bill seeks to fix that error, granting the authority to spend without appropriating any additional money.

In recognizing the position that we find ourselves in, the amendment before us tries to seek something of a compromise. The \$3 million advance from our budget deal has already been transferred into the Clean Election account. The amendment presented today removes \$1 million of that advanced transfer, sending it back to its original date. I can say we feel that it's important to fix this error. As we've seen, we have already over 200 candidates have enrolled in the Clean Election program, with the understanding that it would be sufficiently funded. They've met their standards of qualification and entered into a contract with the state, giving up their right to raise funds traditionally. And, perhaps most importantly, tens of thousands of Mainers have contributed financially in order to see this program succeed.

So, this amendment before us respects the budget deal that we made last July while giving back \$1 million of the advanced transfer. I thank you all for your consideration of this amendment. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Good morning, and thank you, Madam Speaker. I appreciate the efforts of the good Representative from Ellsworth, Representative Luchini.
