THE PRESIDENT: The Chair recognizes the Senator from York, Senator Deschambault.

Senator **DESCHAMBAULT:** Thank you, Mr. President. President Thibodeau and ladies and gentlemen of the Senate, I rise to speak in opposition of the motion to pass L.D. 25, An Act to Remove the Legislative Council from the Capitol Area Development Approval Process. This L.D. does exactly what the bill suggests. It's to remove from the process the Legislative Council comprised of our leaders in the Senate and the House. A bit of history. The statute outlining the procedures in Title V is the Capitol Planning Commission, which was passed in 1967, 50 years ago. There had been only four amendments to this statute in the first seven years and then one more amendment 36 years later. Not bad for an all-encumbering statute. The statute clearly defines the Capitol Area. There is no mistaking this. Also it states in part a construction project may not be initiated in the Capitol Area for the development of State buildings without the approval of the Legislative Council, the Bureau of General Services, and the Commission of the proposals and plans for a project. You note, the Legislative Council is the first entity mentioned and to be considered. The committee heard testimony that there had been a number of projects completed without first needing to seek Legislative approval. The 30 projects listed in the sponsor's testimony were not new construction. For the most part, they were renovations. Windows were replaced, parking lots were repaved, retaining walls were replaced. They were not new construction or expanded projects. One exception, of course, we all know was the new construction of the Riverview Psychiatric Center, which was completed in 2004. This did not need Legislative Council approval because the project was approved by the entire Legislature. This was not so for the latest Riverview plan to expand. The one project mentioned in the sponsor's testimony that did get Legislative approval in 2007 was the greenspace improvement in front of the Cultural Building. It did so because the project was paid for from a sub-account of the

Legislator's own account called General Account. You guessed it. It needed approval by the Legislative Council. There are many more exceptions, and I should say examples, however L.D. 24 was borne from the frustration by some Legislators to comply with the process to initially seek the approval of our Legislative leaders. The majority of the State and Local Government Committee believes that it is in the public's best interest to continue to have Legislative oversight and approval by the Legislative Council for construction projects within the so-called Capitol Area. This transparency in State government has served us well. Therefore, I urge you to vote nay on the motion Ought to Pass.

THE PRESIDENT: The Chair recognizes the Senator from Piscataquis, Senator Davis.

Senator **DAVIS:** Thank you very much, Mr. President. I rise in support of this motion. Just to compliment my colleague, Senator Deschambault, she certainly outlined things quite well. I do have a little more history of it though. I remember quite clearly during my early days here coming down here one morning and there were two trucks here in the middle of Capitol Park and they had an 8-bottom plow hooked to each one of them and they were plowing up the park. You see, the Capitol Building was under construction and we needed more space for the offices for the Legislative staff and what all. So the Council approved doing that. Well, they quickly rescinded their approval. The City was very upset, to say the very least, and they didn't, to my knowledge, ever attempt to approve a project of that magnitude again. After that there wasn't much happening with the Legislative Council until recently. We know the issue that took place earlier this year, or late last year. If, in fact, we remove the Council from this there are still plenty of protections for the Capitol Park. The matter is referred to the General Services Bureau. They go over it with a fine-tooth comb, make sure that everything's in place, and then it goes to the City of Augusta for all the permits and their approval, and probably the worthiness, of whatever projects are coming forward. With all that in mind, Mr. President, I would ask that the Body would follow my light. Thank you very much, Mr. President.

On motion by Senator **JACKSON** of Aroostook, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I introduced this legislation because of the small town in Aroostook County, New Sweden, just north of Caribou, a place that certainly I've driven either with my parents or after I received my license for all my 48 years. For a long time there was a caution light at a four-way intersection on Route 161 that announced, especially for anyone traveling southbound, that there was a blind intersection in an area where one business on one side of the road and the only convenience store in this region on the other side of the road. Somewhere along the line the Department of Transportation, even though the highway had never been changed, had never been modified, somewhere along the line they decided to take down the caution light. Since that time the residents of that area have been asking for the Department of Transportation to reinstall it. I have represented

that area all the time that the light has been taken down, but since then they've asked Congressman Michaud. Received letters with the Congressman asking the Department to reinstall the light. Numerous times they've asked for the DOT to reinstall it and during this past election many of the doors that I knocked on it actually was a topic that came up. Within six days of the hearing the Northstar Variety, that's the convenience store, put forward a petition asking the Legislature to enact this law asking the DOT to put the caution light back up. Within six days' time that small community received over 200 residents that actually signed on asking for that caution light to be reinstalled. I think that's pretty significant. I've never seen a petition drive in small community get that many signatures in that short of a time. So the Committee heard testimony. I know that the Department was asked to do another study on the area, and I appreciate that from the Transportation Committee. I am concerned that, for all this time having U.S. Congresspeople asking, nothing has been done. I'm concerned that another look at it by the Department isn't enough. The community has asked to have it put back up. They certainly believe that there is a safety issue very much at stake and I can't understand if 30 years ago that highway was deemed to be unsafe for the sight distance and if the Department of Transportation has never changed the highway since then why all of a sudden, magically, it's presumed to be safe now. It clearly has a blind spot when you're heading southbound. I actually had one time going along the campaigns placed the 4 x 8 sign alongside the road there. The Sergeant of the Maine State Police of that area, Darrel Ouellette, called me and said, "Your sign is perfectly legal," he said, "but we've had many accidents in that area, many near misses." He said, "Would you consider moving the sign?" Whenever I looked at it and thought about it, I, without a doubt, understood what his concern was. So it's an area that, you know, I certainly hope, regardless of what happens to this bill today, that the DOT is very sincere and serious about making sure that, you know, no further bad issues happens in that area. That's why I put the bill forward. That's why I'm asking for the roll call today, because I think it's something that has been, you know, pushed aside, probably for no real good issue, but pushed aside for too long and the people in that area are asking, sincerely, to make sure that safety of that area is taken into consideration. So with that, I'd appreciate your support today.

THE PRESIDENT: The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT:** Thank you, Mr. President. Men and women of the Senate, just briefly. This is one of those hearings where it didn't fit the rules exactly, but in listening to the testimony and realizing that we have an intersection in Camden and a couple of other communities in my district were it doesn't have an accident every day but it has several near accidents every day, people missing by inches or a foot, yelling at each other, gesticulating, and so forth. This is one of those things that doesn't get picked up in the DOT surveys, well-meaning as they are. That's what came out with the 200 people signing on so quickly. It became evident that, even with the best intentions of the DOT doing another survey, with their rules not being met exactly, this really is time for this light to be back up. It was there. It can't be explained why it was taken down exactly. It's time to put it back up and protect these folks in that area, and the locals know best in this case. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Collins.

Senator **COLLINS:** Thank you, Mr. President. Ladies and gentlemen of the Senate, as most of you know, I've been involved in the Transportation Committee going on - this is my 15th year in that committee. The Department has been very responsive to this bill. As a matter of fact, we've sent a letter to the Commissioner directing him and his Department to do a study on this and come back with recommendations. Now, not every intersection requires lights of some sort or another, but that's what we've got to find out. When the Committee voted 11 members Ought Not to Pass they weren't voting against this region getting a light, they were voting to move it along, have a study done by the professionals who understand traffic flow, that being our own Department of Transportation. Nobody is saying no to this. All we're saying is let's do it professionally, let's get an accurate report from the people who know what they're doing as far as moving traffic along point A to point B. I would recommend to the Senate Chamber that we move the Ought Not to Pass Report, let the Department do their work, come back with a recommendation, and, believe me, I'll be the first one to hold their feet to the fire, so to speak, to make sure this passes and it's done professionally and will be waiting to hear what their thoughts are on this and what their recommendations will be. Thank you, Mr. President.

THE PRESIDENT: The pending question before the Senate is the motion by the Senator from Hancock, Senator Rosen, to Accept the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, across the nation our economic viability greatly hinges on its ability to increase the proportion of our population with high quality college degrees, certificates, and other credentials. Two-thirds of all jobs created in this decade will require some form of post-secondary education according to a report issued by the Georgetown Center on Education and the Workforce. Too many in our state choose not to pursue higher education or fail to complete their programs due to an inability to afford the price tags or because of financial pressures once enrolled. Maine's Chief Executive has shown an interest in addressing affordability of post-secondary education by appropriating last session another \$2 million to raise the grant by an additional \$200 per student. This bill before us, amended, would keep us from rolling back the State Grant and

acknowledges that a \$1,000 grant today doesn't nearly have the same meaningful impact as \$1,000 back in 1992, 25 years ago, when the program began. The Maine State Grant is an important tool for helping Maine's families afford higher education as it is portable to Maine's post-secondary institutions. A student can use the grant to attend Husson or St. Joseph's College, Maine Community College or the University of Maine System. It is a critical partner to the State's funding of our State's higher education institutions. If we are committed to keeping Maine competitive and ensuring an educated and trained workforce to meet the needs of our current and future businesses than it's time to commit to the State Grants being no less than \$1,500 and firmly commit ourselves to investing in higher education affordability and in our workforce. So I ask that you vote to defeat the pending motion and we can consider the Majority Report and invest in our students, workforce, and Maine's future. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Hancock, Senator Langley.

Senator **LANGLEY:** Thank you, Mr. President. Men and women of the Senate, first of all I'd like to go publically on record to commend FAME for the work that they do for our students in this state. They run a terrific program and I don't know if this kind of organization exists in other states, but I would say that it's one of our diamonds here in this state. This program is incredibly well run and one of the programs, among many that they run, is the Maine State Grant Program. As you heard from my good colleague, Senator Millett, in statute we have a \$1,000 floor, but currently it's funded at \$1,500. There was an additional allocation last year that made it at \$1,700. The floor that's there allows some flexibility for FAME to be able to work. Whatever allocation comes to them they divvy out and they make it go as far as they can. They really appreciate that flexibility. What they're worried about is if you put in statute a floor that's higher and sometime in the future there's an allocation, we run into more problems with budgets, and if they lower that allocation that comes to them than they will only be able to help a smaller number of students. So I put my trust in them and how they operate, and I would also like to point out that this Administration has seen the value of them and has continually funded them at above the \$1,000. They're at \$1,500. So I would say that they recognize their value. I'd also like to point out that from this single pot of money that we have here they've also sent money over to the University in the Supplemental Budget to help freeze their tuition. I would argue that that money, freezing the tuition for a sixth straight year in the University System, has helped all Maine students, regardless of whether they got the grant or not. It's not just a single item issue so we're helping more students. Then there's a \$2.5 million allocation in each of the years in this legislation and I would argue that we're working really, really hard and committed to trying to fund education GPA at 55% and will be looking for every dollar we can to go towards that. So my support for the Ought Not to Pass is based on those things and would ask that, while this is not going against FAME or the work that they do, you just recognize the situation that we're in. Thank you very much.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Bellows.

Senator **BELLOWS:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I graduated from Ellsworth High School in 1993. As a low income college student, or as a low income high school student, college would not have been possible for me but for a combination of Maine State Grants and student loans. At that time the recently created Maine State Grant program awarded grants in the amount of \$1,000 annually to students in need. A thousand dollars is a big deal in 1993 but it's not now. A report to the Legislature in 2014, the final report of the Commission to Study College Affordability and College Completion, stated clearly that the Maine State Grant Program individual grants should be at least \$2,500 in 2014 to have the same buying power as they did in 1992 and in 1993 when I graduated from high school. Nearly two-thirds of Maine's students in 2015 graduated with college debt averaging about \$30,000 per student. The State of Maine is one of the smallest need-based grants awarded nationwide and Maine's total state spending is one of the lowest nationwide. I encourage you to consider defeating this motion. We should increase the floor from \$1,000 to \$1,500 to hold us and future Legislators accountable for sufficient funds to support the same or more grants to be awarded. It's time to work in a bi-partisan way to provide meaningful support to increase college affordability and support our young people. I hope you will join me in voting no on the pending motion.

THE PRESIDENT: The Chair would remind the Body that we are debating the acceptance of an Ought Not to Pass Report. The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you, Mr. President. Just a short little response. I respectfully disagree with my colleague from the Education Committee. While I certainly appreciate all of the work that the University has done to keep their tuition frozen, in my view, it does not benefit all of Maine's students and it certainly benefits those students who desire to choose a four-year degree program. The Maine State Grant Program helps even more students. It helps those who choose alternate paths such as certificate programs and two-year programs. That is why the Commission on Affordability made funding the Grant Program its number one priority. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Washington, Senator Maker.

Senator **MAKER:** Thank you, Mr. President. As a former financial aid director, \$1,000 may not be too much to some people but to people in Washington County who gets financial aid from our institution when I worked there it was their books each semester. My concern about passing this bill and increasing it is that we're not going to reach those people that really need help. I know that there's a pressure now to get the Maine State Grant up so that with PELL and the Maine State Grant that will pay Maine's tuition, University of Maine's tuition, and that's a great goal. Where are the people, the middle income families, going to get their help because in my county, Washington County doesn't have a lot of funds for scholarships. I gave an award, a big award, for students there in middle income. They got a student loan, they got \$200 from me, and they got the Maine State Grant because then, at that time, they were allowed to have that \$1,000, and I'm going to tell you it paid for those books each semester. That's what I was looking for, something that would pay for their

books because that is something every student needs to start school. I'm very concerned. By raising this money that we'll never reach that goal of getting back into helping the middle income families. I know it will be said, I'm sure, that they raised the money and didn't reach the middle income families, but I think now, I've heard this from someone I respect, that with the goal of increasing it to reach the tuition for the University then we're never going to reach that goal of trying to help the middle income families who need it the most. So I will support Ought Not to Pass.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Breen.

Senator **BREEN:** Thank you, Mr. President. I think we've all heard a lot about the exorbitant interest rates that student loan payers are being charged. That's something we cannot control. We all care deeply about college affordability and we all have constituents in our districts who are paying huge interest rates and are for decades trying to repay their student loans. Again, this Legislature has no control over that. One of the things we can control is putting more money in those kid's pockets so they have to borrow fewer dollars and pay less in interest. I urge the folks in this Body to vote against this motion. Thank you.
