WHEREAS, Mr. Pert served in the Maine House of Representatives representing Bath in the 99th Legislature and served as executive director of the Maine Democratic Party; and

WHEREAS, Mr. Pert worked as Secretary of the Senate from 1965 to 1966 and he also served 18 years as the Clerk of the House of Representatives, from 1975 to 1992; and

WHEREAS, Mr. Pert spent several years as executive director of the Maine chapters of the March of Dimes and the Arthritis Foundation; and

WHEREAS, Mr. Pert served the Town of Georgetown in many capacities, including as town moderator and as a member of the board of selectmen, the planning board, the town-owned property management board, the recreation commission and committee and the financial advisory committee, and he was named Georgetown Citizen of the Year in 2003; and

WHEREAS, Edwin H. Pert will be sadly missed and long remembered by his family, his friends and his colleagues at the Legislature and throughout State Government; now, therefore, be it

Senator **VITELLI**: Thank you, Mr. President. I rise to pay tribute to Ed Pert, with your permission.

**THE PRESIDENT**: The Senator may proceed.

Senator **VITELLI**: Thank you, Mr. President. Ed Pert has been called a Titan of the Maine Legislature who served both as Senate Secretary from 1964 to 1966 and Clerk of the House from

1975 to 1992. Some of us may remember serving with him, those with hair of my color. He served in the Legislature representing Bath in the 99<sup>th</sup> Legislature and is often credited with reinvigorating the Democratic Party in our county and in the state. He was a mentor to many, myself included, who sought him out for his wealth of institutional knowledge and his understanding of the political process. His advice to all those seeking to run for office was to get out and talk to the people, visit their homes, knock on their doors. He was adamant that if one was to run for office he or she shouldn't rely on direct mail or TV ads, but to go all the way to the voter's front door. Ed was a personal friend, a neighbor, and a beloved member of our community. Ed was such a presence in and around Bath. He would appear at events and gatherings of all kinds and could be reliably spotted at the local farmers' market, often sampling the fresh baked goods. Ed was one of the original foodies. He traveled our state widely and he made it a point to seek out great restaurants, snack bars, bed and breakfasts, and, especially, donuts. He was generous in sharing his finds with his friends and offering his recommendations of where one might find the best lobster roll in the state. If you ask me later I'll tell you. Ed had the curiosity of a journalist, which he once was, an affable and warm sense of humor that earned him the friendship and devotion of all those who crossed his path. He seemed to know everyone. One of my fondest memories is of an evening when he came to our house for dinner and, as often happened, our talk turned to politics. With little prodding, Ed regaled us with the history of the accomplishments and the personalities of Maine's political leaders, starting with the Great Depression up to the present. My only regret that evening was that I didn't have a tape recorder to capture it all. Ed was a gentle giant and is sorely missed in this community. I appreciate this opportunity, Mr. President, to speak on his behalf and would just like to welcome his family members who are here with us today. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator **DIAMOND**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I just want you to know, those of you who did not have the privilege to know Ed Pert, that he instilled in those of us who were new members of the House that he was the institution. He instilled in us decorum, how important it is to follow the rules and how important the rules are to institution. That was such a blessing because when you come new to this place you're pretty much are formed by those who are in charge and who actually lead you in whatever direction that may be. Ed was one that was his Constitution, his integrity, and his love of this institution stayed with me and I cherish the days that I had, and the years that I had, to become friends with him; mostly though, for what he taught me about this institution and how glorious it is and how important it is for all of us to protect it. I'll always remember Ed and thank him for that.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator **CARPENTER**: Thank you, Mr. President. As you probably can imagine, I also served with Ed Pert and I would echo the words of Senator Vitelli and Senator Diamond. Ed was the institution. I'm sure that the present Senate Secretary's mother has fond memories of working when she was Secretary of

the Senate and Ed was Clerk of the House. Decorum and proper handling of the State's business was always paramount with Ed and Ed always taught us to be gentle-people, gentlemen and gentlewomen, in dealing with the members of the other party or a person with whom we had disagreements. He was a great inspiration to many of us who started here, believe it or not, at a fairly young age. I last saw Ed, he came to visit me in the job I have in Bar Harbor, about three or four years ago. He looked well and he said he was enjoying retirement. We'll all miss Ed. He was a lion, if you will, of the Chamber. Thank you.
