In Senate Chamber Thursday April 13, 2017

Senate called to order by President Michael D. Thibodeau of Waldo County.

Prayer by Reverend Joan Smith, South Parish Congregational Church in Augusta.

REVEREND SMITH: Good morning. Allow me to call us together as I call upon that which is most sacred for each of us and invite you into a spirit of prayer and reflection. You and I, each called to moral and political leadership of either church or State, walk a razor's edge. You here in the Senate of the people; I in the pulpit of this capital city. How do we set our feet upon bedrock, keep our eyes trained on true north? Let us begin by remembering a time when we failed and the person who gave us a leg up believed in us, gave us hope. From that experience of our failure, let us make choices that provide hope for others who look like failures, who then have the chance to succeed and help others. Let us remember a time when we were bullied and the person who came out of the shadows on our behalf, who stood with us, protected us. From that moment of fear, let us choose what provides protection for those who have lost the ability to do so for themselves, but who might, in turn, be empowered and do so for others. Let us remember a time when we were tempted by the need to be liked, to belong, to be powerful to keep our jobs, and yet have the courage to take an unpopular stand. From that close call with denying our conscience, let us have the courage to choose what will give us peace in the middle of the night. Let us remember when we've been worn down by confusing, contradictory events and information that defy clear thinking. Then remember getting that inexplicable second wind, getting below the muddy waters to see the clear channel, the "ah aha" that points the way. Let us choose to dive deep for the clear water of truth and follow it. One of sacred scriptures in the Judeo Christian tradition reads, and I quote, "For this law, which I am laying down for you today, is neither obscure for you nor beyond your reach. It is not in Heaven. It's not beyond the sea. The word is very near you. It's in your mouth and in your heart for you to put into practice. I put before you life and death. Choose life, that you and your decedents may live in good measure in the best of their days. Let us choose so that those whom we represent, whom we lead, especially those who cannot speak for themselves, may gain hope, self-respect, and, ves, even a life worth living, that those with ease and resources who have a vision of a more just and thriving community may be inspired to their own actions by our example." In closing, as we share the terrifying responsibility of the razor's edge we are not alone. Let us draw on our sacred source, whatever that might be, to respond to human and community needs in the best of times and in the worst of times. I put before you life and death. Choose life. Amen.

Dear Honorable Members of the 128th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 329 "An Act Concerning the Law Governing the Posting of Newspaper Legal Notices and the Statewide Repository for Legal Notices."

Because we are now well into the Information Age, and given the ubiquity of the internet in our modern life, I believe that it is good policy for legal notices to be posted online. However, I also believe that requiring legal notices to be printed in newspapers at a fee does nothing but prop up a dying, antiquated industry. This requirement is a taxpayer subsidy of the worst sort. It serves to blur the line between a free press and one dependent on the State for revenue.

In the future, I would like the Legislature to explore whether we may eliminate the mandate that legal notices are posted in newspapers, but still maintain adequate notice to the public by posting online notification.

Because I think the issue of legal notices still requires attention, I cannot support this bill. For this reason, I return LD 329 unsigned and vetoed. I urge the Legislature to sustain it.

Dear Honorable Members of the 128th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 7, "An Act To Allow Conveyance of Land Previously Conveyed by the State to the Town of Bridgton." This bill gives the town of Bridgton the ability to convey nonwaterfront portions of a piece of property held for public use, if the town determines the portion to be conveyed have no identifiable public use. It also requires that revenues received by the town from such conveyance be held in a trust for parks and recreational purposes.

The state conveyed this parcel of land to the town in the 1970s with deed restrictions limiting its uses for recreational purposes. If the town does not have a use for portions of this property, which was conveyed for specific public purposes, then it should revert back to the state, and the state should benefit from the sale of the parcel or portions thereof.

For this reason, I return LD 7 unsigned and vetoed. I strongly urge the Legislature to sustain it.
