Dear Honorable Members of the 128th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 365 "An Act To Waive Background Checks for the Parent of a Child Who Is the Subject of an Adoption Proceeding."

Current law states that a court must order a criminal background check of each prospective adoptive parent of a child with the exception of a biological parent. I do not know why there is such interest in the Legislative Branch to create exemptions from the background check requirement that is intended to protect children from predators.

I understand that during the public hearing, the committee had the benefit of hearing from a probate court judge. This judge testified in opposition to the bill that "[f]ar too many stepparent background checks have yielded criminal records that include domestic abuse, felony convictions, and DHHS substantiated abuse against a child. We learn of these criminal records despite the petitioner's signed affidavit denying a criminal record."

This is enough to convince me that this bill would place Maine children at risk.

For these reasons, I return LD 365 unsigned and vetoed. I strongly urge the Legislature to sustain it.

Senator **MILLETT**: Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, for a long time summer learning programs have taken a backseat to more mainstream education reform efforts. Rather than rethink how summers could be used to support student success, policy makers have devoted their time and money to efforts to improve the traditional school day and year. Transcending the punitive and remedial model of summer schools of the past, we are now having the opportunity to look at summer learning's new form as an artful blend of core academic learning, hands-on activities, skill building, art, sports, and meaningful relationships. This new vision stems from a strong desire to use summers more strategically as a natural time of year to pilot innovative partnerships, teaching and assessment strategies while helping youth living in poverty to get a leg-up on their middle class peers. Put simply, our kids need this. Without ongoing opportunities to learn and practice essential skills, kids fall behind on measures of academic achievement over the summer months. Research dating back over 100 years confirms the phenomena often referred to as summer slide. Most youth lose about two months of grade level equivalency in mathematical computations skills over the summer months. More importantly, however, low income youth also lose more than two months in reading achievement despite the fact that their middle class peers make slight gains. This disparity has grave consequences for disadvantaged young people. Differences in child summer learning experiences during his or her elementary school years can impact whether that child ultimately earns a high school diploma and continues on to college. This bill before us, this motion before us, would not support Maine's effort to put this into practice. We have an opportunity to create a summer success program fund that would be dedicated, I mean directed, and administered by the Commissioner of Education and held by the Treasurer of State to encourage the facility of high quality summer success programs. It provides that money paid into the fund may include General Fund appropriations as well as grants, gifts, and other money from any unit of federal, state, or local government, or from any person, firm, partnership, or corporation. It provides that beginning in the fiscal year 2018-19 the Department is required to provide grant funding through a grant application process to cover 90% of the cost of summer success programs in school administrative units with greater than 50% student participation rate in the federal free and reduced price program. That's targeting these funds at those students that really need our help. I ask that you vote against the pending motion so that we can move the Majority Report and make sure more of our children stay on track to succeed in school and in life. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Langley.

Senator **LANGLEY**: Thank you, Mr. President. Men and women of the Senate, I couldn't agree with my colleague more. Everything that she has just told you is absolutely true. I think where other members of the committee may have disagreed is if

this is the best way in which to approach this. As you know, there are a lot of summer programs that are out there; 4H, the Y, there are a lot of summer camps, there are a lot of opportunities, and maybe not every student has access to them in that way. What I would propose - I'm sorry that I hadn't brought this up in committee at the time we were working on the bill because, frankly, I didn't know. I developed a relationship with Maine Afterschool Network in working on another bill regarding after school programming. In that conversation, because I named them in an amendment on a bill, we got to talking about after school programming and then summer programming. I would contend that the place to spend time and effort and finances, whether now or in the future, was within a system that's already set up and serving 6,000 students in underserved areas in after school programs. The Maine Afterschool Network is really looking for help to develop their summertime offerings. They have contact with these students. They're in the schools. They know the students and the parents. They've developed partnerships with the Department of Education, Health and Human Services, the Governor's Children Cabinet, the Maine School-Age Care Alliance, the Maine Chamber of Commerce, University of Maine Center for Community Inclusion and Disabilities, and the Maine Parent Federation, and Maine Roads to Quality. Had I done this work while we were working on this particular bill, I think I would have tried to steer us in that direction in supporting our Maine afterschool network. As it turns out, in the recent couple of weeks I've been working on this, they are looking at possibly losing their federal grant for 21<sup>st</sup> Century Funding for Afterschool Programs. I've long held that that afterschool section of time is where we could do some really good work and I believe that with the folks helping them and working to develop summer school programs I think that would be an efficient way to use a model that's already set up. By no means was my moving of the Minority Ought Not to Pass Report in any way saying that summertime programs are not important. It's extremely important to us. Thank you, men and women of the Senate.

Senator **VITELLI**: Thank you, Mr. President. Members of the Senate, L.D. 197 is a big deal. It asks us, and ultimately the voters of our state, to amend our Constitution to enshrine equal rights under the law by barring discrimination based on the sex of the individual. Amending our Constitution is not meant to be undertaken lightly. Indeed, the framers of our national and state constitutions deliberately set a high bar for doing so. Constitutional amendments have, by large, served to improve the functioning of our democracy and to advance us towards an even more perfect union. Such was the case, certainly, with the passage of the 14<sup>th</sup>, 15<sup>th</sup>, and 19<sup>th</sup> Amendments. I stand here to ask that you support taking yet another big step towards greater equality and justice for all. Why do we need this action? First, discrimination does exist. We can see it in a number of ways. Women still earn 78% of what men do. At current rates of change, this wage gap will not close until 2058. Yes, there are a



number of factors contributing to this wage gap, including the education and career choices made by men and women. I have spent my whole career encouraging men and women to find their dreams and work to fulfill their potential, so I have seen how these cultural biases work.

Studies have repeatedly shown, however, that discrimination remains a consistent factor. The face of poverty is still largely female. Women continue to bear responsibility for childcare and, increasingly, eldercare as well. The work of caring for others remains undervalued and unequally borne. Older women are among the poorest of the poor. Violence in the forms of sexual assault, domestic violence, and stalking have always been gendered crimes. We must end these evils of discrimination.

Other manifestations of discrimination are less visible, perhaps. I am the mother of two grown sons. When they were applying for college they, as males, were required to register for the Selective Service Administration in order to be eligible for financial aid. Females were not. While we have not had a draft for many years, it struck me as inherently unfair. Second, words matter. It mattered when the word "male" was added to the Constitution for the first time in the 14<sup>th</sup> Amendment back in 1868. It took another 70 years before women were granted the right to vote. It has been argued that the 14<sup>th</sup> Amendment to the U.S. Constitution is sufficient protection. Justice Antonin Scalia, in a 2011 reply to a question about the application of the 14<sup>th</sup> Amendment to address sex discrimination, said: "Certainly the Constitution does not require discrimination on the basis of sex. The only issue is whether it prohibits it. It does not." It is further argued that we have made laudable progress in passing laws to protect equal rights. We have the Equal Pay Act of 1963 and the Civil Rights Act of 1964 to address sex discrimination in the workplace. We have Title IX to level the playing field in sports and education and the Violence Against Women Act. But as members of this Chamber know, as anyone does who's paying attention to events at the national level, laws can and are repealed, replaced, revised, and rewritten. I'm not a lawyer, but I know that words matter. It matters that in 1988 Maine changed the language in Article I of our Constitution from "all men" to "all people". Yet, it may not be sufficient and it remains untested in the courts in deterring discrimination based on sex. It is time we made it clear that equal rights under the law applies to everyone, regardless of sex. It is time to guarantee that our courts use the highest standard, a constitutional standard, when faced with cases involving sex discrimination. I ask that you vote in support of this measure and help make Maine the 24<sup>th</sup> state to explicitly prohibit discrimination based on sex. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Hill.

Senator **HILL:** Thank you, Mr. President. Ladies and gentlemen of the Senate, it saddens me that it's 2017 and we're still fighting for this. I don't understand why. If our Constitution is adequate and an equal rights amendment is not needed, than why did women have to fight so long for voting rights? If our Constitution is adequate and the equal rights amendment is not needed, why did we have to fight so hard for marriage equality? If our Constitution is adequate and the equal rights amendment is not needed, why are we still fighting long and hard for equal pay? The list goes on and I ask you why. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Keim.

Senator **KEIM:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I stand to ask you to support the Ought Not to Pass motion. I respect those who hold a belief that this amendment to the Maine Constitution is necessary to guarantee women have equal rights under the law, however I do disagree. I believe women are already protected under the 14<sup>th</sup> Amendment of the U.S. Constitution and that Maine law adequately upholds equal protection. The Maine Constitution eloquently states in Article I, section I, all people are born equally free and independent and have certain natural inherent and unalienable rights among which are those of enjoying and defending life and liberty; acquiring, possessing, and protecting property; and of pursuing and obtaining safety and happiness. The respect of human dignity is genderless. I don't believe that my sex automatically places me at a disadvantage. Though I do not discount that there are instances of discrimination, I believe these are already illegal. There are pockets of society that may still need to change their outlook on women, however, if the Constitution is not already respected, this proposed change will do little to alter their perspective. Thank you.

**THE PRESIDENT:** The pending question before the Senate is the motion by the Senator from Oxford, Senator Keim, to Accept the Minority Ought Not to Pass Report, in Non-concurrence. A Roll Call has been ordered. Is the Senate ready for the question?

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Dill.

Senator **DILL**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I want to speak briefly to this measure. What this bill calls for is a \$300,000 investment into the Coworking Fund. Now coworking, basically, is just what it says. There have been several of these locations throughout the state that have done very, very well. There's one in Biddeford that over 125 businesses has gone through and made a huge difference in that area on these folks. In my area, especially, there are basically four towns that have paper mills. This is the exact type of thing that we want for paper mill towns. Our Katahdin for Millinocket is a group of local folks that's got together and has been working on that exact thing. Taking the Millinocket paper mill site and turning it into one of these coworking spaces. There was one in Portland that does coworking space with foods. Folks that are trying out foods can come here. There's a kitchen area in this type of thing.

It's one of those types of things that you really want to hear about. As I say, I think this is the perfect opportunity for any mill town, whether it be paper mills, old shoe mills, factories, or textile mills. This is happening over the state. What this does, it gives grants to these people that want to start this type of a place and I urge you to follow my light on this and vote the Ought to Pass. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Volk.

Senator **VOLK:** Thank you, Mr. President. Mr. President and ladies and gentlemen of the Senate, my colleague from Penobscot makes an excellent point. This is happening all over the state. There are lots and lots of businesses taking advantage of coworking space. I supported the funding for this program back when Senator Alfond introduced it. I believe it was in the 127<sup>th</sup> Legislature. It was put to good use, but what happened actually was that the majority of the applicants who applied in the second round of funding were the same applicants who had received grants in the first round of funding and some of the testimony to our committee was that, you know, they had purchased furniture and things like that, which I think is a little bit questionable in terms of whether that's a good use of taxpayer dollars. You know, all things being equal, the Maine coffers being full, I would absolutely support the funding of this program. I understand that there are places in this state, particularly in our rural areas, where maybe this is going to take a little bit longer to take hold, but the folks in Portland, the folks in Biddeford, you know, they are proselyting along really, really well. Businesses are taking advantage of these opportunities. They are beginning to grow and some of them even grow to the point where they are able to leave these coworking spaces and, you know, have a number of employees, and that's absolutely what we want to do. Unfortunately, in the 128<sup>th</sup> Legislature we really need to prioritize. We really need to look at our education funding. The voters told us that that was what they wanted us to do and we absolutely need to do that. We need to look at the 11,000 small businesses in the State of Maine that are already employing people that right now are subject, potentially, to an absolutely crushing tax. Our priority needs to be to not send a bunch of spending bills down to the Appropriations folks to allow them to have to sort that out. We need to prioritize and, I'm sorry, this is just not where our funding needs to be going at this point in time. Perhaps in two years. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Carson.

Senator **CARSON:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise in opposition of the Minority Ought Not to Pass Report. During my campaign in Brunswick I had the privilege of visiting a former large P-3 hanger on the Brunswick Naval Air Station that had been converted to an enterprise, or a collection of coworking spaces, called TechPlace. We often talk about how we want to bring clean technology, high paying, high skills jobs to the State of Maine. That is exactly what is happening at TechPlace in Brunswick. I do not know, in all candor, how the physical space redesign was funded, but there are one, two, three, and more person shops in there, some of them very small. One of the businesses there, a start-up, completely blew me away. Two young people started a firm that

actually makes translucent, not transparent but translucent, space dividers specifically to divide hospital care space from hospital construction space. An extraordinary idea. I certainly never would have thought of it. They are growing quickly. They will be growing out of TechPlace, in fact it's possible they will have already, but there were just two young people who started this job in a cowork space. They will be employing more people. It's much, much needed. When I talked with the owner of the business he talked about how needed it is, what a demand there is from hospitals. This is a manufacturing business that will grow and it will employ more people in Maine, and it comes from a coworking space. We certainly need these in rural areas as well as the Brunswicks, and Portlands, and Biddefords of this state. Now, while our economy is doing well, I believe is the time to invest the capital, \$300,000 is a modest amount of money. If you think two or three companies could grow like this hospital interior divider space company is going to grow, it will pay back many, many times and I urge you to vote against the Ought Not to Pass Report. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Breen.

Senator **BREEN:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I also rise to oppose the pending motion. I simply want to encourage the Body to remember that great policy recommendations come from policy committees and then go to the Appropriations process. I urge you, if you think this is good policy, to have faith in the Appropriations process and know that there are a lot of priorities there that we are grappling with and we would be honored to grapple with this one as well if it comes with a strong vote from this Body. Thank you, Mr. President.

Senator **CYRWAY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I was listening to the Senator's speech and it sounds like what I would have said two years ago. Actually, I signed onto this bill two years ago. I really like the bill. I just, you know, I'm looking at it from a standpoint where if I was, you know, I own a home and I have this little extra I'd like to put towards helping someone I would, but with the budget that's being faced to us we have to make tough decisions. This is a tough decision for me and I, you know, I certainly, if we didn't have 10% over the budgeted amount that's facing us, I would be strongly supporting this bill. I just cannot because of the budget that we're looking at. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Bellows.

Senator **BELLOWS:** Thank you, Mr. President. I rise in opposition to the pending motion and encourage you to follow me in defeating this motion so we can get to the Majority Ought to Pass as Amended. This is one of those wonderful situations where we all agree, privacy is important and the Social Security number is the keystone to your privacy and this bill was brought to address the challenge of job applications over-using the Social Security on the application itself and the lack of protections and safeguards on those applications. We heard testimony from individuals who had been directly affected and testimony from an identity theft expert who works with the FBI and with the Muskie School and in private enterprise that this was extraordinarily important. The difference in the two bills; one bill, as amended, the Minority Report, would, basically, reinforce existing law. As many of you know, you can refuse to give someone your Social Security number if requested, except as otherwise provided in federal or state law. The Minority Ought to Pass expands that definition to clarify that benefit includes, but is not limited to, employment. I assert that does not go far enough. The alternative report, that we could get to if we defeat this report, would prohibit employers from requesting the Social Security number on the application itself. The amended version would not prohibit it for pre-employment background checks, fingerprinting, substance abuse testing, or any course during employment itself. Thank you.

**THE PRESIDENT:** The Chair would remind members that it's not appropriate to talk about other reports that aren't before the Body, but to have our comments constricted to the report that is in front of us. The Chair recognizes the Senator from Cumberland, Senator Volk.

Senator **VOLK**: Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, I rise to speak to my motion and the statutes in Maine governing the protection of an individual's Social Security number are actually found in Title X, section 1272B, Refusal to Provide Social Security Number. This states: "No denial of goods or services except as otherwise provided in federal or state law. A person, corporation, or other entity may not deny goods or services to an individual because the individual refuses to provide a Social Security number." The Minority Report of L.D. 613 would add "benefits" to this provision to better cover employment applications. This leaves the decision as to whether to provide a Social Security number up to the applicant and we also would advise employers that it is bad practice to ask for, most employers, Social Security numbers on an application. However, Maine Statute specifically exempts a person, corporation, or other entity if the Social Security number is used in conjunction with a background check of the individual conducted by a landlord, lessor, employer, or volunteer service organization, and a person, corporation, or other entity if the Social Security number is used in conjunction with provision of and billing of healthcare or pharmaceutical related services. So when the job applicant is required to provide the Social Security number for a background check they still must do so. If they are offered employment, or requested to fill out their paperwork for taxes or insurance by that perspective employer, they still have to provide their Social Security number. A job applicant can refuse to provide a Social Security number on an initial job application, however it can be required on other paperwork required to review a candidate prior to the making of a conditional or final offer of employment and may also be required on additional paperwork in a pre-hire packet, like a 99 form, federal and state tax withholding forms, health insurance forms, background check authorization, credit check authorization, and applicant drug testing authorization. Most employers in the State of Maine do have to do pre-employment drug testing because it is too complicated to do post-employment drug testing, unfortunately. The Minority Report includes an exemption for the credit check, which is a requirement of certain types of employment, including positions in finance, data security, and law enforcement. Any other language would place Maine employers in violation of other federal and state requirements for those background checks which are necessary. Thank you, and I ask that you vote in favor of the current motion.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, I rise in opposition to the pending motion. I just would like to share with you a couple of brief remarks that were made by the Auburn Chief of Police, Chief Phillip Crowell. He said, "As Auburn's Chief of Police and someone who has watched too many at-risk kids grow up to become involved in crime, I am always pleased to support efforts to kids started on the right path in life and help them stay safe. With that in mind, I urge you to work in a bi-partisan manner to find additional State funds to expand participation in Head Start. As some of you have heard before from me and other law enforcement leaders from across our state, that include former Sheriff Skip Herrick and former Chief Dick Pickett who now serve with you as Legislative colleagues, there has been a great deal of research on the value of quality early learning programs. These programs reduce crime by helping children develop a foundation

for long term academic success so they don't fall behind and drop out of school. Students who participate in high quality early learning programs, such as those, also do better academically and socially in school and are more likely to graduate on time, less likely to need special education services, and more likely to be employed as adults. I have seen similar results with the Head Start program in my community at the Promise Early Education Center. The Promise Early Education Center provides children with an educational experience that gives them the skills and competence necessary to succeed in their current and future environments. I have had the opportunity to visit those classrooms and see first-hand the amazing work being done." Those are the comments of Chief of Police Phillip Crowell and I hope you will join in defeating the pending motion.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I rise in support of the pending motion and I just have a few remarks to share. In the past I have supported, actually, legislation to increase funding for certain Head Start programs. I do not disagree with my colleague from Cumberland County that there is real value in pre-K education. That said, when we look at Maine comparatively to the rest of the country in terms of the cost for Head Start here in the State of Maine versus the rest of the country we spend, as far as our cost per child, nearly 20% more than the national average, and this was not always the case. If you go back before 2010, we were actually, the cost per child in Maine was less than the national average. So you can't necessarily say that, "Oh, this is just the result of Maine's rural nature or increased transportation cost." No, we were able to be under the national average for the cost per child if you go back, and over the last several years those costs have just risen and risen until we are a very, very far outlier in both early Head Start costs and regular Head Start costs. That really says to me that other states have been achieving efficiencies in the delivery of these services that we, in Maine, have not been achieving. Before we go to the taxpayers and ask for \$2.5 million in more taxpayer money for this program, when we are already struggling to meet our current obligations in our current budget, let us look to the other states, the efficiencies they have achieved, and see if we can duplicate those here in order to provide services to more children. Other states have been able to do it. Why can't we do it? Thank you very much, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you, Mr. President. I rise to address some of the points that were made by the good Senator from Androscoggin. This bill received some testimony to explain this matter about how Maine is paying slightly higher than the national average. First, I would like to point out that Maine's vast rural geography hinders economies of scale. In addition, as a percentage of total service, Maine programs serve a higher percent of infants and toddlers than the national average and these are much more expensive for the providers. Maine's Head Start teachers are highly credentialed. Sixty-two percent of teachers in Maine have a bachelor's degree or higher. The national average is 56%. The percent of children with diagnosed special needs is almost double that of the national average. So

taken all together, these factors certainly can explain why we pay a little bit more for our children's wellbeing. Thank you.

**THE PRESIDENT:** The pending question before the Senate is the motion by the Senator from Androscoggin, Senator Brakey, to Accept Report "C" Ought Not to Pass. A Roll Call has been ordered. Is the Senate ready for the question?

Senator **SAVIELLO:** Thank you, Mr. President. Mr. President, this has been kind of a unique opportunity. I think most of us will agree that if you walk the roads you'll know exactly what the problem is. Our committee was faced with two choices. These little bottles that are out there called Nips are litter and we have an unfortunate situation where people are drinking and driving by buying the Nip, downing it, and tossing it out the window. Unfortunately, we, as a committee, could not deal with the latter part, so we decided to address the former. We addressed it by putting a nickel deposit on those containers. We put a compliance date of 2019 to give those people who manufacture these Nips and fill them the opportunity to comply with that and certainly have given them the choice to put their own labels on if they so desire. It's the best thing for us to do. If we had another company that came into the State of Maine that was creating this

problem, and complained about the 8¢ that may have to be attributed to putting those labels on, we would probably say, "So sorry, so sad, put the labels on." That's what this bill does and I hope you will all support it. Thank you very much, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator **MASON:** Thank you, Mr. President. Mr. President and ladies and gentlemen of the Senate, I won't prolong this any longer, but I'll just say what I said in caucus. As Chair of the VLA Committee and somebody who worked on the liquor contract in 2013, I have concerns about this product, potentially, being pulled off the shelves. I've heard that debate while this bill was going around in the Chambers and, while it may be true or it may not be true, I do have concerns about the revenue that is brought in by this sized product. So that's all I wanted to say about it. I just wanted to register my reservations. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO:** Thank you, Mr. President. The good Senator's absolutely right, but if somebody pulls it off the shelf they pull about \$7 million of revenue from the State, including about \$1 million in tax revenue. I would think twice before I did that.
