Dear Honorable Members of the 128th Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 146 "An Act To Protect the Confidentiality of State and Local Government Employees' Private Information."

This bill would exempt from public view certain information about public servants. I do think there is an important balance between the public's right to know and the privacy interests of public servants. Unfortunately, this bill strikes the wrong balance. I also believe that this bill, if passed, would have unintended consequences. While I support making social security numbers confidential, the public should have a right to know about those who make decisions on behalf of the public while serving in government.

For this reason, I return LD 146 unsigned and vetoed. I strongly urge the Legislature to sustain it.

Senator **DOW:** Thank you, Mr. President Pro Tem. Good morning, ladies and gentlemen of the Senate. I rise this morning to speak to this sentiment recognizing Rick Burt of Boothbay Harbor. Rick grew up in New Hampshire but he came to love Maine through family camping trips at Hermit Island in Phippsburg and Muscongus Bay in Lincoln County. Intrigued by building and architecture from a young age, he graduated from Middlebury College with a major in Art and then completed his Masters in Architecture at the University of Minnesota. Rick and his wife, Barbara, met through their shared affection for Maine islands. Together they decided that Maine was where they wanted to raise their two young daughters. The Burt family moved to the state in 1986 and Rick took a job with the Brunswick firm of Moore Weinrich. Moore Weinrich eventually became Weinrich & Burt when John Weinrich and Rick became business partners. After several years, they relocated the firm to Damariscotta, as both partners lived in nearby Newcastle. Later, upon John Weinrich's retirement, the firm became Richard Burt, Architects.

Within a year or two of moving to Maine, Rick started working on much needed renovations of the Maine State House, among other projects. Throughout these years, Rick completed many projects in Maine, including a master plan, the dining hall, the science wing for Lincoln Academy, and several buildings for the Darling Center Campus of the University of Maine. But his most significant project was the ongoing renovation of the Maine State House. Working closely with the State House Executive Director, the Legislative Council, historic preservationists under the tutelage of Earle Shettleworth and construction managers, Rick helped to bring the aging edifice back to health. Today the Maine State House stands as a proud symbol of Maine's past and a vibrant meeting place for Maine citizens in the 21st century. It is an enduring professional legacy that Rick feels honored to leave as he steps down after 30 years. I am pleased to have Rick join us today, along with his family, friends, and colleagues from Lincoln County and the State House, and congratulate him in front of this Body for dedicating 30 years serving the State of Maine and restoring the State House. Thank you, Mr. President Pro Tem.

Roughly \$1,000 - \$960 when you go to the emergency room. Anybody who goes there is going to pay that much, number one. Number two, how many MaineCare patients went to the emergency room. That last data that I have is from the Muskie Study four years ago and the number is 8,375. Well that means MaineCare spent \$8,375,000 roughly on that group of people. In other words, a significant amount of money. How much will this cost? The fiscal note is roughly \$2.5 million the first year and I think \$3.1 the second year. In other words, it is a question of penny wise and pound foolish if we don't do this. We will be saving money. Can you save money by spending money? The answer in this instance is yes. Thank you, Mr. President.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from York, Senator Hill.

Senator **HILL:** Thank you, Mr. President Pro Tem. This is a complicated part of the law, so I'm just going to try to succinctly put it out there. Basically, we have a premise in law, especially for tort law, that defendants are joint and severally liable for both pecuniary and nonpecuniary damages. This bill tries to move this in a new direction, which is most inappropriate for Maine because the way we developed the law was to protect our Maine citizens. What this bill tries to do is pull out the nonpecuniary part and say it will only be - defendants will only be - severally liable. Not good for Maine people. I want to point out a couple of things. This is a misleading titled bill because it unfairly and unnecessarily removes the foundation of a principle of Maine civil law. Maine is not an outlier here. Forty-six out of fifty states have this same principle. What's bad about this bill is that it would hurt thousands of Mainers who are injured, maimed, disabled, as well as the survivors of those killed by the negligence of others. Once liability has been established and damages are awarded, under this new premise the defendants are free - I'm sorry, under the original premise defendants are free to litigate amongst themselves to come up with a better division of liability, but under the new method it would leave the victims possibly being under compensated and having to go after each and every defendant in hopes of recovering their damages. You know, in my book that just makes our Maine people victims a second time around. So I hope you will follow my light and move against, vote against, this pending motion.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you, Mr. President. Men and women of the Senate, I hope that members of my caucus heard Senator Hill very well because she did a far better job than I did in caucus this morning in trying to explain this very complicated subject. I think she's done it well. The question is here: when someone gets hurt where is the burden going to lie? I think we can all agree where the burden should not lie is on the innocent victim. I doubt that anybody here has heard from any of your constituents on this bill. The reason you haven't is because the people who will be affected by this are yet to be determined. If there were an association of people who would be impacted by this bill you

would call them the Future Victims of America. We just don't know who they are. But when something bad happens to them, I think we should all agree that the innocent victim shouldn't bear any of the burden of the wrongdoing of others and let the negligent parties, if there is more than one, let them sort it out between themselves who is going to pay and don't make the victim pay. This joint and several liability has been a concept in our jurisprudence for centuries and there are efforts that chip away at it, well-funded efforts, by groups that have an interest in doing this, mostly insurance companies. Our law has worked well in Maine. I don't know that there's ever been - if anyone at the hearings suggested there's ever been any abuse of this law and it puts the burden where it should be, on people who negligently cause injury to others. So I hope that my colleagues will follow the light of the good Senator from York in opposition to the pending motion. Thank you, Mr. President.

Senator **KEIM:** Thank you, Mr. President. So I'm going to speak up as not a lawyer and try to explain the other Mainers out there that we also need to protect. So this law, it's true that other states have joint and several liability laws. However, only eight other states have it like Maine does and the rest allow some sort of percentage to be faulted and so this bill goes to more talking about pain and suffering. So the extra added cost on top of medical bills and whether or not, you know, you had certain actual damages to property and to, you know, bodily injury. So what this does is this protects the people that happen to be the only ones that can pay for pain, for everything that went wrong. So I think we are protecting Maine people with this, but we're protecting them fairly so that they're not called upon to make up for someone else's fault just because they're the ones that happen to be able to pay. Thank you for your consideration.

Senator **HILL:** Thank you, Mr. President Pro Tem. I speak against this motion because about eight years ago we formed a commission and we came up with an indigent - as a result of the study commission we came up with the Maine Commission on Indigent Legal Services. We did that not out of choice. I mean some of us may have wanted to see something like this happen. It was already happening at a level within the judicial branch. But the fact is constitutional law for the United States, as well as constitutional law for the State of Maine, requires that we help people have representation, and so the commission came up with a program here and the whole purpose of it was to deliver efficient and high quality representation to indigent criminal defendants, juvenile defendants, and children and parents in child protective cases. This had to be done, again, consistent with

federal and state constitutional, as well as statutory obligations. There's an area that's a little gray, which is really the focus of this bill, and that is if there is a case that should be taken to the U.S. Supreme Court it's not clear, in terms of the commission members, whether they have permission to approve it. After discussing it, many of us on the committee said this is part of the system. If we are going to give people representation then we need to make sure they can take it all the way that they have the right to take it. I just also want to point out that this doesn't open a floodgate of expenses and litigation. The U.S. Supreme Court looks, entertains the thought - well, let me put it this way, the U.S. Supreme Court gets about 8,000 filings a year. Out of that 8,000 they only take about 80 cases on. So the estimate was, from those stepping forward on promoting this bill, that maybe one case would make it in Maine, not even every year. But that would be about the risk. So, again, whether you like this or don't like it, the fact is we really do have a constitutional and statutory obligation to make sure. This is very clear on our books. So I would ask you to please comply, get the State of Maine in compliance with this, and follow my light voting no against this Minority Report.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you, Mr. President. Men and women of the Senate, I rise in support of the pending motion for actually many of the same reasons that my good friend from York County is opposed to it, and that is that less than 1% of these petitions are even granted. The additional expense to the indigent legal system comes not from the rare case in which the cert may be granted by the court but it's the filing fee for every case, whether it's rejected or not. Since less than 1% of the cases is accepted, and since we are mightily struggling to keep up with our constitutional obligation to fund regular old trial defense, I don't believe this is another avenue we need to go down. Thank you, Mr. President.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Cumberland, Senator Carson.

Senator **CARSON:** Thank you, Mr. President Pro Tem. Ladies and gentlemen of the Senate, I was a staff attorney with Pine Tree Legal Assistance a long time ago, 1977 until 1983. During the course of my six year tenure with Pine Tree Legal Assistance I was in federal court perhaps a half a dozen times. I went to the first circuit court of appeals in Boston, which is the level, as I'm sure you know, between federal district court here in Maine and the U.S. Supreme Court, once. But notwithstanding the fact that I had so little experience in the federal court system and went to the U.S. circuit of appeals only once, a fundamental aspect of an American citizen's access to our justice system is to be able to go to any court that will hear the case for the purpose of giving us and our clients, our lawyers and our clients, justice. So I urge members of this Body to vote against the pending motion and to support an affirmation that we, as members of the Senate of the great State of Maine, want to see our citizens have access to justice, including the highest court in our land. Thank you very much.

Senator **VOLK:** Thank you, Mr. President. I do want to take a moment to speak on my motion. This is a very important issue that affects the entire State of Maine, and it is the issue of homelessness. I want to take a few minutes to explain to you what this legislation would do and then I understand that there will not be a roll call, but I still want to take a few minutes to educate everybody on this. So what this legislation, L.D. 970, would do is to fund a model program called Housing First in Portland, likely, and I want to tell you about what has happened since 12 years ago when Preble Street opened the first Housing First Program in Maine. Thirty of the state's most chronically homeless people moved in and the numbers recording homelessness dropped, and they dropped significantly and they stayed low. So Logan Place, that one project with only 30 apartments, caused a 10% drop in homelessness for the City of Portland and a 5% drop for the entire state. So if you think about that impact, 30 apartments and homelessness dropped by 5% for the entire State of Maine. It's quite an impact. So besides shelter numbers dropping, Housing First is also an evidence-based practice that saves money and that's why I'm willing to support this legislation. I've stood up many, many times in this Chamber, and I'll stand up many, many times again before this session ends, and I'll push this button many, many times before this session ends not to fund programs, but I do believe that when we have an opportunity to spend money in order to save money that we do the right thing and the smart thing and we support that. That's what this legislation will do. When you look at the numbers around Housing First, there was a 70% decrease after one year in healthcare usage, a 71% decrease in ambulance usage, a 74% decrease in emergency room usage, and we all know what that equates to, an 88% decrease in jail time, a 95% decrease in emergency shelter use, and a 35% decrease in mental health care, but that impact is actually saving money. So despite the dramatic increase in mental health care utilization, costs fell. Consumers received twice the amount of care for a fraction of the cost because they were relying on regular out-patient treatment that is far less expensive than crisis emergency room or in-patient care. One other point that I just want to make when I'm speaking on this, and the fact that I'm willing to support this, is that I do have some reservations, and the reservations that I have are that in the State of Utah, where Housing First has been extremely successful - and

Utah at this point basically has no homelessness, it's extremely low, - a lot of the funding is coming from private sources and I think we need to wonder why in the State of Maine and ask the question of why in the State of Maine organizations that are doing such good work, private organizations like Preble Street doing such great, amazing work, are now having a very hard time raising funds and doing fundraising. Why is that? Is that going to continue to be a problem and is that problem going to be worse because of some of the policies that we have an opportunity to weigh in on in this Chamber? So I would advocate that we all support this, but I would also advocate that we consider what we are doing to the population of people that have traditionally supported these types of organizations. Thank you.

Ladies and gentlemen of the Senate, I rise to speak in opposition to the pending motion and to share with you what this bill does, or would do, should we defeat the pending motion, to establish the Advisory Council on Senior Housing to study the unmet need for affordable housing units for elderly residents of the State of Maine as well as the financial burden and requirements for home modifications and repairs necessary to enable the state's elderly residents to remain in their homes. This bill, this council, would make recommendations to Maine State Housing Authority and, very importantly, this council would be directed with developing a strategic housing plan for the entire state. We heard no testimony in opposition to this bill at the public hearing. Instead we heard testimony from groups including AARP of Maine, and I will quote, they said, "Safe, accessible, and affordable housing is a top concern for older Mainers. In 2014, we released a survey of 50+ Maine voters and one of the key findings of the survey is that an overwhelming majority of 50+ Mainers want to age in their own home and communities they love." We also heard testimony from the Maine Affordable Housing Coalition who noted that Maine has the oldest population and the eighth oldest housing stock in the nation. There is currently a housing shortage of 9,000 units of affordable housing, that's expected to rise to 15,000 units. There's a huge unmet need. Given Maine's demographics, given our aging population, given the urgent need, I urge you to join me in defeating the Ought Not to Pass Report.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Cumberland, Senator Volk.

Senator **VOLK:** Thank you, Mr. President. Mr. President Pro Tem, I just want to take one more moment to speak on this issue. Ladies and gentlemen of the Senate, this is well-intended. Of course we are all concerned about the housing problems facing our oldest residents. However, creating a Senior Housing Advisory Council is really quite unnecessary. The proposed council would have 12 members, plus invited federal agencies, plus Maine State Housing Authority staff, working for five years to

produce a report that tells us pretty much things that we already know. The council would review existing data and reports. This is being done by many organizations, including Maine State Housing Authority, already. The council would look at the cost of doing repairs that would allow older people to remain in their homes. Maine Housing is currently running a pilot program that does exactly that. The council would identify other innovative strategies to help seniors remain in their homes, secure alternative housing. Many organizations, including Maine State Housing Authority, are doing this now. Creating a 12 to 15 member council in law to spend five years examining things that we are already doing, or could easily do, does not seem like a good use of our time or resources. I urge you to support the pending motion. Thank you.

Senator **MIRAMANT:** Thank you, Mr. Chair. Men and women of the Senate, this was a bill that I put in. We already accept \$5 cash contributions for the Clean Election Fund, but, as you who use it know, we have to sell a money order. It's a costly and confusing process for folks. So I turned this over to the Ethics Commission and they came back with we would like two places where people sign and their initial choice was a money order. It lets them compare signatures and it lets them make people feel like they have signed onto a contract, yet there is nothing on the money order that really says that. The only language is on the qualifying contribution page and I felt it was strong enough. The commission, including the board, felt that having a second page with a statement that talked about not receiving anything of value for your \$5 would just reinforce the seriousness of this. I know some of you are just against the Clean Election and would never use it. That's fine. I understand. But for those of you who use it, and this isn't partisan, this will make it easier for you to do it at those big events that you go to instead of trying to deal with the money orders, and folks will understand it better because they're always confused when you say, "Well, here's the \$5 money order," and they're like, "What?" So you're saying, "Well, this is to show you how serious this is, that you're not taking anything." What? Why would I think that signing my name on this money order that cost you a dollar for this \$5, why would that make me think it's serious. What I think is that it's foolish. Others thought the same thing. So the commission came up with this policy. I heartily agreed with it. It clarifies things. It doesn't change anything. We can still take \$5, just like we could before. This doesn't add any rules. So, for all those reasons, I think it's a great idea and I encourage you to vote against this motion and then to vote Ought to Pass. Thank you very much.
