- 2. Join with any other states that have formed a coalition to implement and comply with the goals of the Paris Agreement.

**THE PRESIDENT PRO TEMPORE**: The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT**: Thank you, Mr. President. Men and women of the Senate, I present this order in response to a crisis that we are facing and that we need to really examine closely. I request to speak to the order.

#### READ.

**THE PRESIDENT PRO TEMPORE**: The Chair recognizes the Senator from Knox, Senator Miramant.

Senator MIRAMANT: Thank you, Mr. President. Sorry, I got anxious there. Men and women of the Senate, the Paris Agreements have been in the news a lot lately and what it represents to me is a coming together of the whole world to address a problem facing the whole world, and each one of us has a part we can play. The United States joined this group. Only two countries didn't. One because they didn't feel it went far enough and the other because its government, if they set foot in France, would have been arrested and jailed. So pretty unanimous consent to the agreement and what I want is that we look at the reasons for it. We need to hold the line at two degrees. We made this focus on STEM. We hear STEM every day in education. Science, technology, engineering, and mathematics. All four of those groups are represented in the folks researching how the temperature rise is affecting us. But we have it every day. We watch it. We deal with it in the Marine

Resources Committee, when I was on it, every day. Sea level rise. Acidification. Acid rain on the rest of the state. We have so much going on because of the carbon dioxide levels in the environment. The fact that the ocean absorbs them. Without a balance we're pushing rise to levels that won't sustain life as we know it and, if not caught and stopped, life at all. So we need to be figuring it out now because we're living the effects of 20 to 30 years ago. What we did then is what we're starting to see. So these agreements are, it will try to hold the line beyond the development of the industrial society at two degrees, or 3-1/2 degrees Fahrenheit. Beyond that, acceleration of damage is pretty rapid. One of the ways that I know that I had a unique perspective on our world was flying back and forth to Europe, watching the glaciers on Greenland, and seeing that there's this expanse of white over a distance you can't believe. That white would have small pools of blue, a blue that you've never seen before. It's unbelievable color. If you could just capture that in a crayon. But now what I'm hearing from my friends who are still doing it is that it's not small pools here and there, that it's big lakes, that it's rivers rushing to the ocean. Greenland has enough ice that if it melts it could raise the level of the oceans 21 feet. So it's important that we keep the ice where it belongs, that we're not doing already. We haven't gone too far towards stemming this rise of temperature and it's going to go way beyond 3-1/2 degrees, another 3-1/2 degrees, by 2050 at the rate we're going. I'm sorry. I'm trying to think of all the things and say them in a way to encourage us to just embrace this with the world and try to use the technologies that are now available to clean up our environment.

So some people are concerned that this is putting a burden on the more developed countries that have had the benefit of using polluting technologies to advance their societies while others are suffering at the hands of it, and the way that we did that was to agree to pool money to help some of those developing countries, but we're not obligated. This is something we can choose to do. I think we must choose to do it. We're also not liable for any damage that the results of warming do to the countries that are going to suffer the worst. That was specifically prohibited in the agreements. But every five years we're required to look at what we're doing to stem the rise of temperature around the globe and I think by working together we have the best chance to do it. We bring everyone in. We report what we've been doing. We see if it's making a difference, and then we work to try to help those countries that are having the hardest time with it to move forward. It's a goal that we need for this planet and for the people of this planet, and I really would encourage you not to support the motion and to instead pass this along and then join us all in working to solve this problem. Thank you. Has a motion been made, Mr. President Pro Tem?

THE PRESIDENT PRO TEMPORE: Just its passage.

Senator MIRAMANT: I move its passage. Thank you.

**THE PRESIDENT PRO TEMPORE**: That one's already out there. The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO**: Thank you, Mr. President Pro Tem and ladies and gentlemen of the Senate. I am concerned about climate change and I am not a climate change doubter. However, in 2002, when I first got here, one of the first things we did in the

Environment and Natural Resources Committee is establish some goals for the State of Maine. I have not have time to look into those goals because I just saw this on the calendar last night. But I would suggest to you that I wouldn't be surprised if we've come very close to those goals. One, because we've gone to natural gas, mostly, in the state. Two, because of the renewables we're using. Three, sadly, because of the number of mills that have closed in area, and, thirdly, which I'd like to expand upon but won't have in my time as legislator, is recognizing the forest as a sequester of carbon. We are very fortunate that over 90% of the state is in a carbon sequestration program. But we do not have the time and resources to address this global issue. However, I will ask DEP to come back and report on their efforts either during the summer, when we have one of our committee meetings, or during the year next year. As a result of that, Mr. President, I make a motion that we Indefinitely Postpone this order and all of its accompanying papers.

**THE PRESIDENT PRO TEMPORE**: The Chair recognizes the Senator from Kennebec, Senator Bellows.

Senator BELLOWS: Thank you, Mr. President Pro Tem. Ladies and gentlemen of the Senate, one of the tragic consequences of the opioid crisis in our state is the rise in the number of babies born affected by drugs. Tragically, Maine has the second highest rate of babies born addicted to opioids. One in every twelve births in our state is a baby affected by drugs. MaineCare covers more than half of the births in Maine and more than 75% of the births resulting from unintended pregnancies. Among women struggling with drug addiction more than 85% of their pregnancies are unintended. Annually MaineCare costs covering unintended pregnancies are \$58 million. The Maine Legislature created the MaineCare Limited Family Planning Benefit in 2015 to provide reproductive healthcare to women who would be eligible for pregnancy related coverage. As it stands now women have to apply for the benefit and ask that the Family Planning be covered as part of a 90 day look-back. But that is about to change under the new Medicaid waiver applied for by DHHS, so women would have to apply for coverage several months - and wait several months to deemed eligible and get those contraceptives. By then, for many women, it will be too late. It's almost an insurmountable barrier for women dealing with addiction. This bill would provide presumptive eligibility to allow women to get the contraceptives they need as soon as they need them. Healthcare staff would be able to deem them eligible for short-term coverage while their permanent application is pending. These are the same women who get presumptive eligibility if they are pregnant. It will streamline access to contraceptives to allow them to avoid unintended pregnancy and avoid getting pregnant while they're still struggling with their addiction. It will save the State millions of dollars over the long-term, but, most importantly, it will help women. It's a concrete step we can take to confront the opioid crisis and I urge you to join me in opposing the pending motion.

**THE PRESIDENT PRO TEMPORE**: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY**: Thank you, Mr. President. I rise in support of the pending Ought Not to Pass motion for a number of reasons. I'll be brief. First let me say what this bill does is somewhat unprecedented. Which is fine. We often do unprecedented things in bills. Sometimes, you know, we're looking to make real changes. But what is done here - I think we need to understand what presumptive eligibility is and what its current status in law is. Currently, there is only one case, or one situation, in Maine where

any group is awarded presumptive eligibility and that's in our hospitals. We have presumptive eligibility in our hospitals because our hospitals are required under law to take people whether they want to or not. They are required to see anyone and everyone who shows up at their doors and so we have offered them presumptive eligibility for their patients so that they can receive some help, compensation, in cases there. It should be noted that they don't always use that, but that is the only situation where we have presumptive eligibility. This would be the first time we provide presumptive eligibility to any group outside of that. Now is that a good thing or bad thing? That's certainly a matter for debate, but the problem is this bill was a concept draft when it came to us at the public hearing. Then this, what we have before us, the amendment relating to presumptive eligibility was just thrown in at the work session. We never had a public hearing on that. We don't know the real pros and cons of what the precedent might be if we were to potentially open Pandora's Box and start awarding presumptive eligibilities for MaineCare. If we'd had a public hearing we could know. So if folks who like this idea want to bring this bill back in the future, when we can hear it and have a real public hearing on it and know what the unintended consequences might be, then that would be a welcomed thing to do. But to make a change like this without a public hearing, I think, is irresponsible. Thank you, Mr. President.

**THE PRESIDENT PRO TEMPORE**: The Chair recognizes the Senator from Cumberland, Senator Chipman.

Senator **CHIPMAN**: Thank you, Mr. President. With all due respect to my good friend and colleague from Androscoggin about presumptive eligibility, I'd like to point out that pregnant women also get presumptive eligibility. It's not just situations where folks show up at hospitals. Again, I just want to stress the importance of this bill as we're dealing with the opioid crisis. It's targeted towards women and adolescents who are participating in substance abuse disorder treatment. So folks that are participating in treatment, they've got a drug addiction. We need to link them up to services and have them have access to contraceptives to avoid more pregnancies with drug addicted babies. It's a serious problem and I hope you'll join me in voting against this motion. Thank you.

**THE PRESIDENT PRO TEMPORE**: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator CARPENTER: Thank you, Mr. President Pro Tem. I rise in part, I suppose, in my capacity as a guardian ad litem. I have stood in the NIC Unit at Eastern Maine Medical Center in Bangor and I have stood in the NIC Unit at the Maine Medical Center in Portland and if this bill will prevent one more baby from going through the hell that they go through when they're withdrawing post-birth from opioids it's well worth it, just in financial terms, if vou want to just boil it down to financial terms, because many of these children that I've watched have the terrible tremors and the uncontrolled crying for hours as they're withdrawing from their mother's addiction. It's heart wrenching to watch. But further, as you go down the line, these children are damaged for years and the amount of State money that we will put into these children going forward, probably never to have them fully recover, but to even get them to a place where they can live something that we might regard as a normal life, thousands and thousands of dollars. So if this bill might prevent one of these little babies,

because these little babies can't tell us how bad they're hurting and they cry for hours and they shake and they tremor. Thank you.

**THE PRESIDENT PRO TEMPORE**: The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I, too, rise in support of the - I'm sorry of the Ought to Pass aspect of this. I, too, have seen drug addicted babies. They are truly heart wrenching. This is a very common sense bill for mothers and for small children. I would simply note that right now a large number of women who are on opioids are not eligible for Medicaid. However, as soon as they become pregnant they then become eligible for MaineCare. This is a backwards way of thinking, to try to go along with the Ought Not to Pass. We want to prevent the pregnancies. It's entirely up to these women, but, as has been said, the study that came out of Johns Hopkins says that 80 - 85% of these women have unintended pregnancies. This is a common sense way that we could begin to cut back on this human tragedy. Thank you, Mr. President Pro Tem.

Senator CUSHING: Thank you, Mr. President. Mr. President Pro Tem, ladies and gentlemen of the Senate, I rise to address the question from the good gentleman from Aroostook County. You will note on your desk I have distributed a copy of my testimony to the committee in regards to L.D. 1174. This is a fairly simply process, Mr. President, that I'm requesting the Body to consider. When anyone enters a piece of mail into the United States Postal System for bulk purposes, either first or third, there is a form that the postal service provides. I have attached a copy of that form. It indicates information regarding this mailer. It does not include a copier of the mailer or the content of the mailer, but it does identify that a certain number of pieces going to certain locations have been entered into the United States Postal System and will be delivered by their carriers. I think that the purpose that we're look at, Mr. President, is an accountability metric, particularly in regards to the use of taxpayer money in the election process. I reviewed the Maine Commission on Governmental Ethics election site which tabulates the expenditures and the contributions to campaigns. This is a form that can be sorted by the vendor and it is clear in the 2012 and 2014 election cycle that certain vendors received considerable amounts of funding from candidates, which I have no problem with. The question that I feel rises to the level of considering this bill is the fact that there is over a quarter of a million dollars' worth of funding that flowed to members of this Body who ran for election using the Clean Election, or taxpayer funded, method. Those funds were expended. I see an important transparency measure that could be addressed by simply using a form that is currently in use by the U.S. Postal Service that attaches to every mailing. I don't understand why somebody would be concerned about this bill. We're very concerned about accountability and transparency in this Body. Mr. President. Anyone who is using taxpayer funding should be willing to accede to the accountability for the tax money that they have received. The simple inclusion of this form does not violate their strategy or their privacy in the mailing that they have put out. It doesn't question the mailing. It just questions whether or not they did, in fact, use money allotted to them through this system for the purpose of mailing to constituents in their district a political advertisement or informational piece. I would look at the numbers on the Ethic Commission's report and note that the vast majority of those numbers going to this consultant, Ourso Beychok, are rounded numbers, Mr. President Pro Tem. They are not indicative of numbers that might consider the calculation of postage being expended. So there may be a simple solution and explanation, which we certainly can't get into here, Mr. President. I believe before the committee, the Veterans and Legal Affairs, that might have been addressed, but sine we're at this point now, and the bill has come forward, I would urge members of the Body to support this measure in the spirit of making sure that we account for the taxpaver money expended in our election process. Thank you, Mr. President.

**THE PRESIDENT PRO TEMPORE**: The Chair recognizes the Senator from Piscataguis, Senator Davis.

Senator **DAVIS**: Thank you, Mr. President. Ladies and gentlemen of the Maine Senate, if you should happen to currently live on a private road that has a legal road association that association can assess your property 1% of its current assessed value to maintain the road. The bill that was brought before our committee would have increased that to 2%. Instead the committee decided to remove the cap altogether, allowing the unlimited assessment. Well, as many thing happen in the Maine Legislature, somebody raised the issue and what the issue was that they raised was that if you live on one of these association roads and say, hypothetically, that it is a gravel road and you live

on land that has been in your family for many, many years and you are of modest income and some wealthy people come in and they buy some property and they decide they're going to have that gravel road be paved. They decide it's going to be paved. Then they can simply do it and you would be assessed whatever percentage of your assessed value would be. What the amendment does, it goes back to the original bill and raises it to 2% but it requires a unanimous vote of everyone on the road, by everyone in the association, including the person of modest income compared to the wealthier people. They all have to agree to raise it above the 2%. That's what it does. Thank you, Mr. President.

**THE PRESIDENT PRO TEMPORE**: The Chair recognizes the Senator from Kennebec, Senator Bellows.

Senator BELLOWS: Thank you, Mr. President Pro Tem. Ladies and gentlemen of the Senate, thank you to the good Senator from Piscataguis County for bringing this to our attention. There's politics that can be more bitter and divide neighbor against neighbor more permanently than their worst partisan wrangles in this Body and that's association politics when they go bad. I live in a district with many beautiful lakes and many road associations. So I paid special attention when a local road association contacted me about the amendment before us. They said that they had no problem with capping payments at 2%, nor do I, but they were concerned about the drafting of this amendment and that allowing elimination of the cap by unanimous vote could cause ceaseless debates and controversy at the local level. For that reason, politically, they've urged us to reject the amendment, but they had two technical concerns with the amendment. The road association pointed out that the voting procedure under the amendment is inconsistent with the underlying statute because of the voting. The amendment reads the unanimous vote of each individual property owner who is a member of the road association, but then under Title 23, Section 3101, Subsection IV, on voting, each individual owner of a property does not necessarily get a vote. The votes are given to the parcels. Additionally, the road association that contacted me pointed out that the amendment may conflict with road association bylaws regarding assessment of fees and might require significant and costly redrafting of road association bylaws. So I would respectfully request that we reject this amendment and consider, potentially, an amendment that might put in place a 2% cap or some other alternative, but that this amendment raises some unintended consequences and at least creates a controversy for at least one of my local road associations. For that reason, I will be voting against it. Thank you.

It's made up of citizens and members elected by citizens to oversee many programs, including our welfare programs. As such, this bill is not necessary. Thank you very much, Mr. President.

Senator **CYRWAY** of Kennebec was granted unanimous consent to address the Senate on the Record.

Senator **CYRWAY**: I stand before you today saddened after learning about the death of Fryeburg police officer Nathan Desjardins. Nathan lived in Albion and was also a part-time police officer with the Winslow P.D. Nathan was one of my DARE students. His mother is a close friend of mine. She worked on

my father's farm and also at the Waterville District Attornev's Office. Great family. Nathan was critically injured while responding to his water rescue on the river in Fryeburg. I believe he had been - it was his first day on his shift for the river duty. This time of year, from now until September, the high crime area is on the river because you get a lot of people from out-of-state and also the college kids and whatever else. It's just historically a high crime area and so he was assigned to it and that was his first shift on that. He's been three months with the Fryeburg Police Department. Nathan's death is a tragedy. It should remind us all that law enforcement officers put their lives on the line each day to protect us all. I have my black band on my badge. We wear it for at least a week, the whole state, when we lose an officer in the line of duty like this, for our brotherhood. That agency they'll wear it for a month. I ask that you keep Nathan's family, friends, in your thoughts and prayers. Mr. President, I ask that when the Senate adjourns today we do in honor of Nathan Desjardins. Thank you.
