Senator **DESCHAMBAULT:** Thank you, President Pro Tem. I would like to speak on this sentiment and make a few comments. Today the Maine Senate recognizes a Maine-based company as they celebrate their 50th year in operation: Volk Packaging Corporation. When I first did this I said, "What is Volk Packaging?" Although I know a little bit about it, Volk Packaging designs, manufactures, and distributes high quality corrugated and foam products, including shipping containers, inner packaging, and stock boxes, throughout New England. Volk Packaging is a third generation family owned and operated business. But what's so special about making a box? Any company can do that. However, they have a special niche in Volk Packaging. They can build packaging solutions through innovative design. Whether you need a rugged container for shipping or a custom painted product to boost retail sales, Volk provides the solution, not only for their product, and you'll later hear how they have positively impacted their host community also. In 1967 Benjamin and Kenneth Volk incorporated their company and the following year they opened a packaging company with five employees. They settled in the little business park on the outskirts of Biddeford and became the anchor for a growing community. Thirty years later, two of their original employees retired. Benjamin Volk passed in '96. After the retirement of Kenneth in 2007, the company is now led by Douglas and Derek Volk. This company, over the years, has been an economic boom for the area, having employed about 2,000 people. Today, they are currently 85 employees working two shifts to keep up with demands. Half of their employees have over ten years with the company. This speaks loudly of the company's reputation as a good place to work. Owners are also proud of the fact that they have given legal immigrants their first job and four have become U.S. citizens. This is evidence of Volk's involvement and commitment to their employees and their families. Volk is a tremendous corporate citizen. The company has donated over 100 different charities in 2016, amounting to almost \$100,000 for the local economy. They expect to spend over \$4 million with Maine vendors this year alone. Volk will manufacture and ship 50 million boxes this year to over a thousand different customers. Alan Casavant, former Maine House legislator and current Mayor of Biddeford, offered the following statement, "Volk Packaging and the Volk family have been an important fixture in Biddeford industrial landscape for 50 years and their longevity is a testament to their values, ethics, and savvy. The number of their employees who have spent decades working at Volk Packaging says a great deal about the workplace and about management. In my opinion," says Alan Casavant, "Volk Packaging is a superb model of a Maine family operated business and I value their presence in the City of Biddeford." Is it any wonder, after hearing all of this, that Volk has been the recipient of one of the Best Places to Work in Maine? Thank you very much.

I rise today to offer my sincere congratulations and thanks to David Sherry who is just retiring as Executive Director of the Maine Educational Center for the Deaf and Hard of Hearing, which used to be known as the Governor Baxter School. It's the only educational institution in the state of Maine dedicated to serving children with hearing loss, no matter how they and their families choose to communicate. Consultants in the early childhood and family services and public outreach school programs; travel to homes, daycares, preschools and public schools; as well as private schools throughout the entire state of Maine to work with families, professionals, and others in their efforts to support deaf and hard of hearing children in their home communities. Mr. Sherry has a forty year career in education, a Masters Degree in Education for the Deaf. He began his career in teaching for the deaf in 1977 in Fort Fairfield, Maine. He took a brief detour and served as Principal in the Yarmouth School System, and he's been the Executive Director of the Maine Center - Maine Educational Center for Deaf and Hard of Hearing since 2012. He's been able to accomplish significant advancements for students who are deaf and hard of hearing throughout the state of Maine. During his time as Executive Director David has been instrumental in the establishment of regional programming throughout the state of Maine for children who are deaf or hard of hearing. He's done this by developing collaborative relationships with the State Department of Education, the State's Child Developmental Services, and the Portland Public School System, expanding educational programming there and elsewhere for kindergarten through grade 12. Mr. President Pro Tem, I hope you will join me

in thanking Mr. Sherry for his service to the state and wishing him well upon his retirement. Thank you, Mr. President Pro Tem.

before us. When the highest paid lobbyist makes close to
\$300,000 and each legislator averages a mere \$11,000 a year
that should tell you all you need to know about the power
dynamics here at the State House. What convolutes the situation
beyond the unlimited amounts of money that flows from these
lobbyists to legislative PACs is the revolving door of former
lawmakers becoming lobbyists. It's not easy championing
reforms like the one before us when members of my own party
are the ones on the forefront of recent inquiries, but I believe it's
vital. This is not personal. It shouldn't be about one particular
person or situation. This is about changing the entire system to
make it more honest and accountable to the people. Under
current Maine law Senators, Representatives, and Executive
Branch State officials cannot become registered lobbyists until a
year after their service has elapsed. However, no one is required
to register as a lobbyist unless they lobby for more than eight
hours in a month. This is a major loophole that allows former
lawmakers to participate in lobbying without waiting a year so
long as they stay under the registration threshold. Now why is
this problem important? Well, it's quite simple. Lawmakers have
spent years developing relationships with individuals under the
dome, fellow lawmakers, government officials, lobbyists, etcetera
so when they themselves become lobbyists you can see where
the inner knowledge of the system, combined with key
relationships, can be a recipe for placing their corporation or
special interest above the rest and above Maine people. This bill
prohibits all compensative lobbying at any amount of time for the
first year after their service has ended for former lawmakers and
Executive Branch officials. According to the National Conference
of State Legislatures at least 34 states have enacted a cooling off
period before a former legislator can come back to work in the
Legislature as a lobbyist. Eight states: Alabama, Colorado,
Florida, Iowa, Kentucky, Louisiana, Montana, and New York,
have the highest bans for former legislators at two years, and I
wish our laws were just as strong but they're sadly not. While
former legislators may make good lobbyist, it weakens the
integrity of the institution by having a government of the lobbyist
by the corporation and for the bottom-line. Maine deserves
better. I would really like to hear particularly from someone on
the committee defend why they think it's okay to vote against this

bi-partisan reform bill. I think each - I hope each of us here today
look beyond the caucus or political talking points to see the good
that this bill can achieve and I have a few questions for the
Chamber. Do your constituents, the people that put us in these
seats, want to limit the influence of lobbyist at the State House?
Do your constituents want to increase ethics and accountability in
government? Do your constituents want to strengthen the
integrity of the Legislature? If you answered yes to any of those
questions the answer of how to vote on this bill is very simple.
Vote no on the pending motion and support this modest proposal
that addresses a major loophole in our ethics laws. I, for one, will
side with my constituents over lobbyists any day. Will you?

THE PRESIDENT PRO TEMPORE: The Chair recognizes the
Senator from Aroostook, Senator Carpenter.

Senator **CARPENTER:** Thank you, Mr. President. On the day
after our nation suffered a great tragedy in Washington, I think it's
important to separate what I believe is fact from fiction and I think
it's important to perhaps answer some of Senator Chenette's
questions. Do I think that my constituents wish to limit the
influence of lobbyists in the Maine Legislature? I don't know the
answer to that question. Any time I've ever had a chance to
discuss this issue with my constituents I feel comfortable that I've
been able to convince them that lobbyists are typically people
paid to represent a group, whether it's the Restaurant Association
of Maine or the Maine Physicians or some other group. They're
fairly easy targets and it's not my job to stand here and defend
them. I don't have any particular relationships and I've been a
clean elections candidate every time I've run. So I'm not allowed
to take money from lobbyists. As far as legislators, I think you all
- some of you may, maybe one or two of you might remember my
speech here a few weeks ago in which I said I was proud of the
people that the people of Maine send to Augusta. I don't think
that changes when they leave here, whether they were defeated
or they leave here voluntarily. We welcome legislators back all
the time. In fact, we hold a special day to welcome legislators,
former legislators, back here. We call it Welcome Back Day. If
somebody in this Chamber is so weak, if they can't decide an
issue based upon their own independent judgment and they are
susceptible to the entreaties of some lobbyist, be that lobbyist a
former legislator or not, then they probably shouldn't be here.
That's the reason I voted against the bill. I, when a bill comes
before any committee that I'm on, I try to discern if there's a
problem and, if there is a problem, I'll try my best to craft a
solution. In this particular situation I searched for a problem I
could not find. Thank you.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the
Senator from Penobscot, Senator Cushing.

Senator **CUSHING:** Thank you, Mr. President Pro Tem. Might I
pose a question through the Chair in regards to comments?

in this bill, cover those who advocate for organized labor and

We're talking about whether or not former lawmakers should have a cooling off period for a year or should they not. Should they be able to influence public policy decision making working for a corporation, any organization. There is no distinction when we're talking about lobbying. So to answer the good Senator from Penobscot, yes this would include any form of compensated lobbying.

No more moose are going to die because of this. This is moose matchmaking for money. Just E-Harmony.Moose. So if you defeat the pending motion, and accept the Minority Report, you are putting - this is good for business. This is a free enterprise bill. This is good for those who want to get in the business of being compensated. Trust me, it's not a business I'm going to start up. Maybe Senator Carson is. But it would allow this. The present law and the amendment pending would prevent swaps for consideration. You can still swap. You just couldn't get compensated for it. THE PRESIDENT PRO TEMPORE: Absolutely.

Senator **CHIPMAN**: Great. Thank you, Mr. President Pro Tem. In 2015 Maine implemented a new law prohibiting candidates for office who run as Clean Election candidates from simultaneously having a Political Action Committee. That was a good step toward ensuring that legislators are responsible to their constituents and that their constituents, alone, by removing the potential, or appearance of potential, for being behold to wealthy donors, lobbyists, and special interest groups. This bill simply takes that one step further by also prohibiting traditionally funded candidates from running a PAC. This bill levels the playing field by ensuring that both Clean Election and traditionally funded candidates are playing by the same rules when it comes to PACs. Candidates for the Legislature should be focused on their constituents, not dialing up lobbyist for dollars to support leadership ambitions. I know that when I talk to my constituents I hear over and over that there is too much money in our political process and too much potential for influence and that candidates who choose to run Clean Elections shouldn't be at a disadvantage compared to others. This bill makes progress on all three of these fronts and I hope you will join me in opposing the pending motion when we take the vote. Thank you.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING**: Thank you, Mr. President Pro Tem. Mr. President Pro Tem, ladies and gentlemen of the Senate, while I consider the present legislation before us a noble objective, I think we have to be honest with ourselves. If we are going to eliminate money completely from the political process that's fine, but when we have outside interests that are going to expend money in identifying what they believe are the horrific reasons why electing said candidate is not in the best interest of the State or why we should, through the instant gratification of referendums, do something that effects the policy of this State, I think it's appropriate for us to have this discussion further. But, frankly, Mr. President, free speech is something that has been determined to take many courses and the ability to disseminate that, while in many cases is free - as exhibiting here in this Chamber, the sad reality is that to reach people in these busy times, in this diverse State and this country, requires the investment of money. So we have to be real about this. I think, as I've indicated, it's a noble thought, but I think it's unfortunate that we're using this as a political whipping child. I guess I would like to pose a question through the Chair, Mr. President Pro Tem.

THE PRESIDENT PRO TEMPORE: The Senator may proceed.

Senator **CUSHING**: Could somebody in this Body really define, so we understand what we're talking about, what the word wealthy contributor is? Thank you, Mr. President.

THE PRESIDENT PRO TEMPORE: The Senator from Penobscot, Senator Cushing, has posed a question through the Chair to anyone who may care to answer. The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT**: Thank you, Mr. President Pro Tem. I had my button pushed before the question was asked. This is not to the question. Should I give a minute for someone who might answer the question?

THE PRESIDENT PRO TEMPORE: That might be appropriate. The Chair recognizes the Senator from York, Senator Chenette.

Senator **CHENETTE**: Thank you, Mr. President Pro Tem. To me, I'd like to comment on political whipping child because, to me, this is about strengthening ethics. This bill prohibits a legislative candidate from establishing Political Action Committees for which the candidate is a treasurer or principle officer or for which the candidate is primarily responsible for fundraising or decision making. While "Leadership PACs" aren't officially defined in statute, they are prevalent in our politics. In 2016 35 of these PACs were in play, taking in hundreds of thousands of dollars from lobbyists, corporations, and special interest groups. You can consider that wealthy or not. It's your choice. In one recent election year Leadership PACs raised more than \$1 million. Now what makes these particular Political Action Committees unique is the fact that they are run by legislators, sitting lawmakers who's responsibility is to regulate the same industries that can dump unlimited amounts of money into their accounts. Some of the top contributors, I think, were very interesting. The Portland Press Herald did a nice little piece - beer and wine wholesalers, banks, big pharma, insurance companies, casinos, large lobbying firms, just to name a few. What this bill seeks to do is simply to deny one particular fundraising mechanism from sitting lawmakers. It would still allow members of the public, including lobbyists, corporations, and special interest groups, the ability to contribute to every political party and to every other Political Action Committee that are not run by lawmakers. This will still allow lawmakers to contribute to other PACs and to political parties. This is about strengthening ethics of our system, so I hope you follow our light and vote no on the pending motion.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT**: Thank you, Mr. President Pro Tem. Men and women of the Senate, I chose last time not to have a PAC, even though it was usually something you do when you're thinking about leadership, before I even came up against the rules because I'm a Clean Election candidate. I thought no, but as the good Senator says, the money has been shown, or has been ruled to be a component of speech. In prohibiting Clean Election candidates from using PACs, it did not stop groups from spending money to try to influence the way they would like to see the country go, the State go. What they do is they send it to the campaign committees now and that little degree of separation - I don't know if I'm the only person - and I don't think so because it's been talked about many times - who, when someone gives you something, especially a large sum of money, you feel like 'I kind of owe them something.' So then what do you start? A battle in your head. Well, but I'm not going to do that. I'm not going to feel that because it wouldn't be appropriate to buy something. That whole battle. It's eliminated in my world because I don't have a PAC. I won't have a PAC. I'm not allowed to have a PAC. So this eliminates that without restricting a group from spending money. They go directly to a campaign committee. That campaign committee uses it. So there is support for that idea. It also has shown to have a few good candidates from both sides of the aisle, as well as Independent - wherever we consider their side of the aisle to be - that they get conflicting messages from the Ethics Commission about what's appropriate to do with a PAC or

they decide without checking with it because it just seems absolutely clear that a PAC could be used in the way they think that they've determined that it should be, and then they make an expenditure and later they become a headline over the way they spent it. Some are still saying, 'Well, that seems fine,' and the others are saying, 'How could you even think that.' I mean, there's just so much room and where your ability to be effective in State government is based on reputation, innuendo, and idea, this just removes it for everyone, Clean Election or not, from getting yourself into that morass of misunderstanding and destroying your career when you're doing good work. Thank you.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING:** Thank you, Mr. President Pro Tem. Mr. President Pro Tem, I apologize to the Body for rising to speak again, but I think we need to clarify something. We're talking here about a Political Action Committee purportedly operated by a member of the Legislature. We're not talking about eliminating the influence of large sums of dark money or special interest money that flows into this State to Political Action Committees on a regular election basis. I think we saw in the referendum process, Mr. President Pro Tem, vast sums of out-of-state money from nonprofits and organized labor that was poured into elections and it was handled by some of the same people that we vilify here as lobbyists - some of those people who represent teachers' unions, who sit in this Chamber regularly, and probably sit in other meetings, coordinating activities in the election cycle; members of nonprofits that sit in those positions of authority in PACs. So if we're going to call a spade a shovel, Mr. President Pro Tem, I think we need to decide whether we're going to be honest about this or we're just going to use this for political gamesmanship in whipping up on legislators as if we are a different class who are much more malleable than those who have great interest at risk before the legislative process. Thank you, Mr. President Pro Tem.
