**STATE OF MAINE  
PROCLAMATION**

**WHEREAS**, the Legislature of this State should meet in special session to consider legislation to correct an issue in LD 725, "An Act to Recognize Local Control Regarding Food Systems" which was passed by the Legislature and signed into law during the last legislative session and is scheduled to go into effect on November 1, 2017 and to appropriate to state agencies funding for the Maine Office of Geographic Information Systems (MEGIS); and

**WHEREAS**, the proposed legislative changes to LD 725 is designed to promote the continued inspection of meat, poultry, fish and milk by federal and state inspectors to ensure compliance with federal and state food safety laws, rules and regulations; and

**WHEREAS**, compliance with federal and state food safety laws, rules and regulations promotes the public health and welfare of all people in the State of Maine and prevents negative economic impacts to the economy of the State of Maine; and

**WHEREAS**, the budget passed by the Legislature to end the government shutdown did not allocate money from the general fund to state agencies for the MEGIS program, and the program has been operating with funds that were carried over from the previous fiscal year of 2017; and

**WHEREAS**, MEGIS provides critical services at the state, regional and local level across Maine in support of economic development activities and public safety; and

**WHEREAS**, State Agencies have funding until November 2017 and without appropriations from the Legislature, MEGIS and the State's ability to adequately provide Geographic Information System services will be in extreme jeopardy.

**NOW, THEREFORE**, I, Paul R. LePage, Governor of the State of Maine, by the virtue of the power vested in me as Governor by Article V, Part 1, Section 13 of the Constitution of the State of Maine, convene the Legislature of this State, hereby requiring the Representatives and the Senators to assemble at ten o'clock in the morning in their respective chambers at the Capitol in Augusta on, Monday, October 23, 2017, in order to receive communications, and to consider and determine on such measures as in their judgment will best promote the welfare of the State.

In compliance with a proclamation of Governor **PAUL R. LEPAGE**, the Senators convened in the Senate Chamber at ten o'clock in the morning and were called to order by President **MICHAEL D. THIBODEAU** of Waldo County.

Prayer by Reverend Susan Berry Taylor, St. Andrew's Episcopal Church in Winthrop.

**REVEREND TAYLOR:** Thank you, Senator Bellows and your colleagues, for the invitation to open with prayer. I'm Susan, the Vicar of St. Andrew's Episcopal Church in Winthrop. Please join me in prayer.

Holy and gracious God, creator of all that was, is now, and is yet to be, we ask Your divine presence attend us. We implore You to look favorably upon the work at hand during this Maine Senate Legislative session. Enlarge within the hearts of our Senators, and indeed all those representing the people they serve, the capacity and keen sense of compassion and justice for those who are most vulnerable and to depend upon the beneficence of their lawmakers to ensure equitability and accountability of the institutions of our society and communities. Incline one another's ear towards the other, that each may, with a spirit of generosity and openness, find resilience to bend and, in neutrality, reach across differences, honoring the dignity of each, to fear not the changes that must take place to ensure that which is pure and noble and the best of our democratic process prevails. Guide our lawmakers, that they may seek not so much to be right as to be in right relationships. Or in the words of a bumper sticker once seen and never forgotten, 'Whatever you do, is it necessary, truthful, and kind?' May we strive to live showing no partiality and befriending all, caring especially for the marginalized, the oppressed, the outcast, the poor, and despised. We are urged to not neglect the stranger nor fail to provide hospitality, to heal the sick and comfort the afflicted, and to be stewards of one another and creation herself. I pray that for our lawmakers and those who govern that these ethical and moral values will be embraced, recognizing that such values are not restricted to any religious tradition, but rather that our unity and common cause of humanity is sufficient. Blessings upon us all. Amen.

But the final thing I'll say is that the week after my Mom's funeral I went to the post office and checked my post office box and for any of you who have a post office box you will know that if you get a key in there the people at the post office are a little upset with you because you haven't picked up your mail in a while. I had two keys. It was cards from almost everybody in the Legislature that I could think of. So from the bottom of our hearts, my family's hearts, we say thank you and we love each and every one of you. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator **CARPENTER:** Mr. President, thank you. Men and women of the Senate, obviously we now have Ranked-choice Voting before us again, a referendum that was passed last November. Before I continue I'd request that somebody in support of Report "B" could explain to the Senate exactly what Report "B" will do.

**THE PRESIDENT:** The Senator from Aroostook, Senator Carpenter, has posed a question through the Chair to anyone who cares to respond. The Chair recognizes the Senator from York, Senator Collins.

Senator **COLLINS:** I rise in support of Amendment "B". Thank you, Mr. President. I am in support of Amendment "B". The committee worked diligently on this matter a couple of weeks ago and as you can see we got four reports. My position would be quite simply to move Amendment "B". This will delay the implementation of Ranked-choice Voting until December of 2021 unless the Maine Constitution is amended to allow Ranked-choice Voting. If the Maine Constitution is not amended by that time, which is quite a bit of time, the laws governing Ranked-choice Voting will be repealed. In my opinion, this is the best option in front of us here today.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator **CARPENTER:** Thank you, Mr. President. My thanks to the Senator from York, Senator Collins. We had an all-day public hearing on L.D. 1646 about ten days ago. We had dozens and dozens of Maine citizens come before the Legal and Veterans Affairs Committee and give their opinion, almost to a person, in favor of 1646, or some version thereof. None of whom would have testified in favor of any repeal of Ranked-choice Voting which, in fact, is what Committee Amendment "B" will do if, in fact, it is contingent upon the passage of a Constitutional Amendment within four years. I would suggest that acceptance of Report "B" would fly directly in the face of the 388,000 plus people of Maine who voted for Ranked-choice Voting last

November. As I've already said on the floor of the Senate last spring, I wasn't a supporter of Ranked-choice Voting. I do support the concept of it, to bring civility, or some civility, into our political process, but it's cumbersome. It's not neat. The Devil's in the details, literally, and in the implementation. I would request the Senate to oppose the pending motion and then I would, if that in fact were to be defeated, then there are other reports that I would be glad to talk about at that point. Mr. President, I request that when the vote be taken it be taken with the yeas and nays.

On motion by Senator **CARPENTER** of Aroostook, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Collins.

Senator **COLLINS:** Thank you, Mr. President. My apologies for rising again but I feel compelled to. One of the things that we haven't mentioned yet this afternoon is the fact that when Ranked-choice Voting was first considered by the Legislature in its early stages Maine's Attorney General came forward and said, quite simply, it's not Constitutional. We have a system that's been in place for nearly 200 years, when Maine became a state. Members of the Legislature, members of Congress, are elected by a plurality of the vote, not Ranked-choice Voting. I have to say that if we put in place Ranked-choice Voting it's going to be a huge expense, additional expenses to conduct these election day proceedings. That was one of the motives I had in the back of my mind was simply cost savings and doing what Maine has done for, like I said previously, nearly 200 years. So that was my reasoning behind Amendment "B", to give interested parties plenty of time to go through the normal procedure of changing Maine's Constitution, whereas a bill is submitted to the Legislature, goes to the committee of jurisdiction, there's a public hearing, a work session on the bill. If it's successful it moves on to the full Body of House and Senate. There it is deliberated. If they get a 2/3 vote from both Chambers, then it moves on to the next stage, and that is a vote by the citizens of Maine. That's how we've always amended Maine's Constitution. Quite frankly, I think we should continue doing it that same way. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator **DIAMOND:** Thank you, Mr. President and ladies and gentlemen of the Senate. I'm rising to support Report B because of the delay that's part of this report, a significant part of this report. This is not a time for us to really focus on whether or not we agree with Ranked-choice Voting. Some of us do. Some of us don't. We've gone beyond that with the question that's before us. We tried to amend the Constitution to fix it. That didn't happen. It didn't even come close. Another choice we have is to leave it as is. That would be totally irresponsible to leave something on the books that we know is going to be unconstitutional. We could ask for a dual election. We could make dual elections, but Report B does not entertain that. You know, Maine's election history has been really one to admire. It's been smooth overall. It's been well done, and that is not by accident. It's hundreds and thousands of people around this state that work on these elections every year, not to mention the

Secretary of State, who, by the way, has eight people plus Julie Flynn. Not a big force of folks. Their job is to anticipate every possible problem. Understand every election, statewide election, is different. No two are the same. It takes special training, special planning, security for sure, volunteers. Signature gatherers are always different; and then, of course, you have the infusion of new people, new questions, unanticipated turn outs, machine failure, ballots are often different, sometimes not enough and you have to really scramble around to make all that work, and, amongst all of that, there is this enormous pressure from the entire state population to get it right. There's very little tolerance for - or room for mistakes; but mistakes happen. Errors happen. After all of that work, everyone comes together and makes it come together very, very well.

Now, now what we're going to say to them, if we don't do Report B, is, "Oh, by the way, we have a totally separate, different election system we want you to put on top of that and run that at the same time." Totally separate. Oh, and Report B also considers the fact that we have 240 towns, thereabouts, that have no electronic counting. So guess what? Those ballots are going to be hand-counted. And if you stop and think of the permutations the Secretary of State has to work out on this, if you have ten candidates, it has to be 10 times 9 times 8 times 7 times 6 times 5 times 4 times 3 times 2 times 1. Over 360 million possibilities for ten candidates.

Mr. President, ladies and gentlemen of the Senate, I really would ask you to consider Report B because it does not allow the dual, two different systems, at the same time, and given the mistakes that happen, honest mistakes - look at Long Island a short time ago. One packet, one packet of votes misplaced, and the accusations and the politicizing. All the things around that election and people who really didn't make a mistake were accused of all sorts of things. Imagine that now statewide. Let me ask you this, too. Picture, if you will, a recount of the system which Report B will give time to consider and to maybe try to work out. For us to put this mother of all nightmares on our local clerks and volunteers and ballot clerks would be unreasonable, unfair, and I would ask you to consider that carefully. If you can go to your town clerk and you can say to him or her, "Look, I know all about elections. I know all about State elections. I can answer all your questions. Don't worry about it. It's going to be good," - if you can do that, then I would suggest that we think very carefully about not supporting Report B. My concerns are the logistics, the local logistics, that go with anything but Report B. So, ladies and gentlemen and Mr. President, I would ask you, please, to consider that so that we can - if we're going to do this, we do it right. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT:** Thank you, Mr. President. Men and women of the Senate, I admire that the former Secretary of State has strong feelings for the process and understands it well, but I'd like to remind him that he took on challenges and met them and that the current Secretary of State has said that they will meet this challenge. We don't stand here and listen to arguments that say, 'You know, this would be hard.' Civil rights, would be hard to change things. Different laws. I won't go into all of them, but we listen to the merits of changing them and then we meet the challenge of changing them. We meet it monetarily. We meet it with labor that's necessary to do it. That's what we do. So when

we consider something we should consider: does the department that has to deal with it think that it can be done. That's what we've heard, that it can be. I know the election clerks in Knox County can deal with it. They rise to any challenge that they are faced with. The example of Long Island is pointed out. It's something that happened when we didn't have Ranked-choice Voting. This is not something to ignore. Citizen's referendum. Enough people spoke that we need to be listening to that and I haven't heard any of the agencies involved say that it would be impossible to do, just that it would be hard, and these are the kind of people that stay in our state government and rise to the top - the people who can meet challenges and do over and over and over. You call Secretary of State Dunlap, you know that and you've all talked to him. So thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Breen.

Senator **BREEN:** Thank you, Mr. President. I just have a slight correction of the record. A mistake that happened in the 2014 election did not happen on Long Island. It happened in a recount. Everything went very smoothly on Long Island and the error happened in the recount here in Augusta. I want to make sure that's on the record. Thank you.

**THE PRESIDENT:** So noted. The pending question before the Senate is Acceptance of Report "B", in non-concurrence. If you are in favor of accepting Report "B" you will be voting yes. If you are opposed you will be voting no. Is the Senate ready for the question?

Senator **KATZ:** Thank you, Mr. President. Men and women of the Senate, the answer to your question - to the question from the good Senator from Kennebec is I don't know what this moratorium means. I don't - I've read it. It refers to L.D. 88, which was a separate bill passed by this Body some months ago. If we were to pass this moratorium I don't know if it means we've got a moratorium on rulemaking starting or if it's a moratorium on the promulgation of rules or if it's a moratorium on the beginning of licensing or the granting of licensing. It is unclear, at least to



this Senator, exactly what the moratorium means. The second reason I would be voting in favor of the pending motion is, and a question for any one, to what end if we pass the moratorium? To what end? So what, so the bill can go back to the committee and we can try to redo our work? To what end? Unless someone can answer both of those questions, I would hope that people would support the pending motion. Thank you.

**THE PRESIDENT:** The pending question is Indefinite Postponement of L.D. 1651. If you are in favor of Indefinite Postponement you will be voting yes. If you are opposed you will be voting no. Is the Senate ready for the question?

Senator **KATZ** of Kennebec moved the Senate **ACCEPT** Report "A" **OUGHT TO PASS PURSUANT TO JOINT ORDER 2017, H.P. 96.**

On further motion by same Senator, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you, Mr. President. Men and women of the Senate, I know the hour is late but I wanted to take a few minutes to explain the work of the committee on this bill so there would be no misunderstanding about what it is that we are voting on here tonight. Back last year the voters went to the polls and legalized the possession and growing of small amounts of marijuana for Maine citizens. You may have voted for it. You may have voted against it, as I did. But now, Mr. President, it's time to make it work. The Presiding Officers appointed a committee, the Marijuana Legalization Implementation Committee, to ensure that the new legal industry would be intelligently regulated, controlled, and taxed to protect the public health and the public safety. It was my honor to work with Senator Dion, Senator Deschambault, Senator Maker, and Senator Rosen on this legislation. I wanted to briefly describe the process we went through to highlight the key points of the bill and to frame the choice we have before us this evening.

First of all, Mr. President, in terms of process. This was a 17 member committee. Larger than most committees are. Republicans, Democrats, and Independents. It ran the gamut of people who had actively worked for passage of this referendum, to those who would actively work to kill this referendum. We worked over eight months. We had extensive public hearings, dozens of them. Excuse me, dozens of meetings. A couple of long public hearings. Heard from over 100 people. We solicited the best information we could get from all the various stakeholders involved, as well as any experts we could find within the industry, within public health, within public safety, and tax. The Chairs and the Leads traveled to Colorado. Spent days meeting with elected officials and regulators in that state to better understand what had gone well for them and what hadn't. We constantly referred to the experience in Washington State and Oregon and Colorado and other states which have gone before us in this endeavor. We discussed. We debated. We listened, and eventually ended up taking dozens of votes and the product of that eight months is before you in L.D. 1650.

Just to mention, Mr. President, a few of the highlights of the bill, from our perspective. First of all, again, the concept here is that people are going to choose to use marijuana. They are going to be able to access it in a well-licensed, well-regulated, safe, lawful, and appropriately taxed environment and not have to go to the black market any more to buy. Secondly, it was important to us that we provided an entrepreneurial edge to Maine people as we enter into this new endeavor and we put a two year residence requirement on anybody who wants to apply for any licenses here, whether it be cultivation or product production or retail sales. We put a sunset on that, but we want to give Maine people the first shot at this and we've kept the size of the various businesses, particularly in cultivation, down low, particularly at the lower ends, so that this could have something of a cottage

industry feel to it, at least for those who want to be involved at that level. Third, we very much respected the concept of local control here. The idea that local communities ought to be able to decide for themselves, in the commercial market, if they even want to be participants of this; if they want to allow commercial cultivation or production of eatables or retail stores within their community, and we have made that an opt-in process. There's been some discussion about why opt-in. The reason is really very, very simple. We've tried to treat marijuana as much as we can as we treat alcohol in the State of Maine and decisions communities reach about alcohol has always been opt-in. A community has to decide yes, we want to allow bars, or we want to allow liquor stores in our community. We've honored that same principle here with local control. Fourth, we've tried to do everything we can to make sure that this product, which is now legal, is going to be kept out of the hands of kids. And we've done that through restrictions on advertising, on keeping any establishments 1,000 feet away from schools, by requiring tamper proof packaging, by putting restrictions on shapes of eatables. There aren't going to be any gummy bears. There aren't going to be any animal shaped anything. There aren't going to be any animal pictures on the cover. We're doing everything we can to try to keep it out of the hands of kids and we're devoting at least a small portion of the tax revenues to public health efforts, particular with respect to marijuana and particularly focused on youth. Lastly, we are cognoscente of the potential increased public safety issues that legalization presents to us, particularly in impaired driving. We put some money aside for law enforcement, particularly for them to train additional drug recognition officers to help keep our roads safe.

We set up a tax system, which involved an excise tax and a sales tax. An excise tax just like every other state which, I believe, which has legalized marijuana and also a sales tax. We've tried to find the sweet spot on taxation. We think we're right there in the middle between states which tax less than we are proposing and states which tax more than we are proposing. We don't want to tax too much because then you just drive people back to the black market. We hope we found that sweet spot.

So that's where we are. Where are we tonight? We have a choice. You're going to get to vote for this bill. You're going to get to vote against this bill. By the way, the bill's not perfect. Seventeen of us were there. Fifteen of us voted for it. There were compromises. There were things in the bill I didn't vote for. I think the only one who always got his way was Senator Dion, but other than that most of us had to make concessions at some point along the way. But this bill will be changed. We set up an advisory committee going forward so that we'll be able to watch the roll-out of this new industry and we'll be able to make changes in this bill going forward. I have no doubt that ten years from now this will look quite a bit different than it looks today. But what is the choice tonight, Mr. President? We can vote for the bill or you can vote no. I just want folks to have their eyes wide open as you consider the consequences of a no vote, because if we do vote no it doesn't mean that marijuana goes away. It doesn't make - mean it's illegal. Some of you might want it to happen that way. It doesn't mean that at all. We'll just go back to the initial 28 pages of the initial Marijuana Legalization Act - I'll give anybody \$20 in here, other than Senator Dion because I know he worked on it, \$20 to anybody who read the thing before the vote at the polls. Nobody read it. But let me tell you some things that will happen if we go back to those 28 pages. I suggest we'll be voting for chaos. We'll be voting for confusion and we'll be throwing -

we'll be putting oxygen onto the fire of the black market. Gone will be many of the safeguards that we spent all this time working on. All the things we've done to try to keep marijuana out of the hands of kids will be gone. All the money we set aside for drug recognition officers gone. All the protections we put in for communities gone. We prohibited home deliveries. That will be allowed if this bill goes down. We prohibited drive-through windows. That'll be gone if you vote no on this bill. We eliminated internet sales. That'll be gone. You'll be able to sell this within 100 feet of a school if this is gone. We put in a 1,000 feet limit. That will be gone if you vote no on this. All the money we have put aside for public health and for public safety will be gone if this is voted down. The protections we put in for children, the tamper proof packaging, the gummy bear prohibition, the prohibition on pictures of animals, and all the rest. All those things will be gone. We put in this bill some pretty significant limits on personal grow. Everybody can grow up to six plants under the law and that will continue, but where the diversion has been taking place has been apartment houses with 20 people in them now can theoretically grow 120 plants, or Farmer Brown, who has 100 acres, who can now set up a co-op and have 100 people on there with 600 plants and the police can't figure out where all that is going. We've said no. We said a limit of 12 plants per premises, and 18 plants if a town votes to extend to that, because we want to go slow, and that's the one thing they told us in Colorado we ought to do. That's where the diversion takes place. That's addressed in our bill and it's not addressed in the underlying bill if you vote no today. Some of the nonsense that we are seeing out there now. You can get free marijuana but there's going to be a \$150 delivery fee. That's, technically, I guess, maybe within the law now. But we've made it clear. You're not going to get away with those kinds of shenanigans any more if this thing passes, and that will be gone.

The debate on legalization of this substance is over for now. That is in the rearview mirror. Our job, I would suggest, is to pass a bill which protects public health, which protects public safety, and which protects our communities. Your colleagues on this committee suggest that that bill is before you tonight and we hope it will have your support. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Cyrway.

**Senator CYRWAY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I stand before you today to implore you to take another look at the marijuana issue. We are on the brink of a disaster but if we act responsibly now we can save Maine from a nightmare. It is understandable that many people in Maine still think that marijuana is nothing to worry about. Millions of dollars have been spent promoting the idea that marijuana is soft and recreational. That is - that it is safe, that they think it's safe. Please believe me that I tell you it is not safe. It is a very dangerous drug. As a DARE officer, patrol deputy, and assistant jail administrator for many years, I have seen first-hand how destructive marijuana is. I have seen young people emotionally devastated by it. I remember a young woman, I shall call Suzie. When I first met her she was a lovely soul with sparkling eyes, happy, and overflowing with life. Then she got involved with marijuana and when she - when I saw her again her eyes were sad, it was empty, and she said she felt lost and scared because of the drug. Suzie is not an isolated case. In 2014, Dr. Wayne Hall completed a 20 year study for the World Health Organization

that showed conclusively that marijuana greatly increases the changes of serious mental disorders, including schizophrenia. It is playing Russian roulette with one's mind. I do not exaggerate when I say that many lives have been ruined by this supposedly benign drug. I know people who have used marijuana just once and had a terrifying experience. The famous example is Maureen Dowd, a commentator for the New York Times. She went to Colorado three years ago and tried marijuana. She wrote about her experience in a column in the Times in which she said, and I quote, "I felt a scary shudder go through my body and brain. I barely made it from the desk to the bed where I laid curled up in a hallucinatory state for the next eight hours. I was thirsty but couldn't move to get water or even turn off the lights. I was panting and paranoid, sure that when the room service waiter knocked and I didn't answer he'd call the police and have me arrested for being unable to handle my candy. I strained to remember where I was or even what I was wearing. Touching my green corduroy jeans and staring at the exposed brick wall, as my paranoia deepened I became convinced that I had died and no one was telling me. It took all night before it began to wear off distressingly slowly."

Some of you may agree that marijuana is dangerous, but may hesitate to go against the will of the people. I can understand the sentiment, but in this particular case other factors take precedence. First, the vote was only 50.2% in favor, 49.8% opposed. Hardly a mandate. Secondly, legalizing marijuana puts Maine in violation of federal law. No small matter. The taxes have to be a cash deal. It can't go into a bank. The federal guidelines - the minute you put that money into a bank - so let's just say you, as a person, has used marijuana and you are selling it or whatever and you get some tax money to put towards the State and you take that tax money over to your town. The town has to count it out in cash bills and then where do they take it? They can't take it to a bank. If they do they're going to say, 'What was this for?' If they say it's from marijuana now an investigation goes into place because it's a federal law, you cannot use marijuana money. No other tax in Maine is like that. Maine becomes an illegal drug dealer, federally. Third, the most important, you and I, here in the Senate, have a sworn duty to protect Maine's citizens, especially young people, from anything dangerous. The evidence is overwhelming that marijuana is not safe. Even the Governor of Colorado stated in his own words that there was a mistake to bring it to Colorado. The Maine Legislature has the legal authority to vote to resend the recent referendum. I'm a Republican but this is not a Democrat versus Republican issue. The DEA, under President Obama, last year refused to lower the classification of marijuana and affirmed it would keep it a Schedule 1 drug, citing its known dangers. The THC levels have risen from 3% in the 1960s to currently up in the 80% and 90%, which is now considered almost hashish, not marijuana. It's in liquid form, liquid marijuana, and they put it in e-cigarettes and they smoke them like bombs and they get an extreme high. This is not just a cigarette. It used to be, when I was in DARE class back in the 90's, one cigarette equaled - one joint equaled 16 cigarettes. Sixteen cigarettes. They claim the person that smoked a pack a day took 15 years off their life with cigarettes. Can you imagine what it does with marijuana? When they take a deep breath of that marijuana and they hold it in their lungs and then they let it out, they go, 'Ummm, good hit man.' What they're telling you is they just had a small heart attack because their heart goes into defibrillation and causes scar tissue.

The false message that pot is okay is what we're giving our kids. I feel uncomfortable about voting for this bill. It doesn't even give you choices. The work that they did, I give them credit for all the work they did, but there was no thought in getting rid of marijuana. It was just saying, and I quote, "Debate is over." It is not over until you decide to vote for this and say, 'Ya, let's go along with it,' and now we're saying it's okay because we're just taking and governing this. We cannot do that anymore. We have to look at how serious this is, we're putting on our children. I beg you to rethink this. Do not give us a world in which our children will grow up thinking that using marijuana is normal. For the safety of our citizens, please join me in doing what is right for Maine and vote to make marijuana illegal. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO:** Thank you, Mr. President. Mr. President, I'd like to pose a question through the Chair.

**THE PRESIDENT:** The Senator may proceed.

Senator **SAVIELLO:** Thank you, Mr. President. Mr. President, I will have a series of about six questions because I have read this bill and I'd like to get into the details, if I may. So I'll start with the first question, which builds on the good Senator Cyrway's question. I appreciate the effort to answer that, but it's a long question. The question is: right now, and let me set the stage, a medicinal marijuana grower cannot deposit his money in a FDIC bank. He has to pay cash. Can a town, yes, collect the taxes as pointed out in the blue sheet come out, deposit that money in the bank and, therefore, write a check from it? That's my first question. Thank you, Mr. President.

**THE PRESIDENT:** The Senator from Franklin, Senator Saviello, has posed a question through the Chair to anyone who may choose to respond. The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** You know, when you're setting up a regulated industry in a way the last thing you want is to have it be a cash business, but that is what we're stuck with because of the federal rules. Right now, in response to the question, we have a medical marijuana market, which has been in existence for years, which has exactly the same problems that the good Senator describes. Medical marijuana providers paying property taxes on property that they're using to grow medical marijuana and, yes, towns have accepted that money. They've worked through their banks and life seems to have gone on. Also, under the dictates of the so-called Cole Amendment, which is a federal guidance on how the federal government intends to deal with these things, there are some guidelines in there which have allowed at least a number of Maine credit unions, and at least one bank that I'm aware of, to start taking cash from medical marijuana operators and doing so in a way which they, at least, do not run afoul of federal law. I suspect the same thing will happen here and that the system of banking will develop, develop slowly, just as it has with medical.

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO**: Thank you, Mr. President. Mr. President, I will address some of these things as I've also done my homework on these. My second question lies in the fact that many towns, such as mine, asked for federal grants. Will they be able to continue to ask for those federal grants if, in fact, they are taking marijuana money, which is illegal at the federal level? Thank you, Mr. President.

**THE PRESIDENT**: The Senator from Franklin, Senator Saviello, has posed a question through the Chair to anyone who may choose to respond. The Chair recognizes the Senator from Cumberland, Senator Dion.

Senator **DION**: Thank you, Mr. President. It's a pleasure to take questions from my good friend from Franklin County. He seems well prepared and a whole list of interrogatories to present to us this evening. Let me just go back up to the banking question first. It's a horrible hypothetical, right. You can go anywhere and find the answer you're looking for, Senator. The truth of the matter is in 2014, just like the blue paper articulates, the Financial Crime Center for the Department of Treasury issued guidelines to financial institutions. It's a SAR Report. That's not outlined in that blue paper. Suspicious Activity Report. What it asks the financial institution is if it takes in money, not just from drug activity, but if I were a bootlegger or I dealt in any type of contraband material and I brought my money and they discovered that I was involved in that kind of criminal conduct, they have to make an investigation before they take my money. That's to make sure that they don't become unwitting money launders to my criminal enterprise. That's the purpose, and the burden it places on the bank is the same burden that your municipality will confront if it issues licenses for marijuana. It's whether or not they want to exercise the due diligence required to participate in that transaction. Some banks have decided, because of the fact that they service customers across many state lines, that they don't want to be involved in that business. I opened up a campaign account recently. The second question after my name was, 'Are you engaged in marijuana money transactions?' Right. I chuckled and said, 'No.' But I've taken money from people involved in the marijuana industry in my role as an attorney, but I didn't take money inside a marijuana transaction. It's the same here. If the Town of Wilton decides the risk is too high, they don't have the resources to explore what they need to explore to determine that they're actually going to provide financial services to a legitimate business, they can simply say what many banks have already enunciated, 'We're not interested in that business. It's not in our best interest and we don't want to do the work necessary.' At the same time, Senator, Mr. President, there are institutions who see this as an investment opportunity for their shareholders or their stakeholders and have provided those services. So, I think that's the short answer that I can give you. It's a difficult road for financial institutions. I think it's okay. If I'm going in to pay taxes, as far as the municipality is concerned they're receiving tax money. It's a footnote, but an interesting one. The current federal tax form provides for the reality that if you engage in the sale and transfer of marijuana products you are actually supposed to declare that to the IRS despite the fact that there could be Fifth Amendment problems with other parts of the federal government in your declaration, but you can get a stamp from the federal tax people to cover you on your obligations in the sale and transfer of marijuana. So the U.S. government is more

than willing to take their marijuana money if you're so willing to give it up and I think the Town of Wilton or Farmington or Portland can do the same. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO**: Thank you, Mr. President. My third question: in the bill, if you've read it, you have the word 'natural' in there.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING**: Thank you, Mr. President. What do the rules say about a member addressing the Body more than three times?

**THE PRESIDENT**: The Senator from Franklin, Senator Saviello, has indicated his desire to have as many as six questions answered. The Chair would advise the Senator from Penobscot, Senator Cushing, that I intend to allow him to ask his six questions. I hope that folks will be as succinct as possible so that they clearly can answer the question in as quick a time period as possible. The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO**: Thank you, Mr. President. In my 15 years no one has asked anyone how many questions they want to ask and I think these are critical to be defined if we're going to vote tonight. My second question - third question is very simple. The work 'natural individual' is used throughout the bill. Can someone please define 'natural individual' please? Or 'natural person'.

**THE PRESIDENT**: The Senator from Franklin, Senator Saviello, has posed another question to anyone who may choose to respond. The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ**: I observe it might have been helpful to have these in advance of now. But in any event, a 'natural person' refers to a person, as I understand it, as opposed to a corporation or a LLC or some other artificially created business entity.

**THE PRESIDENT**: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO**: Thank you, Mr. President. Mr. President, I think my next question was partially answered, however, does it say anywhere in there that Citizens United does not apply?

**THE PRESIDENT**: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ**: I suppose if Citizens United wants to apply for a cultivation license they probably could do so.

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO:** My last question. Mr. President, I'm glad my good friend from Kennebec reminded me. The definition of resident. Where is it and what is it in the bill?

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** The concept of what a resident is is a well litigated concept throughout Maine case law. Generally it means that somebody is residing in the state with an intention to remain therein.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. Seems like ages ago that I initially hit my request to speak light. So I guess we all have a lot to say here. I'll keep my comments - I'll try to keep them uncharacteristically brief. You know, I just say, you know, thankfully we've had a lot of down time today because I wanted to have the final opportunity to go through the entire bill, and I did today. I wanted to make sure I didn't miss any details. All 76 pages here. You know, I have to say I am, at this point, I don't think there's any way I could vote where I could say that I knew with 100% certainty that I was making the right choice because, I'll tell you, there are some things that I very much like in this bill and some things that give me some real heartburn. You know, I think probably, at least on this side of the aisle in the Senate, I think I'm probably the only member who, at least publicly, supported the referendum when - on this side of the aisle when it was up for vote last November. For me, that was personal. I just think that adults have the right to make their own choices in their own lives and I think it's a good thing to take cannabis off the streets and put it behind the counter where people are asked for I.D. But in 2016, when we voted to pass - when the Maine people voted on adult use cannabis, we were one of four states that passed that, along with California, Massachusetts, and Nevada. At this point, we all started at the same starting block and yet we're kind of in last place right now when it comes to implementing - implementing the will of the voters in a timely way. I think there are certainly some very real imperfections in this bill, some things that give me real heartburn, especially some restrictions on people's freedoms. I would much rather - I'd like to see lifted and will continue working for that in the future. But as of right now, I think this is probably the best starting point we can - I think this is the best starting point we can have right now, realistically, and I think it is time to get started. I think it is time to implement the will of Maine voters.

And I do just want to respond to one very quick thing that was brought up from - by my good friend and colleague from Kennebec County. The question about where implementing this falls in place with federal law. You know, I keep my pocket Constitution on me at all times. I don't think that surprises people. I just want to very quickly read, you know, the Tenth Amendment of the United States Constitution. As we're looking to implement - implement a law that some will say, well, conflicts with federal law. The Tenth Amendment of the United States Constitution reads: 'The powers not delegated to the United States by the Constitution nor prohibited by it to the States are reserved to the

State's respectively or to the people.' If you look through the U.S. Constitution, I don't think anyone - at least no one has been able to point out to me anywhere in plain language where the people of and the states of this country ever gave the federal government the constitutional authority to prohibit cannabis. So this is a State decision. This is something that should be decided by the people of Maine and I'm glad that we have this opportunity right now, today, to move forward and start implementing their will. Thank you very much, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Breen.

Senator **BREEN:** Thank you, Mr. President. I'd like to pose a question through the Chair.

**THE PRESIDENT:** The Senator may proceed.

Senator **BREEN:** Thank you. I'd like to check my understanding, Mr. President. I believe that the report before us makes sure that municipalities across Maine have control over how to license recreational marijuana in their towns. My concern is if the current motion is defeated that the towns in my district, and any other towns in Maine, would have to take affirmative action to prohibit recreational marijuana facilities in their town, whereas the pending motion requires towns to affirmatively opt-in. I would like some clarification on that issue. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you, Mr. President. I thank my good colleague for the question. This was an important part of our debate. I think that the first concept here that was important was we needed to answer that question definitively, one way or the other, so the rules of the game would be very well defined and very well known. If you don't pass this, in the original bill it does talk about local control but it is far from clear, as I read it at least, exactly what that means; whether it is an opt-in or an opt-out. I believe that there is some ambiguity about that under the existing MLI that was attached to the referendum question. So, again, we thought important, I think I'm speaking for the committee, so that if somebody were taking a look at the - if your town or the town of any citizen of the State of Maine, they'd be able to say, 'I can do business in Falmouth,' 'I can do business in Yarmouth,' 'I can't do business in Augusta,' or 'I can't do business in Vassalboro,' and they would know at least where these businesses are welcomed and where they are not welcomed. So we had a choice again to do an opt-in or an opt-out and we chose opt-in for the reason that it most closely mirrors alcohol. That's why we did it. We think it was the right way to go and the Maine Municipal Association, which, of course, they're constituency is all the towns and cities that are looking for some clarity, they are supportive of this concept. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Bellows.

Senator **BELLOWS:** Just briefly. I wanted to correct Senator Brakey and say that there's more than one Senator in this Chamber that voted for legalization. I think the committee's done

an excellent job in negotiating many competing interests and I'll stop there, it's late.

**THE PRESIDENT:** The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT:** Thank you, Mr. President. Men and women of the Senate, to my colleague who raised a couple of questions that even asked for answers, I share his concern for protecting the population. One of the things I had heard about, since we're not citing anything, we're just telling stories, is that somebody was trying to drive a study that would prove that marijuana was as harmful as cigarettes or many times worse. It turned out that it had so many medicinal properties that it didn't increase cancer, lung cancer, or anything else. It actually started improving the health of people who were smoking it. The other part is, just a reminder that this bill tries to get ahead of things with a bunch of people on a committee who don't want this, but the people spoke and we have it. The other is that certainly someone who's been involved in DARE, has been in law enforcement, has watched the war on drugs for 50 years, realizes that we're losing. It's everywhere. I know professionals of every type of profession who use it and then do their job in a wonderful manner. It's all around us. It's everywhere. It's in the schools in spite of DARE, in spite of every effort. It's here. That's why people are finally embracing, 'How about we profit from it. How about we regulate it and take it out of the hands of the black market?' I know I'm not going to change your mind, but I'm trying to ease your mind so you'll realize that no more people will be hurt. Maybe many less will be hurt by getting in front of it for a change because I really want you to feel better. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, first of all, I'd just want to say that there was a federal bust of the vape store in Bangor and also when we're dealing cash for taxes for drug money. And that's what it is, drug money. Where there's drugs there's money. And when they take cash and they bring it to the town and then the town takes it to a bank and it seems like it was kind of softly said that the banks will accept it. Well federal banks are mandated. If they ask where that money has come from and they find out it's from marijuana they are mandated to have an investigation done from a bank. So that in itself is a concern. Dealers don't always report their incomes and, if you don't believe it, in law enforcement you'll see them with an RV, a snowmobile, a boat, a yacht almost. You know, and they've got all these things and they're on welfare. So they're going to take that cash and they're going to take the honest amount and bring it to the town. It's coming to the State. It's not going to happen. The other part of this is that they said there's protections in this bill. The DREs. Anybody in law enforcement knows it's very difficult to prove a case even with DREs. I just talked to one officer today who was a DRE for ten years. He's had six convictions of being a DRE. So we're going

to add all these officers and I don't know if there was any real inquiry of what this money is going to do towards going to DREs. Drug prevention. Some of this money is going to go to drug prevention. So here we're going to take drug dealer money, cash money, that's going to go for drug prevention. That's just great. I listened that we're losing, so let's accept it. Sorry, I don't give up and I hope you don't give up on our people in this State of Maine. I hope you care about their health and their safety. I don't want to see a drunk driver kill your daughter, a drunk driver from marijuana. You're going to see more people on marijuana not doing proper driving and they're going to cause accidents. Or your son. This is very serious and I'm not taking it lightly and I hope that this floor, this Body, takes it a little more seriously. This is not just a play toy to say okay, let's vote for it and let's accept it because we're losing. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO:** Thank you, Mr. President. Mr. President, the first thing I want to make very clear, I do appreciate all the work the committee did. I know, as many of them gave up their summer and that is much, much appreciated. However, I'm one that wants to have answers. So when I hear the words, 'I think it will be okay' and that maybe it will be okay when my banker says it may not be okay, I want a clear answer before I vote affirmatively on this bill. I also think that some towns may decide not to take the risk, that they don't want to take the risk that if, in fact, they bring this money in there they jeopardize grants and other things that they may have coming to them. On the opt-in / opt-out, I believe that's already there. Most towns can already put a moratorium in place if they want it. They've already done that. Some towns have looked at it, like my town, about modifying their ordinance and told us to change it. If that ordinance change is not put into place, is voted down, we won't have any recreational opportunities because there'll be nothing for them to apply for. The fact that we define and not use the idea that it's a resident, that it is intent to stay, I'm not sure how that gives an advantage to a Maine citizen. So I'm glad I'm a natural person who'll be voting against this bill. Thank you very much, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you, Mr. President. Men and women of the Senate, just a few last comments from me. First of all, I appreciate the debate here, the questions from my good friend from Franklin, the passion, and the heartfelt passion of my good friend from Kennebec, Senator Cyrway. But this is not a vote on legalization. We've had that vote. That train has left the station and I hope that those of you who are opposed to the idea of marijuana will channel your inner John Hickenlooper. John Hickenlooper is the Governor of Colorado and he worked very hard to defeat legalization of marijuana in his state, and he lost. It probably took him a little while to get over that because he put his heart and soul into it, but then he realized that his job shifted and his job was to honor the will of the people and to put into place as good a regulated market as he could in order to protect the health and safety of the citizens of Colorado, and he worked very closely with the Legislature to do that. And I hope that those people here, who are opposed to legalization - were opposed to legalization will approach this difficult decision in exactly the same

light. You know, Senator Cyrway mentions Maureen Dowd. Thank you for bringing that up. Maureen Dowd, a columnist for the New York Times, who did go to Colorado, had a bad experience with marijuana there. The reason she did, Mr. President, is because in the early stages of legalization, of their law, they did not require appropriate information about doseaging on their packages and they did not have a campaign or anything on labeling which warned about the fact that if you eat a brownie right now and it's 40 minutes later and there hasn't been any impact on you it's not time to eat another brownie and then a third one because of the delayed reaction of the marijuana. Colorado learned from those mistakes and changed their rules. We have looked at that. We have learned from the mistakes of Colorado so that we don't make the same mistakes here. In summary, Mr. President, I would just suggest that there's only two groups of people in this room who ought to vote for this bill, and that's people who like marijuana and people who hate marijuana and everyone else in between. Thank you.

**THE PRESIDENT:** The pending question before the Senate is Acceptance of Report "A" in concurrence. If you are in favor of accepting Report "A" you will be voting yes. If you are opposed you will be voting no. A roll call has been ordered. Is the Senate ready for the question?

The Doorkeepers secured the Chamber.

The Secretary opened the vote.
