THE PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Vitelli.

Senator **VITELLI:** Thank you, Mr. President. Men and women of the Senate, much has been said about Chris' role as a reporter in the State and I know that everyone in this building has come to respect and admire and trust his work. I'm here to speak of Chris as a family friend and a valued colleague to my husband. In fact, they were scheduled to have one of their regular Friday lunches tomorrow, in which they shared the equivalent of war stories, I would imagine, that fellow journalists shared. Robert Long has spoken of Chris as a storyteller. Robert is someone who worked with Chris at both *The Times Record* and the *Bangor Daily*. And, as all good storytellers, Chris had strong listening skills. He was

an acute observer of the human condition and he approached his stories with an open heart and with genuine curiosity. These are also what made him a great friend. When I first came to the Legislature I was comforted by his presence. His friendly face and his warm smile welcomed me whenever I saw him, and I can see him now, and I would often welcome him - greet him with open arms as the friend to me that he was. But early on in my days at the State House Chris took me aside and said, 'Perhaps we ought to use a little more restraint in our greetings, that perhaps a nod and a Hey, how're you doing? would be more professional, given our circumstances.' And he was right. Although it was difficult not to want to just give him a big bear hug, I followed his lead. I will miss him, as I know we all will, and I extend my condolences to his family; particularly to Jen and his two sons that he adored, Caleb and Lucas. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I'll be brief. I think we've all known and worked with Chris Cousins over the years. I know in the four years that I've been in this Chamber I feel like I've gotten to know him decently well. You know, for all of the rancor in the media these days and for all of the sometimes feelings on both sides of the media mistreating one side or the other, one thing I could always say about Chris Cousins was he was always fair, he was always decent, and he loved his family. In fact, I know so many times, just having a free moment, going down to the little press area down in the basement of the Cross Building, just sitting there and talking with him and that was the thing - you know, whenever we got off the subject of politics, that was the thing he always talked about, was his family and particularly his young children. So I know it's, as we are all striving for decency and integrity in everything we do and hoping for decency and integrity in our media, Chris was really an excellent example of that and it is a great loss that he is no longer with us. I sincerely hope that his example will endure for a long time.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Waldo, Senator Thibodeau.

Senator **THIBODEAU:** Thank you, Mr. President Pro Tem. Ladies and gentlemen of the Senate, a lot of things have already been said about Chris Cousins. My guess is that there are probably 35 great stories about Chris Cousins and your interactions with him here at the State House. Every one of them special. My guess is every one of them positive. He was a terrific

human being and, as Senator Brakey had mentioned, reporting what happens here at the State House has got to be difficult because you're trying your best, as a reporter, to do it in a way that's non-partisan, that reflects, really and truly, what is going on inside of this building. I'll assure you that Chris Cousins was one of the best that this building has ever seen. One of the reasons is he earned peoples' trust. His calm demeanor, his non-partisan approach, non-threatening approach, won him the trust of many people, including myself. The countless times that Chris would come into the President's Office, not trying to necessarily garner information so that he could put it in the story but truly trying to understand what was going on in this building just for background. I can't tell you how many times I was able to say, 'Chris, okay, Chris, off the record,' and he would say, 'Yes,' and we'd talk about what was going on and why things were happening the way they were happening. Not once, not once in Chris' tenure here was that trust ever violated. A consummate professional, a man that wanted to write the story in the most accurate possible way he could while trying to understand what was going on inside the four walls of the State House. I know that in his profession it's not appropriate that he be my friend, Senator Vitelli's friend, but my guess is, just knowing what a decent - what a great human being he was, that he'd been heartbroken if he were here and one of us had passed the same way each one of us that got to know Chris is heartbroken and feel a tremendous loss. Again, tough job. The media, I believe this in my heart, is trying to get it right, trying to understand what's going on in this building. Heck, a lot of times I'm trying to understand what's going on in this building. Not once did I ever reach out to Chris and say, 'Chris, you know this story, do you understand this background or that?' that he didn't take that serious and was always willing to clarify, not change but clarify, a situation if he felt it was important. Very humble man, a man that did a great service, not just for the *Bangor Daily News* but a great service to the people of the State of Maine, trying to help them understand what was going on in their State government. I think I can speak for every one of us saying we're all heartbroken and we'll all miss Chris very, very much. Thank you.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Waldo, Senator Thibodeau.

Senator **THIBODEAU:** Thank you, Mr. President. Ladies and gentlemen of the Senate, you know, it's - we live in a very special state and every one of us know why it's so special. It's special because we have amazing people that live in it. They live in each and every one of our communities. They're Republicans. They're Democrats. They're unenrolled. They're people that love the state just like you and I do and they love this nation every bit as much as well. You know, some of these people make a conscious decision to go and to serve this nation in our Armed

Forces, willing to put their very life on the line in service to our nation. This bill will create a memorial in the park across the street in remembrance of some of the people that have lost their very lives in service to this nation. They've served in a way that I will never have the opportunity to serve and what I've done in public service is so small and minute in comparison when you look at what these brave men and women have done for this nation. So, to me, I think we're here to really celebrate, to celebrate coming together, passing a bill, which is a no brainer, that honors the people who have given so very much in service to this country. Thank you, ladies and gentlemen.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I also wanted to rise. The Senate President did a great job explaining why this is such an honor to be here in the State Senate today. I think here in this Body, and I think of it a lot, you know, we have at times disagreements. Sometimes, you know, we come together on many things. But we're always able to speak our mind. We're always able to talk about issues that are important to us. And I do - I think about it often that there's places in this world that people can't do that. You know, they can't be free to speak about things that are important to them and the reason why we have that great ability in the Senate Chamber today is because of the men and women that have fought for that freedom, fought for that right, consistently. And so for myself, it is - it's a real debt that I can never repay to the people that have gone forward and fought for those freedoms that, you know, often times we maybe take for granted. But standing in the Senate, or in the Maine Legislature, it hits me often that, you know, I'm able to fight for things other people in other parts of this world can't do and it's all because of people that have given the service and, unfortunately, people that have actually died giving that service, something, like the Senate President said, I have never actually had to do. You know, we have members in here that have. Families that are here today, you know, myself with two sons, I can only imagine what it must be like to have to worry about them as they're serving and then, you know, for the sacrifice that they did give to this country. I mean, for me, this is a very small thing that we're able to do today for the tremendous effort, sacrifice, that you've given. I can't tell you how much all of us in this Chamber thank you for what your families have done for us in this State and us in this country. It truly is an honor to be here today to recognize your families because none of us would be here without what you've given to us. So, seriously, thank you from each and every one of us in the Chamber for what you've done. We appreciate it.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, I just had the privilege of attending a leadership conference in Gettysburg this week and as part of that we went up on Little Round Top, the far left flank on the second day of the Battle of Gettysburg, where Joshua Chamberlain and the 20th Maine held the flank and it just struck me, as I participated in this event, how Maine has been a leader and has made some significant sacrifices. Not that we are the only ones who sacrificed in that war or other wars, but it brought home that these were men and boys from communities around our State and there was not any promise made to them when they stepped up to serve in that role. There was an expectation that it might be over soon, but it dragged on for a number of years. For those families in that day, they didn't have the benefit of the instant communications that we have now; text and social media and other things. So it could have been weeks before people realized that a loved one had been injured or lost and there was actually a story of an officer whose wife came to the battlefield to care for him because she had heard that he had been injured and she had missed by hours being able to see him before he had passed away. As we reflect on what we're doing here today, Mr. President, it gives me pause to think about the sacrifices that were made and I just wanted to add my appreciation and respect for those whose families have paid that ultimate price and I am pleased, as one of my final duties here, to be able to vote in favor of something that will memorialize those who have served our State and country. Thank you, Mr. President.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from York, Senator Deschambault.

Senator **DESCHAMBAULT:** Thank you. My mother was a Gold Wife. I want to tell you a little bit about that. Excuse me. My mother was 29 years old in 1944 when she received, excuse me, the Western Union telegram that her husband was lost at sea, or they couldn't find him, he was missing. She was 29 years old. Had two children, 5 and 7. She married my father three months later and had three children. Although he's not my father, Second Lieutenant Tom Baker, we honored him throughout our whole life. I'm just saying this because it affected my mother for her whole life. She kept it to herself, but when she had her - she planned her own funeral and told the funeral director she wanted it to be known that she was a Gold Wife and was proud of it. They weren't going to put that in the paper, but she made them put that in the paper. My Mom was diagnosed with dementia in 2000. Five years later, she was in a nursing home and had full blown Alzheimer's. In 2005, I got a phone call late at night asking to speak to my mother because she had been crying all day. Couldn't understand why. They said that she was reliving the day that she received the Western Union telegram. So even with Alzheimer's and full blown dementia, my mother could still remember the pain of that day. Again, he's not my Dad but I feel great that we're going to honor Gold Wife families. Thank you.

Senator **BRAKEY** of Androscoggin moved the Senate **ACCEPT** the Minority **OUGHT TO PASS** Report.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I rise in support of the motion in front of us. You know, as folks know, we, earlier this week in the Health and Human Services Committee, heard five bills related to reforms of the overall Child Welfare Program, in direct response to the two very terrible tragedies we saw take place in our state earlier this year. This is one of those bills and I just want to give folks a quick overview of what this bill does because it's a small but significant language change in the statutes. Currently the statutes read, in regards to rehabilitation and reunification, when a child is taken from the home, from the family, because of concerns of what's going on in that home, potentially, that could negatively impact that child, current law reads that they must give family rehabilitation and reunification priority as a means for protecting the welfare of children and prevent needless delay for permanent plans for children when rehabilitation/reunification is not possible. This bill would simply make a small change to say instead of giving family rehabilitation/reunification priority it would require that reasonable efforts be made to rehabilitate and reunify families. The reason for this change, I know the first time I read this bill I thought, 'Okay, what exactly are we changing? What's going in this bill?' Really this goes back to actually the early 2000's. You know, the tragedies that we saw take place in this state earlier this year are not altogether unique in our history as a state. If you go back to the early 2000's there were some similar tragedies. Only instead of these tragedies taking place in the child's own home and family it took place in foster homes. At that time there was a real swing of the pendulum because we saw some of these tragedies take

place in a foster home and a push was pushed to the other side, that we have to focus on the highest priority of being reunifying children with their families. I can completely understand that impulse. We certainly do not want to take children away from their homes, separate children from their families, unless it is absolutely necessary for the welfare of that child. But the concern is, as we - as that was instituted in law, perhaps the pendulum swung a little too far in the other direction, to the point where the law seems to imply that reunification should be the absolute highest priority, sometimes, perhaps, even above what might be in the best interest of the child. This language change seeks to strike a balance. It seeks to continue to have reunification continue to be a priority but emphasize that the welfare of the child is the highest priority. Whether that means reunification with the family or it means that that child needs to find a permanent home somewhere else, the welfare of that child needs to be the highest priority, and so I will be voting in support of the motion in front of us and I invite my colleagues to exercise their judgment on this important matter before us and do the same. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you, Mr. President and men and women of the Senate. First of all, part of the reason I rise is because I had the honor of replacing, temporarily, Senator Hamper on the Human Services Committee last week because of a work commitment he had. We also dealt with this subject matter in the Government Oversight Committee now for several months and we tasked OPEGA with looking into these two terrible tragedies and trying to make some sense of them and trying to figure out what we might do to change our laws to increase the chance of these things would never happen again. So this is one of the discussions that came out of that and I feel conflicted about this bill for some of the reasons that Senator Brakey just said and also it's the enthusiastic advocacy of this by my good friend, Senator Diamond, who sponsored this bill. But I - this is a tough one. But I think that the question for me was: in one day, because we heard five bills in one day, and now we're hearing these bills here today. So in one week, what can we do now to try to help fix what I think everyone agrees is a broken system and what things are better left for more deliberate consideration of the next Legislature? I think everybody agrees that the most important thing is the safety of kids and that's the controlling principle that ought to rule here, and we ought to make sure that our statutes state that in no uncertain terms. But I respectfully suggest that our current statute is not the problem, that our current statute does honor that principle. I want to read to you from Title 22, Section 4003, which is the purposes section of that law, which says, 'Recognizing that the health and safety of children must be of paramount concern and that the right of family integrity is limited by the right of children to be protected from abuse and neglect,' then it goes on to other sections. I don't know that we could have a more definite statement about what the principle purpose of this law is. It states it in no uncertain terms. This proposed language change, I'm not entirely sure what it does, but Senator Brakey talked about the swinging pendulum, that maybe we went too far towards taking kids out of the home before and maybe the pendulum swung to too much reunification. I don't even know if that's true because we heard conflicting, no disrespect to Senator Brakey, but we heard conflicting evidence in the Committee hearing and some of it suggested that if the

pendulum is swinging it's actually against, away from, reunification and taking more kids out of the home now. So I'm not sure that the evidence is any way clear that we need to be readjusting that pendulum back to where it was.

Secondly, you know, we heard that there is increasing evidence, based upon studies, which show that wherever possible that reunification actually is in the best interest of kids and that that ought to be our priority. I'm hardly an expert on this thing, but the point is that trying to sort through that, and see what best practices today in the United States, I don't know what the answer to that is. I can assure you, we didn't have time in the couple of hours we considered this particular bill to sort that out. What I think we did learn, and what I heard at the hearing, was that there's really nothing wrong with our statute. What's wrong is that apparently some people within the Department are interpreting the statute in a way which, perhaps, is not best for our children. I don't know that the proper response to that, though, is to change the statute if it's good. The proper response is in the administration of the Bureau of Child Protective Services to train their workers, to educate them on what the law actually says, and not to change the law. As somebody put it during the Committee, this change which is being suggested is really kind of sending a subliminal message to the Department that they've got to start doing things differently. I don't know that we need to change the law to do that. This may be a good change in the statute but, from my perspective, it needs a lot more work and thought and study and consideration of best practices before we go into it. I'm very proud of the rest of the package we came up with on Tuesday because I think it is that down payment that we all want to be making on this crisis. This one, I think, can wait and needs a little bit more deliberation. Thank you, Mr. President.

On motion by Senator **MASON** of Androscoggin, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator **DIAMOND:** Thank you, Mr. President and ladies and gentlemen of the Senate. A few words on this bill. I would suggest probably this is the most important bill out of the five, in many ways, that we're going to vote on today. I got involved in this, as Senator Katz indicated, through the Government Oversight Committee and all the OPEGA and all the research that's been done and public hearings for months. What we found out is we're running out of time. Too late for Marissa Kennedy. Too late for Kendall Chick. Too late for the next little child, we don't know the name yet because they haven't died yet. We can't wait before we do anything and this is one of those areas where we can do something. If you talk with front line workers, with caseworkers, not with research people in some cubical someplace, if you talk with the caseworkers who deal with this every day they'll tell you that this law should be changed. They'll tell you that the word 'reasonable' is reasonable because the current law says 'priority' not 'a priority.' It says 'priority.' So I'd ask you to think about that. It's too much potential for problems for us to put this off and not make this change. One of the problems we're having now with the front line caseworkers is that their time is so limited and there are so few of them, so when the pressure is on them to reunify, even when they know it's not the best thing to do after hours and hours and hours of working with

these kids, they still are pressured to put that square peg into the round hole because that's what the law says. 'Reasonable' is part of the federal statute. I think it's a reasonable approach. These caseworkers are having these kids. They can see what's going on inside those walls. They take these kids to their office and keep them in their office all day for days at a time because there's no other place to put them. They spend nights in motels watching over these kids because there's no other place to put them. This - to push these kids back into a place that they know is not safe, but it's the priority, is doing an injustice. I'd really ask you to think about this. This bill is simply common sense. It simply says what is best for the child. That's all it's doing. Give that caseworker, that knows more about this than you or I, but I can tell you after talking with so many of them you feel like you're part of it, give that caseworker, those caseworkers, a little flexibility. They really know what they're doing. Give them a chance to act. Take away this bureaucracy, this little bit, and feel good about reasonable because that's what this is. It's just saying the word 'reasonable.' So I'd ask you to vote in favor of this motion. Mr. President, thank you for this. This is a very important issue and I appreciate your time.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Bellows.

Senator **BELLOWS:** Thank you, Mr. President. Ladies and gentlemen of the Senate, over the summer I have met with dozens of caseworkers and foster parents and family members, and I want to applaud both the personnel at DHHS who do such very difficult work every day, sometimes risking their own safety to protect the safety of children. I want to applaud the foster parents who work so hard to keep small children safe. I posted on Facebook last week that, because many of the caseworkers and foster parents and even parents of children involved in the system, shared with me fear of coming forward because of retaliation, perhaps, or because of consequences, either from DHHS or from the community. So I put an invitation on Facebook that if anyone wanted to leave testimony on my doorstep, if they wanted it to be truly anonymous, they could write testimony, print it out, not put a name, and leave it on my doorstep. I had a conversation with a family that I met over a year ago and they had fostered an infant who was born drug affected and they went through the process of family reunification. Mom was no longer in the picture but Dad did go through certain steps. These parents expressed concerns that this child would not be safe in the home but, alas, the child was returned to Dad and, over the course of the last couple of years, different incidents would pop up in the paper and these foster parents would express concerns, or reports about driving to endanger or different charges that this gentleman was charged with, and felt very helpless. Then this summer the worst case scenario happened, Dad died and their foster son is now parentless, but he's also not with them and they're still worried about his health and his safety. What they said with me, when they met with me, and they didn't feel comfortable coming forward and being named, but what they said is this bill is a parental rights friendly approach and it doesn't take parents out of the process, and I think we can all agree that the research does show that when family reunification can happen, and be supported and be safe, it is the right approach. But this bill does not take family reunification out of the process. What it does is introduce the language of 'reasonable' and I'm going to quote from this anonymous constituent. 'Placing child safety and

wellbeing in greater importance than the current law allows, the new language protects children without negating parental rights and is paramount to fixing this broken system. There is a climate of automated fervor to keep children with their parents at all cost.' The constituent went on to implore me to vote yes to this legislation. So I'm casting my vote yes today because of this constituent meeting but also a series of conversations that I had that made me feel that there does need to be a little more discussion for the courts, for the Attorney General's Office, for DHHS, for people involved, case managers, foster parents, kin, etcetera to come to agreement on what is reasonable. I think that does provide flexibility, and maybe it's not perfect but it's a step forward. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator **CARPENTER:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I briefly rise to just maybe clear up a little bit of confusion. Many of you know that my law practice is now limited to acting as guardian ad litem almost exclusively in DHHS Child Protective cases. I have probably 30 open cases in my office at this point. Real briefly, the way this works, and why I think this change is appropriate, is that when a complaint comes in, a complaint is called to the toll free number here in Augusta, if it doesn't get screened out, that's a whole other issue, then it will be assigned to an assessment worker in Houlton. That assessment worker will go out and they'll attempt to do an assessment. Those assessments can last for weeks while they're trying to gather evidence. There may clearly not be enough evidence for a case to be brought but there may be a safety plan. Maybe Grampy and Grammy's a more appropriate place for this child at this moment. Ultimately, when the case is - when the evidence has been gathered, that assessment worker will sit down with his or her supervisor and Assistant Attorney General, and they'll try to decide whether or not there is sufficient probable cause to bring a case here. So the AAG becomes a very important component here. I think this change, if it is enacted, will send the appropriate message. Prosecutors don't bring cases that they're not fairly certain they can win, for a variety of reason. Child protective cases, you don't bring a case - in the old expression, if you're going to shoot at the King make sure you kill him. In this case it may be very harmful to the child if a case is initiated and there is insufficient evidence there. So I do think that this is potentially an important step forward. Also we have to have a little bit of faith in the system. We sit in this Chamber, we confirm men and women to sit on the bench with black robes and that's who is going to make these decisions. They're going to look at the evidence, there's going to be a guardian ad litem report, and they're going to make the decision. I have never, and I've been a rostered guardian ad litem for close to 20 years, I have never seen a judge move forward with a case in a DHHS purview when the parent is making commitments and progress. I have seen cases get right up to the point of termination of parental rights, the end, the death sentence if you will, for that relationship, and all of a sudden the parent begins to turn themselves around. The courts will pause and they'll give them an opportunity. I'll give you a real quick example. A young woman had three children with the same parent. Both parents were into drugs and substances. All three children were on my case load. I recommended the termination of all three of the children's rights. They were terminated. In the meantime, the

mother had another child with the same father. The child was born drug affected. That child and that mother are doing wonderfully today. At that point something happened. The mother went and got her some help - got herself some help. She moved out of the community, which got her away from some of her sources. I could bring her - and she's already told me she would love to come down and talk to the Legislature at some point about what she's gone through. She has done wonderfully. She has that child with her. He's absolutely prospering in her care. So the courts don't look at these - I truly believe they look at these on a case by case, individualized basis. There was no reason to believe that young woman was going to be successful, yet the court gave her a chance because they saw her step up and they saw her make progress. So I think we have to allow some belief in the system, some belief in the judges that we put on the bench, that they will make the right decision, and I have never seen a judge, in my opinion, prematurely either stop a reunification process or terminate a parent's rights. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Dow.

Senator **DOW:** Thank you, Mr. President. I, also, have talked with some caseworkers and their concerns had to do with the longevity of the cases that they were looking at being carried out in the courts for such a long period of time and represented instability for the children. So I believe, after listening to them and looking at this bill, I believe this bill helps move the needle a little bit towards the welfare of the child instead of towards making sure that the parents always have the right to hold things up in the courts. The welfare caseworkers simply told me there are cases that a child should never be returned to, for the home. There are those cases, yet we could be stalled in the courts for up to 18 months or more while this is occurring, and it just is not good for the welfare of the child. So I think this bill, while to me small, moves the needle a little bit towards the welfare of the child and that's why I will be supporting this bill.

THE PRESIDENT: The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT:** Thank you, Mr. President. Men and women of the Senate, I think that all of the folks who have spoken have made some great points and I do support this bill. Sometimes we're talking about a fix that seems to appear in the absence of some of the other problems. We're saying we must fix this and the Committee dealt with it and people with direct experience say this is a great way. Senator Diamond's worked on this forever. It's wonderful. We also should consider how we got here. When an organization, a company, a government manages a system, and manages it well, many of the tools in place work quite well. When they don't we start looking at other fixes. I read recently about TOTE, the company that owned the El Faro and the sinking of El Faro. They had a number for their Captains to call if they needed to deviate for weather and their Captains were afraid to call it. Then the Captain of the El Faro calls it. It's an answering machine. Please put on hold. Yes, I'm in danger of sinking, but I can't get permission to take a different route and I may jeopardize my job for doing it. We find ourselves in the same situation where the management of the Department that's supposed to take care of these children, when positions became open they weren't filled over and over until one person

was doing the job of three or four. The phones not getting answered. The caseworkers don't have the time to work on the problem. So instead of looking at that, we're looking at five different fixes that may help the workers if they can use the solution, if they don't have so many people that they're responsible for that they can't get to them with the new rules, that they can't make a good case for taking the children from the family or leaving them with the family because that's the best option. We'd better go to the source of the problem. Who is managing the Department and says don't fill the positions, leave everyone hanging, and make up some new rules so it looks like it's not the leadership's problem? I'm tired of that in corporate America and I'm tired of it here in Maine. So keep that in mind as we do solutions for Child Protective Services please.

Reports **READ.**

Senator **BRAKEY** of Androscoggin moved the Senate **ACCEPT** the Majority **OUGHT TO PASS AS AMENDED BY COMMITTEE AMENDMENT "A" (S-548)** Report.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. So the motion that I've made is actually to adopt the report that is not the report that I supported in Committee. The two reports are very similar and I'm going to suggest that we adopt this one because I think that in the interest of there are some very important things in this legislation and I would hate to see it fail because of disagreements over small matters. Let me go over, generally speaking, what is in here because this is a big financial ask. It's a big financial ask from the Maine taxpayers. It's just over \$20 million for reforming some things that are in place related to our Child Welfare Programs. I'm just going to give you a small overview of those items and how these items are going to make an impact to make sure that what we saw take place earlier this year that we can work to avoid it in the future.

One of the problems that we hear a lot from our caseworkers on the front lines, and I think those of us who talked to our caseworkers on the front line have heard many of these things, is the huge caseloads and how overworked they are. It's like treading water infinitely. So everything in here, for the most part, is geared at how can we both give our caseworkers more support to be able to lighten their load a little bit to help them be more efficient. I'll start with one of the first items in this bill, \$3.5 million General Fund for increasing rates for foster care. Foster care, we have a shortage of foster care families here in Maine and, not only is that problematic for the children when they are removed from their birth family and are in the system, it creates a situation where the caseworkers, you'll have to have two caseworkers in a hotel room with the child for 24 hours a day. That's taking them off the job, doing other things that they need to do. It makes it difficult for them to address the other cases in their caseload. So this is one thing that we could do. Not only do the rates that we currently pay to foster care families, not only are they below the average for other states, not only out of a sense of fairness and gratitude for these families taking in kids in need, should we want to increase their rates, but it will also effectively help our caseworkers be more effective and focusing on the cases on their plate.

There's \$1 million for adding more supervisors. Now supervisors aren't necessarily supervisors like we would often think. When I hear 'supervisor' I think of someone sitting in an office, you know, barking out orders. That's not what these supervisors are. These supervisors, the 16 supervisors that would be hired are working hands on with caseworkers, helping to train new caseworkers as they come on, and often times go directly into the field with them, working side-by-side with them. Often times they are veteran caseworkers who've been, you know, exceptionally good at what they have done for years and helping to support other caseworkers.

We're also \$3.6 million for raises for caseworkers. You know, we have a big problem in terms of retaining people in this field. It is an incredibly demanding field and it can be incredibly traumatic at times, as you can imagine. So there would be a \$5 an hour increase for caseworkers. This would help both retain caseworkers and help to attract new people to fill some of the vacant positions that exist, as well as an \$1 an hour bump for

those who achieve a Masters Degree. So \$5 an hour bump for all caseworkers plus an additional \$1 an hour for those who achieve a Masters Degree.

There's a pilot program to support supportive visitations. That would be \$2.2 million. Also \$800,000 for hiring some clinical support staff, mental health support staff, in each of the districts. These support staff will not only help in cases where mental health is a factor for the child, perhaps the parents involved, but also can help debrief some of these caseworkers as they go through some of the traumatic experiences that they have encountered, as we can only imagine. You know, when you are a caseworker in a family's life you're seeing, kind of, the family at their worst moments and those can be some traumatic situations and that can really wear on some of these folks. So these mental health staff will both help with the cases themselves and helping to debrief and help our caseworkers. Also an \$8 million investment in a new computer system for the Child Welfare - for Child Welfare. You know, the computer system that they're currently operating with is about 20 years old. I asked in the Health and Human Services Committee meeting if that meant they're still operating on Windows '98. You can imagine what computer systems were like 20 years ago. They've not kept up and these computer systems will help our caseworkers be a lot more efficient in dealing with their caseloads, though there will be - this is one of the things that will take a little time to get up and going.

I do want to emphasize, overall, - and I will say there's one item in this bill as well, the item that I disagreed with but I'm going to look past for the purpose of getting some important things through, is there's up-front money for hiring 16 new additional caseworkers. I think there was agreement in the Committee that there is a potential need for more caseworkers. I think the disagreement was in terms of the timetable of that. I know the Department wanted to have this package here, in terms of building the infrastructure and the support structure around our caseworkers to make sure they are effective so we can look at adding on additional caseworkers in the future. I think that what this will effectively do - well, I don't want to put the cart before the horse, but I think that, you know, this was something that many on the Committee were very passionate - they wanted to see funded right now, and so if that is to be funded right now then the Department will have discretion in terms of the timetable and how those new folks are brought on.

I will say this is not going to fix all the problems. This is intended to be a first step. This is intended to be a phase one in reforms that are needed for Child Welfare. But I do think that having gone through exhaustively over these five bills, we had a 12 hour day when we were in. We worked from 9:30 to 9:30. We spent a lot of time going through this bill, in particular, each and every Appropriations item that's being asked for. Folks here know that I am loath to spend money. I consider myself a strong fiscal conservative. I think that we need to - you know, our government has some very important roles however, and when that comes to protecting our most vulnerable, whether that be our seniors or adults with intellectual disabilities, as we've often talked in front of this Body, or our vulnerable children who are potential victims of child abuse, we need to make sure that that role is being executed well and we need to spend the resources that are needed to protect our most vulnerable. So I would encourage that we pass this legislation today and that we get started on the work that needs to happen to make sure we're taking care of our kids. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Chipman.

Senator **CHIPMAN:** Thank you, Mr. President. Men and women of the Senate, I want to first of all, I guess, start out by thanking my good friend from Androscoggin, Senator Brakey, for supporting this report as opposed to the Minority Report. I hope we can all be on the same page with this. You know, I think of the five bills that we're considering today this, in my mind, is the most significant bill that will go the farthest, in terms of fixing the problems that need to be fixed. As you've heard, we had a long day on Monday and, leading up to Monday, we heard a lot of information across the state about problems with our Child Welfare system and protecting kids in the state and, in my mind, after hearing everything we heard on Monday, it's really not an issue about reports not being made by mandated reporters, it's not an issue about how things are defined in statute, it's really mostly an issue of staffing and the ability to handle reports that come in, follow up with them on a timely manner, and take action. That's what this bill is all about. So, as you've heard, it does add 16 caseworker positions, which I think is important. There are some positions still in the Department that aren't filled now that need to be filled and I don't believe that it's because the Department doesn't want to fill them. I think it's because of the tight labor market and the low pay and the fact that caseworkers are overburdened. They get burned out. They leave. They can't find people to fill those positions. I think the \$5 an hour pay increase will go a long way to filling those unfilled positions and then adding 16 new positions will help ease the workload that caseworkers are dealing with so that they can follow up on complaints when they're made. You know, we've heard that reports, when they're made, sometimes mandated reporters have to wait on hold for up to two hours or longer to make a report, only to have that report, in some cases, not followed up on. So, clearly, updating the computer system is important, updating the staffing and increasing the staffing is important, and increasing the pay for foster parents is also important because it is my understanding that foster parents are currently only paid \$16.50 a day to care for children for the State and that's a very low rate of pay. It's going to be very hard to attract people, obviously, to do that. So that increase is going to help and I think everything in this bill is great and I hope that we'll all vote for it. Mr. President, I'd like to ask that when the vote is taken that the yeas and nays are recorded. Thank you.

On motion by Senator **CHIPMAN** of Cumberland, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, I first want to thank the Government Oversight Committee and the Health and Human Services Committee, all the dedicated professionals at DHHS and our legal system who are working so hard to try to take care of these vulnerable children. I appreciate that this is recognized as a first step in reforming our Child Welfare system. But I urge us all to think beyond this, that there is a companion piece that is at least as important and perhaps, in my mind, even more important

and that is by the time those children reach these services we have failed. The damage has been done. The fact that we have a need for so many child welfare workers is a sign of our failure to ensure safe and healthy environments for Maine's children. Many of our Maine families are stressed and our children are suffering as a result. Making smart investments in supporting families, who are strong but perhaps are faced with unexpected adversity, to help them stay strong. For those families that are in distress, help them come out of that distress quickly and make them whole because yes, indeed, a child's best place is with their family but not if it's so dysfunctional that their safety and their health is put at risk. I know that there are some excellent conversations that are happening across this state around how to work to make our families whole and strong, and what existing systems are supporting that and what existing systems are making that harder. So I hope when the next Legislature comes together that we're not just talking about child welfare reform but we're talking about how to support our Maine families and, therefore, supporting our youngest citizens. Thank you, Mr. President.

THE PRESIDENT: The pending question before the Senate is Acceptance of the Majority Ought to Pass as Amended by Committee Amendment "A" Report. If you are in favor of that report you will be voting yes. If you are opposed you will be voting no. A roll call has been ordered. Is the Senate ready for the question?

The Chair noted the absence of the Senator from Aroostook, Senator **JACKSON**, and further excused the same Senator from today's Roll Call votes.

The Doorkeepers secured the Chamber.

Senator **KEIM:** Thank you, Mr. President. Ladies and gentlemen of the Senate, as Chair of Judiciary, I did oversee the Errors Bill and there's been a long history that the Errors Bill is never about policy. It's always a very black and white look at what was the intention and it is simply to correct clerical errors, basically. Sometimes clerical errors do change the outcome of a law that but it's unintentional, and I think this bill is about integrity. Every

single one of you would expect the Judiciary Committee to take this bill and to walk through it with the utmost integrity, not ever trying to change law in some backhanded way or underhanded way that no one would ever recognize because we pass - according to tradition, the Errors Bill gets passed as one complete unit. Because as one complete unit, everything that's in there is an error and it goes against what I believe I was tasked with for me to vote and take out something that we all recognized as an error. I think that the correct way to govern Maine is to follow through and do things with integrity on this bill and that's - so I will be voting against my own motion. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you, Mr. President. Mr. President, I, too, rise in opposition to the pending motion. This Errors Bill, if I recall correctly, we had before us it seems like months ago now, and I think it was months ago, and, as I recall, passed this Body by a vote of 35 to nothing. As it should have. It's an Errors and Omissions Bill. It's designed to correct mistakes that were made in drafting by staff, I believe - entirely by staff. They're human beings and they make mistakes and the way we deal with that is with an Errors and Omissions Bill. I'm unaware that there has ever been any controversy about an Errors Bill. It's probably always passes under the hammer. This time, unfortunately, it was used by some people, none in this Body, to try to gain leverage to accomplish some other policy goal and that's largely why we had a stalemate and a big part of why, I guess, we're still here on August 30th. The problem with Clean Election Funding is apparently gone away and I think we're all happy that that's true. But I worry about the precedence we set here because I think we are - I think we all honor the institution and all honor the precedent and the way things are done around here, and it has always been the way things were done around here, that an Errors and Omissions Bill goes under the hammer because it is, in fact, only correcting clerical errors. The moment we start pulling a thread out of that, and that's what this Recede and Concur motion does because this pulls out the Clean Election language, the moment we start doing that we're setting a precedent for the next Legislature or the one after that, well, we can do it because after all they did it in the 128th. I think we ought to be very concerned about precedent and I will be voting against the pending motion for that reason. Thank you, Mr. President.

The Senate was called to order by President Pro Tempore **RONALD COLLINS** of York County.

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Waldo, Senator Thibodeau. Would the Sergeant-At-Arms please escort Senator Thibodeau to the rostrum.

Senator **THIBODEAU:** The Chair thanks the President Pro Tem for recognizing me and looks forward to an opportunity.....

THE PRESIDENT PRO TEMPORE: The Chair recognizes the Senator from Waldo, Senator Thibodeau.

Senator **THIBODEAU:** Thank you, Mr. President. Ladies and gentlemen of the Senate, you know, there's a lighter moment and maybe that's a good way to start because you know we are talking about a lot of heavy issues today and, you know, Supplement 7 is no exception to that rule. The fact of the matter is, in large part the reason that the Senate and the House of Representatives is in session at the end of August, probably the latest date in the history of our State, is because of this particular bill and our inability to come together and find a solution for what has traditionally been the most non-partisan piece of legislation to go through this building and, make no mistake, there are people that are very, very disappointed that we find ourselves here, and I am one of them. I have no desire at all to celebrate the fact that we're going to finish up our work today and that in 10 days we can come back for a Veto Day and finally adjourn the 128th Legislature. I'm disappointed. This work should have been done in April, yet we found a way to make the most non-partisan bill a partisan bill, something that was to be negotiated for. The fact of the matter is it goes back to the question of Clean Election Funding. Everybody in this room knows that. I personally believe that the part that we negotiated in the budget, that we passed together in a bi-partisan way, signed by the Chief Executive more than a year ago, we settled the question of funding for Clean Elections. I am disappointed, just like many of my colleagues on both sides of the aisle, that we ended up in a situation where we were trying to renegotiate on a settled matter. It's not the way to

do business. That's what I believe. I don't want, in any way, for people to think that my vote in favor of the Recede and Concur motion is somehow a vote to validate what's gone on in any way. I agree with people that are going to vote no on this, that the negotiation of a partisan issue shouldn't happen in a bill like this and that the language for the Clean Election Funding probably should be in the Errors Bill because it belongs in there. But I also recognize the box we find ourselves in. I think everybody in this Chamber recognizes that box. That we have a group that won't vote for it, the Errors Bill, if it even references Clean Elections. If we put it in there, which it probably belongs there, we can be here until Election Day. A lot of really good bills will be impacted if we don't pass the Errors Bill, the stuff that needs to be cleaned up. There is not one thing in the Errors Bill that anybody in this Chamber has raised a voice against and really the only debate is whether or not there's an omission. I actually do think that there's an omission. Most people in this Chamber believe that there's an omission. But right now, today, we can pass the Errors Bill without that language about Clean Elections. We can get it passed through both Chambers and we can get adjourned Sine Die and, because of decisions that have been made outside of the four walls of this State House, the money for campaigns is flowing. So I just want to make clear to everybody and put it on the record that the Errors Bill not having the Clean Elections fix is not as clean or as good or as accurate as it could be and I wish it were there, but I'm willing to vote for it without it. Thank you, Mr. Chair.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I'll say upfront, I intend to vote in favor of the Recede and Concur motion in front of us. But I just want to take the occasion to remark a little bit on some of the controversy that has, you know, led us to being here today, here on the - in the final days of August. Over the last several months, you know, we've heard a lot about the shortfall, or the wait list, of taxpayer funding for the upcoming public financing of political campaigns and we've been told that, you know, it's a crisis. A crisis so big that it merited holding hostage of tax conformity legislation, threatening the already over taxed Maine people with higher taxes. I just want to say, you know, over the last four years I've really had the distinct honor to serve as the Senate Chairman for the Health and Human Services Committee - it really has been an honor - and during my time I've

loudly advocated to the best ways that I know how for reprioritizing our limited resources to fund the wait list that still exists this very day for Maine's most vulnerable: for our seniors and those with severe intellectual disabilities and Autism. Over these last four years, in dismay, I've watched other priorities continue to come first: from welfare for the able bodied, welfare for non-citizens, and in this session welfare for politicians. You know, we're told that ...

Senator **CHENETTE:** Point of Order, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Chenette.

Senator **CHENETTE:** Thank you, Mr. President. Relevance to the topic at hand and the bill at hand?

THE PRESIDENT: The Chair would advise the Senator from York, Senator Chenette, that we are trying to stay on topic and I believe that the Senator is going to circle back to that very soon.

Senator **BRAKEY:** Thank you, Mr. President. Considering that, the subject of this program is at the heart of the debate around this bill. I'll just say this, we're told that funding - ensuring that there are no wait lists in the Welfare for Politicians Program is an emergency. But I've never seen funding the wait list for Maine's seniors and intellectually disabled treated as an emergency on the same level. I've never seen us be dragged out into late August for those wait lists. Our most vulnerable citizens are still waiting for us to make them a priority and now it seems that I will not be in this Chamber to witness it. I look forward to the day when we treat our seniors and the disabled as well as we treat our politicians. Thank you very much, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator **CARPENTER:** Thank you, Mr. President. I don't want to debate trains that have already left the station. I want to talk about the remarks from the good Senator from Waldo, and I thank him for that. As somebody who, over the years and many years that I've served in this Chamber, has regarded myself as a traditionalist and, if you will, a small protector of the process. I really do appreciate what the Senator from Waldo had to say. He's absolutely right. The many years I've served here I can count on my two hands the number of people that I could not come to an agreement with and shake hands with and be done with it. Never had to worry about them changing their position or double crossing me, and the reason we're here today has absolutely nothing to do with anybody in this Chamber. We all know that. It has to do with people outside of this Chamber and I'm not going to talk any more about that. But suffice it to say that even though I am a traditionalist in this and really, really, really want to preserve the integrity of the process that we go through here, including the Errors Bills, it seems to me that this is a fix that needs to be - that needs to take place so we can move forward. It's removing something. It's not adding something. I think it's something necessary because of the political situation we find ourselves in, because of the actions of people that we have no control over. I thank the President for his remarks and I'm going to also support the motion to Recede and Concur. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, I don't want to belabor the point but as this is, to me, a fundamental vote as to the process, I do, respectfully, disagree with the pending motion. I respect the passion and the common sense that has been presented here in many of the arguments to support the pending motion, but to me it's a fundamental question of whether the Legislature advocates its role and requires the courts to intercede in actions that really are, in my opinion, in the purview of the Legislature, Mr. President. While it sometimes is odd for me to be on the same side as my good friend from Kennebec County, Senator Katz, I respect highly his intellect and his commitment to the law and I concur with him that we are setting a precedent here that is troubling. Now I say that recognizing the peril of us sending this bill to the other Body without acting upon it, but sometimes it's important to do what's right rather than what's expedient. In this case, Mr. President, I regret that I will not be able to follow your light when it comes to the vote. Thank you, sir.

THE PRESIDENT: The Chair recognizes the Senator from Washington, Senator Maker.

Senator **MAKER:** Mr. President, ladies and gentlemen of the Senate, unfortunately, we find ourselves in this predicament. There wouldn't have been a court decision had there been this bill passed the way it should have been passed, and we all know what happened with that. There's also a lot of things in this bill that's helping other people and to ignore it is wrong, just like it was wrong when we didn't pass the bill originally, the way it was. It's a sad day for government. I think it's a sad day that we're going to be hearing more of this happening throughout the State of Maine and the United States, that we can't be truthful and fair and work together. In this particular case, I agree with everyone that says that this is not the right thing to do but I will be supporting this for all the other bills that we're correcting and I would hope that anybody, again I give you a little advice, when you come back, that we prevent this from happening again. Somehow we need to determine when we put something together someone can't play a game with it and can't decide that they want something bigger so they're going to hold us in here. We've been having a little debate in our caucus. My husband has been very animate about when we're going to finally get done, and the sad part of it is he's been right all along. So if we don't pass this, and I don't think that we should be passing this because he says we're going to come back a day before the Swearing-In Ceremony and that's what his prediction is, but because it's the right thing to do. We've already had the wrong thing - we've done the wrong thing. We now need to do the right thing. We didn't do the wrong thing, others did. But we can prevent that from happening again. Thank you very much.

THE PRESIDENT: The pending question before the Senate is Acceptance of the Recede and Concur motion. If you are in favor of Receding and Concurring you will be voting yes. If you are opposed you will be voting no. A roll call is in order. Is the Senate ready for the question?
