When I was growing up, I knew my grandmother and the family were Democratic leaning, they were very high on Franklin Roosevelt, but that's all that we really talked about when I was a young person in Knox County, visiting them I Knox County. But later on, I discovered that my -- later on I discovered that my grandmother actually had been vice-chair during that important 1954 convention that brought back two-party politics to the State of Maine. She was vice-chair to the chairman of the committee at that time, Frank Coffin.

Frank Coffin was born just 100 years ago this year and lived 90 long years. He was out of Lewiston, he was out of Bates College, Harvard Business School, Harvard Law School. He was a Congressman for a couple of terms and -- but even though that 1954 period, we all think of Governor Edmund Muskie, my folks -- my grandmother kept mentioning this fellow that she was so high on named Frank Coffin. I just happened to speak in the hall with a former Chief Justice of the Supreme Judicial Court, Dan Wathen, and he explained to me that Judge Coffin was his mentor and he offered that he's probably the smartest person to ever come through these halls in public service. Frank Coffin ended up being appointed by -- he worked in the Kennedy administration and then was appointed by Lyndon Johnson under the Circuit Court of Appeals, where he served as Chief Judge for the First Circuit for 11 years.

So, in honoring Frank Coffin and his dedication to justice, he did help form or, I'm not sure the degree, but he was the chief founder of the Justice Action Group and I congratulate Justice Mead for his leadership on this group and I also thank Representative Cardone for recognizing Access to Justice Day.

I just want to mention that as a high school teacher for years and years and years, we began every day with the Pledge of Allegiance, which had those amazing five words at the end; liberty and justice for all. But next to the flag up there, I had it's up to us, and it's something that takes vigilance and I know that the Justice Action Group is interested in equal opportunity, equal access to justice regardless of economic and social standing and that's a wonderful thing and I congratulate Justice Coffin and Justice Mead and I thank the Representative for the resolution. Thank you, Madam Speaker.

I'm related to one of them, so shout out; thanks, Dad, I appreciate all the hard work you do

as well as other folks in the Judicial branch. So, thank you all very much.

Representative **GATTINE**: Thank you, Madam Speaker, Women and Men of the House. I just rise to say a few words in support of LD 1000, an amended version of the supplemental budget presented to the Legislature by the Chief Executive.

Although undoubtedly more modest in scope and in cost than supplemental spending packages that many of us have seen and been forced to deal with in the past, this supplemental budget does accomplish a number of things that are important and will have a real benefit to Maine people across the state and in our communities. I just want to highlight a couple of those things. The bill in front of you provides two and a half million dollars to over 200 communities across the state to reimburse for disaster relief efforts related to storms in October of 2017 and March 2018. This bill removes restrictions that have been impeding the ability of the medical community to address the opioid crisis that continues to kill people and destroy families across our state every day. It provides \$350,000 in additional resources necessary for the public advocate to represent Maine people in rape cases, and it provides a modest level of state support for the upcoming bicentennial celebration in 2020.

I'd like to just take a second and thank everybody who supported this budget up until this point. Certainly the legislative staff has done the amazing job that they always do. We had some very, very good and almost entirely unanimous support for these items from various policy committees. And, of course, I'd like to thank my fellow members of the Appropriations and Financial Affairs Committee, calling out particularly my friend, the Representative from Waterford, Representative Millett. I'm pleased to be able to present this report unanimously. It reflects some diligent and hard work and solid bipartisan work. I think it gets the AFA committee off to a good start as we begin our public hearings and deliberations on the biennial budget that will occupy so much of our time over the next few months. So, again, I'm hoping that this bill will get broad support from the entire body and, Madam Speaker, I'd also request a roll call.

The same Representative **REQUESTED** a roll call on **PASSAGE TO BE ENACTED**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.
