SENATE PAPERS

The following Joint Resolution: (S.P. 409)

JOINT RESOLUTION RECOGNIZING MARCH 2019 AS BLEEDING DISORDERS AWARENESS MONTH

WHEREAS, bleeding disorders, which are distinguished by the inability to form a proper blood clot, are characterized by extended bleeding after injury, surgery, trauma or menstruation and can lead to significant morbidity and can be fatal if not treated effectively; and

WHEREAS, many individuals with hemophilia became infected with HIV and hepatitis C in the 1980s due to the contamination of the blood supply and blood products; and

WHEREAS, Bleeding Disorders Awareness Month will generate greater awareness and understanding of not only hemophilia but all inheritable bleeding disorders, including von Willebrand disease, which alone affects an estimated one percent of the U.S. population, or more than 3.2 million individuals; and

WHEREAS, Bleeding Disorders Awareness Month will foster a greater sense of community and shared purpose among all individuals with inheritable bleeding disorders; and

WHEREAS, Bleeding Disorders Awareness Month will elevate awareness of and engagement in the inheritable bleeding disorders journey for the general public, enabling the prevention of illness, unnecessary procedures and disability; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-ninth Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize March 2019 as Bleeding Disorders Awareness Month.

JOINT RESOLUTION RECOGNIZING THE MAINE STATE HOUSING AUTHORITY ON ITS 50TH ANNIVERSARY

WHEREAS, the Maine State Housing Authority, also known as MaineHousing, was established as a quasi-public housing agency charged with expanding affordable housing opportunities for the State's low-income and moderate-income families and individuals; and

WHEREAS, MaineHousing has been helping Maine people own, rent, repair and heat their homes since 1969; and

WHEREAS, MaineHousing has financed 54,851 first-time homebuyer mortgages and 323 affordable apartment projects with a total of 10,697 units; and

WHEREAS, MaineHousing has helped 23,038 low-income families and seniors afford their rents, weatherized 15,292 homes, served an average of over 42,000 households a year with fuel assistance benefits, helped shelter the homeless and provided needed repairs to many thousands of homes, addressing problems of radon, arsenic, accessibility, lead paint and general disrepair; and

WHEREAS, through prudent investment, MaineHousing has grown to become a \$1.8 billion public purpose financial institution with its bonds rated AA+, thanks to the support of a wide network of partners including Maine's financial institutions, real estate agents, community action agencies, local homeless shelters, developers, apartment owners and managers, landlords and federal and state political leaders; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-ninth Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to commemorate the 50th anniversary of the Maine State Housing Authority and its record of success in service to the people of Maine; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Maine State Housing Authority.

Representative **HIGGINS:** I'm reminded that 200 years ago one of my natives who grew up in Charleston, Daniel Wilkins, went to the Convention of the Maine State Constitution and I would guess that the issue of residency was a pretty simple issue at that time. The general intent of the Constitution is that one would reside in the -- maintain residency in the district in which they represent.

This bill talks about ensuring that one lived and represented where they maintained a primary residence. I want to give you an example using my own situation. I live in Piscataquis County and I have two homes there. I'm not sure why, but I do have two homes there. And they're in two legislative districts. So in District 120, which I represent, I also maintain a homestead exemption and when you file a homestead exemption, you have to indicate on the form it's your primary residence. I think most people would understand that primary residence is where you live and you can define it any way you want. I also have a home in District 119. And here's the situation; I could very easily, according to the findings that the testimony on this particular bill with the Secretary of State's office, I could very easily change my voting residence to 119 and still maintain my homestead exemption, which is where I've declared my primary residence, in a different district.

I think that voters expect those who are candidates and those of us are here, we would actually maintain a primary residence in the district in which we live. I ask for your -- I ask that today you do not support the pending motion. I think it's important that we maintain transparency and maintain the integrity of our institution. Thank you, Ladies and Gentlemen of the House. Thank you.

Representative **SCHNECK**: Thank you, Madam Speaker, Men and Women of the House. I rise in support of the pending motion.

True early voting, where the voter actually completes a ballot and puts it into the ballot box or tabulating machine on the day that they vote early, is an excellent method of reducing the backlog town and city clerks face caused by an ever-growing use of absentee and in-person absentee voting. As a matter of convenience, after the long waits to vote in this last election, I can only imagine that large numbers of voters will be considering participating by absentee or in-person absentee voting next time. In Bangor, for instance, on election day massive lines of voters four across circled the floor of the Cross Center. Many stood in line for more than an hour waiting to vote. This was a serious problem for many elderly and disabled voters.

The high volume of absentee voting is one of the biggest issues facing our local election officials. The numbers of absentee voters are growing in ever-increasing numbers each cycle, in some municipalities as many as 60% of ballots cast. Without early voting, these numbers are sure to rise.

Handling absentee, in-person absentee ballots is time-consuming, inefficient, and expensive. First, the clerk must enter the absentee ballot information into the central voter registration system so that the voter is designated as having voted by absentee ballot. According to the Secretary of State's office, final processing of absentee ballots requires at least two election officials to review the envelopes one by one and takes the following steps for each voter. They have to check the notes of the clerk to be sure that the ballot is okay to cast, they

have to check the name of the voter on the absentee voter list and/or the incoming voter list, they slice open the envelope, remove the ballots, and they have to keep them folded. Then they have to separate the state ballot from local ballots and place the folded ballots into a holding bin until there are enough ballots to provide anonymity for the voters. Then they take a batch of folded ballots to the tabulator, unfold them, and insert them one by one into the tabulator. Hand-counted ballots, on the other hand, are placed one by one into the opening of the ballot box.

In November of 2009, the Secretary of State's office ran an early voting pilot program in nine communities. At the time, it was hailed as a complete success. Nearly 13,000 citizens participated. Ninety-three percent of these voters completed a survey. Of this group, 98% said they would like to have early voting in future elections. The League of Women Voters puts it this way; early voting reduces congestion on election day, it helps eliminate long lines at the polls, it reduces pressure on election officials, it provides an important convenience to many voters, and it contributes to a more secure and orderly process for the conduct of elections.

True early voting will save towns and cities time and money. It's time to offer this constitutional amendment to the voters of our state to improve this process for the good of all. I hope you will agree with me that it's the right thing to do. Thank you, Madam Speaker.

But the one difference there will be will be the cost that this will put on our local municipalities as they will have to hire poll workers and others for however long the early voting lasts. Thank you.

Representative **DILLINGHAM**: Thank you, Madam Speaker. I'd like to pose a question through the Chair, please.

The SPEAKER: The Representative may proceed.

Representative **DILLINGHAM**: Thank you. The previous speaker, chair of the committee, actually spoke to the process and value of what is being proposed going out for a vote. I just would like clarification that this is actually just hearing it from, from looking at the summary, it says that this is about proposing an amendment to the Constitution of Maine to allow the legislature to then authorize a process by which municipalities may conduct early voting. So, this is actually asking for the amendment to the Constitution and not so much -- there's no definition about what would be included in that process. Is that correct?

The SPEAKER: The Representative from Oxford has posed a question through the Chair to anyone who is able to answer. The Chair recognizes the Representative from Pittsfield, Representative Strom.

Representative **STROM**: Thank you, Madam Speaker. That is correct; this is just changing the Constitution so the

Legislature could come back in the future and then submit legislation for early voting.
