The House met according to adjournment and was called to order by the Speaker.

Prayer by Pastor Justin Thacker, Praise Assembly of God, Rumford.

National Anthem by Windham Chamber Singers, Windham High School.

Pledge of Allegiance.

Doctor of the day, Donald Medd, M.D., Portland.

The Journal of Tuesday, April 2, 2019 was read and approved.

At this point, pursuant to her authority under House Rule 401.1, the Chair assigned Representative PAULHUS of Bath to Seat 106.

At this point, the Members of the House stood and joined in a moment of silence in honor of State Trooper Detective Benjamin Campbell.

Representative MOONEN of Portland assumed the Chair. The House was called to order by the Speaker Pro Tem.

SENATE PAPERS

The following Joint Resolution: (S.P. 448)

**JOINT RESOLUTION MEMORIALIZING THE PRESIDENT
OF THE UNITED STATES AND THE UNITED STATES
CONGRESS TO LEAD A GLOBAL EFFORT TO PREVENT
NUCLEAR WAR**

WE, your Memorialists, the Members of the One Hundred and Twenty-ninth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the President of the United States and the United States Congress as follows:

WHEREAS, global arsenals have over 14,000 nuclear weapons and most are far more destructive than those that killed hundreds of thousands of people in Hiroshima and Nagasaki, Japan in 1945; and

WHEREAS, the detonation of even a small number of these weapons anywhere in the world could have catastrophic human, environmental and economic consequences that could affect everyone on the planet; and

WHEREAS, a large-scale nuclear war would likely kill hundreds of millions of people directly and cause unimaginable environmental damage, producing conditions wherein billions of people would likely die from starvation or disease; and

WHEREAS, the United States maintains nuclear missiles on hair-trigger alert, capable of being launched within minutes after a presidential order, greatly increasing the risk of an accidental, mistaken or unauthorized launch; and

WHEREAS, the United States, as well as the United Kingdom, China, France and Russia, are obligated under the Treaty on the Non-Proliferation of Nuclear Weapons to take concrete steps toward eliminating their nuclear arsenals; and

WHEREAS, in July 2017, 122 nations approved the Treaty on the Prohibition of Nuclear Weapons, which makes it illegal under international law to develop, test, produce,

manufacture or otherwise acquire, possess or stockpile nuclear weapons or other nuclear explosive devices; and

WHEREAS, United States taxpayers spend over \$4 million every hour of every day on nuclear weapons and the planned expenditure of more than \$1.2 trillion over the next 30 years to operate and enhance the United States' nuclear arsenal will exacerbate nuclear dangers by fueling a global arms race and diverting crucial resources needed to ensure the well-being of Maine people; and

WHEREAS, in 2017, Maine taxpayers averaged \$192.33 per capita, with the State collectively paying an estimated \$257 million, in federal taxes toward the cost of producing, deploying and maintaining nuclear weapons; now, therefore, be it

RESOLVED: That We, your Memorialists, on behalf of the people we represent, take this opportunity to call on the President of the United States and the United States Congress to lead a global effort to prevent nuclear war by renouncing the option of using nuclear weapons first, ending the sole, unchecked authority of any president to launch a nuclear attack, taking United States nuclear weapons off hair-trigger alert, cancelling the plan to replace the country's entire arsenal with enhanced weapons and actively pursuing a verifiable agreement among nuclear-armed states to eliminate their nuclear arsenals; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Donald J. Trump, President of the United States, and to each Member of the Maine Congressional Delegation.

Came from the Senate, **READ** and **ADOPTED**.

READ.

Representative STEWART of Presque Isle **REQUESTED** a roll call on **ADOPTION**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Berwick, Representative O'Connor.

Representative **O'CONNOR**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I rise in strong opposition to this pending Resolution which says in the second to last paragraph, "RESOLVED: That We, your Memorialists, on behalf of the people we represent, take this opportunity to call on the President of the United States and the United States Congress to lead a global effort to prevent nuclear war by renouncing the option of using nuclear weapons first, ending the sole, unchecked authority of any president to launch a nuclear attack..."

It is not, I repeat, not my goal to undermine any effort there is to try and prevent nuclear war or any other type of warfare. I prefer peaceful and prosperous society with no war. War has taken members of my family since the inception of this nation, as well as my friends and many of yours. We cry together, we bleed together every day, and I pray we bond together to heal every divide.

This Resolution expresses a desire to secede from everything we as a nation of people have shed our blood, sweat, and tears for, and relinquish any position of dominance in securing and keeping world peace is not acceptable to me.

I would like to believe other nations would keep all of their promises, but history paints me skeptical. As I said, I am unwilling to acquiesce any dominance we have in insuring our security as a sovereign nation. I am secure in my knowledge there are protocols to secure the abilities to launch any nuclear attack by any one president in our Constitutional Republic of the United States of America. I will always shake a hand in mutual respect and introduction to thought, but I cannot in

good moral conscience consent to anything that weakens our ability to protect the life, liberty, and prosperity of the individuals of our nation and diminish what we have fought for and would openly pray other nations accept. Thank you.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Pittsfield, Representative Strom.

Representative **STROM**: Thank you very much and I also rise in opposition to this Resolution.

A lot of what I was going to say was just said by the good Representative before me and, obviously, that one line of renouncing the option of using nuclear weapons first, that is just not something I can go along with. And then below that the hair-trigger alert; there is no hair-trigger alert. I spent 20 years of my life in the United States Navy, six of those on-board Trident submarines, first the USS Rhode Island, then the USS West Virginia. And for an idea that there is some kind of hair-trigger alert -- I cannot even begin to express how many people have to agree that an order has been given and that order is lawful before any kind of launch can be done and in the amount of time it takes to do a launch, I can't really get into a lot of details about those procedures but it takes a great many people to agree to accomplish something like that. And our whole mission when we were out to sea and, doing some math, I've probably spent over two years of my life actually underneath the water on board these Trident submarines, and our whole mission, our whole goal there, is to be a deterrent, and I feel what's in front of us is basically taking that deterrent away. Thank you.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Lincoln, Representative Hanington.

Representative **HANINGTON**: Thank you, Mr. Speaker, and Ladies and Gentlemen of the House. I, too, have to express my opposition to this and I concur with the Good Representative from Berwick and the Representative from Pittsfield.

I served two deployments -- I served in two deployments, and I said back in 2003 when I was over in Kuwait and Southern Iraq, there was going to be a problem with nuclear weapons with Korea and Iran. I see this as a deterrent but also I am very disheartened to the fact that says "We, the Members of the One Hundred and Twenty-ninth Legislature." If certain people want to do this and put this in, exclude my name from that because I'm a part of the 129th Legislature and I totally denounce this because if we do away with this nuclear -- it's a deterrent. I mean, we don't want to annihilate another country, but we want to be able to defend our country from stupid, ignorant people that want to annihilate us. So, take my name out of the 129th Legislature in the first paragraph because I denounce this and I think it's an embarrassment, it is saying that any one of us that served in the combat theater or in any Armed Services that we are any part of this, so be it, but I want to go on record saying that I oppose this because I think it's headed down the wrong road and it's going to send a message to the rest of the states and the rest of the world that they're weak and we don't want to defend our rights. Thank you.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Winter Harbor, Representative Faulkingham.

Representative **FAULKINGHAM**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, I rise in strong opposition to the pending motion.

The last time an atomic bomb was used in warfare was 1945. The reasons for that are pretty obvious. A nuclear strike is the last option of any American president. To suggest

otherwise is ludicrous. This resolution, for those of you that have read it, it says that nuclear missiles are on a hair-trigger alert, capable of being launched within minutes of a Presidential Order. And then it goes on to suggest accidental or mistaken launch. This line is perfectly placed to instill fear against our current President. As the Representative from Pittsfield said, this is not how our nuclear arsenal is used.

Mr. Speaker, it seems there are a steady stream of these resolutions coming before us. I would suggest that we stop wasting the people's time on these resolutions and represent the people -- and go do the work representing the people we represent. If people want to send these resolutions to the President, they can do so with letters with their names on them. I urge the Members to vote no on this Resolution. Thank you.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Belgrade, Representative Keschl.

Representative **KESCHL**: There's not much more I can add to what my good fellow Representatives have said. I served nearly 31 years in the military and if this resolution is to go forward and pass today, I would like my name removed as well.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Lincoln, Representative Hanington.

Representative **HANINGTON**: Mr. Speaker, I already spoke once, but I'll speak again; remove my name.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Caribou, Representative DeVeau.

Representative **DeVEAU**: Thank you, Mr. Speaker. I also rise in strong opposition to this resolve.

As a Member who has served this country in the Armed Forces, I do not support this. I have served in Korea and twice in Iraq. The comment that a hair-trigger -- is a hare-brained comment that is made by an uneducated individual or individuals. There is no such thing as the hair-trigger for this and that is just made by somebody who doesn't understand the system of the military or the process that's in place.

I ask -- no, I demand that my name be taken off of this. I do not support this and will not support this. Thank you.

The **SPEAKER PRO TEM**: The Chair will remind all Members not to impugn the character of other members.

The Chair reminded all members that it was inappropriate to question the character of other members of the House.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Paris, Representative Andrews.

Representative **ANDREWS**: Thank you, Mr. Speaker. As the proud husband of a Navy Lieutenant Commander, I would also ask that my name is removed.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Orrington, Representative Campbell.

Representative **CAMPBELL**: Thank you, Mr. Speaker, Men and Women of the House. I rise to expect my name to be taken off this resolution as well.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Canaan, Representative Stetkis.

Representative **STETKIS**: Thank you, Mr. Speaker. As a former Airman, at 19 years old, handling nuclear weapons myself, being trained to do that, I would expect that my name would be removed from this and, you know, if this Resolution was to pass as it stands, I don't believe it's right for anybody in this House to impose their opinions and include our names on them, especially those of us that are veterans. Thank you.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Plymouth, Representative Costain.

Representative **COSTAIN**: Thank you, sir. I stand today as a veteran of the Air Force. I would like to have my name removed, as well.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Weld, Representative Skolfield.

Representative **SKOLFIELD**: Thank you, Mr. Speaker. I respectfully request my name be removed from this Resolution. Thank you.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Hampden, Representative Haggan.

Representative **HAGGAN**: Thank you, Mr. Speaker. I also would like my name removed, respectfully, thank you.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Berwick, Representative O'Connor.

Representative **O'CONNOR**: Thank you, Mr. Speaker. I apologize for rising a second time. I would suggest that everyone who votes no on this should have their name removed. Thank you.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Presque Isle, Representative Stewart.

Representative **STEWART**: Thank you, Mr. Speaker. The previous Representative -- I echo her comments and would request the same thing of the House Republican Caucus. Thank you.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Oakland, Representative Perkins.

Representative **PERKINS**: Thank you, Mr. Speaker. As a veteran of the United States Air Force, I ask that my name be removed also. Thank you.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Penobscot, Representative Hutchins.

Representative **HUTCHINS**: Thank you, Mr. Speaker. I rise today in opposition to this and would like my name also removed from it, if it should pass.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Beals, Representative Alley.

Representative **ALLEY**: I would have my name removed as well.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Knox, Representative Kinney.

Representative **KINNEY**: Thank you, Mr. Speaker. As a daughter of an Army veteran, I request my name to be removed from this Resolution as well.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Bethel, Representative Head.

Representative **HEAD**: Thank you, Mr. Speaker. I would like my name removed. My dad served, my son served, and I'm a member of the American Legion and I think it would be very disrespectful. Thank you.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Dover-Foxcroft, Representative Higgins.

Representative **HIGGINS**: Thank you, Mr. Speaker. As a veteran, I request my name be removed from it as well.

Representative **FECTEAU** of Biddeford moved that the Joint Resolution be **TABLED** until later in today's session pending **ADOPTION**.

Representative **STEWART** of Presque Isle **REQUESTED** a roll call on the motion to **TABLE** the Joint Resolution until later in today's session pending **ADOPTION**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The **SPEAKER PRO TEM**: A roll call has been ordered. The pending question before the House is to Table the Joint Resolution until later in today's session pending Adoption. All those in favor will vote yes, those opposed will vote no.

He would be able to sit in his living room and watch these children play and he absolutely loved that.

The year we opened our sugar house in 2005, we had our big Maine Maple Sunday celebration. He brought his draft horses down and gave rides to all of our visitors who wanted to take a ride around the area, which on our little dirt road it was really quite a sight to have these massive draft horses come

and bring our visitors around. He absolutely loved horses, almost as much as he loved the youth, the children of our area, to the point that because of his construction business he was able to help those of us when our horses passed from the earth, to be able to properly give them a burial. He would come to our farm and help us properly bury those animals when their time came to leave us.

We've suffered a huge loss. I stood last -- in February to -- in recognition of our town's 200th birthday which we are having a celebration in July -- or June, June, I believe, and Clayton was a big proponent of getting that whole celebration going. He absolutely loved the town, he was born in the area and never left until last week. The funeral over the weekend was a packed house and we will miss Clayton terribly in our area, and I thank you.

I didn't prepare any words for this because I didn't know it was on the calendar, but he was my second cousin, so we invited people from the family to come today so I guess I am the family of recognition. The SPEAKER PRO TEM: The Representative may proceed.

Representative **SYLVESTER**: Thank you, Mr. Speaker. LD 217 was passed out of the Veterans and Legal Affairs Committee a unanimous Ought to Pass. It's a bill to help veterans' organizations on islands in remote posts so that they have a lounge that serves members and it allows them to invite the community into the lounge legally. And so what it does is, you know, for a remote place like an island, our Legion, our, you know, our veterans' posts, these are the things that bind the community together. They struggle to survive and so this bill, the community worked -- or the committee worked with all stakeholders in order to find a unanimous Ought to Pass. It was on the consent calendar, at the last minute the Attorney General had a question about smoking, they wanted to fix the language, this amendment fixes that language to make it clear that when the public is in the building there shall be no smoking, and that's what this does, and I appreciate your patience.

Subsequently, **House Amendment "A" (H-61)** was **ADOPTED**.

Representative STEWART of Presque Isle **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought to Pass as Amended** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Orrington, Representative Campbell.

Representative **CAMPBELL**: Thank you, Mr. Speaker, Men and Women of the House. This is an interesting issue. We are banning Styrofoam cups, plates, bowls, platters, and trays from food establishments. The circular that was brought to our attention as it came across our desks today had some interesting comments. I'd like to address the somewhat misleading absolutes.

In red, plastic foam can't be recycled in Maine. If you break that down, can't be recycled is an untruth. There is a machine called a densifier that's created by Dart, which is the

manufacturer of these Styrofoam products, that is available to anyone who would like to purchase one with a grant for \$50,000 to pay for it.

It said that these can't be recycled; well, yes, they can. It's also said that these food containers are contaminated, but in the densifier process, it's cleansed so it can be used, it's cleaned, cubed, and can be reused in things such as moldings. This product also can be burned in the waste to energy facilities and it's welcomed in those facilities. It speaks of alternatives. Yes, there are alternatives. They're made out of palm leaves for bowls and plates or paper cups, better to use a paper cup than a Styrofoam cup. Well, unless you know how it's made. In order to keep things hot, you have to line that paper with plastic. We hear about this product breaking down and floating in the oceans, but if you have a paper cup lined in plastic, it sinks, all in its own shape, and becomes more of a problem. Styrofoams use less product in manufacturing, it creates a smaller Eco footprint, and there's less volume in trash.

Something that was discussed and might be able to be looked at soon in the future if this item is defeated, is a study to look at all plastics, a taskforce to study all plastics. We've got a plastic problem, but rather than banning them, why don't we talk about how to reuse them, talk about how to recycle them. This is a very narrow ban, which is, for many small businesses and consumers, a problem. This will affect your food carts, the seasonal businesses, takeout establishments, churches.

As mentioned in this circular, there are communities that are already banning them. I believe it's a local control issue. It's already happening. So the state doesn't have to ban. But the biggest problem here is our culture. I may be old, but I remember baskets on downtown streets poles called litter baskets. It had a little bug on it and as kids we knew that litter was not good. Rather than banning a product, why don't we talk about not throwing it away? We aren't working on the problem here, we're just addressing a feel-good issue. The problem here and the root of that problem is our culture. We're a throw-away culture. Why don't we do that rather than banning products? Thank you, Mr. Speaker.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Montville, Representative Zeigler.

Representative **ZEIGLER**: Mr. Speaker, Fellow Legislators, I rise to support LD 289, a bill to prohibit the use of certain food containers made of polystyrene.

It has been suggested that we are being premature in replacing this packaging with other material and that we need more studies. With other material that -- excuse me, although I agree that there should be more studies looking at plastic that are environmentally harmful, in this case the information is already conclusive that polystyrene needs to be replaced. Polystyrene cannot be economically recycled or reused. I talked to Mr. Roche, who heads ecomaine, and he said that he does not even like to use it to burn for fuel because of the fact of its weight, it is not economically -- to be able to transport it costs more than what they receive in burning the energy, this polystyrene. If we can't burn it and we can't recycle it because no one is using those -- the machinery to condense it, it ends up in the landfill, and because of the fact that it is mostly air, it uses more space than regular plastic that is not extruded.

Polystyrene has been shown to be carcinogenic and a neurotoxin, especially when it's in proximity of grease or heat. Polystyrene is made of petrol chemicals which are not found in Maine but, rather, imported. Presently, wood products are being used as a substitute at just a few cents point difference. If we vote to prohibit polystyrene, we would be aiding an

emaciate industry using a resource that Maine is struggling to support.

Maine-grown industrial hemp could be another option for the insulating values of its tight cellulose structure. Henry Ford built an automobile out of hemp, so it shouldn't be too difficult to build a takeout container for a hamburger. Already in Waterville, they are producing a product that will substitute for polystyrene as takeout. That's a Maine industry.

When polystyrene enters the water system, it breaks down into small pieces. These pieces then become part of the aquatic food chain. There's proof that these microplastics affect the reproductive rate of fish and stunt the growth of shellfish. Why would we threaten a huge part of the Maine economy to use a product that is not native to Maine?

And, lastly, we have a tourist economy. To have polystyrene trash littering our lake and ocean beaches makes absolutely no sense. New York City, Tacoma, Seattle, Washington DC, Freeport, Maine, Portland, Maine, and 16 other Maine towns along with Nantucket, Minneapolis, Los Angeles County, San Diego, Charleston and San Francisco have all banned polystyrene. As we speak, there is a bill in the Maryland State House to prohibit the use of polystyrene containers and the European Union is also discussing the issue. If we pass this bill, we will be the first of many states doing this. We are charged with protecting the environment and the health of our state. They're our goal.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Camden, Representative Doudera.

Representative **DOUDERA**: Thank you, Mr. Speaker. Mr. Speaker and Ladies and Gentlemen of the House, I rise in support of LD 289, "An Act To Prohibit the Use of Certain Disposable Food Service Containers". You've heard about the detrimental effects of this plastic and I don't need to repeat them again. But, today, as a long-time owner of a business and a former member of the hospitality industry, I'd like to speak to this bill from a business perspective.

Firstly, this bill provides plenty of lead time for businesses in Maine to get themselves ready for implementation. When passed, the law does not go into effect until January 1, 2021. Second, the bill provides uniformity for businesses that have more than one location. More than a dozen Maine towns, including my own, have already banned foam food containers in their communities and many businesses are already complying with this measure. A state law will help businesses by making uniform what's already happening in various towns across our state. This bill encourages and recognizes that there are biodegradable, environmentally friendly alternatives to polystyrene that are cost effective and easily obtainable. And, finally, this bill helps Maine businesses retain and keep customers. Maine consumers want to know that the businesses they patronize have our precious Maine environment in mind. So, for all these reasons, I urge you to vote to support LD 289 and vote Ought to Pass. Thank you.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Orrington, Representative Campbell.

Representative **CAMPBELL**: Thank you, Mr. Speaker, Men and Women of the House. Sorry to rise a second time. Like I mentioned earlier, these absolute words used; can't -- again, I'll just go back to the one in red, can't be recycled. Yes, it can, in Maine, not yet, but to use can't be burned; I represent a district with a waste to energy facility and they welcome it. Thank you.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Winter Harbor, Representative Faulkham.

Representative **FAULKINGHAM**: Thank you, Mr. Speaker. I also rise in opposition to the bill.

It's been suggested that it's not cost effective to transport this for fuel, but then what becomes of it? Does it stay where it's at? It's already being transported, so why not transport it to a facility to use it for energy?

Secondly, it's been suggested that there are products to replace the polystyrene. That's great. Why don't we wait for them to come out and they'll replace the polystyrene on their own? We don't need to move ahead with this.

The third thing I would like to bring up is right now we're going through a plastic bag issue, a one-use paper -- plastic bag. What precipitated that issue? It was a premature rush to go away from paper bags. It caused this huge problem. Now what are we trying to do? Go back to paper bags. So, it's not wise to rush ahead on these things. The first time you hear them, they may sound like a good idea, but we should use patience and it's not a good time to move forward with this. I would say Ought Not to Pass on this. Thank you.

The **SPEAKER PRO TEM**: A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought to Pass as Amended Report. All those in favor will vote yes, those opposed will vote no.

On **POINT OF ORDER**, Representative **BICKFORD** of Auburn asked the Chair to remind Representative **TUCKER** of Brunswick to address the Speaker and not turn to the rest of the House.

The **SPEAKER PRO TEM**: The Chair will remind all Members to direct their comments to the Speaker.

The Chair reminded all Representatives to address their comments toward the Speaker.

Representative **TUCKER**: Thank you, Mr. Speaker. I will address you directly.

This floor amendment will change some wording. The committee bill as amended uses the term food establishment to define what the scope of the prohibition was under Title 38. A concern was recently raised that this term, food establishment, is also used by the Department of Agriculture in Title 22. The concern was that it would be a confusion of terms because in Title 22, there's a special word for food establishments, like food stores and eating establishments like restaurants. Therefore, we change the word food establishment as defining the scope of this restriction to covered establishment. So, now we're using that word but it doesn't change the substance or the coverage of this bill one bit.

The **SPEAKER PRO TEM**: The Chair recognizes the Representative from Belgrade, Representative Keschl.

Representative **KESCHL**: Thank you, Mr. Speaker. Just I'd like to pose a question to anyone that would care to answer.

The **SPEAKER**: The Member may proceed.

Representative **KESCHL**: If this is -- if the use of these Styrofoam containers is bad, why would we exempt anyone from using them?

The **SPEAKER PRO TEM**: The Representative from Belgrade, Representative Keschl, has posed a question through the Chair to anyone who cares to answer. The Chair recognizes the Representative from Orrington, Representative Campbell.

Representative **CAMPBELL**: Thank you, Mr. Speaker. Might I ask a question of the definition -- or clarity of the word covered? I don't understand that -- covered in what form?

The **SPEAKER PRO TEM**: The Representative from Orrington, Representative Campbell, has posed a question through the Chair to any Member who cares to answer. The Chair recognizes the Representative from Canaan, Representative Stetkis.

Representative **STETKIS**: Thank you, Mr. Speaker. I have a question through the Chair. I guess I'm wondering, what is the difference between one organization's trash and another use of that same trash; how is that trash any less destructive to our environment, if that's what we're after?

JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES TO EXPRESS THE STATE'S OPPOSITION TO THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY'S REVISED SUPPLEMENTAL COST FINDING FOR THE MERCURY AND AIR TOXICS STANDARDS

WE, your Memorialists, the Members of the One Hundred and Twenty-ninth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the President of the United States as follows:

WHEREAS, under the United States Clean Air Act Amendments of 1990, the United States Environmental Protection Agency finalized the Mercury and Air Toxics Standards to protect air quality and promote public health by reducing emissions of hazardous air pollutants from coal-fired and oil-fired power plants; and

WHEREAS, coal-fired power plants represent the largest source of mercury in the United States and were responsible for nearly half of all mercury emissions in 2015; and

WHEREAS, mercury, once released into the environment, can become methylmercury, which accumulates in living tissue and causes serious health effects, including neurological and reproductive disorders in humans and wildlife; and

WHEREAS, coal-fired and oil-fired power plants emit significant amounts of toxic metal particles, including arsenic, beryllium, chromium, cadmium, lead and nickel; and

WHEREAS, coal-fired and oil-fired power plants emit large amounts of acid gases and organic pollutants that are listed as hazardous air pollutants under the United States Clean Air Act; and

WHEREAS, mercury levels in Maine fish, loons and eagles are among the highest in North America, leading to a statewide advisory regarding mercury and fish consumption that has remained in effect since 1994; and

WHEREAS, our communities, businesses and industries depend on clean air and a healthy environment for the benefit of current and future residents, property owners and visitors; and

WHEREAS, in Maine, commercial fishing contributed over \$500 million to the State's economy in 2017; and

WHEREAS, pollution from coal-fired and oil-fired power plants threatens the quality of life and the livelihoods of Maine citizens, important Maine industries, such as commercial and recreational fishing and tourism, and small businesses that rely on a clean and healthy environment; and

WHEREAS, hazardous pollution from coal-fired and oil-fired power plants can travel significant distances and across state borders; and

WHEREAS, the United States Environmental Protection Agency reports that between December 2014 and April 2016, the deadline to achieve compliance with the Mercury and Air Toxics Standards, coal-fired power plants in the United States made investments in control technologies and other related changes for over 112 gigawatts of capacity; and

WHEREAS, the United States Environmental Protection Agency states that the Mercury and Air Toxics Standards have already reduced mercury emissions from the power sector by 86%, acid gases by 96% and toxic metals by 81% and protected public health and the environment accordingly; and

WHEREAS, controlling and reducing emissions of all air pollutants from coal-fired and oil-fired power plants, including pollutants not directly regulated by the Mercury and Air Toxics Standards but nevertheless reduced by the controls installed to implement the Mercury and Air Toxics Standards, is providing improvements in the quality of the air and environment, to the benefit of Maine citizens; and

WHEREAS, the United States Environmental Protection Agency issued a proposed revised Supplemental Cost Finding for the Mercury and Air Toxics Standards on December 27, 2018 that puts the Mercury and Air Toxics Standards in jeopardy; and

WHEREAS, this resolution must be initiated before the 60-day period expires following publication of the proposal in the Federal Register in order that opposition to the proposal may be communicated to the United States Environmental Protection Agency forthwith; now, therefore, be it

RESOLVED: That We, your Memorialists, on behalf of the people we represent, take this opportunity to respectfully request that the President of the United States direct the United States Environmental Protection Agency to withdraw the revised Supplemental Cost Finding for the Mercury and Air Toxics Standards; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Donald John Trump, President of the United States, to the Administrator of the United States Environmental Protection Agency, Andrew Wheeler, and to the Assistant Administrator for the Office of Air and Radiation, William Wehrum.

The SPEAKER PRO TEM: The Representative from Friendship, Representative Evangelos, has requested unanimous consent to address the House on the record. Hearing no objection, the Representative may proceed on the record. And the Chair will remind the House that the House is in order.

Representative **EVANGELOS**: Thank you, Mr. Speaker. Men and Women of the House, 51 years ago today, Dr. Martin Luther King was assassinated. That was a tremendous loss for our nation. Many of you may be unaware that on December 8, 1999, a court in Memphis ruled unanimously 12 to nothing that we hadn't been told the truth about that death and that James Earl Ray, the accused assassin, was not the person who shot and that there were some pretty dark forces responsible for it.

Lastly, Mr. Speaker, something happened on Dr. King Day, January 21st of this year, that was not reported in the American media, but 60 very important people in our country wrote a petition to the United States government asking for an investigation into the deaths of John Kennedy, Robert Kennedy, Dr. King, and Malcolm X. Amongst the signatories to that document were Robert Kennedy, Jr., Kathleen Kennedy Townsend, members of the King family, Daniel Ellsberg, who wrote the Pentagon Papers, a man named Ray McGovern who did the president's daily briefing for the Central Intelligence Agency for eight years, and many, many others. Not one American newspaper reported these facts to us, but it is a fact that on January 21st, the United States government was petitioned to investigate the deaths of those four individuals because we never got a criminal investigation on any of them. We got commissions. Thank you for letting me speak, Mr. Speaker.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Bath, Representative Paulhus, who wishes to address the House on the record.

Representative **PAULHUS**: Thank you, Mr. Speaker. I just want to first say, as this is my first time standing as the Representative for the City of Bath, what an honor it is to be a member of this body.

As some of you may know, I used to work in the State House as a chamber staff in this body, as a Sergeant-at-Arms of the other body, so I understand the responsibilities of the staff, of what members go through, and it is a great honor to be here today to represent the people of Bath and to be among you today, and tomorrow, and the rest of the session. Thank you.

By unanimous consent, all matters having been acted upon were **ORDERED SENT FORTHWITH**.

On motion of Representative PAULHUS of Bath, the House adjourned at 12:28 p.m., until 10:00 a.m., Tuesday, April 9, 2019, pursuant to the Joint Order (S.P. 455) and in honor and lasting tribute to Bessie M.
