He and Sam Lanham founded the law firm Cuddy & Lanham, P.A., which for 23 years represented clients in a wide variety of matters, including class actions involving pharmaceuticals and product defects and civil rights and constitutional issues. Justice Cuddy will be long remembered and sadly missed by his family and friends and all those whose lives he touched;

The **SPEAKER**: The Chair recognizes the Representative from Winterport, Representative Cuddy.

Representative **CUDDY**: Thank you, Madam Speaker, Members and Ladies and Gentlemen of the House. I have to say, I did not expect to start crying during that part of this, but there we have it.

So I rise today to publicly pay my respects to my late father, Kevin Cuddy. Dad passed away early Tuesday morning with his wife, Carol, and my brothers and I at his side. His passing was peaceful. Some of you in this House knew my dad. Some people had practiced law alongside him and some people may have appeared before him when he was a judge. Some others may never have heard his name before today so I do want to say a little about him.

My dad was born in New York, please don't hold that against him. He graduated from Bucknell where he met my mother, Judy, and then later from Suffolk Law. He and my mom moved to Maine after securing work with the U.S.

Attorney's Office under Sumner Peter Mills, Governor Mills' father, so I have many reasons to be thankful to the Mills family. Being here is one of them. My parents moved to Winterport and I was born there, as was my younger brother, Kevin. My older brother, Matt, is technically, I have to admit, from away. In my dad's professional life, he worked as an attorney in the same firm for many years, Mitchell, Blue, and Keith in Bangor, but eventually set out to start his own firm with Sam Lanham and they had a very successful practice.

I'm very proud of my father's professional life for many reasons, but two times stand out particularly. First, when I went to Washington D.C. to watch him try a case in front of the Supreme Court, that's not an honor that a lot of attorneys get. He played the role really well of the small-town lawyer. It was a case he had no chance of winning, the opposing counsel knew it, it's why they took it for free, it'd really boost their numbers in front of the Supreme Court. But he stood there at that small rostrum in front of the nine Justices and took every question they had without flinching. If you've ever been nervous in front of one of our committees, just imagine standing in front of those nine people and taking their questions.

The second time was when my wife, Kate, and I went to watch his confirmation here in this building to be on the Superior Court. All of us have watched our fathers -- have hopefully had a chance to watch our fathers go to work each day, they come home at night, we have no idea what they've done. I know my kids have very little idea, really, of what I do on a daily basis. Sometimes I think I may have very little idea of what I do on a daily basis. But I got to stand there and watch a parade of people come through and talk about the wonderful things my father had done in his career; the pro bono work, organizing other lawyers to do the same, mentoring younger attorneys. It was eye-opening, to say the least.

So, Madam Speaker, that's how I learned about the good that my dad did on a daily basis. It was the stories of others. My dad did not brag. He didn't tell me about how fair he was or how hard he worked or how many people he'd helped, he just did it. To be frank, he would've been a failure on social media.

When I was traveling the Second Congressional District, I worked for a guy named Tim Woodcock on his congressional campaign. I met a lot of people that dad had represented, I met a lot of people that sat across the table from him, and even people that he had been a mediator or arbiter for. Later in life, I met a lot of people who came before him when he was a judge and I met people that he found for and I met people he found against. But all of those people, every -- and I mean literally every single one had good things to say about my father; that he was fair, that he had given them every opportunity. Their lawyers told them yeah, we lost, but we had every chance to present our case. And that says something about any man or woman if you have found them lacking in some way and they still respect you. I think that's impressive.

In his personal life, my dad was very private. He'd be appalled that I'm talking right now. I suspect that many of you in this chamber who knew my dad did not know that he was sick. That was how my dad wanted these things. If you were somebody who needed to know for some reason, he'd let you know. If you were not, then you should feel free to mind your own business. My dad also -- he wasn't a hugger. He was very uncomfortable talking about how much he loved my brothers and I. He came from an Irish-Catholic tradition that doesn't place a premium on being open with your emotions. If you have Irish-Catholic relatives, you probably know what I'm talking about. However, as he got older and he learned that

his children wanted that, he changed. He fought against that tradition to help give his children what they needed. I left some space in here in case I felt the need to say anything else and I don't. The next two sentences are going to take me about an hour to get through, so I'm going to apologize right now. But today, in closing, Madam Speaker, is April 25th of 2019. Today is my father's 75th birthday, and I would just ask that everybody in a very quiet and respectful way at some point in time today, just wish my dad a happy birthday. Thank you.

The SPEAKER: The Chair recognizes the Representative from Presque Isle, Representative Stewart.

Representative STEWART: Thank you very much, Madam Speaker, Ladies and Gentlemen of the House. I rise today to extend my condolences to the Cuddy family.

Their family and mine share a lot of similarities, growing up surrounded by attorneys and now judges -- justices. And I recall a memory, in particular, of when I was a freshman -- the summer between my freshman and sophomore year in college. I was thinking about law school, for obvious reasons, and was working with my dad a little bit to get a sense of what that might be like. And he had a case in Bangor, in Penobscot Superior Court, and the case had settled early and so had some time to kill and the presiding judge just happened to be Justice Cuddy. And knowing that if I probably heard from somebody else why law school is not a bad idea, particularly in rural Maine, it might sort of turn the tables a bit. And so without hesitation, Judge Cuddy, who was a very busy man, said come on back to my chambers and we'll chat. And it was a bit intimidating, no doubt, for an 18-/19-year-old kid to have an opportunity like that but it was a memory that is firmly implanted on me, not just about what I should do and, you know, what sort of path I should take as an individual, but what the needs of our state are in regards to access to justice and why that matters as much as it does and Judge Cuddy was a very fierce advocate for access to justice.

And, to sort of come full circle here, a few months ago I had the opportunity to sit down with none other than Judge Cuddy once again in my office as he explained what he's now - - was then working on, which was to ensure that folks who needed a voice in Maine be able to have access to that voice, that the unrepresented and underrepresented would have just as fair a shot in front of any judge in any court in Maine, because he knew how much that mattered. And he was what I would refer to as and what many in the business would refer to as a judge's judge. And I, again, would like to just extend my condolences to the entire Cuddy family. Thank you for sharing your father's life not just with me but with the rest of the state. We are better off because of him. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Cardone.

Representative CARDONE: Thank you, Madam Speaker. I first met Kevin Cuddy in 1985 when I became a member of the Bar in Penobscot County. Then attorney, later Judge Cuddy was known for his intellect, he was known for his knowledge of the law, and he was known for his skills in the courtroom, but most of all he was known for his willingness to help. He would help in the mentoring of new lawyers and that was whether or not you worked for him in his law firm, and whether or not you were on the opposite side of a case. If he could help you out as a new lawyer, he was always willing to do so. He was also a mentor and supporter of the Maine State Bar Association Peer Assistance Program and was willing to reach out to lawyers across the state, if they needed his assistance. And he was a tireless supporter of legal volunteer

programs in support of civil legal services. He felt that all of us, regardless of our socioeconomic status, deserved access to justice and he did whatever he could to secure access for all in this state.

If somebody asked Judge Cuddy for help, he was always willing, he was always wise, and he was always, always kind. It's an understatement to say that he'll be missed as a member of the Bar. He has left a gap. My hope and my aspiration, Madam Speaker, is that I, the members of the legal community, and the members of this legislature can help to fill that gap by emulating his behavior and reaching out and supporting each other, being willing to help and supporting the causes that he supported. Thank you.

The SPEAKER: The Chair recognizes the Representative from Brunswick, Representative Tucker.

Representative TUCKER: Thank you, Madam Speaker. In my early practice, Kevin Cuddy and I were often on opposite sides. He is among one of the most honest and upright persons I have ever met in the profession.

The SPEAKER: The Chair recognizes the Representative from Sanford, Representative Harrington.

Representative **HARRINGTON**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I rise in opposition to the motion.

This is a pretty simple piece of legislation. It merely directs the State Board of Education to adopt rules to allow Reserve Officer Training Corp instructors who are very well-trained by the Department of Defense to receive an endorsement by the Maine Board of Education. I've already met with the Board, with members of the Department of Education. When they saw what the Department of Defense required of these folks, they said that this would be a pretty streamlined process because as they meet almost every requirement already. So, I'd ask that you follow my light and let's get this legislation passed and I request a roll call.

The same Representative **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought Not to Pass** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Kornfield.

Representative **KORNFELD**: Thank you, Madam Speaker. This bill is about certification requirements, not about JROTC. I think it's important that there are standard Maine teaching requirements for everyone who teaches. If the -- you can apply to the Department of Education and if you have already taken these courses somewhere else then they will give you the certification. I'm very familiar with the JROTC program because we had it at Bangor High School where I taught for 30 years and it was one of the oldest programs in the state. It is not a requirement in this class, the JROTC class, that you are able -- pardon me -- that you are able to go into the service. There may be, and are, special ed students, for example, in the class. I say this because it's to show you how important it would be to take the course on exceptionality and inclusion.

We also received an email from the officer who was there and had requested this bill which thanked us for hearing the bill and said he understood and would not have voted for the bill, either, the way in which it was written. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Alfred, Representative Sampson.

Representative **SAMPSON**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. The interesting thing about the Junior ROTC program is that this is an opportunity that we don't have -- it's basically opening the door so that these folks who can -- who are well-trained can come to the state. They only accept retired military who go through the training in order to teach this program. Currently, Maine is shut to them. If they are in a position where they would like to be giving back to the young people in this country, they can go to many other states but they can't come to Maine. Maine is not even on their radar because we don't have this opportunity for them. There are isolated schools where the principals have hired individuals to run either a Junior ROTC, Navy ROTC, Air Force ROTC; there's only a handful. But this -- this would require us or this would allow them when they are considering states to move to, to come here. It would open the door for them. Thank you.

The SPEAKER: The Chair recognizes the Representative from Fort Fairfield, Representative McCREA.

Representative **McCREA**: Thank you, Madam Speaker. I worked in my local support system which has a lot to do with certification for -- well, ever since that was turned over to the local districts in 1984 through 2016. And I'm quite intimately involved -- informed on the endorsement area and certification. There is a pathway for someone with a background in a particular area through the department to be certified but there is already, I repeat, a path. What happens is the department, the DOE, looks at a person's transcripts, looks at their background, and requires certain courses. I don't care if they're moving into being a science teacher or JROTC, those are all good things, but what they do is they screen to see where the applicant may need some future work or some additional education. But they can get a certificate to do that as long as they are making progress at a certain level per year towards full certification. So I think this is a great program, I'm not in any way against the program, but I am very much against sort of end-around against endorsements and certification. Thank you.

The SPEAKER: A message from the Chair. We are going to proceed, however we will -- and we will be recording the roll call votes, however, we will not be able to print them in real time. So, we will record every roll call vote and at the end of session we will be able to print them and if anyone wants

them, but as we normally go through a roll call and then distribute the printed copy to folks who request that, that won't be available for the time being.

Representative **KORNFIELD**: I would just like to say two sentences. Sentence one: There is nothing in the law right now that would prevent any schoolboard from establishing a late start time for their high school and, number two, if you say you believe in local control and unnecessary laws, you will vote with me Ought Not to Pass.

The SPEAKER: The Chair recognizes the Representative from Brunswick, Representative Daughtry.

Representative **DAUGHTRY**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I just wanted to really quickly provide some clarification about why this bill is before you.

This is something that's been a passion project of mine for many years, since I was at Brunswick High School and we were working to provide a later start time at that school district. This is a bill that I think will keep coming back. A lot of school districts are trying to move to a later starting time but having it at a state level, many of the school districts have said it would ease the transition when you're trying to coordinate bussing schedules as well as sports schedules. I'm not asking for a roll call at this time, but I would just urge all of you to look up the science. This is something that's not in dispute; having a later starting time for high schools will provide students a better chance to be able to learn, it's medically proven that their brains are on a different circadian rhythm so having a student up at 7 a.m. is akin to sort of waking and shaking any of us up at 3 in the morning and expecting us to work. And for those legislators who have been here in the legislature at 3 a.m. working on votes, just think how well you're functioning then

and that sort of gives you an idea of how it feels for a lot of high school students with these early start times.

A late start time of 8:30 a.m. has been one of the major policy priorities for the American Academy of Pediatricians, every major medical society has said this is something we need to do. It reduces risks of suicide and depression for teens, it helps close the achievement gap. I mean, it's one of those things the science is undisputed and this is a conversation that's going to keep happening until we recognize that teens need to have a later start for high school. Thank you.
