The following Joint Resolution: (S.P. 762)

**JOINT RESOLUTION MEMORIALIZING THE NATIONAL OCEANIC AND ATMOSPHERIC ADMINISTRATION TO CONSIDER THE SAFETY OF THE MEN AND WOMEN WORKING IN MAINE'S LOBSTER INDUSTRY**

WE, your Memorialists, the Members of the One Hundred and Twenty-ninth Legislature of the State of Maine now assembled in the Second Regular Session, most respectfully present and petition the National Oceanic and Atmospheric Administration as follows:

WHEREAS, the men and women who work in the Maine lobster industry are constantly at risk of injury and loss of life; and

WHEREAS, the safety of these workers must be the primary concern of all government agencies that regulate the ocean; and

WHEREAS, the Maine lobster industry has made many changes to help protect the right whale; and

WHEREAS, no right whales have been killed by Maine lobster gear and deaths in 2019 were predominantly by ship strikes in Canadian waters or in one instance due to Canadian fishing gear entanglements; and

WHEREAS, the National Oceanic and Atmospheric Administration has stated that right whales likely are not traveling in the waters in which Maine lobster fishing occurs; and

WHEREAS, the proposal to modify the existing Atlantic Large Whale Take Reduction Plan developed by the National Oceanic and Atmospheric Administration will not save any right whales in Maine waters but will put the lives of workers in the Maine lobster industry at great risk; and

WHEREAS, the lobster industry is one of Maine's core traditional natural resource industries and has employed generations of Maine's citizens; and

WHEREAS, the lobster industry contributes \$1.5 billion to Maine's economy and entire communities depend upon the work that the lobster industry provides; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully urge and request that the National Oceanic and Atmospheric Administration take the lives of the men and women of the Maine lobster industry into account in the agency's decision making and understand that the agency's proposed changes to the Atlantic Large Whale Take Reduction Plan will not save one right whale in Maine waters but will put many human lives in danger; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the

Honorable Donald J. Trump, President of the United States, to the President of the United States Senate, to the Speaker of the United States House of Representatives, to Dr. Neil Jacobs, acting Under Secretary of Commerce for Oceans and Atmosphere, and to each Member of the Maine Congressional Delegation.

Representative **MAREAN:** Thank you, Madam Speaker. Good morning, Ladies and Gentlemen of the House. I'm pleased to stand today on behalf of the House Delegation of

the Bonny Eagle High School to recognize the Frost family and the Bonny Eagle team of wrestlers.

The wrestlers here with us today all qualified and participated in the state finals in Sanford in February. Although they all didn't win state titles, they did participate and saw two of their teammates win state championships. The two state champs are both brothers and they have seen plenty of action on the mats and have earned respect from those across the State. But this is only half the story of the Frost brothers, for they number four; four brothers, and two of them are twins. The Frost boys, as they are known, have a reputation on the wrestling scene and a headline by their opponents when they're coming to town as a Frost warning when they're scheduled to meet the opposition. The boys have great support from their parents, who are also with us today, and parental support and guidance is one of the key ingredients to a team success.

Three of the Frost boys are wrestlers and one is an assistant coach and who was also a wrestler when he was in high school. The four Frost brothers, starting with the oldest, are Caleb, the assistant coach, then Colby, a junior, and then the twins, Caden and Cam, both sophomores. Our state champs today are Caden and Colby. Caden's wrestling stats are 76 wins, six losses. He finished second in the State last year as a freshman and went on this year as a sophomore in the 106-pound weight class to win a state Class A championship in his class. Colby's wrestling stats; 113 wins, nine losses. He finished second in the state as a freshman in 2018 and then in 2019 he won a state Class A championship as a sophomore in the 120-pound class and went on in 2020 to win another Class A title in 126-pound class as a junior. Colby got his 100th win this year at the Skowhegan Invitational, where the Bonny Eagle Scots team also won first place in that event.

Congratulations to Caden and Colby on your state titles. And I would be remiss if I didn't congratulate the coaches on their work for this team, Coach Josh Lund, Coach Greg Gonyea and Coach Caleb Frost. We're all very proud of you. And the latest update on the Frost boys is this past weekend they qualified to participate in the New England Finals coming up this weekend in Methuen, Massachusetts. Last weekend, Colby had a win, as did Caden, and Cam finished third. They will be going to Methuen, Massachusetts this weekend, so there is another Frost warning for this weekend. Thank you, Madam Speaker.

Anyway, I request that members follow my light as I think we were referring to committee at this point to try to find some common ground on this three-way report. It would make more sense at this time. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Bangor, Representative Schneck.

Representative **SCHNECK**: Thank you, Madam Speaker. This change came to our committee at the very last minute, at the very end of the committee process, during language review. We were ready to move this bill down here. It makes a lot of serious changes to the bill. In my mind, Murphy's Law and the Law of Unintended Consequences also can happen here. This is not something that requires minimum legislative scrutiny; it requires normal legislative scrutiny. And to put these changes into a lightning round of committee work at this point in time is neglecting the major work that needs to be done on this amendment. I will ask you to follow my light and vote against this motion.

The **SPEAKER**: The Chair recognizes the Representative from Topsham, Representative Tepler.

Representative **TEPLER**: Thank you, Madam Speaker. Madam Speaker, can you explain to me and the Chamber what will happen to this bill at this point if we recommit it? Does it go back to the Senate?

The **SPEAKER**: The Chair will answer in the affirmative, that if the House were to vote to recommit to this bill to committee, then we would be in nonconcurrency with the other body and that means it would be sent back to the other body for consideration of the same question. The Chair recognizes the Representative from Monmouth, Representative Ackley.

Representative **ACKLEY**: Thank you, Madam Speaker. Madam Speaker, this bill, the suggestions made at the very end of the hearings on this bill were critiqued and it was pointed out that the major concern was some of the changes in this bill had not yet had a public hearing. The purpose for sending it back to the Veterans and Legal Affairs Committee is simply to fulfill the wishes of those who are opposed or have concerns about the last-minute changes to this bill. So, we're simply following exactly what was requested so that this bill can be considered in its entirety.

The **SPEAKER**: The Chair recognizes the Representative from Harrison, Representative Riseman.

Representative **RISEMAN**: Thank you, Madam Speaker. I rise to speak in favor of referring this bill back to committee.

In my opinion, this bill does not sufficiently address our need to fully represent the needs of the entire constituency we serve. According to sources, there are 828,000 registered voters in Maine and of that number approximately 300,000, or over 35%, are unenrolled in a party. Three hundred thousand constituents we need to remember are there and want to participate. They include equal amounts of left- and right-leaning values as well as those who have for personal reasons not enrolled in an organized party. Unfortunately, these people feel the process purposely excludes them. We need to do more as government to encourage involvement by all, especially the unenrolled. The unenrolled, also known as independents, we need to encourage more involvement to create a stronger democracy, and it will be stronger. Let's ensure the process works for all by referring this bill back to a committee for further review. Thank you.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The **SPEAKER**: The Chair recognizes the Representative from Bradley, Representative Lockman.

Representative **LOCKMAN**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, the bill before us has a very appealing title; Resolve to Ensure Safe and Inclusive Learning Environments. Who could possibly be opposed to safe schools? But, as is often the case when a bill has a motherhood and apple pie title, the content of the bill may bear little or no resemblance to the appealing title. We should always pay close attention to the actual text.

This Resolve purports to be about ensuring safe learning environments for LGBTQ students and teachers. In fact, the very first whereas of the Resolve refers to concerns about the safety of LGBTQ students. But the so-called working group that would be convened is directed to make recommendations for hiring and recruiting practices that favor teachers who identify as LGBTQ, and nobody really knows what that means in practice since there is no definition of LGBTQ. Quoting now from the bill; for the purposes of this Resolve, LGBTQ includes, but is not limited to, lesbian, gay, bisexual, transgender, queer, questioning, intersex, and asexual, close-quote. The so-called working group mandated by the Resolve will be stacked in favor of such hiring preferences, with representatives of legal and advocacy organizations that support LGBTQ interests in addition to union bosses, lobbyists, and bureaucrats, as well as representatives of various and sundry stakeholder groups that feed off state government.

Given the makeup of the working group and the explicit directive in the Resolve before us, it's not hard to imagine what sort of legislation the working group will suggest when it reports back to the Education Committee. In any case, local school districts don't need any more heavy-handed mandates from Augusta. Teachers and administrators are responsible for making sure all students have a safe learning environment. If faculty and staff are unable or unwilling to fulfill this basic responsibility, they should be fired and replaced with people who will get the job done. I'm confident our local elected school boards, are up to the task. They don't need any more Augusta-based working groups telling them who to hire and, frankly, they're fed up with the incessant meddling by busybodies and bureaucrats at the Department of Education. Thank you, Madam Speaker.

The **SPEAKER**: The Chair will remind Representatives that when discussing a bill, impugning the character of the rest of the body with the intention of the bill or members of the Legislature at large is prohibited. The Chair did choose not to interrupt the Representative during his speech today.

The Chair recognizes the Representative from Augusta, Representative Fecteau.

Representative **FECTEAU**: Thank you, Madam Speaker. Just like in committee, I rise in support of the bill in front of us.

To understand why, I would like to give a short history of the Education Committee.

Last year, the Education Committee established the School and Safety Center, which was a bill presented by the Representative from Windham. It was to be a large tent that focused on the physical security and school safety. The safety portion speaks to things like bullying, inclusion and a trauma-informed classroom. Trauma-informed practices was another bill supported last session unanimously by the committee. For some reason, a letter to the department and a January 2020 report had changed the entire purpose of the School Safety Center and the role of two new and capable hires in the Department of Education. It was my caucus's task to call this out, right the ship, and use bills like LD 1813 to prop up the School Safety Center tent.

I think it's important to have all of the security and safety resources in one place. Due to some of our efforts to advocate for the center, a report on February 15th of this year showed that the School Safety Center had been established and its original intent was underway. This bill, LD 1813, is one or two stakes in the overall Safety Center tent. I make no apologies for my support for all students in the State of Maine and I spoke passionately about that during the committee. I support all students, regardless of the color of their skin, things like sex, religion, or national origin, a person's identification in the LGBTQ community, or even their philosophical objections. The facts are, as confirmed by the department School Safety Center representative or new hire, all minority groups are the fiercer targets of bullying, more likely to be high risk and experience poverty, etcetera, etcetera, in higher rates. They are looking into many strategies to support security and safety of all students.

We've been too many years since Columbine and too many years into cyberbullying to delay these strategies any longer. If you care to read through the 700+ pages of the 2019 Maine Integrated Youth Health Survey, like I have begun, it will show that for high school alone in the State of Maine, 2.8 responded that they were gay or lesbian, 9.6% of students responded that they were bisexual, 4.4% of students responded that they weren't even sure of their sexual identification or orientation, and 1.6% responded that they were transgender. Gay and lesbian students are nearly four times more likely to experience housing instability. Gay, lesbian, and bisexual students are twice as likely to feel unsafe at school. Gay, lesbian, and bisexual students are twice as likely to be threatened with a weapon at school. In nearly every category, these students are responding to high-risk behavior when compared to other groups. This represents thousands of our Maine students, not outliers; thousands.

I teach students across all kinds of minority groups every day in our schools, except when I'm here, that is, including those a part of the LGBTQ community. It is perfectly reasonable to be both inclusive and rigorous in the classroom. You must look no further than the Augusta school department or Maranacook Community High School, where I teach. This bill is one piece of a much larger task to provide security and safety in our schools. For me, personally and personally alone, it is impossible to be the party of Lincoln in one breath and then not work towards equal treatment for all minority groups in the next breath. I won't allow my students or my constituents to be defamed, bullied, or threatened with injury for no reason other than they might be LGBTQ. I make no apologies for supporting all students in the classroom. Thank you.

The **SPEAKER:** The Chair recognizes the Representative from New Gloucester, Representative Arata.

Representative **ARATA:** Thank you, Madam Speaker. The concerns brought forward by this bill are already addressed by the Maine Human Rights Act. Also, the commissioners of our various departments are already overburdened by the large number of working groups required by the 129th Legislature. Thank you.

The **SPEAKER:** The Chair recognizes the Representative from Brunswick, Representative Daughtry.

Representative **DAUGHTRY:** Thank you, Madam Speaker. Thank you, Ladies and Gentlemen of the House. I wanted to speak up because this is my bill.

I just want to start with saying that I think we can all agree here that all children deserve a safe and inclusive school environment where they can focus on learning and they're not frightened or concerned about their very identity. We're talking about supporting children so that they can focus on what they should be doing, which is enjoying learning and doing as much as they can at school to further their education.

This bill came out of the Education Committee with a unanimous report. It creates a working group that was actually encouraged and asked for by the Department of Education. This is something that is not already being covered by the Maine Human Rights Commission or Maine Human Rights Act or by the Safety Group. This is something more. And unlike what the Good Representative from Bradley said, it does not create a preference for hiring for staff who are LGBTQ. Instead, it creates practices to help schools make sure that they're being inclusive, that they are following the Equal Employment Hiring Act. This is something we need to do. Just think about the fact there's a statistic that I saw that eight in 10 LGBTQ students are verbally harassed at school during their time and four in 10 are physically harassed. As long as that statistic exists, I don't see how we can't do everything to make sure that all children are safe in their learning environments. So, I urge you to please follow my light, please support this bill, it's one of those wonderful, incredible moments where the committee worked with the Department of Education and everyone unanimously agreed this is something that we need. It is not a mandate, it's a research for our teachers, for our schools and, most importantly, for our students.

So, I urge you to follow my lead and let's take a strong vote for Maine's children today.

The **SPEAKER:** The Chair recognizes the Representative from Portland, Representative Sylvester.

Representative **SYLVESTER:** Thank you, Madam Speaker. The Good Representative from Amherst spoke today saying that it would not be difficult to imagine what the legislation would be in LD 1813 and, in fact, one of the things that I am most interested in is what those recommendations will be.

I did not grow up LGBTQ and I cannot speak to the life and experiences of those students. I grew up poor, I grew up hungry at times. The teachers who reached out to me in large part were those who had experienced poverty like I had. I was bullied, I had fights because I did not have clothes like everybody else. And it was important for me to have those teachers who lived my experience to say that there's another place to be and in large part I am here today because of those teachers.

Now, in order to take care of all our students, in order to be certain that teachers have all the tools they need, I urge this body to protect all students. Because when this body asks our

constituents of all ages to add their voice to government, then government is doing exactly what it should be doing. Thank you, Madam Speaker.
