Senator **LIBBY:** Thank you, Mr. President, and men and women of the Senate. I'm very honored to be hosting today the Maine State Mock Trial champions from Lewiston High School. They have joined us, they are in the back of the Chamber, here today. Mr. President, men and women of the Senate, this is the first time that Lewiston High has won the Mock Trial State Title, a completion that is held in front of a Justice from the Maine Supreme Judicial Court and lawyers at a Cumberland County courtroom. In mock trial competitions high school students take the roles of prosecutors, witnesses, and defense lawyers in real courtrooms. Students from Lewiston and Cape Elizabeth, just a few weeks ago, filled the roles of lawyers making opening statements, conducting direct examinations and cross examinations, and presenting closing arguments. Lewiston High School has had a mock trial team for 25 years, started by my friend Joan Macri who taught debate and was the aspirations leader before she retired very recently. Lewiston, I'm very happy to say, prevailed over Cape Elizabeth, which had held the State Title for the previous five years, and I know both Senator Millett from Cumberland and myself congratulate this outstanding Lewiston team. Mr. President, I think it's important to recognize some of the amazing things that amazing people from Lewiston are doing in the state every day. Lewiston, as you know, is a community that has, at some times, an unfair reputation. But, in my experience, it is a community on the rise, a community that is constantly rebuilding itself. Lewiston public schools, as an example, even though we do have our challenges, we send kids to elite colleges every single year. In fact, just last week there was about 65 lawmakers, some from this Chamber and some from the House, who visited Lewiston as part of the MDF tour. The accolades, the compliments, the expression of appreciation from those folks is still coming in. Lewiston is doing amazing

things in our downtown, in our community, and for our people, and the young people who are here today as part of the mock trial championship team are yet another example of that. So please join me in wishing them well at their national competition in Georgia in May. We, of course, want them to bring home the national title but we also want them to know we are exceptionally proud that they are representing the great state of Maine on behalf of all of us. So thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, six years ago I arrived at the State House extremely wet behind the ear, a freshman legislator, assigned to Chair the Committee on Education and Cultural Affairs, feeling like a deer in headlights, and wondering what had I gotten myself into. Then I began hearing how it would be all okay because Dr. Phil was the analyst. Many refer to Dr. McCarthy with that moniker but as I began to work with him it never felt right to associate such a consummate professional and one of the smartest minds in education in the State of Maine and nationally with a former television entertainer and here's why. Dr. McCarthy holds a Bachelor of Art from Colby and Administrative Science and MS in Education from the University of Southern California and a Ph.D. in Educational Leadership and Policies Studies. Dr. McCarthy joined the Maine Legislature's non-partisan office of Policy and Legal Analysis in 1996 as a Legislative Analyst and was promoted to the position of Senior Legislative Analyst in

2012. He provided policy analysis for the Joint Standing Committee on Education and Cultural Affairs for 22 years. His contributions to the work of the Legislature includes providing his highly professional and dedicated service to our committee but he also staffed numerous task forces and commissions. The Commission to Study the Funding and Distribution of Teletypewriters and Other Telecommunications Equipment for People with Disabilities; Committee to Review the Governance Structure of the Governor Baxter School for the Deaf; the Task Force on Educational Programming at Juvenile Correctional Facilities; Task Force to Study the Implementation of Alternative Programs and Interventions for Violent and Chronically Disruptive Students; the Commission to Study Providing Educators with More Authority to Remove Violent Students from Education Settings; the Commission on Fatherhood Issues; the Special Education Committee to Study the Financing of Kindergarten Through Grade Twelve Public Education; the Task Force on the Maine Learning Technology Endowment; the Commission to Study the Scope and Quality of Citizenship Education; the Legislative Youth Advisory Council; Commission to Study Public Health; Commission to Study Strategies to Increase Postsecondary Access, Retention, and Completion for Low-Wage, Low-Skilled Adults. Mind you, there are still six more task forces that I could list, and maybe I will. Study of Laws in Other States That Permit the Dissemination of Confidential Information. He did wrap up on the Task Force on Maine's 21st Century Economy and Workforce; and the Task Force to Identify Special Education Cost Drivers and Innovative Approaches to Services. Phil has served with distinction, representing Maine's non-partisan legislative staff on committees at the National Conference of State Legislatures, including as a member of the Assembly on State Issues as the Education Committee Staff Vice-Chair and as a member of the Legislative Educational Staff Network Steering Committee, during which he was awarded the 2006 LESN Recognition Award, and most recently as a member of the International Education Study Group, whose findings upon I rely on greatly. I went through all of that so you could share with me a deep understanding of how impressive an individual we have before us. His service to our children, our schools, the State House, and our State is immense and his expertise immeasurable. It was on his shoulders that I scaled the steep learning curve of education policy and legislative process. I can never thank Dr. McCarthy enough for his constant availability, calm demeanor, readiness to assist, and encyclopedic knowledge of all things education. I wish Dr. McCarthy and his family all the best as they move onto the wondrous adventures and opportunities of retirement. Thank you, Mr. President.
