Prayer by Senator Dana L. Dow of Lincoln County.

Mills, Governor of the State of Maine, an invitation to attend the convention and make such communication as pleases her.

The Chair appointed the Senator from Sagadahoc, Senator **VITELLI**, to deliver the message to the House of Representatives. The Senator was escorted to the House of Representatives.

Joint Resolution

On motion by Senator **KEIM** of Oxford (Cosponsored by Representative **HEAD** of Bethel and Representative: **MILLETT** of Waterford), the following Joint Resolution:
S.P. 238

**JOINT RESOLUTION
RECOGNIZING MARCH 2019
AS CHILDHOOD CANCER AWARENESS MONTH**

WHEREAS, in the United States, 15,780 children under 21 years of age are diagnosed with cancer every year and approximately 1/4 of them will not survive the disease; and **WHEREAS**, the causes of pediatric cancer are still largely unknown and, though new discoveries are resulting in new treatments, this disease continues to harm families and communities with wounds that may never fully heal; and **WHEREAS**, due to ongoing advances in research and treatment, the 5-year survival rate for all childhood cancers has climbed from less than 50% to 80% over the past several decades; and **WHEREAS**, researchers around the world continue to pioneer new therapies and explore the root causes of the disease, driving progress that could provide cures or improved outcomes for patients; and **WHEREAS**, Childhood Cancer Awareness Month will put a spotlight on the survivorship issues that children and families face, the types of cancer that largely affect children, recent gains against the disease and challenges that still lie ahead and will help raise funds for research and family support; now, therefore, be it **RESOLVED:** That We, the Members of the One Hundred and Twenty-ninth Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to proclaim March 2019 as Childhood Cancer Awareness Month and urge citizens of the State to become informed about childhood cancer, including both the issues that are involved and the progress that is being made.

The Joint Resolution was **READ**.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Keim.

Senator **KEIM:** President Jackson, I rise today to speak in favor of this Joint Resolution. The causes of pediatric cancer are still largely unknown and treatments have been discovered but, as was stated, the disease continues to inflict such harm on families in our communities. This Joint Resolution recognizes March as Childhood Cancer Awareness Month for Maine and it was proposed by Tabaiitha Steward of Hailey Hugs, a charitable organization here in Maine founded by John and Tabaiitha Steward and their beautiful daughter, Hailey. Hailey was diagnosed with cancer in October of 2012 and lost her battle on September 23, 2017. Before her death, Hailey advocated on

behalf of other children and is a beautiful light in her community. Today the Hailey Hugs team continues to champion the children and the families affected by childhood cancer, raising awareness and fundraising to help ease the financial burden of everyday expenses in these times of crisis. According to the National Cancer Institute, childhood cancer is the leading cause of death by disease in children under the age of 15 and nearly 2,000 children die of cancer each year in the United States. The rates in Maine are higher than the national average. Although there are a handful of organizations that aid families and their children during these horrific times while enduring treatment the need is still greater. Childhood cancer research also receives significantly less attention and funding than other cancers. To be alive is to experience deep heartache but there is a particular devastation in a child battling cancer. Just like Hailey, all those families and children who are in a fight for life want greater attention to this terrible disease and its devastating affect here in Maine. The first step is acknowledgement. Therefore it is right for us to set aside a time to recognize the courageous heroes, some who are here with us tonight, who are also the victims of childhood cancer and designate March 2019 as Maine Childhood Cancer Awareness Month. Thank you.

Following the Joint Convention the Senate was called to order in the Senate Chamber by the President.
