# JOINT RESOLUTION COMMEMORATING THE RATIFICATION OF THE 19th AMENDMENT TO THE UNITED STATES CONSTITUTION PROVIDING FOR WOMEN'S SUFFRAGE

**WHEREAS**, at the time of the country's and the State of Maine's founding, women were not recognized as citizens and were unable to vote;

**WHEREAS**, on July 19-20, 1848, the first national women's rights convention, including a call for women's suffrage, was held in Seneca Falls, New York;

**WHEREAS**, on January 29, 1873, the first Maine Woman Suffrage Association meeting was held;

WHEREAS, on September 23-24, 1885, the first statewide suffrage convention in Maine was held at the Methodist Episcopal Church on Chestnut Street in Portland:

**WHEREAS**, from 1886 to 1915, several bills in support of suffrage were submitted to the all-male Maine Legislature and all were defeated:

WHEREAS, on September 10, 1917, a statewide referendum on the suffrage issue in Maine was defeated by a 2-to-1 margin of voters, all male:

WHEREAS, in June 1919, the United States Congress passed and submitted to the states for ratification the 19th Amendment to the United States Constitution, which prohibited the Federal Government and the States from denying the right to vote to United States citizens on the basis of sex;

**WHEREAS**, on November 6, 1919, during an emergency legislative session, Maine became the 19th state to ratify the 19th Amendment to the United States Constitution:

WHEREAS, on August 18, 1920, the proposed 19th Amendment to the United States Constitution achieved the ratification by 3/4 of the states necessary for women's suffrage to become law; WHEREAS, in 1923, the first woman was elected to the Maine House of Representatives; in 1926, the first woman was elected to the Maine Senate; in 1940, the first woman was elected to represent Maine in the United States House of Representatives; in 1948, the first woman was elected to represent Maine in the United States Senate; in 1996, the first woman was elected Speaker of the Maine House of Representatives; in 2003, the first woman was elected President of the Maine Senate; in 2009, the first woman was elected Attorney General of Maine; and, in 2018, the first woman was elected Governor of Maine:

**WHEREAS**, the One Hundred and Twenty-ninth Legislature of the State of Maine now includes 71 women Legislators, the largest number in Maine history;

WHEREAS, the Maine Suffrage Centennial Collaborative is committed to commemorating the centennial without repeating the discriminatory and exclusionary aspects of the original suffrage movement and encourages all Maine people to participate in numerous events to celebrate the centennial all over the State, including an exhibit in the Maine State Museum that opens to the public on March 23, 2019; now, therefore, be it

**RESOLVED:** That We, the Members of the One Hundred and Twenty-ninth Legislature now assembled in the First Regular Session, on behalf of the people we represent, recognize the 100th anniversary of women's suffrage and the opportunity it offers to encourage civic engagement and voting today; and be it further

**RESOLVED:** That We hereby honor the suffragists who struggled for decades to fulfill the promise that all Americans are equal under the law and urge everyone to recommit themselves to ensuring that all Maine citizens have their voices heard through the election process; and be it further

**RESOLVED:** That suitable copies of this Joint Resolution, duly authenticated by the Secretary of State, be transmitted to the Maine Suffrage Centennial Collaborative.

Senator BREEN: Thank you, Mr. President. Thank you, Mr. Secretary, for reading the Joint Resolution. Men and women of the Senate, I rise today with great humility and gratitude for the many, many people on whose shoulders we all stand today, marking the 100<sup>th</sup> anniversary of the right of women in Maine to vote. It wasn't just women but men also who joined the effort to make sure that suffrage was available to all Maine citizens. regardless of gender. But yet there were mistakes and some unsavory aspects to that campaign that included some blatant racism and blatant discrimination among other groups. The Maine Suffrage Centennial is committed to bringing forth some of those unpleasant aspects of the campaign and making sure we don't do that again as we celebrate the 100<sup>th</sup> anniversary. This issue was brought to me by a constituent, a woman named Ellen Alderman, who lives in my district and she called me back in the summer and said, 'You know, this is going on. Can you help?' It quickly became clear to me that Ellen was an extraordinary organizer and she brought groups and stakeholders from all over the state together and as she asked folks to get more involved the answer was yes over and over again. When she asked simply if your organization is doing something this year, or you can incorporate this anniversary into what you're already doing, please let us help you do that and tell us about it. She's gotten extraordinary responses. One of the responses was from the Maine State Museum and on March 21st there will be an exclusive opening of the exhibit celebrating the centennial that we are all invited to. You'll be getting a floor sheet about it. You've gotten an e-mail already in your in box. The Governor will be joining us and we will be opening the exhibit in the Maine State Museum that celebrates the 100<sup>th</sup> Anniversary of Women's Suffrage in Maine. In addition, if you go to www.Mainesuffragecentennial.org you will see that there are lots of events happening in communities all over the state and I just want to remind you that every one of these had volunteers behind it. There's been no State expenditure on any of this, but it's an extraordinary array of events and activities all over the state. So I hope you will avail yourself and help people in your community celebrate this amazing centennial and if you have any questions about next week's opening please let me know and I thank you for your attention. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Chenette.

Senator **CHENETTE**: Thank you, Mr. President. Men and women of the Senate, I rise as a proud member of the Senate Ethics Committee in support of passage of L.D. 256, An Act to Ban the Use of Leadership Political Action Committees for Personal Profit. This is one part of a comprehensive campaign finance and ethics reform package that I introduced this session. We all know that political action committees, or PACS, are a favorite mechanism to gain influence over our political system. PACs are so popular, in fact, that many legislators, themselves, operate one and, while legislator-led PACs should be banned entirely, I think at the very least we need to tighten the rules with how they are used. An investigation by the Maine Ethics

Commission found that in a prior election cycle, with a former member of this Body, a Legislator used a PAC to profit his business by \$11,000. The legislator, himself, referenced that the transfer of these funds was a loan to keep the business afloat. Now the worst part is none of this was deemed illegal or a violation of campaign finance rules. This individual ended up racking up thousands of dollars in fines, not for the action itself but for simply not disclosing the activity. Rules governing PACs in Maine are so lax that nothing prevented one lawmaker from using our campaign system as his own personal lending agency. I use this recent example to illustrate the problem but, honestly, there are many more examples that were probably never investigated or reported and no party affiliation is safe from participating in this activity. The issue we are trying to solve is an elected official profiting off our political system. Specifically, profiting off political contributions from lobbyists, special interests groups, and the very corporate entities we are supposed to be regulating. PACs don't fall under the same contribution requirements that traditional, or even Clean Election, candidate have to follow. When a legislator can operate a PAC and can funnel unlimited amounts of contributions from it to a private business operation it represents a major conflict of interest situation. Now I know we're not paid very much, Mr. President, but using political contributions to fund your lifestyle isn't a way to do it. Now I don't fault a lawmaker for participating in this system, though I fault the system for allowing this practice to occur. It's a very slippery slope when you allow legislators to fund their private business operations with political contributions. Now we've already made it illegal for PACs or campaigns to pay lawmakers directly, but there's a major loophole. Politicians can get around this current law by simply writing checks from their PAC to businesses they control as a "loan" and many of those businesses are simply pass-through entities to their own bank accounts. Moreover, by allowing individuals to co-mingle PAC, personal, and business funds it's hard to differentiate between what is what. The money could be considered loaned without even recognizing it. This bill closes a major campaign finance loophole by making it illegal to use a PAC for personal profit. Politicians who collect checks from lobbyists shouldn't be allowed to turn around and write checks to themselves through their businesses. Specifically, this would prohibit a Political Action Committee from making loans or gifts to a business owned or operated by a legislator and prohibits co-mingling the funds of such a Political Action Committee with the personal funds of a legislator or the funds of a legislator-owned business. The public is looking to us to prevent situations like this, the one that occurred recently, from happening again. They want reassurance that we are stepping up to address this and not just simply sweeping it under the rug. No legislator or candidate should be profiting off political contributions. It raises major ethical and conflict of interest questions when your business is relying on contributions originally marked for political purposes. Closing this blatant loophole will ensure high ethical standards for current and former elected officials. It would increase governmental transparency and accountability in our politics. I urge this Body to follow the committee's lead and have a strong showing of bipartisanship to ensure our political system benefits the public good. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator CYRWAY: Thank you, Mr. President. Ladies and gentlemen of the Senate, I sat in on the committee and I listened to Jonathan Wayne, the Director, and he said that in this one instance that it was taken care of. There was a fine and there was a situation where he was actually voted and removed from the Whip situation. So there was a consequence. But he felt that pretty much everything's being covered now. This would more apt to target people and so that's what I'm kind of concerned about and that's why I had voted against this, just for discussion and to make sure that people understood that it is not necessarily quite as dramatic as what you heard. Thank you, Mr. President.
