But it really is extraordinary that it's actually been 50 years since the last State Championship. I was particularly moved when I read the story about Austin Findlen and his grandfather, who quite possibly was the team's number one fan and how the team came together after his passing. To me this story really highlights what this team was about. They work with each other, they play for each other, and they always have each other's backs. I can promise you, men, that you have not only made Mr. Findlen proud but you have made all of us in Aroostook County proud. I'd like to especially acknowledge Coach Kyle Corrigan who brought out the best in each player. He really created a family amongst his team that led them to an impressive victory. I'd also like to acknowledge Parker Deptrey, who was named the William C. Warner Most Valuable Player of the tournament. I really want to extend the congratulations of the entire Senate to the Caribou Boy's High School Basketball Team on their extraordinary season and personally thank them for bringing the State Championship Trophy back home to Aroostook County and giving people in Aroostook County one more thing to be extremely proud of. Thank you, all of you.

They had to overcome a good deal of adversity and in order to win the State Championship they had to travel many, many hours to Southern Maine to defeat a very good team from Cumberland County, as Senator Jackson said, in double over-

Senator **MILLETT**: Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, just briefly, walk you through this amendment that's before you today. Simply, it removes the mandate that student assessments must be used in the current system. If local steering committees in the district find that the current system to be working for that district the system doesn't need to be changed. Again, this bill does not remove the requirement for schools to have robust teacher evaluation systems. Those are still required. Many school districts were reluctant to use student growth measures when it was required, when it was put into place, a number of years ago. Among the pitfalls of the current system are that competent teachers find the student learning objectives, or the SLOs, which require a baseline pre-instruction assessment followed by a post-instruction assessment to be both very time consuming and of little or no actual value to inform better instruction. Very competent teachers whose classes may include a disproportionately high number of either low achieving students or students identified to receive special services find themselves often confronting the reality with

their evaluation effected negatively when student assessments are used as part of their evaluation. I have to add that recently it has become somewhat fashionable for students to simply refuse to take tests, especially standardized tests, with or without parent permission or to intentionally perform very poorly on a given assessment, thus also creating an unfair representation of teacher effectiveness under the current evaluation system. Based on this, I would ask that you follow my light. Thank you, Mr. President.

Mr. President, men and women of the Senate, the biennial budget proposal put forward by the Chief Executive does not include the more than \$25 million annual cost that it would take for the State to fund this initiative. We, speaking for myself, certainly support any efforts

we can make to reduce the local property tax. However, this will not help that effort. There are other initiatives that have been put forward this session which are going to drive up property taxes at the local level, such as increasing the teacher salaries to \$40,000, and the local districts are the ones that negotiate these contracts. So they're the ones that have say in how these teacher retirement benefits are being paid. It shouldn't be the State's responsibility to pick up the cost for that. If we were to move the responsibility of negotiating salaries and benefits to the State level it would be appropriate for the State to pick up this cost. However, short of that, I don't think that this is a prudent move at this time. Thank you, men and women of the Senate.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you, Mr. President. Ladies and gentlemen of the Senate, until 2013 teacher retirement costs were paid by the State. Teachers are part of the State retirement system. Retirement benefits are determined at the State level and municipalities have almost no impact on teacher retirement costs. Then in 2013 the State shifted the costs of retirement for working teachers onto school districts simply as a cost-saving measure for the State. Making school districts responsible for teacher retirement costs was a shift of responsibility, pure and simple, and it put an additional burden on property taxpayers. It put school and municipal officials in the position of having to choose between cutting necessary educational services or raising property taxes. In many communities some of each happened and both students and taxpayers suffered. It is time to put the cost of teacher retirement back where it belongs, with the State. Thank you very much.
