Senator FOLEY: Thank you, Mr. President. Ladies and gentlemen of the Senate, I'm pleased to recognize Tyler Bridge, a star running back, quarter back, punter, and returner for the Wells High School 2018 Class D State Champion football team, their third State Championship. As mentioned, Tyler was recently named the Fitzpatrick Trophy winner for the most outstanding Maine high school football player for 2018, as well as the Maine Sunday Telegram Player of the Year. Tyler Bridge is the first winner from Class D to ever win the Fitzpatrick Trophy and the first winner from Wells. Here are some of his statistics. Tyler accounted for 3,055 all-purpose yards with an average of 254.6 yards per game. He set an unofficial state single season record with 45 touchdowns. Twenty-one of those touchdowns covered 30 yards or more, ten were 50 yards or more. He was also a devastating blocker and good coverage quarterback with four interceptions. He excelled from the season opener to the finish, when he rushed for five touchdowns and threw for a sixth as Wells beat Foxcroft Academy for its third straight State Title. Simply put. Tyler's an unbelievable athlete, a super humble kid both on and off the field, who is also ranked in the top fifth of his class. He's also a very good basketball play, helping his team to the Class B Southern Maine State Championship game this past year and will no doubt be a force to be reckoned with on the baseball diamond this coming season. I'm honored to have him here today to receive this much deserved recognition. Also with us today is Tim Roche, the Head Coach of the Wells High School football team, who has won four State Championships under his watch. Coach Roche has won State Titles in 2011 in Class C, in 2017, '18, and '19 in Class D. The team has won 28 straight games dating back to 2017 and he was recently named the Class D Coach of the Year by the Maine Football Coaches Association. More importantly, other than the fundamentals of football, Tim teaches his players to be good citizens, to respect each other and themselves, to strive to be good leaders both on and off the field and in life. I have a great deal of respect and admiration for the role Tim has played in these kid's lives and I thank him for that. My congratulations to both Tyler and Coach for a tremendous season. Thank you, Mr. President.

Senator DIAMOND: Thank you, Mr. President. Ladies and gentlemen of the Senate, I just wanted to rise briefly and say how appropriate and how timely this resolution is. The month of April, but more importantly the time of year. So many committees are now working on this very important issue of child abuse. We now have the Committee on HHS who, of course, has been working on it for a few years and the GOC, Government Oversight Committee, last year put out a report and another one this year, defining some of the severe problems we all face and the State faces in protecting these children. So I just wanted to rise and say this is very, very timely. Some of the gains we've made over the years are just that, some gains. This is an opportunity this year to really do something great by coordinating all those committees together, taking advantage of all their expertise. Along with that we have the Governor's budget. She has actually put in an entire reorganization of the Computer Crime Unit, which goes hand-in-hand with all of this. So this is the year we have a chance to really make a difference in protecting kids who are being abused and neglected and sexually assaulted. So I'm excited about the last three months of this session to see what we can do. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT**: Thank you, Mr. President. I, too, want to rise and support this resolution. We talk a lot about adverse childhood experiences in the Education and Cultural Affairs Committee and long lifetime impact it has on their health; on their ability to be successful, contributing members of our society. This is not just an issue of poverty. This is something that impacts our middle class and upper class as well. So in April we get to talk about this even more and celebrate the good work that's happening, because there are some amazing organizations and professionals who are dedicated to addressing this issue. But we all have a role to play in healthy childhood development. This month I ask all of us to consider mentoring a child or mentoring a parent. I think we all know somebody in this Chamber who is a new parent and probably would welcome our support and guidance. Continue to advocate for policies that support children

and families and, finally, consider donating your time or your money to these wonderful organizations that serve our children. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator **CARPENTER**: Mr. President, just to follow on the comments of the two Senators from Cumberland, Senator Diamond and Senator Millett. I think I'm up to pretty close to 30 cases now involving probably in the order of, I should count and get an actual number, around 45 children. Picked up a new case yesterday and just got the word from my secretary this morning I picked up two new cases today.
